## NEWSBRIEFS

### Candidate viewing

An opportunity to meet candidates for local elections will be Saturday, April 19, 10 a.m. to noon, in an event sponsored by the Concerned Citizens of Horizon City at the Emerald Springs Golf Club. Candidates have been invited to speak for five minutes and briefly answer audience questions. The El Paso County Water Authority will make a presentation on the proposed \$45 million bond election.

### Voting by touch

With early voting to open next week it is easier than ever for voters to cast their ballots, from anywhere in the county, due to touch-screen voting. El Paso County Elections Administrator Helen Jamison said those casting early votes may do so from any early-voting location in the county regardless of whether it is within their home precinct. Between April 16 and 29 voters can reach out and vote for candidates of their choice with touch-screen technology. "The voter is given a 'smart card' that has the voter's precinct number which will bring up the correct ballot style and correct candidate names for that individual precinct and entity," Jamison said. "That means that every entity that we contract with will be programmed into the system and any voter will be able to vote at any location during early voting." A listing of these locations is on page 3. The County also has two mobile units which will be at various locations during early voting days — information is at 546-2154. On election day, votes must be cast at the voters' home precinct polling location.

### In other news

■ An economic and business informational workshop, hosted by the Town of Horizon City, will be held Wednesday, April 19 at the Oz Glaze Senior Citizens' Center at 6 p.m. The workshop is an initiative arising from the recent Horizon economic development summit and will acquaint local businesses with a proposal to create a local economic development council. Marketing consultants Scott Goodwin and Geronimo Garcia will make presentations regarding use of standard graphics in signage, advertising and promotional material to strengthen local economic identity. The meeting is open to all businesses in the wider Horizon area. The Horizon marketing study was funded by the Horizon Communities Improvement Association (HCIA) and further information is available at 852-1811.

### Tie a yellow ribbon 'round the old pecan tree...

CLINT — The bright yellow ribbons are not tied to an old oak tree as suggested in the song which inspired them, and the pecan trees lining North Loop near the town of Clint are still young, but the sentiment remains the same — the community of Clint wants those who have gone away to come home again. ## Horizon water authority asking voters for \$45 million in bonds

HORIZON — The El Paso County Water Authority, which serves the greater Horizon area, is asking voters to approve \$45 million in tax bonds when they go to the polls on May 3.

In a release mailed to Horizon residents last week, the EPCWA claims an annual growth rate of 9.32 percent over the last six years, and says the district "can expect continuous and accelerating demand upon its water and sewer system."

"Like many areas of El Paso, our district...has been experiencing tremendous growth in recent years," reads the release. "While developers contribute the infrastructure for new development, the district maintains the system after dedication. Many areas of our water and sewer system are old and major line replacements and upgrades can be expected in the future."

The release says that over the last several years the district has issued all of its bonds previously authorized by voters and that future projects will have to be funded either by tax bonds approved

by voters on by selling revenue bonds which do not require voter approval.

"It is estimated that these funds (the requested \$45 million) will be spent over the next 20 years to rehabilitate and improve the district's water and sewer system as part of a long-range plan to ensure our community remains strong," the release says.

If approved, the bonds would be released in stages so that growth in the district would provide sufficient tax base so that the tax rate would not have to go up, the release says, noting that cost of tax bonds can be "spread not just over the homeowners but over all property owners, including commercial property and undeveloped property."

However, should voters turn down the bond issue, the district will be "forced to raise water and sewer rates to repay the debt" incurred to make replacements, additions and repairs to the water system infrastructure, the release says.

## Council infighting impedes progress for the City of Socorro

Mayor, some representatives air their views after one-minute council meeting

SOCORRO — The regularly scheduled Socorro City Council meeting on April 3 was without a quorum and lasted only one minute. Mayor Irma Sanchez and City Representatives Sam Brewster and Gary Gandara were the only council members present.

Reasons given by those who did not attend the meeting appeared justified, although some

rumors lingering around City Hall stated otherwise. Community members feel the lack of a quorum was in protest against agenda items not being placed on the council agenda by Mayor Sanchez. They believe this to be one reason for the absence of at least one City Representative.

If the rumors are true, this type of action by council members is consistent with the type of infighting present for at least the last three

## Highly contagious poultry and bird disease suspected near El Paso

EL PASO COUNTY — A flock of non-commercial chickens south of El Paso is suspected of having Exotic Newcastle Disease (END), a foreign-origin virus that is deadly to poultry and birds.

A U.S. Department of Agriculture (USDA) veterinarian examined the birds Saturday, April 5, after receiving a report of high death loss in the flock. While awaiting laboratory confirmation of the presumptive diagnosis, which should be completed by Friday, April 11, a team of state and federal animal health officials has gathered on site to contain the

flock and to assess the area to determine if infection may have spread to nearby flocks, or if birds or poultry might have been exposed to the sick birds recently transported from the area.

If the disease is confirmed Texas would be the fourth state to be stricken by this foreign

poultry disease since October 2002 — others are California, Arizona and Nevada.

"An END outbreak creates an extremely serious situation for bird owners in Texas. With the possibility that this disease is in our state, we again remind bird owners that they must follow strict biosecurity procedures and movement restrictions in order to guard against the accidental introduction of disease to their flocks, to other backyard or hobby flocks, or to the Texas and New Mexico commercial poultry industry," warned Dr. Bob Hillman, Texas state veterinarian and executive director for the Texas Animal Health Commission (TAHC), the state's livestock and poultry health regulatory agency.

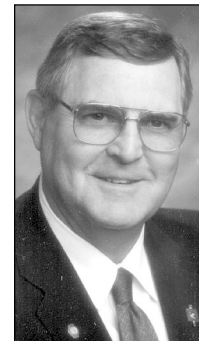
"Bird and poultry owners must not move birds from the El Paso area," he said. "When buying birds or poultry, ensure also that they did not originate from quarantined areas in southern California. Because END can spread from direct contact, keep newly purchased birds isolated for at least 30 days."

Dr. Hillman explained that, while END usually has an incubation period of two to 15 days, pet birds, especially parrots, can be infectious for more than a year, without exhibiting any signs of illness. Commonly, END can cause birds to sneeze or gasp and develop a greenish, watery diarrhea. Birds may also develop muscle tremors, a twisting of the head and neck, complete paralysis, or a swelling around the eyes and neck.

However, in many cases, sudden death loss is the only sign that a problem exists within the flock.

"END does not affect humans, and chicken and eggs are safe to eat. For the poultry and bird industry, however, END has deadly — and expensive — consequences.

As of early April, more than 3.5 million birds in southern California have been destroyed to stop the spread of the disease. In late winter, END also was detected in several backyard flocks in Nevada and Arizona, but fortunately these small outbreaks were eradicated quickly.

# One perspective

## Chicken Little

It is spring-time for sure. Water has arrived — irrigation water that brings life and color back to the fields and orchards along the Rio Grande in El Paso County’s Upper and Lower Valleys.

Driving up to Canutillo last weekend I saw thirsty fields covered with a sheen of silvery blue water the farmers had been anxiously awaiting to flow again.

Another disaster averted. The sky didn’t fall.

El Paso’s narrow escape from sure waterlessness as trumpeted by our water providers was sure a close one, wasn’t it? But El Paso managed to get their strict water conservation measures in place — just in time! — and the public perception of impending water disaster has been heightened.

Here on the border we don’t engage in pre-planning — the kind of calm, logical, well-thought-out methods of developing public projects and policy in which various aspects of concern to all parties are considered.

Instead we prefer crisis management.

The public cooperates better that way.

There’s always a few nasty little nay-sayers in the audience, but if we can make the impending disaster seem real enough to the general public they will hush up and go along with whatever it is the local government wants to do.

Afterall, somebody has to keep the sky from falling.

I’ve heard local government officials say that if they talk about these things in a logical way to the public they will just have to listen to a bunch of sniveling taxpayers bemoan their high tax bills.

They may be right about that but I don’t know for sure because in the 18 or so years I’ve lived here, I’ve seen so few well-thought-out logical projects presented to the public in a straight-from-the-shoulder, look-you-in-the-eye sort of way. Most projects without a life-threatening aspect never make it off the drawing board.

Creating a disaster has worked well for our public utilities — from the projections of “serious” shortages of electricity in fast-growing county subdivisions as justification for running high-voltage power lines through our neighborhoods to natural gas bills going up because of “weather disasters” and “uprisings in Venezuela.”

Other county water providers besides El Paso’s have used theoretical emergencies quite effectively. That’s how Horizon’s El Paso County Water Authority committed millions in public funds for a water treatment plant without public input.

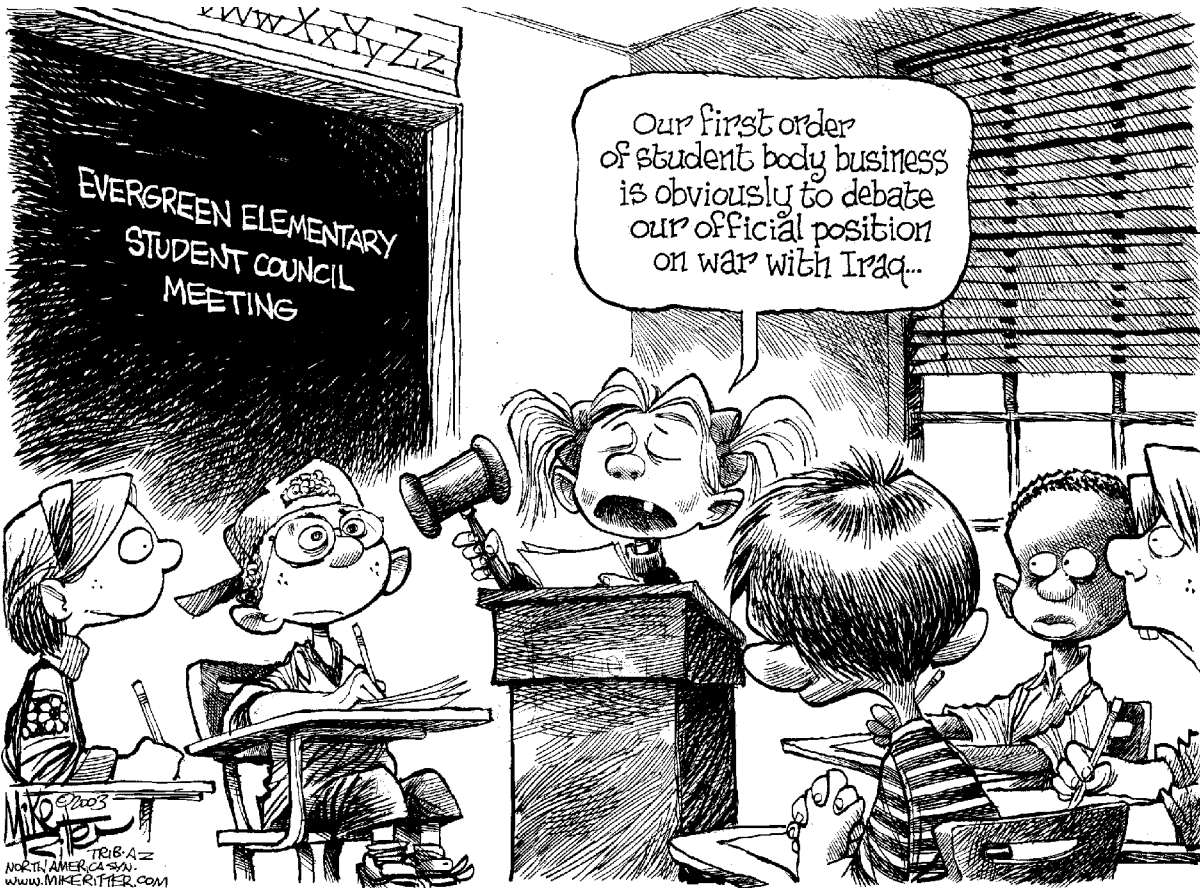
The term “water project” brings to mind all the standard images we’ve seen over the past several decades of colonia residents living in substandard conditions. Unfortunately, since many of those subdivisions have been provided water, those who are still living in those conditions are getting lost in the shuffle. A highly questionable new “study” suggests that all but about 3,000 or so county residents now have water. Therefore, state and federal funds intended for water projects — hundreds of millions of dollars — can be snapped up by “regional water planners” to pay for studies, projections, power and control rather than on finishing the job.

Worse yet, it appears that thousands of water project dollars have been misused on personal expenditures by the very people entrusted with the good of the community.

I stand equally in awe of our road construction planners and crews.

### CHIP essential to El Paso children

The state Children’s Health Insurance Program, known as CHIP, is critically important to El Paso area children and families. CHIP provides children of working families with basic healthcare coverage, including regular checkups, immunizations, eyeglasses, doctor visits, prescription drug coverage, and hospital care. Currently over 25,000 children in El Paso county are enrolled in CHIP, yet state and federal budget cuts are threatening the future of this vital program.

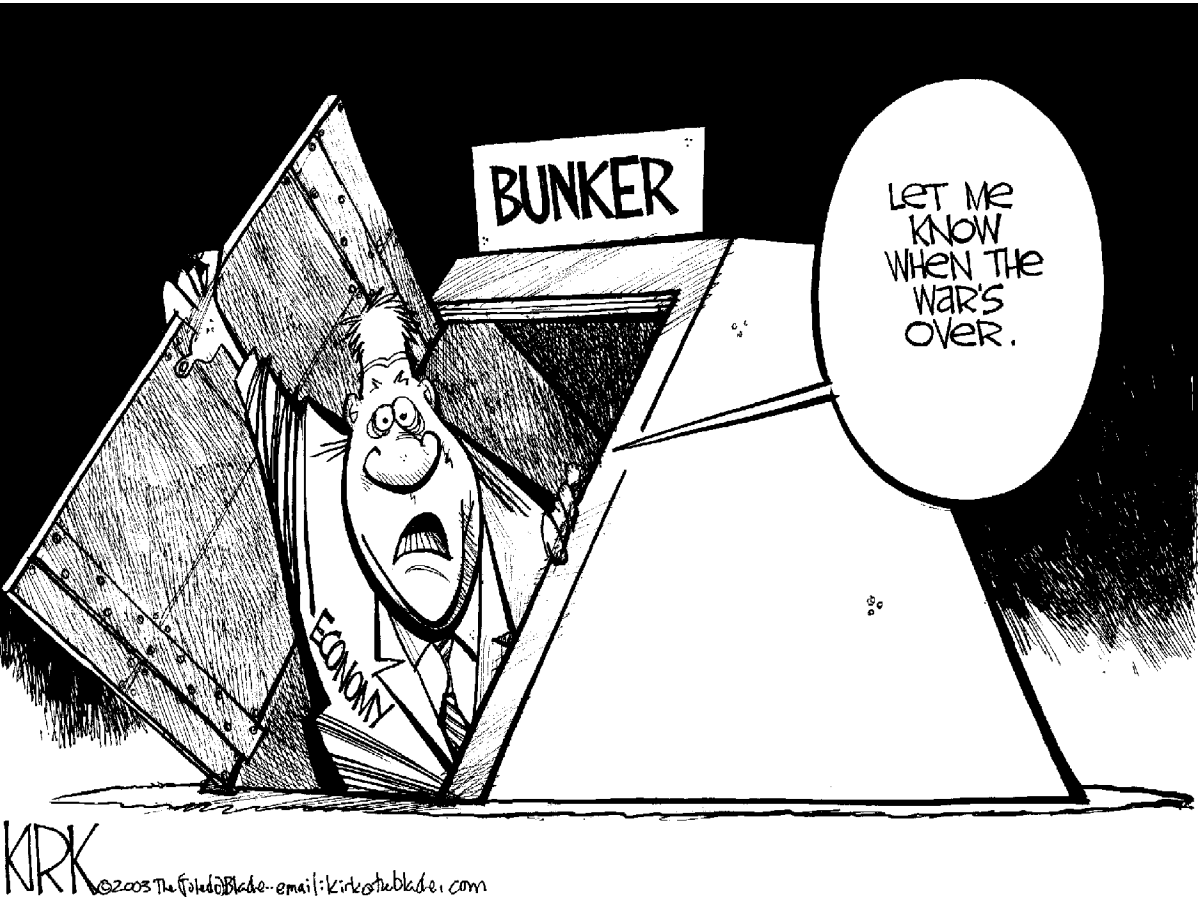
The CHIP program targets children from working families with incomes too high to qualify for Medicaid, but too low to afford private family coverage. CHIP is not only critical to children and families, it is terribly important to the healthcare infrastructure. Our system is already taxed as it is, and cutting CHIP funding will only result in a greater burden on our hospitals.

Currently, children from families whose income level falls below 200 percent of the poverty level are eligible for CHIP. The national poverty level income for a family of four is \$18,400. That means that a family of four earning less than \$36,800 a year currently qualifies for CHIP. In an effort to curb spending, there is talk of making CHIP only eligible to families whose income level falls below 150 percent of the poverty level, or \$27,600 for a family of four. This change would leave thousands of El Paso area children and hundreds of thousands of children throughout the nation without basic health care coverage. We must fight this and other efforts to cut back CHIP.

In El Paso, we know all too well that illness doesn’t recognize a border on a map. It also doesn’t recognize a poverty line. We continue to absorb the costs of providing emergency healthcare to undocumented immigrants, and also must deal with the nursing shortage that exists throughout the U.S.-Mexico border region. Many of the families that are currently eligible for CHIP do not have access to any other source of health insurance. That being said, if these families are cut out of the loop, they will not stop trying to provide medical care for their kids. Instead, they will likely bring their children to Thomason Hospital or other local clinics for emergency care, thus creating additional costs for the county, and ultimately the taxpayer. This is not good for our children or for the general public.

Throughout the state of Texas, average monthly enrollment in CHIP nears 500,000, and has reached nearly 550,000 in the recent past. Currently there are over 9 million children in the United States without health care, 5.8 million of whom are eligible for CHIP or Medicaid. Ninety percent of these children have at least one parent who works, but for many of these families, affordable health coverage is not offered through their employers. As we work at the federal and state levels to increase access to affordable healthcare, we must make sure that children come first.

months during Socorro city council meetings. These meetings have had their share of lengthy arguing which includes name calling and finger pointing between the city representatives and Mayor Sanchez.

Efforts were made to speak to several members of the elected administration to get their views of the reason for the constant fighting.

When asked about her view of the root of the problem, Mayor Sanchez replied, “Some of the city representatives are lining themselves up to be the next mayor and it is their hope to make me look bad to the citizens of Socorro. My motives for the city of Socorro are sincere. This city needs a lot of work and needs to be cleaned up. It cannot be done if we cannot agree on issues due to personal and political agendas. Those feelings must be set aside to do what is best for the people who had confidence in us and elected us as their representatives.

“My whole purpose in running for mayor was to turn the city of Socorro into a city people could be proud of. It is disappointing to watch the progress of smaller surrounding cities and having Socorro remain stagnant. The infighting has increased and has greatly impeded the progress of our city. Socorro has great potential with proper leadership.”

## Childress sixth graders unveil ‘Character Counts’ mural project

**CANUTILLO —** Students at Childress Elementary School in the Canutillo School District celebrated recently the unveiling of their art project that depicts the six pillars of the Character Counts program.

# County takes next step toward new Fabens/Tornillo border crossing

EL PASO COUNTY — The Texas Transportation Commission has given approval for the County of El Paso to seek a presidential permit to construct a new improved border crossing between the East El Paso County communities of Fabens and Tornillo.

The county had to have approval from the state before seeking a national permit to construct the six-lane, \$11 million project. It is expected to take about six-months to obtain the national approval as compared to the state request which took a year. The length of approval time differs because the federal agencies

usually go along with what the state decides, said Commissioner Miguel Teran, a staunch proponent of the project.

Others on the commissioners court have been less enthusiastic about the project, including Dan Haggerty who voiced concern again this week that the county may be getting in over its head.

Officially known as the “Tornillo-Guadalupe Port of Entry,” the project is intended to relieve a portion of the thousands of east-bound vehicles, especially 18-wheelers, headed to border crossings in El Paso.

It will replace the much smaller,


two-lane existing border crossing at Fabens which is said to be about 70 years old.

The county will bear the cost of construction on the U.S. side, to be recouped through bridge tolls. The Mexican government and the state of Chihuahua will bear the cost of the other side in an international agreement. The federal government will kick in about \$40 million to construct the high-tech customs facilities and it will provide security and personnel.

The crossing site is about 272 acres and the bridge is expected to span about 1,300 feet over the Rio Grande.

# Veteran of 3rd Infantry Division shares unique perspective on war, then and now

Rivers have played a major role in the history of the 3rd Infantry Division.

Now the Tigris and Euphrates Rivers are becoming a part of the new lore and distinguished history of the division as it battles the forces of Saddam Hussein in Operation Iraqi Freedom.

“Doughboys” of the old 3rd Division received their baptism in fire and stood firm — firm as a rock — on the banks of the Marne River in France in July of 1918. Elements of the division held against a tide of German troops in a major offensive and earned the nickname, “Rock of the Marne” division.

During World War II, the division came ashore in southern France in August of 1944 and drove up the Rhone River valley into the German heartland. This was not the 3rd’s first entry into WWII. It landed in French North Africa in November of 1942 in Operation Torch and later fought in Sicily and went head to head with Germans after coming ashore in Italy in Anzio.

Reflecting the environment in which its members now serve, the division’s distinctive blue and white patch the division is changed—muted now in taking on a desert hue.

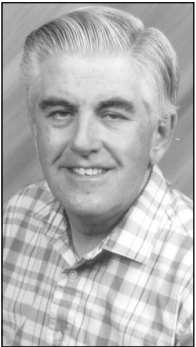
As a former member of the Marne Division when it performed a NATO role in southern Germany, I follow with interest this new chapter in its history that dates back to its birth on Nov. 21, 1917. Monthly readiness tests and field training exercises marked its Cold War mission of defending Western Europe against possible Communist aggression during the three years I was assigned to the division.

My association with the 3rd began in late 1960 when, as a young lieutenant, I was assigned to division artillery headquarters in Kitzingen as counter-mortar radar officer. With a newspaper background, I was later reassigned to the division information office in Wurzburg as assistant division information officer, supervising publication of the division’s

newspaper, the *Marne Rock*.

One of my duties was to update the division history book. I became the unofficial division historian. I enjoyed the challenge of writing about its exploits, which, at that time, covered three wars. Among its members was 1st Lt. Audie Murphy, the most decorated soldier of World War II. His actions and the exploits of the division were depicted in the movie “To Hell and Back.” He was one of 49 Marne Medal of Honor recipients, reportedly the most received by any division through the Korean War. The 3rd also received the Presidential Unit Citation and French Croix de Guerre with Palm and Fourragere in WWII for clearing the Colmar Pocket. In the Korean War, it earned two Korean Presidential Unit Citations.

The 3rd has an illustrious history and is certainly adding to it in the

history, one thing has not changed for the 3rd — and that is its purpose and mission. As it was in World War II, it is still in 2003 — to help rid the world of an evil, a dictatorship. Hitler then, Hussein now.

This is certainly the new 3rd Infantry Division that is carrying forward the proud traditions of its predecessors. I am proud of the division and my brief association with it. I am equally proud of all the other units, Allied as well as American, that are carrying the fight to Hussein. God bless them and God bless America!

I make these observations on war coverage:

Journalists are now “embedded” with a unit. Why can’t they simply be assigned to a unit as they were in the past? Embedded to me always was used in regards to inanimate objects, not people. A nail embedded in the wall; a splinter is embedded in the finger.

I don’t think the famous WWII correspondent Ernie Pyle would have been comfortable being embedded. I admire the timeless writing of Pyle — simple, yet eloquent as he told the story of GI Joe from the foxhole level. He lived their life, enduring the same hardships as the soldier. Journalists today would do well to try and emulate his approach to writing rather than trying to second guess field commanders about strategy.

It seems to me that in many cases, journalists ask carefully-crafted, multi-part questions designed more to make themselves look good rather than to inform others. They want to sound profound, but end up looking foolish. The most idiotic question came from a correspondent on an aircraft carrier who asked a pilot why he dropped his bombs on a particular target.

What is your plan, general, some ask? Where do we go from here, ask others? A thirst for knowledge; an insatiable thirst to be first with information for their viewers and readers often outweighs what should be common-sense considerations by journalists for the safety of the troops about whom they are reporting. A boxer tries not to telegraph his punches. A military commander does not telegraph his punches on the field of battle.

This is not a freedom of information thing.

Allied battle to oust Hussein and eliminate the threat of his weapons of mass destruction. Its campaign streamers include Champagne-Marne, Meuse Argonne and St. Mihiel in World War I. In World War II, battle streamers included Sicily, Tunisia, Naples-Foggia, Rome-Arno and Southern France. Action in Korea earned the 3rd new streamers. They included CCF Intervention, UN Summer-Fall Offensive and Korea Summer-Fall 1953.

Iraq will undoubtedly earn the Marne Division new battle streamers.

The advances in weaponry between 1918 and 2003 are astounding. Old photos show soldiers firing bolt-action rifles and machine guns from trenches. New technology has high-tech, rapid-fire weapons wielded by the infantryman who can see in the dark with night-vision goggles.

Lumbering tanks with limited capability made their first appearance in WWI, a far cry from the Abrams main battle tank that can fire on the run and Bradley fighting vehicles that carry infantry in greater safety.

While tactics, techniques and structure have changed in its storied

## HawkQuest brings raptors to Ensor

EAST EL PASO COUNTY — It was a first for Col. John O. Ensor School — and a first for El Paso County as the HawkQuest organization of Parker, Colorado, brought four fascinating birds to the Horizon City campus April 7.

HawkQuest is a non-profit effort to educate children and adults about eagles, falcons, hawks and owls. “I can show you a picture of a hawk,” presenter David Thomas told the crowd, “but it’s a lot more exciting if I can show you a real one.”

So Thomas and his assistants Nancy Thomas and Kathy Jo Clausan brought out the stars of the show one by one — a Harris hawk, a peregrine falcon, an owl, and a golden eagle. As the birds were displayed, Thomas explained their hunting habits and the way the birds developed eyes, ears and talons necessary for survival.

Among stories related was that of the golden eagle, a large, powerful bird boasting a six-foot wingspan.

“The only reason we have this animal is because someone decided to raise it as a pet. They took it out of the nest when it was a chick you could hold in your hand. The bird never learned to hunt for food, and was abandoned when it got too big. It came to HawkQuest after it walked up to a group of people in Idaho, begging for food.”



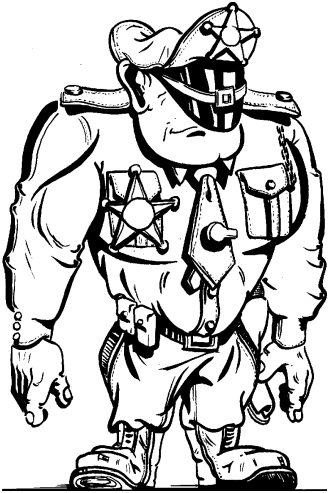

## Hybrid vehicles are alternative to dependence on oil, study says

COLLEGE STATION — Cars combining the standard internal combustion engine with a battery and electric motor — hybrid vehicles — may provide an answer to the world's energy woes and could extend the life of the world's energy supplies by 15 years, according to a study by Texas A&M University electrical engineering students.

Texas A&M electrical engineering professor Mark Ehsani had his fall semester 2002 graduate students compare cars using hydrogen fuel cells to hybrid vehicles and determined how long each car would extend the life of the world's oil reserves.

“If we were to start converting the world's vehicles into hybrid electric vehicles today, taking into account market penetration and estimating that 40 percent of oil consumption is currently due to vehicles, it would be equivalent to doubling the annual rate of oil found through international exploration,” Ehsani said. “Instead of a total depletion of oil reserves by 2038, we can delay this impending depletion until the year 2053.”

The study found that hybrid vehicles are a more cost-effective alternative than ones powered by hydrogen.

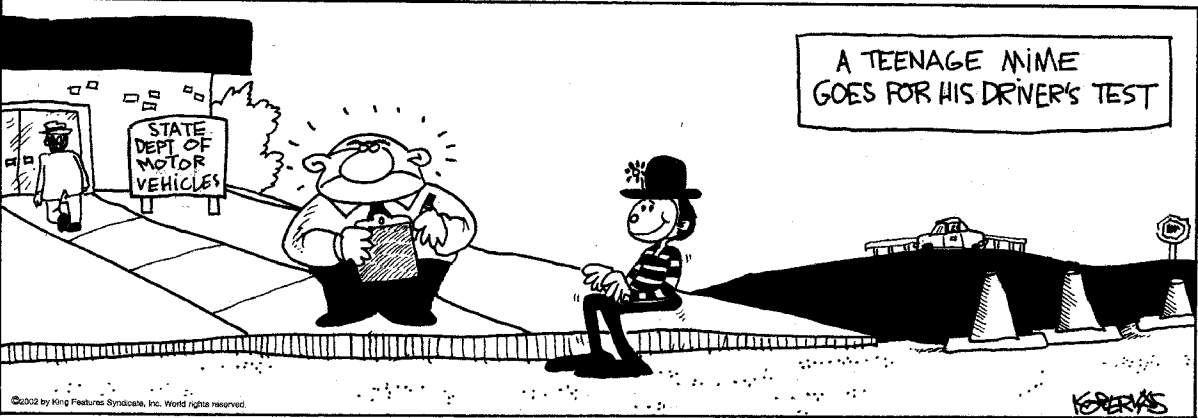

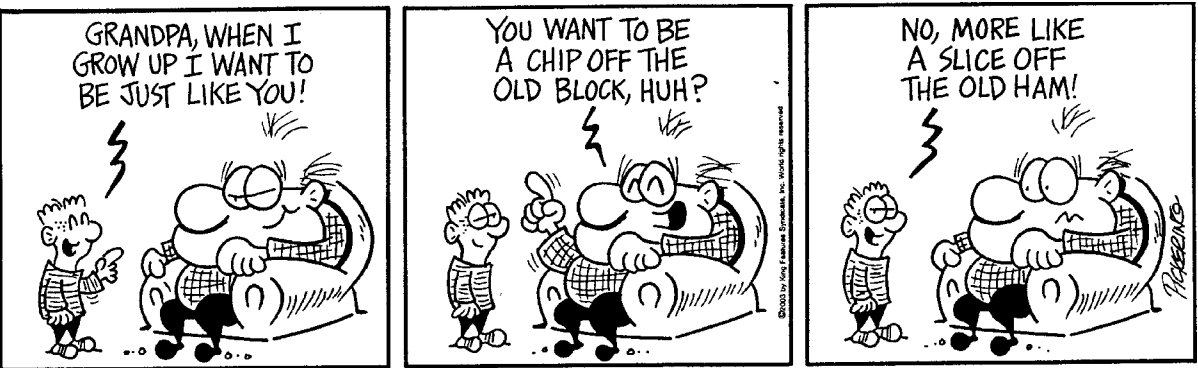

closures and construction projects mentioned nothing about the disaster we encountered Saturday morning at the intersection of Lee Trevino and I-10. Three of the four lanes heading in to town had been closed down — not for construction but for street cleaning, not during times of light traffic but during the hours of brisk morning traffic.

The only pre-planning for this disastrous bottleneck of 18-wheelers and frustrated speedsters seemed to be making sure that numerous El Paso police units were on hand with lights flashing to provide security for this dangerous project.

Better still, in their infinite wisdom, street cleaning crews were operating a massive blowing machine on the exit ramp at Lee Trevino, almost totally cutting off the only lane of escape.

Social Security Q&Q

*Q: I am about to retire. I worked for the same corporation for almost 40 years and will collect a rather sizable pension. Will this large pension in any way mess up my Social Security payments?*

A: No! The amount of your company pension has no effect on your Social Security payments. But there are some companies that will reduce their pensions after Social Security kicks in.

*Q: I am going to retire at age 62 in July of this year. I know there is an*

*\$11,520 limit on my earnings. Does that apply to the whole year or just after I go on Social Security?*

A: It applies to the whole year. The law says we must withhold \$1 from your Social Security benefits for every \$2 you make more than \$11,520. But a second part of the law provides a special rule that can be applied to your earnings for one year. For most people, it's the first year of retirement. During that year, you will receive a payment for any month you earn less than \$960. So even if you earn a lot more than \$11,520 before

you turn 62, you'll receive a Social Security payment after you retire.

*Q: I am 71 years old and have been married four times. My Social Security isn't very much. Can I get Social Security off the guy I was married to the longest? That would be number three.*

A: Maybe you can. And maybe you can get some Social Security based on the work of numbers one, two or four! But you won't get them all, only the one that pays the highest rate. Whenever you are due two or more benefits, you only get the one that pays the most, not all of them. To find out what and whose benefits you might be due, we would need a lot

more information. So please call Social Security's toll-free number, 1-800-772-1213 or visit your local SSA office.

*Q: My best friend's husband is near death. He's 67 and gets a Social Security check. But my friend is only 50 years old. Will she get any Social Security on his record when he dies?*

A: She'll probably be eligible only for the \$255 death benefit ñ at least for the time being. A wife must be at least 60 years old to qualify for monthly widow's benefits from Social Security. But there are two exceptions. If she has some physical or mental impairment that keeps her









from working, she could get a disabled widow's benefit as early as age 50. Or if there are minor children at home, we pay what we call a "mother's benefit" to widows of any age. But assuming she meets neither of these exceptions, she should file an application for the \$255 death payment after her husband dies and 10 years from now, apply for widow's benefits.


