New officer

Alex Sanchez is the new Code Enforcement Officer for the Town of Clint to help curb illegal dumping and environmental damage. He has 16 months of experience with the Clint Police Dept. as a volunteer officer and is now in a paid full-time position. His position is funded by a \$50,000 grant through the Texas Commission on Environmental Quality (TCEQ) administered by the Rio Grande Council of Governments (RGCOG). Sanchez will perform his duties from a new four wheel drive F-150 pickup also purchased with the grant. Sanchez will patrol Clint and its extra territorial jurisdiction looking for violators. Mayor Dale Reinhardt said people need to stop dumping trash illegally in and around the Town of Clint and is optimistic about the new program.

Linebacker support

Gov. Rick Perry has released the \$3.8 million pledged in February to the Texas Border Sheriff's Coalition to provide continuing support for Operation Linebacker, the coalition's effort to increase manpower and equipment to reduce border crime and violence. Since December 2005, nearly \$10 million has been provided to support the operation. "The sheriffs are the front lines of the fight against border crime, and I am pleased the state can support their continued fight against criminals and terrorists who wish to exploit our border," Perry said. "It has long been demonstrated that our strategy to increase manpower and patrols decreases the ability of criminal groups to operate in the region. Operation Linebacker is working and making our communities safer." In June, Perry announced that Texas will dedicate an additional \$20 million in available state funds to sustain Operation Rio Grande so that funding can continue to flow to local law enforcement agencies up to 100 miles from the border. Perry has also pledged to ask the legislature to authorize \$100 million in the next session to sustain border security operations until the federal government fulfills its responsibility of securing the border.

In other news

■ The City of El Paso has approved the contract with a selected vender for the redlight cameras at major intersections. The El Paso Police Department and the City of El Paso have partnered with Redflex Traffic Systems for the implementation of the City's Red Light Camera Program. The agreement was signed and went into effect on July 24, 2006. This is a oneyear agreement with an option to extend the contract for five years. The Red Light Camera Systems should be installed and operational within 90 days and will consist of 10 intersections located



TORNILLO — Seven students from Tornillo Junior High School recently participated in the

and Occupations Program (HCOP).

The federally funded program helps students learn about various health care professions and, hopefully, continue their education in order to work as a health care professional.

The HCOP Summer Camp, which took place El Paso Community College Health Careers at the EPCC Rio Grande campus, ran from June

5 to July 21. In order to be accepted into the program, students needed to submit an essay, their school transcript, and a letter of recommendation from their teacher or principal.

During the seven-week program, students were involved in academics, career counseling and presentations by local health care professionals. Also, the students were paid a financial stipend of \$600. The seven TJH students who applied and were accepted into the program were: Christina

It takes an act of Congress for Clint to use property

EAST EL PASO COUNTY — Clint Independent School District will soon be able to utilize additional land which was once the Ag Farm for Clint High School, thanks to legislation (HR 860) passed by the U.S. House of Representatives on July 18, 2006.

Congressman Silvestre Reyes introduced the bill, which removes the U.S. State Department's legal interest in a parcel of land currently owned by Clint ISD, allowing the school district to use this property to help meet their growing educational needs. The State Department approved H.R. 860, and the House International Relations Committee reported it out of committee favorably.

In 1933, the U.S. government granted 20 acres of land to the District. As the U.S. received the land through a diplomatic treaty and due to its location on the U.S.-Mexico border, the U.S. State Department retained reversionary interest in - or power to reclaim — the land.

The State Department's reversionary interest prohibits the district from selling the land which is outside Clint's boundaries in San Elizario, and due to local regulations, Clint ISD cannot develop land outside its geographic boundaries. Ridding the land of this reversionary interest requires an act of Congress, and Clint ISD approached Congressman Reyes to pass a bill on behalf of the district.



SISD names Hart as interim superintendent

EAST EL PASO COUNTY - The Socorro ISD Board Trustees has named Charles F. Hart, Jr. as interim superintendent

while the district begins the process of replacing Dr. Robert J. Durón, who resigned after he was named superintendent of the San Antonio Independent School District.





He will begin his duties as Interim superintendent for SISD this week.

The board also approved a compensation package for all employees during a special board meeting on July 25. The package adopts the state mandated scale for teachers, nurses, librarians, speech therapists, counselors and diagnosticians, which adds \$2,500 to every step of the 2005-06 teacher salary scale. This raises the starting teacher salary in the Socorro District to \$39,100.

The board also approved a six percent increase off the midpoint for information systems personnel and administrators and a seven percent increase off the midpoint for auxiliary and paraprofessional workers.



Sheriff's Office. We accomplished this task by going above and beyond what is required in terms of training and policies.

"My resolution remains the same; we will not engage in selective enforcement and will work daily to protect everyone's rights. We will continue to enforce all laws impartially and vow to protect the constitution of the United States," Sheriff Samaniego said.

"There are some misguided and well-meaning individuals who believe that law enforcement is the problem rather than organized crime groups and gangs that prey on El Pasoans and undocumented immigrants alike. These crime groups threaten our security. I will continue my strategy of positive patrol presence to dismantle and disrupt these criminal enterprises' that prey on the less fortunate."

The resolution was brought to Court by Commissioner Miguel Teran and supported by Commissioner Larry Medina. It said that the "safety and security of all residents in El Paso County... has been jeopardized by a lack of clear policy guidance regarding the enforcement of federal civil immigration law by local law enforcement agencies."

It further stated that it was important to gain the trust of immigrant residents so that "all communities" feel safe in working with local enforcement agencies, and further, that for local law enforcement agents to act as immigration agents would place an undue burden on taxpayers. It attempted to mandate that county agents "shall not single out individuals for legal scrutiny based solely on their country of origin, religion, etc., and that the immigration status of any person assisted by the county — be they crime victim, witness or other — not be questioned by law enforcement.

Big Bend National Park, Amistad National Recreation Area, Fort Davis National Historic Site, and Guadalupe Mountains National Park are all exciting locations to explore with your family.

Big Bend National Park

Covering more than 1,250 square miles, Big Bend National Park is the largest protected area of Chihuahuan Desert in the United States. Big Bend is a favorite area of many archeologists who have discovered artifacts they believe to be 9,000 years old. There are historic buildings and scenic landscapes that give visitors a glimpse into pioneer days along the Rio Grande. Due to its remote location, Big Bend is one of the least-visited national parks in the contiguous United States. However, it is a favorite park for hiking and backpacking on numerous trails including the Chimneys Trail, the Marufo Vega trail, and the Outer Mountain Loop that takes visitors on a breathtaking tour through the Chisos Mountains. Amistad National Recreation Area

Fort Davis National Historic Site

At the Fort Davis National Historic Site nestled in the rugged Davis Mountains in West Texas you will find one of our nation's most remarkable examples of an Indian Wars frontier military post still in existence. Today your family can explore the twenty-four remaining roofed buildings including of five refurbished buildings that take you back to the 1880s. During the mid to late 19th Century Fort Davis was a strategic stronghold for the United States due to its location near the junction of several pivotal routes including the Trans-Pecos portion of the San Antonio-El Paso Road and the Chihuahua Trail. Fort Davis also holds great historical significance in the role African Americans played in the settlement of the Wild West and their service in the frontier military. Several

ments including the 24th and 25th U.S. Infantry as well as the 9th

and 10th U.S. Cavalry were stationed at the post following the Civil War. Fort Davis was abandoned in June of 1891 having "outlived its usefulness" according to the United States Army.


Guadalupe **Mountains National Park**

Families more important than politics



House of Representatives finished its legislative work before breaking for House considered bills affecting working families in El Paso and line pilots. across the nation, but unfortunately, the House Republican leadership did not always have the best interests of those families in mind when crafting this last-minute legislation.

The House considered a pension bill that missed an important opportunity to address the U.S. retirement security crisis, as well as a minimum wage bill so weighed down with tax provisions that the Senate has signaled they will not even consider it.

Pension bill

This bill was a disappointment, especially at a time when El Pasoans are deeply worried about how they are going to pay for their retirement. It failed to slow the severe underfunding blocked the LHHS bill and instead

Late last of private pension plans, it failed to brought HR 5970, the Estate Tax, shore up the federal pension insurance agency — known as the Pension Benefit Guaranty Corporation, and it failed to encourage companies to keep offering traditional pensions to their employees. The bill will also lead to pension benefit cuts — often very deep the summer district work period. Minimum Wage

The minimum wage has not increased since 1997 and is now at its lowest level in 50 years, when adjusted for inflation. Nearly 75 percent of minimum wage workers are adults over the age of 20, many of whom are responsible for over half of their family's income. There are also 760,000 single mothers who would benefit from a raise.

In June, Democrats successfully attached an amendment to the fiscal year 2007 Labor, Health and Human Services (LHHS) funding bill to increase the minimum wage from \$5.15 to \$7.25. However, House Republicans

Minimum Wage, and Extenders bill, to the floor Saturday night for a vote.

Democrats have forced votes on the floor of the House of Representatives eight times during the year, and have pressured Republican leaders to hold a fair up-or-down vote on urday night's eleventh hour package was effectively a strategy for the majority to block minimum wage legislation while providing political cover for vulnerable Republican Members. By attaching provisions to reduce the estate tax permanently and extend expiring tax breaks, the majority created a bill destined to fail in the Senate. Senate tax-writers have already rejected, on a bipartisan basis, proposals combining the estate tax with a tax extenders package.

The needs of our working families are too important for politics and partisan squabbling. We need to work together to address these pressing needs, and ensure that, throughout one's professional career and during their retirement, they are able to earn a livable wage and live with dignity.
