### Beneficial reading

In less than nine weeks, students in Christine Hayden's English Language Arts 7th and 8th classes helped get 100 books to disadvantaged children nationwide. As part of Scholastic Book Clubs Classrooms Care initiative, these students promised to read 100 books and in turn the company would donate 100 books to children in need. Hayden's goal for her students was to finish by winter break, but realized seven weeks from the start of school her students had reached their mark. "We had some students reading three or four books because they really love reading and this gave them a purpose to read more," she said. "I am proud of them because this project was in addition to what we do in class." These students are part of a big network of classrooms across the country that have joined together to get books to children, including many who have been affected by natural disasters such as Hurricane Katrina. Scholastic Book Clubs Classroom Cares is a literacy based campaign to teach children about the joys and importance of reading and giving. The campaign is on going until Dec. 31, 2006 and its goal is to donate a total of one million new books.

The vehicle in question at the site of the arrest on Oct. 6 was an RV in which was found items "that are not normally stored in a recreational vehicle," and were subsequently found to have been stolen from the Wal-Mart in Las Cruces, valued between \$5000 and \$10,000. Christopher J. Sherman, 41, a Minnesota resident, was arrested.

■ The abandoned Clint Cemetery, located among cotton fields off of San Elizario Road, will be getting a clean-up this Saturday, Oct. 28, thanks to the Upper Rio Grande AmeriCorps group. "Not too many people in the area are even aware of its existence," said Romy Ledesma, AmeriCorps program manager with the Texas Cooperative Extension. Records show that there are only 16 visible grave markers in the cemetery, probably dating between 1900 and 1933, and are believed

## University 101 comes to San Eli

SAN ELIZARIO — SEHS seniors take college applications seriously.

Eddie Barragan already knows where he wants to go to college and what he wants to major in. In fact, he can envision what he'll be doing in the next 10 years.

"Working at a company like Sony designing circuits," Barragan said.

As the top ranked student in the 2006-2007 senior class, even this soon-to-be Texas Longhorn is looking to still take advantage of available scholarship money in order to see his vision through. Barragan, along with 49 other seniors with a 3.0 grade point average attended a workshop with UTEP recruiter Karla Iscapa in order to fill out the Texas Common Application and to get started on applying for UTEP scholarships.

"These students will have an opportunity to apply for the Presidential Excellence Scholarship (\$16,000), the Presidential Scholarship (\$8,000), and a few other scholarships at UTEP," Iscapa said.

The class of 2006-2007 is taking the college application process seriously. According to Joe Keith, principal, every senior has submitted an application to El Paso Community College and UTEP. In fact, all seniors are required to fill out the Free Application for

Federal Student Aid (FAFSA) regardless of whether they are going to be attending college or just aren't sure yet.

Students are not only encouraged to look into local colleges and universities, according to Dickie Garza, lead counselor at SEHS. Next week, top seniors will have the chance to talk to admissions representatives from Boston University, an opportunity made possible by SEHS teacher Terry Baca, who graduated from the school.

Garza, when asked how important it is to expose SEHS students to different schools, said, "It's extremely important. That's why we'll be taking them to The College Fair on November 23 at Socorro High School."

"We're going to take as many seniors as we

## Town of Anthony adopts new budget with lower tax rate

ANTHONY — The Town of Anthony, Texas adopted a budget for the 2006/2007 fiscal year totaling 2,300,158 which includes the General Fund budget and Water and Sewer Budget combined.

To support this budget, the Town Council adopted a tax rate of .433112 per \$100, a reduction from last year's rate of .4774686. According to Mayor Art Franco, the Town Council felt they needed to approve the lower tax rate which is the effective tax rate rather than the rollback rate. He said the Town would have been able to receive additional funding by adopting the rollback rate and the citizens would not have been able to have an election rollback.

He said the council believes the citizens need a break considering the increase in the appraisals and increased taxes by other entities. Also the town received more money than was budgeted last year due to the increase in new construction. Other revenue increases included additional fees such as building permits and other charges associated with construction.

The town anticipates additional funding for the upcoming fiscal year due to several commercial ventures committed to locating in Anthony. Three residential subdivisions are currently under construction.

the judges and the audience.

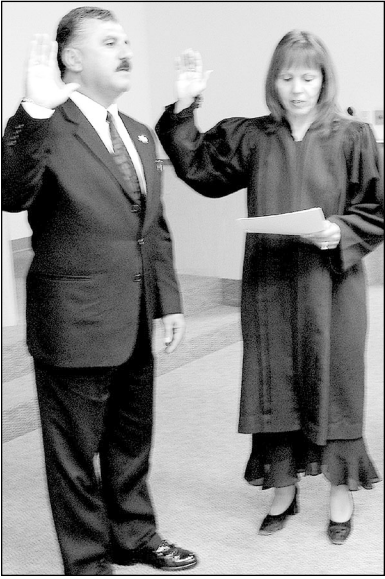
As the performance concluded, the students congregated around the buses, some shedding tears of joy because they had played and marched their best while others shed tears because they felt they had made mistakes.

# Canutillo ISD administrator appointed to Texas Commission on Fire Protection

CANUTILLO — Yusuf Farran, P.E., R.S., executive director of Facilities and Transportation for Canutillo Independent School District, has been appointed to the Texas Commission on Fire Protection by Gov. Rick Perry.

Farran was administered the oath of office by U.S. District Judge Kathleen Cardone during a ceremony on Oct. 9 at the CISD Administrative Facility. His term of office expires Feb. 1, 2009.

Farran will join the 13-member commission whose mission is to help protect the lives and property of the citizens of Texas by developing and enforcing professional standards for the fire service.

Farran is a current member of the El Paso City/County Board of Health, the Texas Society of Professional Engineers, and the El Paso Community College Foundation. He has also served on the El Paso City Water Conservation Advisory Board and the El Paso City Plumbing and HVAC Board of Appeals.

Farran has over 20 years of civil, environmental, and sanitary engineering experience. He earned a bachelor of science in mechanical engineering and a master of science in civil/environmental engineering degrees from the University of Texas at El Paso.

In March 2004, Farran was hired by CISD to be the district's first construction administrator. In March 2006, he was named executive director of Facilities and Transportation.

# City of El Paso pulls officers from off-duty service as funeral escorts

EL PASO — El Paso Police Chief Richard Wiles has announced that off-duty El Paso Police Officers will no longer be allowed to function in funeral escorts beginning Dec. 1. The decision comes after a severe traffic collision that resulted in serious injuries to an off-duty police officer who was conducting a funeral escort.

The latest injury involved a 16-year veteran of the El Paso Police Department who on Saturday, Sept. 30 was working as a funeral escort in Socorro and was seriously injured in a collision.

"This decision is being made to prevent any deaths of officers or further injuries," said Wiles said in a prepared statement. "In addition, since many injuries involving these escorts have been serious in nature, the officers are being forced to take


leave and be away from duty which also impacts the safety of other officers due to current staffing shortages. The El Paso Police Department has investigated collisions involving citizens as a result of escorts. Due to a provision in the contract between the El Paso Municipal Police Officers Association and the City of El Paso, Officers injured in off-duty employment whose off-duty employer does not provide workman's compensation insurance can make a claim with the City of El Paso workman's compensation program to pay for the injury."

The statement further said that this results in taxpayers monies being expended for off-duty employment injuries. The research included Salt Lake City, Reno, Detroit, the State of California, Dallas, Phoenix, Tuc-

son, Albuquerque and Denver — all of which have prohibited their officers serving as funeral escorts.

Effective Dec. 1, El Paso Police Officers will not be allowed to participate in this type of off-duty employment. The statement said this announcement was being made to allow time for the escort service to find replacements from other agencies if they wish to continue this practice.

"The El Paso Police Department respects and believes that those deceased deserve respect and tribute," Wiles said. "However, the lives and safety of our officers and citizens must also be considered." This decision will apparently affect about 12 officers. There are currently 288 off-duty employment permits not including the escorts, the statement said.

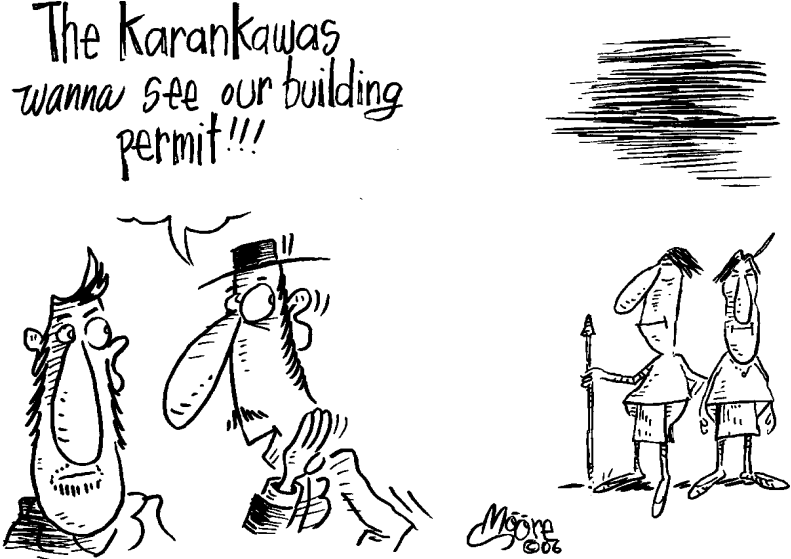
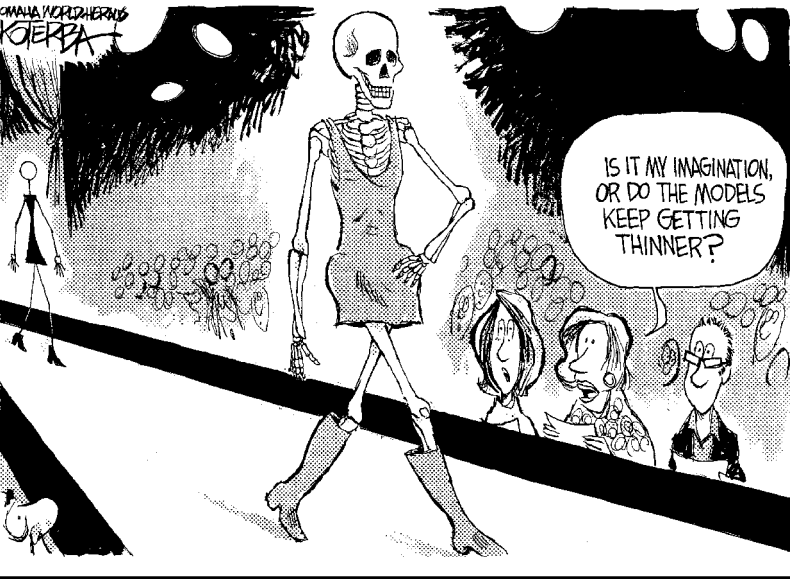

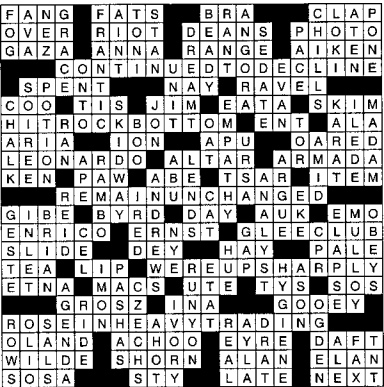

# San Elizario wins first district title in tennis

SAN ELIZARIO — In just its third year as a program, the San Elizario High School tennis team won its first District 2-4A title ever with a 10-5 win over Riverside on Oct. 18 in a match that took two days to complete because of darkness.

"Tennis was the last sport these kids thought they would ever play," said coach Pedro Vasquez, noting that San Elizario is traditionally a soccer community. "So it's very gratifying to see that hard work and determination can lead to success."

Both schools entered the final meet with identical 5-0 district records, meaning that the winner would automatically take the 2-4A title. And while both schools will be heading to Wichita Falls, Texas for the Regional round of play, pride and a better regional seeding were at stake.

The match that would best define the whole meet was the boys doubles tilt between Riverside's Anthony Navarette and Angel Hernandez against San Elizario's Hugo Melendez and Adrian Solis.

Facing Riverside's top player in Navarette, San Elizario started the match slow, double faulting away points and committing numerous unforced errors. As Navarette and Hernandez cruised through the first set 6-1, the rest of the San Elizario team wasn't faring any better, according to Coach Vasquez.

San Elizario began the second set

with better serving by Solis and strong net play by Melendez. More importantly, the duo managed to break Navarette's big serve by putting the ball in play and forcing Riverside to commit their own errors, changing momentum in favor of San Elizario in both the match, and, it seemed, on the surrounding courts, as San Eli picked up important victories as the afternoon wore on.

With the doubles match now tied at a set apiece, Navarette had his chance to open the third set with his dangerous serve, but his four double faults to open the frame set the tone for what should have been a tough deciding set. Instead, Melendez and

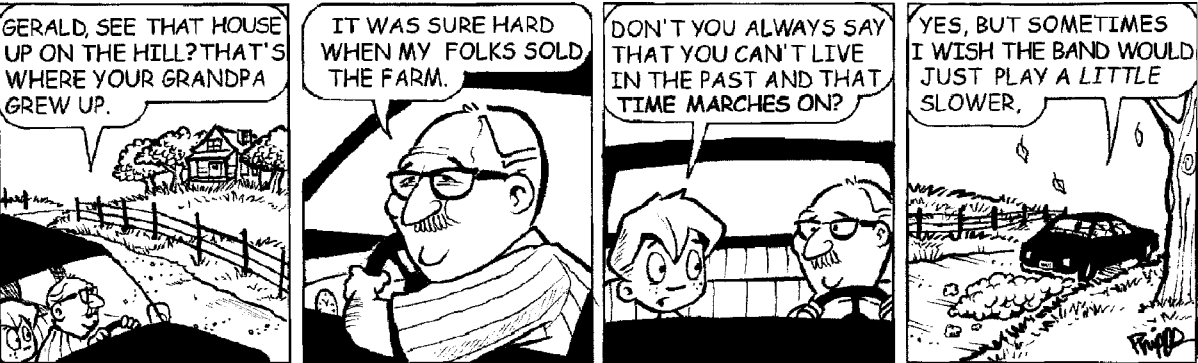

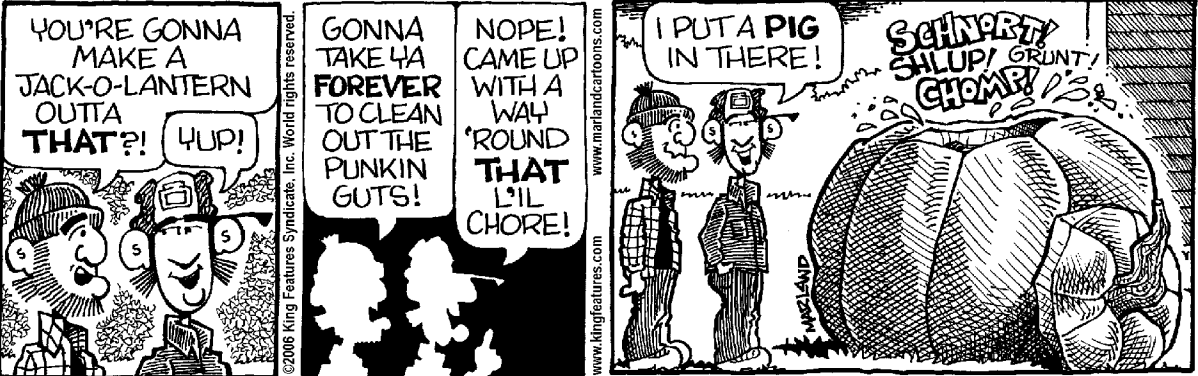

# Social Security Q&A

**Q:** When a Social Security beneficiary dies, does the funeral home notify Social Security or is notification the responsibility of the family?

**A:** Many funeral directors voluntarily provide death information directly to Social Security. But family members of a deceased individual still have the legal responsibility to notify Social Security.

**Q:** Last month my husband, who receives Social Security disability ben-

efits, was convicted of a felony and sentenced to prison. Will my 13-year-old daughter and I continue to receive Social Security benefits?

**A:** Yes. Social Security benefits are suspended if an otherwise eligible person is confined in a jail, prison or other penal institution for more than 30 continuous days due to conviction for a crime. But eligible family members can continue to receive benefits.

**Q:** What is the average monthly So-

cial Security disability benefit payment, and does it rise every year with the cost-of-living?

**A:** The average monthly Social Security disability payment for an insured worker is now \$943, and the monthly benefit payment for a disabled worker and a spouse and one or more children is about \$1,575. The payment amounts do increase each year, based on the increase in the Consumer Price Index. All Social Security (and Supplemental Security Income) beneficiaries received a 4.1 percent increase in 2006.

**Q:** For several years I have been re-

ceiving monthly Supplemental Security Income (SSI) payments because of a disability. I took up pottery last year as a personal hobby, but friends tell me that some pieces are good enough to sell at a local artists' market. If I would actually sell any pottery, would that affect my SSI payments?

**A:** Possibly. Any money you would get for selling your artwork would probably count as income in the month you get it. However, Social Security does not count all of your income so you could end up with more money. You should contact your local Social Security office for more information.

**Q:** If someone is collecting Social Security disability benefits, what happens when the person reaches retirement age?

**A:** If a person is getting disability benefits when he or she reaches full retirement age, benefits will be automatically changed to retirement benefits, generally in the same amount.
