#### **Juveniles beware**

The consequences teenagers face when they agree to become "drug mules" and try to smuggle drugs from Mexico through the International Ports of Entry can be severe. For several years now, drug dealers have recruited teenagers from bars and night clubs in Ciudad Juarez, offering them hundreds of dollars to drive cars loaded with drugs across the border. The dealers falsely claim that nothing will happen to them if they are caught because they are "underage." The recruiting becomes particularly aggressive during spring break. More El Paso teens than usual take advantage of the off-school period to party in Juarez during the break. "We need El Paso families to be aware that teens that get caught smuggling drugs might have to spent months in Juvenile Detention Facilities, and in some cases, they can be sentenced to serve several years in an adult prison," said El Paso County Attorney José R. Rodríguez.

#### **Distinguished** performance

#### Water hazard

Due to spring runoff and early release from dams in New Mexico, the water levels in the American Canal are dangerously high and the U.S. Customs and Border Protection is issuing warnings to anyone who attempts to cross the waterways that parallel the international boundary. On Sunday, a migrant was pulled under and swept away by the undertow after entering the canal waters and was found alive an hour later clinging to a drainage tube. The swift, high currents and other dynamics are sufficient to pose a danger even to the best swimmers. CBP agents have rescued 27 migrants in life-threatening conditions

# Canutillo High School senior qualifies for state computer exam

UPPER VALLEY — Victor Solis, Canutillo High School senior, qualified to take the State Computer Technician Exam by placing third in Computer Maintenance, one of over 70 contests held recently during the Texas SkillsUSA competition at Western Technical College. ## **Red Sands Elementary gets** smart about Internet safety

Keeping students safe is always a priority at the Clint ISD's Red Sands Elementary and that includes keeping students safe while they are on the Internet. Officers Gerry Ceniceros and Efren Pulido from Socorro ISD Police Services were invited to the campus to educate all third, fourth and fifth grade students on how to be safe while on the Internet using a program called NetSmartz Workshop.

During the sessions, students were advised by the NetSmartz program to never meet in person with anyone you first met on line; tell groups which are easily accessed on the an adult you trust if you are scared, uncomfortable or confused; and ask parents before

sharing any personal information.

Officers Pulido and Ceniceros also advised students against visiting sites like My Space. "Never give personal information. There is no way to tell who you are talking to," says Officer

Ceniceros.

the workshops we found that about a third of our 3-5th graders visit My Space. One student had even invited a stranger to meet at his house," says Michael Mackeben, Red Sands Elementary Principal. For this reason, the school decided to provide the NetSmartz Workshop to parents as well.

During the parent workshops, parents were made aware of the types of dangers that children may encounter while on the Internet. The Internet does contain useful and educational material. However, students may come across dangerous content such as sexually explicit material, hate group web sites, promotional material about drugs, graphic violence, and cult

San Elizario High School senior from Class of '89 finally receives diploma

SAN ELIZARIO — Yvette Garcia was not unlike many parents. She worked hard devoting most of her time to raising three children. Yet there was something missing in her life, something Yvette had put aside for many years, at least since 1989. She had never received her high school diploma.

One day Yvette was visiting San Elizario High School to attend to some paperwork related to one of her daughters. She was unprepared for what happened next — she was presented with her high school diploma.

With the help and encouragement of a friend, Yvette had registered to take the math portion of the TAAS test which was the only element she needed to fulfill in order to receive her diploma. Soon after testing, however, she received a letter that notified her that she still needed to pass the test because she was recorded as being absent on the test day. Disappointed and a little unsure of herself, Yvette did not pursue the matter further.

The journey that finally lead Yvette to receiving her diploma began back in 1989. At that time Yvette was trying to finish school and adjust to being a mom to daughter Valerie who was just six months old. Although she was allowed to walk at the graduation ceremony, Yvette was not given her high school diploma. She needed to return the following summer and pass the mandated TAAS test but she didn't go back. Later Yvette accompanied a friend to El Paso Community College and registered for classes, but again she never went back. She was too embarrassed to tell anyone at the college that she did not have her diploma.

Instead, Yvette concentrated on caring for Valerie and then her family grew with the arrival of two more children, Stephanie and Adrian. Soon she began working, juggling still more responsibilities when she became a single mom. Achieving her high school diploma at that time was not a priority, and time passed.

On that fateful day in January of this year when Yvette visited San Elizario High School, Ricardo Garza, Head Counselor at the high school, had organized an impromptu celebration for her. Garza and other school administrators brought in Yvette's daughters, Valerie and Stephanie, to the office to hear the happy news. "They saw me there and asked if they were in trouble. I showed them the diploma and they cried and told me they were so happy for me," she said. "I wanted to prove to my kids that I could do it. That I finished what I needed to," added Garcia.

Yvette's children are also excelling, both Valerie and Stephanie are members of the varsity volleyball at San Elizario High School. Valerie will soon be attending college, possibly in Seattle. While Yvette's youngest, Adrian, is a student at Campestre Elementary.

But Yvette's story does not end here. She continues to pursue other goals like attending a computer literacy class through the San

I was talking to a friend who recently came home from Iraq. The history, intricacy and even the artistry involved in the way humans design and utilize explosive weapons is a source of morbid fascination, you know, a little like staring at a deadly viper in a zoo knowing you are safely separated by several layers of unbreakable glass.

Unfortunately, weapons of this nature, like snakes of the most venomous kind in the wild, aren't always so mercifully separated from vulnerable human flesh.

The death and devastation that follows the mining of a field by warring factions is a global shame. These machinations of destruction don't evaporate with the cessation of armed conflict. Instead, they lie dormant but deadly long after the soldiers are year in the fields of war. gone, only to be activated by the most innocent of passers-by.

Whatever my opinion may have been of the personal drama that surrounded the late Diana, Duchess of

Humans Wales, I admired her deeply for love things choosing the global problem of landmines as her cause to champion. As a result of her astounding popularity, she was able to focus a glaring spotlight on the problem by walking

That was no small feat.

According to the Centers for Disease Control, the incidents of landmine injuries doubled between 1980 and 1997 and an estimated 2,000 people — mostly civilian men, women and children — fall It is something the children aspire victim every month to landmines left behind in the wake of armed conflict. An estimated 800 will die of their injuries while the rest will usually suffer amputation of at least one limb.

> An increasing number of those injured are public health workers.

Virtually no country that has suffered the scourge of war on their homeland soil has escaped the landmine problem. Somalia, Afghanistan, Angola, Cambodia and the Congo are all poster nations for the more than 71 countries that suffer this plaque.

While we would like to believe our world is becoming more civilized, the continued use of landmines dispels that hope — an estimated five million new landmines are sown every

As a child playing in the deserts of Southern New Mexico on what was once the practice bombing range for the U.S. military during WWII, it was common to come across spent cas-

ings, even strips of machine gun rounds.

Still, nothing I've ever experienced brought me as up-close-and-personal to unexploded ordinance as that lady in Rome last month who found a WWII vintage hand grenade nestled comfortably in her bag of potatoes. ANSA news agency said officials believe the grenade was picked and packaged with potatoes from a field in France — but it was anything but a dud. It made a very convincing boom when officials exploded it in a nearby park.

Then there were those two kids playing in the woods near their home in South Carolina a few weeks ago when they ran across a small, inactive military practice bomb and dragged it home to show mom. The AP says no military agency has claimed the little lost ordinance.

They say you need nerves of steel to handle explosives. A little historical jaunt through some Texas history on the role that dynamite played in establishing the oil fields of West Texas is enough to make your hair stand on end — many of those good old boys died young from unnatural causes.

The worst part about things that go boom these days is that those prepared to utilize them are equally prepared to make it a one-time event that will end their own lives. As astonishing as the Japanese kamikaze fighter pilots were during WWII, they pale in comparison to the threat the world faces today. A suicide bomber's reasoning flies in the face of every natural urge humans have for self preservation.

Even the young people driving on the street who are sacrificing their hearing to the booming of subwoofer speakers are not literally trying to blow themselves up — no matter how explosive a situation they create with their fellow motorists.







## Texans at risk for 'rescue loan' scam

COLLEGE STATION, Tex. — Convinced that home foreclosures will rise dramatically in the next two years, the chief economist for the Real Estate Center at Texas A&M University warns that a new scam threatens homebuyers desperately looking for a way out of financial stress.

"Predatory lenders now offer what they call 'rescue loans," said Dr. Mark Dotzour, "but homebuyers are neither rescued nor do they actually receive loans."

Homebuyers who purchased homes with subprime loans are especially vulnerable, he said. Predatory lenders are targeting subprime borrowers who have some equity built up in a home but who are having difficulty meeting monthly mortgage payments.

Homebuyers with impaired or non-

existent credit histories often turn to ing to get much worse. As of Oct. 31, subprime loans despite the higher interest that comes with them. According to Dotzour, many are about to discover that their "American dream" has turned into a nightmare.

Here is how the scam works. The homebuyer gets behind on mortgage payments. The predatory lender offers a "loan to get caught up" on the delinquent mortgage payments. In exchange for the rescue, the homeowner signs over the title to the predator, who promises that the homebuyer may remain in the home while paying rent. The predator then sells the house to someone else, and the original homeowner gets an eviction notice.

About a dozen states have passed laws designed to deter rescue loan fraud, but Texas is not one of them.

"The scam is called a loan, but it is not," says Dotzour. "It really is a buy-out with a leaseback."

Dotzour fears the problem is go-

some four percent of borrowers who obtained subprime loans in 2006 were 60 days or more behind on payments. He said the delinquency rate is running twice that of a year ago.

"Foreclosures are up 27 percent in the last 12 months," said the noted economist, "but that's still low in my books. I'm betting 2007 U.S. foreclosures will double last year's total."

Subprime mortgage volume has increased fivefold in five years. The Mortgage Bankers Association estimates that \$1.1 trillion to \$1.3 trillion in subprime loans are due to adjust to higher interest rates in 2007.

"Obviously there will be a much higher foreclosure rate in the next five years," said Dotzour, "regardless of whether there is an upswing or downswing in the economy."
