## CBP offers ways to make holiday border crossing a little easier

EL PASO, TEXAS — U.S. Customs and Border Protection (CBP) officers at the El Paso port of entry and other area international crossings are providing guidance to assist travelers who intend to travel between the U.S. and Mexico in the days around the Easter holiday. These tips are designed to ease the crossing process as CBP officers maintain their principal anti-terror mission.

The upcoming Easter/Holy Week season is historically one of the busiest travel periods at southwest border crossings. Along with a general 10-15 percent increase in overall traffic figures, another area that experiences a significant increase in volume is the number of Mexican laser visa card holders who request the I-94 travel documents required to travel beyond the border zone. Applications for I-94's typically double or triple at the El Paso port of entry during the week before Easter. CBP officers routinely process about 1,000-1,500 I-94's a day in El Paso but that number jumps to between 2,500 and 3,000 a day in the week before Good Friday. Similar increases are typically recorded at other major border crossings.

CBP officers also typically seize large numbers of confetti-filled cascarones in the days leading up to the Easter holiday. The colorful eggshells are prohibited because they may introduce Exotic Newcastle's Disease to the U.S. poultry industry and should not be imported from Mexico. Violators will be subject to penalties.

In an effort to provide the best possible service to the traveling public during the upcoming holiday season, CBP officials are proactively reminding members of the traveling public that there are a number of steps they can employ to cross the border as quickly and safely as possible while avoiding violations of U.S. law.

"By getting the word out early and working closely with the community, we believe we will be able to keep holiday related traffic moving while insuring that all our enforcement concerns are properly addressed," said David Longoria, U.S. Customs and Border Protection El Paso Port Director. "It is important that we do all we can to protect the American public while allowing law abiding border crossers to reach their destinations in a timely manner. We believe these tips will help the process."

- Visit border ports early to obtain I-94 travel documents (\$6 each). This will allow travelers who require I-94 documents (those planning to travel beyond the border zone or stay in the U.S. for more than 30 days) to by-pass busy I-94 issuing lines when they formally enter the U.S. They will still be subject to the inspection process.

- Travelers should prepare for the inspection process before arriving at the inspection booth. Individuals should have their crossing documents available for the inspection.

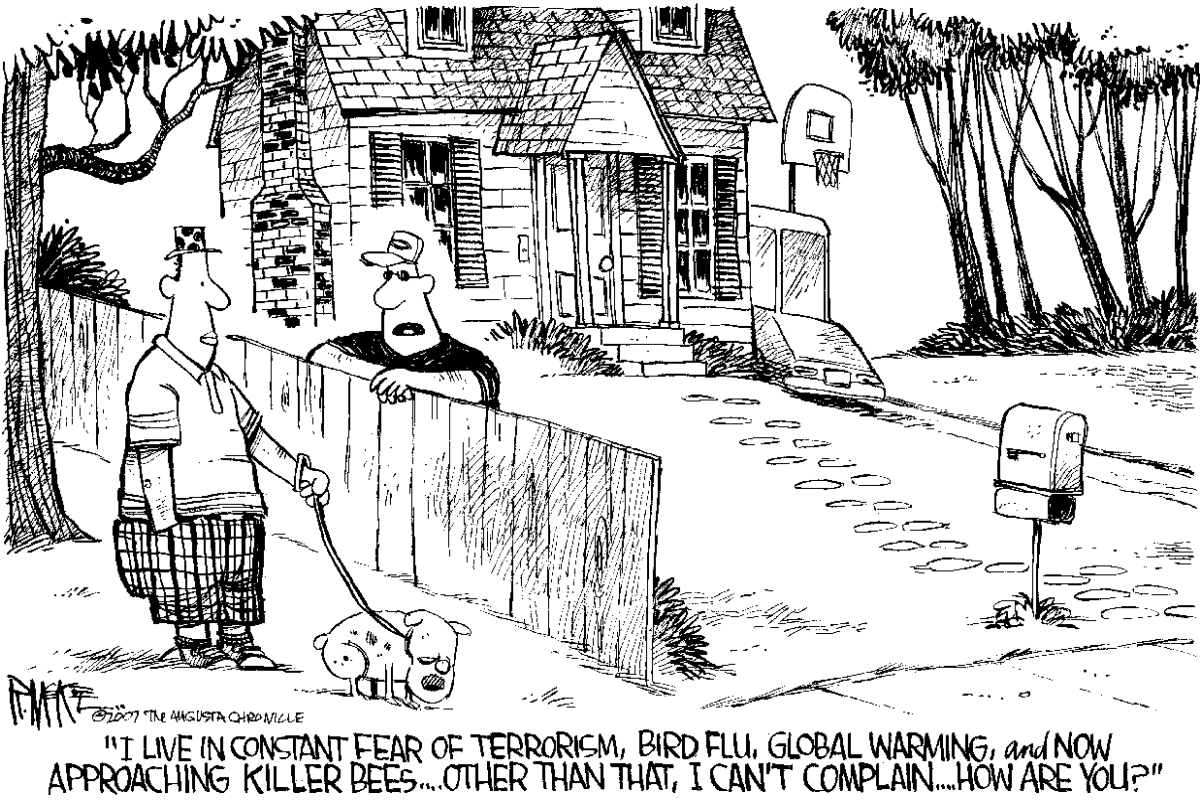

Greedy taxpayers?

With Texas taxpayers struggling under rising property taxes, the former Democratic candidate for governor, Chris Bell, calls them greedy. In demonstrating why 70 percent of Texans voted for someone else, Bell says taxpayers shouldn't be asking for a refund of the tax surplus.

In a commentary being distributed by the failed candidate, Bell chastises me for pointing out that voters should get back the \$14.3 billion surplus — extra revenues collected by the state during this current budget period. It's their money!

My organization, Texans for Fiscal Responsibility, has now mailed almost 33,000 voters in nine senatorial districts. The districts were selected based on senators who either serve on the important Senate Finance Committee, or chair another influential committee.

Bell complains that his home was one of those to receive the mailing. He describes our mailing as inspiring voters to "summon all the greed they could muster and demand money back from the Texas state government."

He suggests that a long litany of failings in government welfare services are "proof" taxpayers have under-funded the bureaucracy.

As was evident to Texans in the November '06 campaign, Bell simply has his facts wrong. He is either unaware of, or indifferent to, the fact that state funding for Child Protective Services, public education, and the Children's Health Insurance and Medicaid programs have all increased year-after-year for years, and especially during the last two sessions. Again, legislators grew government at 18.7 percent; that is real — unsustainable — growth in spending.

But on one important point, Bell is right. He is correct in characterizing many government programs as failing. He's just wrong about the cause.

We've tried the Bell approach for years: throwing more and more taxpayer money at problems. The result has been failure.

Let's try something different. Let's let taxpayers keep more of their money, and address

social problems through real charity and efficient stewardship of government programs, not wasteful bureaucracy.

The state's surplus amounts to \$600 per Texan. If Mr. Bell and other liberals feel guilty about the rest of us being under-taxed, they can simply write extra checks to their charity of choice: big government.

Of course they don't have the humility or charity to do that. They prefer to use your money, and a lot of it, to fund high-cost programs that simply don't work.

Is it greedy to ask for your change back? That is precisely what thousands of taxpayers have now done as a result of TFR's mailing.

Bell wants to grow government with your money. And he correctly understands that returning the surplus to taxpayers takes money out of the pockets of the spenders, and puts it back in the hands of the earners.

Taxpayers are continuously told to foot the bill for an increasingly costly government. Last legislative session state lawmakers grew government 18.7 percent, and yet our economy has still managed to produce a surplus of \$14.3 billion.

Far from being greedy, Texans want lawmakers to be honest with our money. We were given a price tag for the cost of government, we overpaid, and now we should get our money back. As a trial lawyer, Bell can apparently afford to overpay everywhere he goes, but most working Texans cannot.

Bell claims the surplus grew out of "draconian cuts" to the state's budget by legislators. If an 18.7 percent increase in state spending is a "cut," not even Bill Gates could afford the "increases" that Bell apparently wants imposed on us. It's no wonder 70 percent of us said "no" to his liberal philosophy.

Texans deserve true tax relief. Lawmakers should continue to ignore Chris Bell, and return the surplus to Texas' taxpayers.

Legislature must empower Texas crime victims

The U.S. Court of Appeals for the Ninth Circuit recently overturned a murder conviction — solely because the victim's brother sat in the courtroom wearing a small pin with a photo of the victim on it.

Fortunately, a December decision by the U.S. Supreme Court reversed this miscarriage of justice and reinstated the conviction. But this case, *Carey v. Musladin*, demonstrates how victims have been marginalized from not only the courtroom, but the entire criminal justice system.

The 80th Texas Legislature should act to restore the primacy of victims.

First, restitution must be more than an empty promise. Only one-third of restitution owed to crime victims is actually collected. House Corrections Committee Chairman Jerry Madden (R-Plano) is filing a constitutional amendment to allow Texas judges to order the garnishment of an offender's wages to pay restitution. Currently, the Texas Constitution only permits garnishment for child support, but restitution to crime victims is equally important.

Texas can also strengthen restitution for crime victims by linking the funding of probation departments to their restitution collections. Not all departments report their collections to the state.

The Texas Public Policy Foundation, based on our research, has recommended to the Corrections Committee that five percent of basic adult probation funding be tied to restitution collections so that departments receive 9.4 cents for every dollar in restitution they collect. Such performance-based funding will encourage departments to maximize their efforts in collecting restitution, which should include assisting offenders with finding work and effectively managing their finances.

However, victims cannot drink from a well that is dry, and inmates earn no money to pay

restitution. The Legislature should promote the availability of victim-offender mediation as a voluntary alternative to traditional prosecution and incarceration in cases involving minor property offenses by first-time offenders.

Such mediations result in a written agreement that typically requires restitution, community service, and counseling, which is then ratified by the prosecutor or judge. Failure to comply subjects the offender to traditional prosecution and, if necessary, incarceration.

Victim-offender mediation results in improved restitution collection, better offender outcomes, and reduced costs. There are more than 300 such programs in North America and their success is well documented. Some 95 percent of cases mediated result in a written agreement, and 90 percent of these restitution agreements are completed within one year, giving victims a sense of closure.

This indicates that coming face-to-face with a victim instills a moral obligation in many offenders. And because completion of the agreement avoids a conviction, offenders are more likely to hold a job that enables them to pay restitution. Victim-offender mediation has also been found to reduce recidivism by 32 percent.

Furthermore, mediations cost \$250 per case, a fraction of the cost of court proceedings, let alone incarceration. The state could impose an offender fee paid by property offenders upon conviction or a participant fee for offenders who choose victim-offender mediation that would cover the up front cost of grants to local district attorney's offices for such programs.

Victim-offender mediation is not for everyone, but many victims of minor property offenses primarily want answers, an apology, and restitution — all of which only the defendant can provide. Victims deserve this option in such cases and studies suggest 60 to 70 percent would choose it.

Finally, Texas must ensure that restitution and other priorities of victims are fully

Intelligence Committee investigates FBI's misuse of NSL

The House Permanent Select Committee on Intelligence held an open hearing recently on the Federal Bureau of Investigation's (FBI) use of National Security Letters. The focus of the hearing was the recent report by the Justice Department Inspector General, who found that the FBI had misused this tool — the authority to request private records, secretly, without judicial review — hundreds of times between 2003 and 2005.

As someone who spent over 26 years in law enforcement prior to becoming a member of Congress, I appreciate the importance of strong investigative tools. I want the FBI to have strong authority to find terrorists. But massive data collection does not serve that purpose. If you are sifting through mounds of irrelevant data on people you believe have done nothing wrong, you are more likely to miss the relevant leads that can stop the next terrorist attack.

The expanding use of NSLs would not be troubling in itself, if the FBI had proper controls for this powerful investigative tool. But the FBI does not. And, in fact, Inspector General Glenn Fine — our first witness

— found significant misuse by the FBI of this authority.

The Committee received testimony from two separate panels. The first consisted of witnesses from the Executive Branch and included the Inspector General Fine of the Department of Justice; Kenneth Wainstein, Assistant Attorney General for National Security; and John Pistole, Deputy Director of the FBI.

The second panel consisted of experts from outside of government: Jim Dempsey, Policy Director of the Center for Democracy and Technology; Lisa Graves, Deputy Director of the Center for National Security Studies; and Viet Dinh, Professor of Law at Georgetown University and former Assistant Attorney General for Legal Policy.

The IG's report found several serious problems in the issuance and record-keeping of NSLs, to include an absence of effective FBI controls on the use of NSLs; possibly as many as 3,000 violations of law or policy;

vast under reporting to Congress on the number of NSLs issued; and extensive misuse of the "exigent letters" provision.

We have learned that, despite repeated assurances, the FBI was unable to do an effective job of policing its own use of this powerful tool for investigating terrorism.

The FBI uses National Security Letters to obtain information from third parties, such as telephone companies, financial institutions, Internet Service providers, and consumer credit agencies.

NSLs are no longer a limited, precise tool. They have become a broad license to collect information on Americans. Much of the information sought is not useful to a terrorism investigation. Indeed, FBI officials admit that most of the time, the FBI uses NSLs to gather information on people it believes are not suspects in order to eliminate them from further consideration.

In passing and reauthorizing the USA PATRIOT Act, we entrusted the FBI with very effective investigatory powers. Unfortunately, whether through abuse or simple mismanagement, they have betrayed that trust, and there must be accountability.

We will remain focused on this subject moving forward in the 110th Congress.

# Resignation of Anthony ISD’s superintendent tops area school news

EL PASO COUNTY — After three years at its helm, Vern Butler is retiring as superintendent of the Anthony Independent School District.

The AISD board of trustees approved his letter of resignation at its monthly meeting last week.

Butler, who has been in the education field for 36 years, says he and his wife are moving to the Fort Worth area to be with family. Asked about future plans, he was noncommittal, merely saying he was “leaving my options open.”

Butler will finish out the current school year.

Sally Flores, president of the AISD board, praised Butler’s work, saying he has been a “wonderful addition, a wonderful asset to the district.”

Flores says the board voted to ask Dr. James Vasquez, executive director of Region 19 Education Service Center, to work with them to find a successor. With Region 19’s assistance, she hopes the board can have a successor in place before Butler leaves in June.

“He will be missed,” she added. “He is a good man to work with. He is totally dedicated to the kids.”

Butler’s resignation was the highlight of actions by trustees during March board meetings in the An-

thony, San Elizario and Canutillo school districts.

## San Elizario ISD

The results of preliminary TAKS (Texas Assessment of Knowledge and Skills) reading tests came for third- and fifth-graders under sharp scrutiny by SEISD trustees at their March 21 board meeting.

Principals from Sambrano, Borrego, and Alarcon Elementary Schools were taken to task as they reported results ranging from 50 percent to overall scores of 79 percent.

Indicating something has to be done, trustee Armando Martinez said he was “very upset” with the teachers and the low scores. His concern was echoed by other board members as well.

Agreeing with the thrust of the trustees’ questions and concerns, Dr. Mike Quatrini, SEISD superintendent, looked directly at the assembled principals and said, “We cannot tolerate mediocre teaching; our kids don’t deserve it. Enough is enough.”

He suggested that the principals need to get out and into the classrooms and find those teachers who are not measuring up to standards.

The board received an update on \$8 million in construction projects at Alarcon Elementary and Garcia-Enriquez Middle schools. Aug. 1 is the scheduled completion date on

construction of the new 10,000-square-foot cafeteria at Alarcon. Work on the new library and classroom addition at Garcia-Enriquez is expected to be completed sometime later in August.

The board also approved administration recommendations for new math textbooks in the middle school and high school.

It also approved Aug. 27 as the starting date for classes for the 2007-08 school year.

tion and they should be prepared to declare all items acquired abroad. In addition, individuals should end cellular phone conversations before arriving at the inspection booth.

- Travelers should familiarize themselves with the “Know Before You Go” section of the CBP website at [http://www.cbp.gov/xp/cgov/travel/vacation/kbyg/introduction\\_mission.xml](http://www.cbp.gov/xp/cgov/travel/vacation/kbyg/introduction_mission.xml) to avoid fines and penalties associated with the importation of prohibited items.
- Travelers should look to alterna-

tive entry routes. Border crossers may consider using the nearby and less utilized Fabens or Santa Teresa ports of entry instead of the El Paso port.

- Travelers should plan to build extra time into their trips in the event they cross during periods of exceptionally heavy traffic. This includes Dedicated Commuter Lane users.
- Unless absolutely necessary, border crossers may wish to avoid crossing the border during traditionally heaviest periods of traffic including morning/evening rush hour periods and weekends.
- Members of the traveling public should consult the CBP website site at [www.cbp.gov](http://www.cbp.gov) to monitor border wait times. Information is updated hourly

and is useful in planning trips and identifying periods of light use/short waits.

- Drivers should insure that the vehicles they use to cross the border are properly maintained and mechanically sound and that occupants avoid riding in areas of vehicles not specifically designed to carry passengers. Failure to follow these steps can expose crossers/passengers to carbon monoxide.

CBP officials will closely monitor traffic and border crossing times during the upcoming holiday period. They plan to fully staff all inspection lanes during peak periods and to implement various traffic management operations to maintain the flow of traffic during periods of exceptionally heavy usage.

# Operation Lifesaver teaches students to stay safe and off of railroad tracks

A train horn echoes through the hallways at Ernesto Serna School but its not coming from the railroad tracks near the school. The horns and whistles are coming from the school’s gym as students try their hand at being a train conductor. The simulation is part of “Operation Lifesaver” that aims at increasing awareness about railroad safety. As students take their turn at the real train console, engineers and conductors are showing them why they need to stay away.

“We are educating the public about train safety and working on the trespassing issue,” says Bennie Grayson, engineer and Operation Lifesaver

presenter. “We want kids to stay away and stay safe. Most of them did not know that it is illegal to be on or near train tracks.”

According to the Federal Railroad Administration, in 2006 Texas ranked second with 51 pedestrian rail trespass fatalities. Topping the list is California with 91. Operation Lifesaver is a non-profit, international continuing public education program first established in 1972 to end collisions, deaths and injuries at places where roadways cross train tracks, and on railroad rights-of-way.

“By using a real train console, we are showing students what we experience. We teach how dangerous trains can be. We show them that trains can’t go left or right to avoid cars and that trains don’t stop quickly,” says Grayson. “This gives

them an idea about being inside the cab and hopefully they share the lesson with their parents.”

One of the students who had the chance to be a conductor was Jesse Contreras who surprised to learn about the laws protecting rail yards.

“It was interesting to learn what you can and can’t do around trains,” says the 8th grader. “Kids don’t understand how dangerous it is to be around trains when they are passing or not to play by the tracks or under the trains when they are stopped.”

Grayson along with other engineers, conductors and bus drivers will spend another day with students at Serna. Their presentations will be held on Thursday, April 5, starting at 7:45 am until 10:00 am. Grayson expects to reach more than 500 students by the end of this four-day session.

incorporated in sentencing. Plea bargaining accounts for 90 percent of sentences, but Texas is not among the 22 states that require prosecutors to obtain the victim’s opinion concerning a proposed plea.

Arizona requires prosecutors to consult with victims, guarantees

victims the right to be present and heard during any settlement discussions, and requires that judges consider the victim’s viewpoint in deciding whether to accept the plea. Texas law only says the judge must “inquire as to whether a victim impact statement has been returned.”

We must not view crime as simply an offense against the state, and instead ensure that crime victims have a place in the courtroom and a seat at

the table. The marginalization of victims is not only unjust, but deprives us of the public safety benefits that are only realized when an offender’s conscience is awakened upon realizing the harm caused to another human being.

a Dallas Cowboys Football Operations Intern for the Summer Training Camp from 1990-1994 and in 1998.

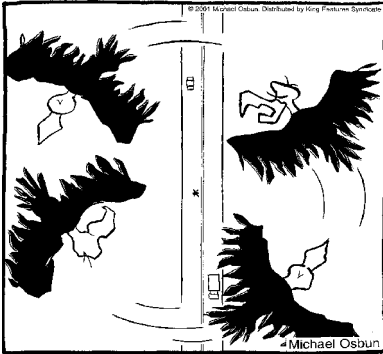

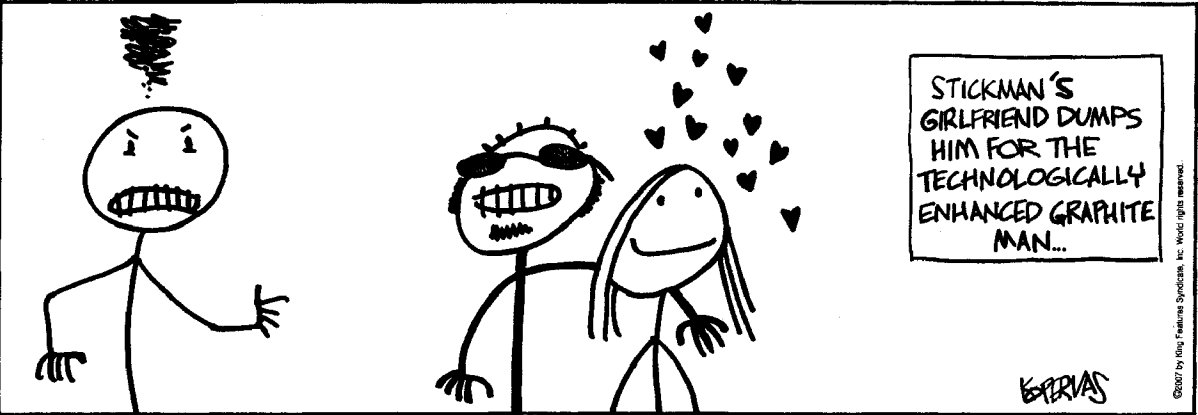

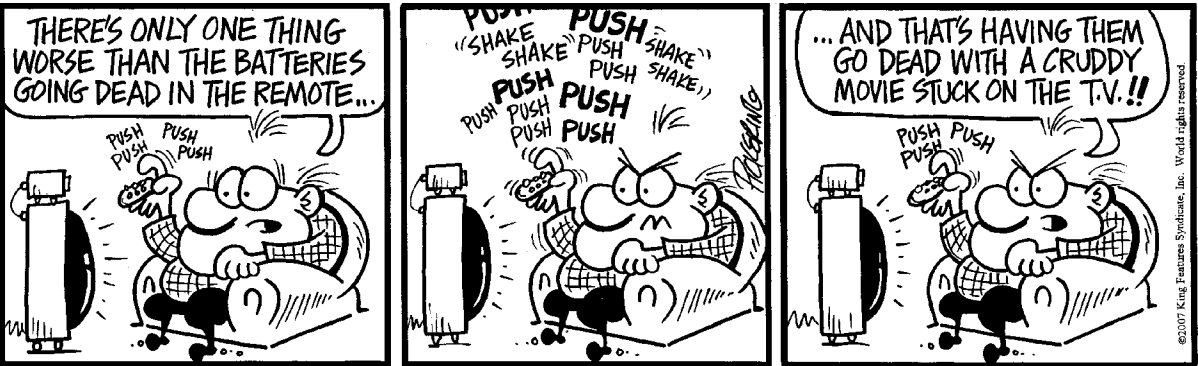

What's so great about Canada?

A recent poll asked people around the world if they viewed various countries positively or negatively.

The United States, unfortunately, landed near the bottom — just behind North Korea.

North Korea — a country led by a crazed dictator with a funky fashion sense who recently set off a nuclear bomb!

And there's more. Canada, our neighbor to the north, ranked first. And France finished third.

Why would France be more popular than us?

Excellent question. Many people seem to think so, including many

otherwise intelligent Canadians.

But I've been there. We walked over while visiting Niagara Falls. Frankly, it seemed about the same, though Canadians like to make a show of having different money and flags and whatnot. But the tacky souvenirs were strictly American, made in China, just like here.

And look at all we share, including baseball, the quintessential all-American sport that a surprising number of people find boring.

Canadians also play in the National Hockey League, even though they have a hard time understanding the sport.

Assuming Canada is another country, how would we go about annexing it?

That's the good part. All we need is an executive order from the President. Canadians need not be involved.

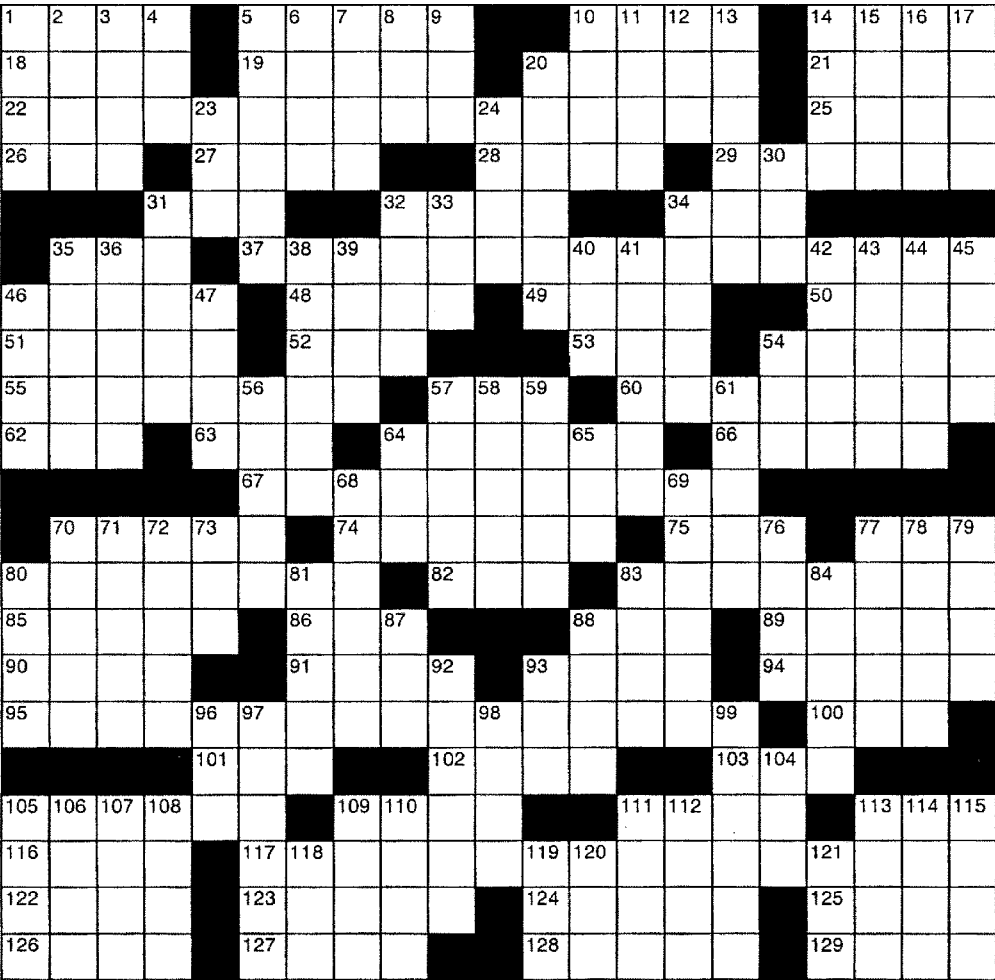

# Make sure you have a Social Security Number for your newborn child

Are you among the approximately one in 10 parents who last year did not apply for a Social Security number for their newborns before leaving the hospital? If so, you should know that you will need a Social Security number to claim your newest family member as a dependent on your federal tax return. And don't

wait until April 15 to apply for that number. You need to apply now. Here is what you need to do to get a new Social Security number. Complete an Application for a Social Security Card (Form SS-5). This form is available online at [www.socialsecurity.gov/online/ss-5.html](http://www.socialsecurity.gov/online/ss-5.html). If you do not have online ac-

cess, you can request a form by calling Social Security's toll-free number, 1-800-772-1213, or visiting a local Social Security office. You also will need to provide documents that prove both your and your child's identity, and documents that show your child's U.S. citizenship and age. All of these documents must be either originals or copies of originals that are certified by the issuing agency. We do not accept copies or notarized copies of documents. Keep in mind there are strict requirements on what documents Social Security can accept to prove citizenship and identity. For example, only certain documents can be ac-

cepted as proof of U.S. citizenship. These include a U.S. birth certificate, a U.S. passport, a Certificate of Naturalization or a Certificate of Citizenship. In addition, Social Security will need to verify your child's birth record before you can be issued a card. You must take or mail the completed Form SS-5 to the nearest Social Security office, together with the originals or certified copies of your supporting documents. We will return your original documents right away, and we will then mail a Social Security card as soon as your documents are verified, which can take several weeks.

Once you have a Social Security number for your newborn, you should safeguard that number, as well as the numbers of other family members. Keep that card in a safe place with your other important papers. Do not carry your Social Security card in your wallet.

# Fraudulent telephone tax refunds among IRS top 2007 'dirty dozen' tax scams

WASHINGTON — The Internal Revenue Service today identified 12 of the most blatant scams affecting American taxpayers and warned people not to fall for the schemes. This year the "Dirty Dozen" highlights five new scams that IRS auditors and criminal investigators have uncovered. Topping off the list are fraudulent refunds being claimed in connection with the special Telephone Excise Tax Refund available to most taxpayers this filing season. The IRS is actively investigating instances of this scam involving tax preparers who are preparing inflated refund requests.

Also new to the Dirty Dozen this year are abuses pertaining to Roth IRAs, the American Indian Employment Credit, domestic shell corporations and structured entities.

"Taxpayers shouldn't let their guard down," IRS Commissioner Mark W. Everson said. "Don't get taken by scam artists making outrageous promises. If you use a tax professional, pick someone who is reputable. Taxpayers should remember they are ultimately responsible for what is on their tax return even if some unscrupulous preparers have steered them in the wrong direction." Persons who become involved in tax schemes risk significant penalties, interest and possible criminal prosecution. The IRS urges taxpayers to avoid these common schemes:

## 1. Telephone Excise Tax Refund Abuses

Early filings show some individual taxpayers have requested large and apparently improper amounts for the special telephone tax refund. In some cases, taxpayers appear to be requesting a refund of the entire amount of their phone bills, rather than just the three-percent tax on long-distance and bundled service to which they are entitled. Some tax preparers are helping their clients file apparently improper requests. The IRS is investigating potential abuses in this area and will take prompt action against taxpayers who claim improper refund amounts and against the return preparers who help them.

## 2. Abusive Roth IRAs

Taxpayers should be wary of advisers who encourage them to shift under-valued property to Roth Individual Retirement Arrangements (IRAs). In one variation, a promoter has the taxpayer move under-valued common stock into a Roth IRA, circumventing the annual maximum contribution limit and allowing oth-

erwise taxable income to go untaxed.

## 3. Phishing

Phishing is a technique used by identity thieves to acquire personal financial data in order to gain access to the financial accounts of unsuspecting consumers, run up charges on their credit cards or apply for loans in their names. These Internet-based criminals pose as representatives of a financial institution — or sometimes the IRS itself — and send out fictitious e-mail correspondence in an attempt to trick consumers into disclosing private information. A typical e-mail notifies a taxpayer of an outstanding refund and urges the taxpayer to click on a hyperlink and visit an official-looking Web site. The Web site then solicits a social security and credit card number. It is important to note the IRS does not use e-mail to initiate contact with taxpayers about issues related to their accounts. If a taxpayer has any doubt whether a contact from the IRS is authentic, the taxpayer should call 1-800-829-1040 to confirm it.

## 4. Disguised Corporate Ownership

Domestic shell corporations and other entities are being formed and operated in certain states for the purpose of disguising the ownership of the business or financial activity. Once formed, these anonymous entities can be, and are being, used to facilitate underreporting of income, non-filing of tax returns, listed transactions, money laundering, financial crimes and possibly terrorist financing. The IRS is working with state authorities to identify these entities and to bring their owners into compliance.

## 5. Zero Wages

In this scam, which first appeared in the Dirty Dozen in 2006, a Form 4852 (Substitute Form W-2) or a "corrected" Form 1099 showing zero or little income is submitted with a federal tax return. The taxpayer may include a statement rebutting wages and taxes reported by the payer to the IRS. An explanation on the Form 4852 may cite statutory language behind Internal Revenue Code sections 3401 and 3121 or may include some reference to the paying company refusing to issue a corrected Form W-2 for fear of IRS retaliation.

## 6. Return Preparer Fraud

Dishonest return preparers can cause many headaches for taxpayers who fall victim to their schemes. Such preparers make their money by skimming a portion of their clients' refunds and charging inflated fees for return preparation services. They attract new clients by promising large refunds. Some preparers promote filing fraudulent claims for refunds on

items such as fuel tax credits to recover taxes paid in prior years. Taxpayers should choose carefully when hiring a tax preparer. Remember that no matter who prepares the return, the taxpayer is ultimately responsible for its accuracy. Since 2002, the courts have issued injunctions ordering dozens of individuals to cease preparing returns, and the Department of Justice has filed complaints against dozens of others. During fiscal year 2006, 109 tax return preparers were convicted of tax crimes and sentenced to an average of 18 months in prison.

## 7. American Indian Employment Credit

Taxpayers submit returns and claims reducing taxable income by substantial amounts citing an American Indian employment or treaty credit. Although there is an Indian Employment Credit available for businesses that employ Native Americans or their spouses, there is no provision for its use by employees. In a somewhat similar scam, unscrupulous promoters have informed Native Americans that they are not subject to federal income taxation. The promoters solicit individual Indians to file Form W-8 BEN seeking relief from all withholding of federal taxation. A recent "phishing" variation has promoters using false IRS letterheads to solicit personal financial information that they claim the IRS needs in order to process their "non-tax" status.

## 8. Trust Misuse

For years unscrupulous promoters have urged taxpayers to transfer assets into trusts. They promise reduction of income subject to tax, deductions for personal expenses and reduced estate or gift taxes. However, some trusts do not deliver the promised tax benefits. There are currently more than 150 active abusive trust investigations underway and 49 injunctions have been obtained against promoters since 2001. As with other arrangements, taxpayers should seek the advice of a trusted professional before entering into a trust.

## 9. Structured Entity Credits

Promoters of this newly identified scheme are setting up partnerships to own and sell state conservation easement credits, federal rehabilitation credits and other credits. The purported credits are the only assets owned by the partnership and once the credits are fully used, an investor receives a K-1 indicating the initial investment is a total loss, which is then deducted on the investor's individual tax return. Forming such an entity is not a viable business purpose. In other words, the investments

are not valid, and the losses are not deductible.

## 10. Abuse of Charitable Organizations / Deductions

The IRS continues to observe the use of tax-exempt organizations to improperly shield income or assets from taxation. This can occur when a taxpayer moves assets or income to a tax-exempt supporting organization or donor-advised fund but maintains control over the assets or income. Contributions of non-cash assets continue to be an area of abuse, especially with regard to overvaluation of contributed property. In addition, the IRS is noticing the return of private tuition payments being disguised as charitable contributions to religious organizations.

## 11. Form 843 Tax Abatement

This scam rests on faulty interpretation of the Internal Revenue Code. It involves the filer requesting abatement of previously assessed tax using Form 843. Many using this scam have not previously filed tax returns and the tax they are trying to have abated has been assessed by the IRS through the Substitute for Return Program. The filer uses the Form 843 to list reasons for the request. Often, one of the reasons is: "Failed to properly compute and/or calculate IRC Sec 83-Property Transferred in Connection with Performance of Service."

## 12. Frivolous Arguments

Promoters have been known to make the following outlandish claims: the Sixteenth Amendment concerning congressional power to lay and collect income taxes was never ratified; wages are not income; filing a return and paying taxes are merely voluntary; and being required to file Form 1040 violates the Fifth Amendment right against self-incrimination or the Fourth Amend-

ment right to privacy. Don't believe these or other similar claims. These arguments are false and have been thrown out of court. While taxpayers have the right to contest their tax liabilities in court, no one has the right to disobey the law.

# IRS still watches scams that fall off the list

Five of last year's Dirty Dozen tax scams rotated off the list for 2007. While the IRS has seen a decline in the occurrence of some of these scams — abusive credit counseling agencies, for example — other problems, such as offshore abusive transactions continue to be an area of particular concern for the agency. The absence of a particular scheme from the Dirty Dozen should not be taken as an indication that the IRS is unaware of it or not taking steps to counter it.

Suspected tax fraud can be reported to the IRS using IRS Form

3949-A, Information Referral, available for download from the IRS Web site at [IRS.gov](http://IRS.gov), or by mail by calling 1-800-829-3676. The completed form or a letter detailing the alleged fraudulent activity should be addressed to the Internal Revenue Service, Fresno, CA 93888. The mailing should include specific information about who is being reported, the activity being reported, how the activity became known, when the alleged violation took place, the amount of money involved and any other information that might be helpful in an investigation. The person filing the report is not required to self-identify, although it is helpful to do so. The identity of the person filing the report can be kept confidential. The person may also be entitled to a reward.
