Tragedy avoided

An accident in San Elizario on Saturday evening, May 5, that could have ended in tragedy is being called a "miracle." According to law enforcement, Adriana Flores was parking her van when her threeyear-old son unfastened his seatbelt from the booster seat and climbed out. The child fell underneath the vehicle and was run over, struck by the right rear tire. He was immediately transported to R.E. Thomason General Hospital with reports of serious lower abdominal injuries - but was later released after being treated for only minor injuries. "When I got the page I was expecting the worst case scenario," said Sergeant Jim Belknap, Criminal Investigation Division, El Paso County Sheriff's Office. "The little boy suffered minor injuries and has been released from the hospital. Sometimes divine intervention presents miracles - I'll take that any dav of the week." According to a witness statement, Flores pulled up to the residence and stopped while another person exited the vehicle to open a gate. The gateopener got back into the vehicle but didn't completely secure the car door. As the driver was parking the vehicle the little boy exited the van. The name of the injured child is being withheld as an investigation continues. The case is being listed as an "Accident on Private Property," Sgt. Belknap said.

Mock bio-terrorism event leaves Anthony better prepared

ANTHONY - Today, residents of the Upper Valley are better prepared to handle major emergency situations.

Under the direction of the El Paso City/ County Health and Environmental District, a POD (Point of Dispensing) drill was held April 25 in the gym of Anthony Middle School. Approximately 40-50 volunteers took part in the half-day drill to evaluate staffing procedures for setting up and running a POD during an emergency such as a bio-terrorism threat.

"Overall, things went very, very, well," says John Carrillo, Anthony ISD's director of technology and communication and volunteer coordinator. Carrillo says he was impressed with the broad scope of volunteer support. He cites the performance of emergency responder personnel, numerous AISD teachers as well as members of city government, including Anthony Mayor Art Franco.

The volunteers manned seven stations in the POD. They included registering people coming through, some who served as "patients." There was also a first aid area and evaluation of seriousness of the illness of those patients in a triage concept.

Carrillo says he first got the official notification about the mock emergency at 6:30 p.m. the evening before. He initiated a "calling tree" in which he calls four key people who, in turn, notifies others about the situation.

Rosalinda Garcia, an SNS (Strategic National Stockpile) planner with the health and environmental district, echoed Carrillo approval of the project. "It went very well. We learned a lot," she adds. "The objective was met.

"The volunteers got a new perspective, and we all got insight into just how a POD should run."

She indicated some minor improvements such as changing forms and using a different procedure for crowd control. A formal debriefing was to be held May 9.



Last week, I along with some of my colleagues, Representatives Henry Cuellar, Bob Filner and Ciro Rodriguez, testified before the House Committee on Transportation and Infrastructure to express our support for the creation of a Southwest Regional Border Authority.

This important legislation addresses one of the most critical issues facing the Southwest Border region - persistent poverty. According to research compiled by the Interagency Task Force on the Economic Development of the Southwest Border, over 20 percent of the residents in the

I am convinced that economic development in border communities is difficult to stimulate without assistance from the government, private sector, and community non-profits. The bill would establish a five-member Authority, comprising the four Southwest Border state governors and a federal member (confirmed by the U.S. Senate). The primary purpose of the Authority is to award grants to economically distressed communities for projects that stimulate economic development in one of four categories: (1) infrastructure development; (2) technology development and deployment; (3) education and workforce development; and (4) community development and entrepreneurship. The bill also establishes a "ground-up" development planning process, which would en-

sure that the projects funded by the

candidate for Alderman Place 7 in the May 12 Horizon City elections has long been interested in the growth and development of Horizon City. This will be his second candidacy.

Armass, who attends and participates regularly in council meetings, said he turned down opportunities to be appointed to council when vacancies occurred due to resignations. However, he decided to run for office after becoming concerned that decisions were being made outside of public meeting and that the meeting agenda was being manipulated.

He also said he has concerns about the lack of cooperation being demonstrated by the council.

"My belief is that, no matter who is chosen as a leader, you work with them and not against them. You must work as a team and put your differences aside," he said. "At a recent city council meeting (I heard) an alderman make the comment that the city council runs the city and not the citizens. Whatever happened to representing what the citizens want and need?"

Armass was nominated by Mayor Raymond Morales to the Planning and Zoning Board and appointed unanimously by the City Council in October 2006. Among items he supported

"I am a political newcomer and I do not subscribe to the ideals of special interest.


"As a former educator, husband of an educator, and father of three school age children, I want what all working families want — active representation. I believe that my background affords me a unique in-



What's up, doc? By Albert Balesh, M.D.

When old is new

Machines hum, oscilloscopes beep, and telemetry thunders. In today's world of impersonal, hightech medicine, it has become downright tough to get well, what with all those inanimate eyes staring at us. As we long for the days of house calls, glass thermometers, enemas, kind words, gentle hands, and a reassuring smile, we come to realize that those times are long gone. Were the patients of yesteryear any more deserving than we are? Were the physicians of the past any more competent and compassionate than their contemporary compadres? Where has all the love gone? Personally, my ticker refuses to play for an audience of lifeless electrodes, cathode-ray screens, sonic probes, and drones, in the absence of the expert and caring supervision of a human conductor.

The human side of medicine has been forgotten or, at the least, overlooked for far too long now. Patients' emotions and concerns are no less important than their physical ailments. To ignore the former inevitably exacerbates the latter. The human mind and spirit are quite sensitive and all too discerning. They sense a wolf in sheep's clothing and a physician in a hurry. While this has become the status quo, the name of the game should be patience and putting the patient's psyche at ease. When this is accomplished, only good things can follow.

The attitude and conduct of a physician in the presence of a patient, namely bedside manner, is an art

countless years of observation and relation to innumerable faces whose names are long forgotten. The maladies etched in those countenances, however, are the stuff of a physician's long-term memory, sleepless nights, and vivid nightmares. Doctors of old knew this, and sought every conceivable opportunity to learn from their patients. Medical texts and learning tools were mere ancillary implements, clarifying a gospel expounded by the sick, but not replacing it. Our healers of today, with their personal data assistants (PDAs), laptop computers, portable instruments, and fiber optics are more "wired" than ever to their patients, and yet there is no real connection. What Bruce Springsteen once said in a lyric, our men and women in white have forgotten in a song. The intangible power of "human touch" is what makes the moderately or severely ill feel secure, supported, cared for, and understood. Human touch is what makes them get better.

As doctors hurry between examining rooms, hide in inner sanctums, and shield themselves behind legions of gatekeepers, they lose sight of the fact that they are fooling no one. The sick, for the most part, recognize that their health care providers are human, and stressed out over the demands and productivity of managed care. So, why not meet each other half way? Symbiosis is a beautiful thing, and give-and-take can be mutually beneficial. A joke, a pat on the back, or the mischievous wink of an eye consumes seconds, minutes at most. The return on it, in an outpatient, can be notable, especially since upwards of 80 percent of people who visit a medical office are not stricken by strange and exotic medical dilemmas. form created and perfected over They simple don't feel well. Com-

plicity, in the noblest sense of the word, in resolving the day-to-day trials and tribulations of a patient's life, not only achieves more than truckloads of medical silver bullets and heroic measures, but is curative in most cases.

Inpatients, on the other hand, are horses of a different color. While computers and electronic medical records enable our knights in white armor to detail and annotate a myriad of signs, symptoms, and complaints from A to Z, archival collections of bytes are as useless as buried treasure, if the reasons for their existence succumb for wont of humanity and psychologic sustenance, rather than science.

Placebos, psychosomatics, and hypochondriasis have shown us that the mind really does exert an overbearing influence on matter. That being the case, why has it taken so long for physicians to embrace this, or, if they accept it as a forgone conclusion, why have they been so reluctant to put the tenet into practice? Shakespeare stated it succinctly in Julius Caesar, "Men at some time are masters of their fates. The fault, dear Brutus, is not in our stars, but in ourselves, that we are underlings." As physicians, we must break the current mold, and, not meaning to sound trite, proverbially return to the future.

Patients must never be backed into a corner, left to apply the principle of caveat emptor, i.e., that they be ultimately responsible for assessing and directing the quality of their medical care. That onus rests proactively with their caregivers, whose return to the old will inevitably revitalize the new.

Virtual monkeys fail at Shakespeare

There's exciting news on the virtual monkey front.

A new book, "The Iron Whim: A Fragmented History of Typewriting" (yes, this is a real book), discusses, among other topics, the well-known million-monkey problem - namely, how many years would it take a million monkeys on a million typewriters to produce Shakespeare's "Hamlet"?

How about an episode of "Friends," one of the really dumb ones?

How about this column?

(And no, the answer is not: "One monkey typing aimlessly for about 15 minutes, assuming nine minutes of coffee slurping.")

Back in high school, our teachers often wondered how many students it would take to write one coherent essay. As far as I know, not one was produced during my four years of high school.

The first one to consider the million-monkey problem was, of course, Shakespeare, who grew tired of churning out hits year after year and longed to turn over his writing duties to monkeys so that he could become a director, which he felt would allow him first crack at the babes.

Solving the million-monkey problem has always revolved around one issue: keeping those darn monkeys on task in front of the keyboard.

But Dan Oliver of Scottsdale, Ariz. — this is true — has solved this problem by creating: virtual monkeys!

(Shakespeare was considered pretty smart, but he never even considered virtual monkeys.)

And Oliver put these virtual monkeys to work.

According to the book, he had these virtual monkeys slaving away - you have to read this slowly - for 42,162,500,000 billion billion monkey years. (They

weren't even paid overtime!) I think we can agree we're talking serious monkey years here.

The virtual monkeys, however, were not particularly successful authors, although, to be fair, they never had their books hyped by Oprah.

The closest they came to reproducing Shakespeare was something similar to the first 19 characters of "The Two Gentlemen of Verona."

From this I think it's safe to conclude that Shakespeare's dreams of assembling a team of live monkey writers would have ended in failure.

The closest thing to a successful experiment involving live monkeys was conducted in 1998 at the Massachusetts Institute of Technology.

A million monkeys were interviewed and placed in front of a million typewriters. Monitors were placed around the classrooms to ensure that no cheating (or "monkeying" around - HA!) was allowed.
