Bite out of crime

The newest member of the Anthony Police Department is Rugby, a six-year-old mixed German Shepherd who comes to Anthony after retiring from the Customs Service where he was a narcotics dog. Police Chief Edward Miranda, who introduced Rugby to the Town Council, said they would be getting bullet-proof vests for the department's dogs. Rugby's handler is officer Eddie Orozco, a 10-veteran in law enforcement. Rugby joins a staff of 14 full-time officers, two reserve officers and one dispatcher. Miranda also said his department has added two new, eightcylinder Dodge Chargers to better apprehend speeders on I-10. In a later interview, Miranda thanked the community for its support of the police. "For the most part it is a calm, quiet community; gang activity is minimal."

Tech lab winners

Canutillo Elementary School was one of five grand prize winner's in this year's Win a Wireless Lab sweepstakes. Held annually for five years, the contest is sponsored by CDW Government, Inc. (CDW-G) and Discovery Education. Each of the five grand prize winners receive a mobile wireless lab valued at approximately \$50,000, including:

- 20 notebook computers or Tablet PCs from HP, Lenovo or Toshiba;

Water raises risk of livestock disease

Rushing water, stagnant ponds, or even the dry stages after wet periods can lead to outbreaks of livestock disease. Mosquitoes and biting flies, capable of carrying and transmitting diseases, thrive in the damp weather, and naturally-occurring anthrax can take a toll on livestock and wildlife when pastures dry after prolonged wet periods.

Horse owners should take precautions against mosquito-transmitted diseases by having their animals vaccinated against West Nile Virus (WNV) and the reportable diseases Eastern and Western Equine Encephalitis (EEE and WEE). "If you wait until cases of "sleeping sickness" occur in your area, you may have waited too long to vaccinate," said Dr. Bob Hillman, Texas' state veterinarian and head of the Texas Animal Health Commission (TAHC), the state's livestock and poultry health regulatory agency.

"You need time for the vaccine to do its job, which is to build the animal's immunity to a particular disease," he said. "Vaccine can provide the best disease protection possible, but it's also crucial to keep up with booster shots, as recommended by the vaccine manufacturer or your private veterinary practitioner. In 2006, 111 horses were confirmed to have West Nile Virus in Texas. So far this year, the disease has been confirmed in one horse, located in Willacy County."

Three cases of Potomac Horse Fever, which is not a regulatory disease, have been confirmed in Kerr County by the Texas Veterinary Medical Diagnostic Laboratory. Potomac Horse Fever, first detected in Maryland in 1979, is not typically found in Texas. Clinical cases usually are found near rivers, streams, ponds or canals. The infection involves tiny flukes that are parasites of water snails. The flukes hatch their offspring into the water, and these are then picked up by aquatic insects that molt into flying insects, including caddis flies and mayflies. Horses can become exposed to Potomac Horse Fever when they eat or drink anything contaminated with the insects.

Kerr County equine veterinarians are urging all owners to call their practitioner if equine animals exhibit signs of Potomac Horse Fever, which can include a reluctance to eat, fever, diarrhea, colic or inflammation around the hoof. Treatment includes antibiotics and supportive care.

Biting flies can mechanically transmit equine infectious anemia (EIA), sometimes called "swamp fever." This incurable disease, for which no approved vaccine exists in the U.S., is a regulatory disease. TAHC regulations require horses and other equine animals to have a negative test for EIA within the previous 12 months before entering the state, or going to events, assemblies, trail rides, undergoing change of ownership or entering a breeding farm. The most commonly known test for EIA is the "Coggins" blood test. The incidence of EIA has dropped dramatically since 1997, when 750 equine animals in Texas were found to be infected. Since January 2007, only 29 infected animals have been detected.



Steroids don't belong in Texas schools

passed don't get too much attention until someone is affected by it. One such bill may very well be SB 8 by Senator Janek.

Janek's bill requires the University Interscholastic League to implement random tests on our high school athletes for steroids. Considering the fact that there have been many reports of severe health problems associated with careless use of steroids, this bill is long

Perhaps the first headline story about steroids was the death of NFL player Lyle Alzado. Alzado played professionally for the Denver Broncos and then the Oakland Raiders. He was a prolific lineman responsible for many tackles.

Initially, in high school, Alzado was undersized. When he went on to college, he started taking the steroids to build up his mass. He continued through his professional football career sometimes spending up to \$30,000.00 a year on steroids. The emotional effect of the drugs cost him his marriage. The physical impact of the drugs cost him his life as a result of

I think that many of our local athletes are tempted to supplement their normal training with enhancement drugs such as steroids. So many of the other Texas athletes are bigger than the El Paso athletes, it is understandable how the desire to compete would make steroids at-

tractive. Perhaps the student athletes in other parts of Texas use steroids to gain the size advantage. Winning in high school athletics is not worth the risks associated with steroid use. I sincerely hope that none of the athletes in El Paso are supplementing their training with those drugs.

In the fall, the random testing program should be in full swing. Not all of the schools or athletes in Texas will be tested. The UIL will determine the targets for this and future tests.

Although quite expensive, the local communities will not be charged for the testing this school year and the next. At that point, the UIL should have developed the mechanism of funding the tests.

I have been assured that there will be great care in preserving the privacy of anyone tested in the program. If a student is tested positive, there will be policies in place to first confirm that the test was not a false positive, and then to address the problem with the parents, the student athletes, and school administrators.

I hope all of you will support the testing program. I want our student athletes to avoid the drugs altogether. This program, and educating them about the dangers of steroids, will keep any of our children from experiencing what Lyle Alzado experienced fifteen years ago.

Let us all be drug free.

USDA announces \$8.9 million for broadband grants

WASHINGTON DC — Deputy Agriculture Secretary Chuck Connor has announced the availability of \$8.9 million in grants for communities without broadband service to provide residential service and connect facilities such as police and fire stations, health care, libraries and schools.

"The Community Connect Grant Program has proved to be effective in reaching those rural communities where broadband service is least likely to be deployed," Conner said. "Connecting residents and essential community facilities improves local services and the protection of the citizens of these communities."

Grants are available to communities in the most rural, economically challenged areas where loans will not be sustainable. In Horseshoe Bend, Idaho, for example, no company had invested in providing broadband delivery at http://www.usda.gov/rus/telecom/.

to the community of 770 people. However, local businesses, schools and residents worked with the BitSmart Corp. to file a USDA Community Connect Grant, which was approved. Now, BitSmart has established wireless internet availability and an integrated system connecting law enforcement, health care providers, and school and government offices. Additionally, students in a business class at the high school are serving as BitSmart's local operations staff.

"Providing community residents with access to the internet and training on how to use it helps rural citizens understand the benefits of broadband service and is one more economic development tool available through USDA Rural Development," said Agriculture Under Secretary for Rural Development Thomas C. Dorr.

Applications for grants are due by close of business August 13, 2007. There is a minimum grant level of \$50,000 and a maximum grant level of \$1,000,000 for projects. The application guide for this grant program can be found

Lough, was suspended and removed as student council president for bringing a pencil sharpener with a twoinch blade to school.

Last year, Casey Harmeier, a Tomball ISD 11-year-old, was arrested for allegedly pulling a fire alarm and was initially charged as a felon. The charge was reduced to a misdemeanor and ultimately dropped.

Texas students have been suspended or expelled for incidents such as a pocket knife left in a car parked on school property or an asthma inhaler not registered with school authorities. In 2005, the Legislature passed HB 603, which provided that districts may consider a student's intent and prior disciplinary history, if any, in suspension or expulsion decisions. During the 2007 session, the House voted to make such consideration mandatory, but the Senate failed

However, policies must be fundamentally changed to be more restorative than punitive, and ensure that interventions take place within the school, particularly for nonviolent infractions.

Sendelbach should have been required to clean up her graffiti and perhaps other graffiti as well, perform school and community service, and meet with a local business or homeowner who has been victimized by graffiti to discuss its impact on a community's quality of life. All of this can be accomplished through programs such as victim-offender mediation, peer mediation, and teen courts that should operate within schools.

Unlike prosecutions that typically take many months, these interventions can occur within days, and numerous studies show that the proximity of the sanction is the most important factor

State law already provides a framework for this, but Harris County is not utilizing it. Chapter 52 of the Family Code describes police informal disposition programs that allow juveniles — particularly first time offenders like Sendelbach — to avoid prosecution by agreeing to make restitution and perform community service. While Harris County utilizes deferred prosecution, such cases still must go to court. The juvenile board has failed to adopt guidelines for diversion of youth by law enforcement, including school police. However, Section 52.03 states that each county's juvenile board "shall, in cooperation with each law enforcement agency in the county, adopt guidelines" for informal disposition.

In 2006, Dallas diverted 800 juveniles under this law. More than 80 percent of them successfully performed their agreement; the rest were sent to court. If the required guidelines were in place, Katy ISD police would have had a clear procedure for informally disposing of Sendelbach's case instead of giving her a summons to appear in court, and she could have already fulfilled her agreement.

A law passed this session should encourage schools to move in this direction for Class C misdemeanors. Schools will no longer be able to issue criminal citations to students

Decades ago, such incidents were handled within the school. Our current system has become excessively punitive, and protracted adversarial legal proceedings have displaced less formal means of accepting responsibility. It's time to write a new chapter in Texas discipline and return to old-fashioned common sense.

anemia, fever and swelling. In severe cases, EIA can kill the animals, but many times, the infected animal has few signs of disease," noted Dr. Hillman. "Prevent EIA transmission by avoiding blood-to-blood contact between infected and 'clean' equine animals. Disinfect medical instruments and tack, and control flies. Biting flies carry blood from one animal to the next on their mouthparts, and they play a key role in the mechanical transmission of EIA."

Infected equine must be maintained at least 200 yards away from other equine animals, euthanized, or sent to slaughter.

"In the past, untested equine animals could be sold for slaughter through a livestock market. At the slaughter plant, blood samples were collected and sent for laboratory testing. Now that Texas equine slaughnot ensure that horses moving to plants in other states or countries are tested. Therefore, we are requiring all horses to have a current EIA test. even when being sold for slaughter," said Dr. Hillman.

Rain, followed by hot weather can coax the invisible bacteria Bacillus anthracis to the surface, a situation

Green County, where 17 head of cattle and a number of white-tailed deer have died. "Anthrax in Texas occurs nearly every year, and it is a reportable disease to the TAHC. If we or hunters to worry about naturally know an outbreak is occurring, we can let ranchers in the area know that it's time to vaccinate their livestock. There is no preventive treatment for wildlife," said Dr. Hillman.

Anthrax naturally occurs worldwide and in many states of the United States. Disease outbreaks have been reported in Minnesota, South Dakota and Canada this year. When an anthrax-infected animal dies and isn't properly burned, the bacteria will infiltrate the soil and lie dormant (but not spread) for many years. Under ideal weather and soil conditions a cool, wet spring, followed by a hot, dry spell — the bacteria will resurface on grass and forage. The disease cycle starts again, when another animal ingests the resurfaced anthrax bacteria.

ter plants have been closed, we can infected animal's carcass, manure and bedding be incinerated. This prevents wild animals from being exposed to the disease, and it kills the bacteria, preventing another site where the anthrax bacteria can resurface. Dr. Hillman urged ranchers to wear gloves and long sleeves when preparing the burn site and to avoid moving the carcasses, if possible.

that has occurred on a ranch in Tom Exposure to anthrax carcasses could cause a handler to develop a black skin lesion that requires prompt medical treatment.

> "There is no need for vacationers occurring anthrax. Just don't touch or handle sick or dead animals, and don't pick up bones or shed antlers. We usually advise hunters not to hunt feral or wild swine in the area during an anthrax outbreak. Feral swine may root around carcasses of anthraxkilled animals, becoming exposed to the bacteria but not contracting the disease."

> Dr. Hillman advised swimmers to avoid ponds or streams, if dead animals are nearby. The same advice goes for pets, too. By the time hunting season starts, he said, cool weather usually puts an end to anthrax cases. "Always harvest only healthy-looking animals, and, as a routine practice, wear gloves when processing meat," he said.

"In Texas, it is often 'feast or fam-TAHC regulations require that an ine' drought or flood," said Dr. Hillman. "With each of the conditions, there are concerns about livestock health. So, while ranchers enjoy the lush grasses the rains have produced, they may have to control pests to lower disease risks. However, I don't know many ranchers who would choose last year's drought over some extra vigilance this year."





Seeking the women's vote

"Yeah, I'm a babe magnet," presidential candidate Fred Thompson recently announced.

Well, not quite.

Speaking to a group of Republican Congressmen, Thompson did say, "I was single for a long time and yep I chased a lot of women. And a lot of women chased me. And those who chased me tended to catch me."

But the interesting part is the role these women are expected to play in the election.

The following story actually appeared on Times Online:

"In the battle for the women's vote, Fred Thompson has a secret weapon against Hillary Clinton who still adore him and who want him to be president."

According to historians and political pundits, this may be the first presidential election where past girlfriends hold the deciding vote.

In just the state of Florida, for example, Thompson is said to have 189,000 former girlfriends enough, political observers say, to swing the election.

And some contend that estimate is far too low, that — owing to Thompson's extraordinary discretion — the actual number could be easily top 400,000 or more.

Thompson's highest concentrations of adoring ex-girlfriends reside on the coasts, with 1.6 million and 1.3 million in California and New York, respectively. He is also estimated to have about 9 million ex-girlfriends spread across the Sunbelt.

However, strategists from opposing camps point out there are wide swaths of the West and Midwest where Thompson has virtually no ex-girlfriends. Past Iowa girlfriends are said to number as few as 2,000 and there are even rumors — aggressively discounted

by Thompson aides — that in states like Montana and Wyoming the candidate may have no more than 500 ex-girlfriends — not enough to make a difference in most elections.

Thompson also faces the danger of a backlash in some states.

Said one woman who likes Thompson but remains hurt that he never tried to date her or her sisters, "How come he's only got 3,000 ex-girlfriends in Idaho? What — he doesn't think we're woman enough for him?"

The Northeast also remains something of a soft area for Thompson, where some women find his folksy manner and habit of appearing to fall asleep in the middle the legions of former girlfriends of a long Tennessee sentence annoying.

> Off the record, campaign staffers say Thompson is well aware of his potential weaknesses and plans to make extra efforts to woo the voters in those states.

> "It's a question of the Electoral College politics," a senior Thompson aide explained. "If it was just the popular vote, we'd have enough right now. But we have to shore up states where Sen. Thompson's ex-girlfriend count is low."

> But adding more ex-girlfriends before the election — even though it's 16 months away — remains problematical for at least one reason. That would be Mrs. Thompson, who is likely to cramp her husband's style.

> And Hillary, after all, has her own secret weapon to unleash, her husband, the legendary Arkansas horn dog.

> Scoffed one Clinton aide, "We'll see who can line up more babes come Election Day."

> It's going to be an important and illuminating election.



A: If your annual income is below \$20,535 if you are married and living with your spouse), you may qualify for the extra help.
