Tigua bill

The U.S. House of Representatives passed legislation introduced by Congressman Silvestre Reyes to give the Tigua Tribe the right to determine requirements for tribal membership. "Fundamentally, this is an issue of equity and fairness," said Reyes. "The Tigua are a sovereign nation and deserve the right to exercise their own selfdetermination. The Tigua are one of only two American Indian tribes required to go before Congress to change their membership eligibility. My bill simply creates parity with the vast majority of Indian nations

Socorro ISD student learns about 'CSI' trade

When students tell their summer vacation stories in class, Alani Pon will be describing how to analyze DNA and crime scene investigation (CSI). The 5th grader from Benito Martinez spent six days working with other students from across the country learning about forensic science. She was the only Socorro ISD student selected to attend the National Young Scholars Program (NYSP) held in Dallas in July.

"I was going to do the theater one, but I saw the CSI one and changed my mind," says Alani.

NYSP gives students the chance to unleash their full learning potential as they further their interest in specific areas of study, such as the natural sciences, architecture, literature, musical theater, forensics, physics of flight, the human body, consumer marketing and Greek mythology. The goal of the program is to inspire outstanding fourth, fifth and sixth grade students to explore, invent, learn and think creatively.

Alani and her group were challenged to solve a mystery using the building blocks of forensic science like handwriting and fiber analysis. The class taught the students about deductive reasoning, testing glass density and examining microscopic pieces of evidence.

"She is the one and only SISD student to at-

tend the NYSP," says Marta Provenghi, Principal at Benito Martinez Elementary. "It was a great opportunity for her to meet other students across the country and learning about forensic science."

Cocaine bust puts two 17-year-olds in custody

EL PASO COUNTY — U.S. Customs and Border Protection (CBP) officers performing anti-terror inspections at the Paso Del Norte border crossing in El Paso seized 50 pounds of cocaine Sunday afternoon. Two 17-year-old juveniles from Mexico were taken into custody following the discovery.

The seizure was made just before noon when 1990 BMW 325i entered the U.S. from Mexico. The 17-year-old male driver from Juarez made 1,979 pounds of marijuana.

CBP officers removed a total of 17 cocainefilled bundles from the car. County files lawsuit against Western Playland

El Paso County Attorney José R. Rodríguez has filed a civil lawsuit on behalf of El Paso County against Western Playland, Inc. alleging it has failed to perform a costly clean up of its former site at Ascarate Park, including the removal of dangerous asbestos and toxic chemicals.

The suit also seeks to recover hundreds of thousands of dollars El Paso taxpayers have been unjustly deprived of after Western Playland breached its contract by failing to operate an amusement park at Ascarate Park as required under the current agreement. Because Western Playland did not comply with its obligation to restore the property to its former condition, the County has been unable to look for another vendor to operate a similar amusement park at Ascarate. By doing so, Western Playland has taken away from the residents of El Paso the opportunity to enjoy a much-needed family entertainment venue.

Western Playland Inc. executed a written contract with the El Paso County government in 1960 to lease a parcel of land in Ascarate Park for the operation of an amusement park. In the fall of 2005, Western Playland president Pat Thomson made several media statements announcing the transferring of his amusement park operations to Sunland Park, New Mexico, even though the term of the lease did not expire until August 2014.

In January 2006, in response to an inquiry by the County government, Thomson expressed his intention to operate the amusement park at Ascarate in a reduced capacity during the 2006 summer season. The agreement further stated that at the end of the season, Western Playland would vacate the premises within 30 to 90 days, leaving the land in a neat, clean and orderly condition, as required by the original contract. However, Thomson failed to fulfill his end of the agreement and the amusement park remained closed all year.

On June 11, 2007, the County Commissioners found that Western Playland had effectively terminated the contract by failing to operate the amusement park during 2006 and 2007, and by abandoning the premises. The County gave Western Playland Inc. 30 days to remove all of its equipment and property, and leave the land in a neat and clean condition.

As of today, Western Playland has failed to comply with the terms of the contract, leaving behind several partially demolished structures (some of them contaminated with asbestos), piles of debris, trash, barrels containing unknown substances, old tires, pools of murky water, broken furniture and abandoned fuel tanks. The condition of the premises is likely to attract or harbor mosquitoes, rodents, vermin, or disease-carrying pests few yards away from where hundreds of families and kids play and eat every day.

On July 23, 2007, the El Paso Commissioners Court authorized the county purchasing agent to search a company to clean up the site. It is expected that the El Paso County will have to pay several tens of thousands of

idea on the surface of things but that's the whole problem — it's just a surface relationship and all the genuine and sincere benefits of having an animal friend are completely overlooked compassion, affection, friendship and respect between living creatures.

Meanwhile, we are afflicted with himself if authorities took them away. the opposite end of the spectrum the animal hoarders — who have formed such extreme emotional attachments to large groups of animals that they lose all sense of reality.

I'm not talking about people who are involved in agriculture and produce animals for food. And I'm not talking about people who are breeding animals for sale so they have lots of 'em on hand during production.

These are people who, for whatever reason, believe that they are doing the animals they collect a favor. In most cases, hoarders don't physically abuse the animals other than through neglect and inability to properly provide adequate maintenance, food and shelter.

There have been four severe cases over the last three months in the Las Cruces area which required intervention by law enforcement.

Sheriff's investigators found 59 cats, 33 dogs, 26 chickens, five ducks and two goats in the possession of a man after his neighbors finally turned him in. Even though the animals were in very poor condition, he threatened to kill

In another sad case, a woman pleaded no contest to 73 counts of failure to adequately provide for her creatures after an accidental fire at her home caused the death of 73 cats. Another 21 were found on property she managed at another location.

About 129 cats had to be destroyed after they were found in a home in mid-May, suffering from a variety of severe illnesses including AIDS and feline leukemia. Still another 34 live cats and 16 dead ones were found at another Las Cruces home.

Every now and again you will hear about the discovery of some kind of extraordinary wild animal living in domesticated conditions, like the man who had a full-grown tiger and several other jungle animals living in a tiny apartment in New York. They were discovered when the tiger made a ruckus while devouring his cellmates.

On second thought, maybe we shouldn't be trying to understand what's the deal with animals. Maybe we should just figure out how to deal with them better.

about land formation, map and compass reading. After completing the class the cadets were sent on a quest to find set points in the area. The course was six kilometers long, if not longer.

The following day cadets dressed out in Battle Dress Uniforms. They had to safely climb from the ground to an elevated rope course and hike up a

steep mountain. A tree-mounted, 40 foot high, two-by-two-foot platform was waiting for cadets. The object was to jump from the platform to a trapeze bar that seemed an impossible distance from the tree and platform. Cadets used their leadership and teamwork skills to accomplish their task.

The Odyssey was an obstacle course that had two levels of difficulty — one at 40 feet and the other at 50 feet above ground. It was a challenge to control your thoughts when the task seemed impossible

or improbable.

The last afternoon was reserved for capture the flag and a small graduation ceremony which recognized the outstanding cadets in every company: the most athletic, best land navigation team, best drill cadet, top pentathlon team, best survival shelter, and top cadet overall.

Ultimately was the hardest exercise was saying goodbye to new friends —the cadets and instructors. All this would not have been so great with out the help of the Army instructors, chaperones, and the staff from Aspendale that made sure cadets had a fun and safe experience.





across our country by allowing the Tigua to determine, through whatever means the Tribe believes most appropriate, who is and who is not a member of the Tribe." Reyes's bill, H.R. 1696, amends the Ysleta del Sur Pueblo and Alabama and Coushatta Indian Tribes of Texas Restoration Act of 1987. This bill federally recognized the tribe and established membership eligibility. The Texas Restoration Act requires a oneeighth Tigua-Ysleta del Sur Pueblo Indian blood quantum, or minimum degree of blood relationship, for potential tribe members. Commonly known as the Tigua, the Ysleta del Sur Pueblo is the oldest community in Texas and the only pueblo that still exists in the state. It was established in 1681 by refugees from the Pueblo Revolt, an uprising against the Spanish in New Mexico.

If your car stalls, abandon it immediately and climb to higher ground. Many deaths have resulted from attempts to move stalled vehicles.

Never let children play near storm drains when the water is rising or is high. Every year, deaths or injuries occur as a result of people being swept away. Sadly, the most frequent victims are children.

If you live in a low-lying area, pay close attention to water levels during heavy rain events. Be prepared to move quickly to higher ground if water levels begin to rise. Sandbags are available at all city fire stations and are free to the public.



Canutillo Independent School District **Public Forum**

The Canutillo Independent School District will hold a public forum on Thursday, August 9, 2007, at 6 p.m., at the CISD Central Administration Building, 7965 Artcraft Road, El Paso, Texas.

The purpose of the forum is to discuss the latest changes to election laws adopted by the Legislature in 2007, which affect the Canutillo ISD's Board of Trustee Elections. The District cannot conduct an election in November, 2007 as originally scheduled because this is not allowed, according to an interpretation of the law by the Attorney General and subsequently by the Secretary of the State. Below is a list of the alternatives to be discussed:

- Schedule the November, 2007 election and all subsequent elections for the May Uniform Election Date commencing with May, 2008 to coincide with the Town of Vinton. After initial adjustment, trustee terms would continue to be three years.
- Select the May Uniform Election Date for future elections but align with the City of El Paso election date in May, 2009. Modify school board member terms to four years to allow for strict alignment with the City of El Paso.
- Continue the School Board elections on the November Uniform Election but have elections only on the same date as the state and county officers, which is every November of even numbered years commencing 2008. Change Board members to four year terms so there will be strict alignment.

Q: Why do some people get both Social Security disability and Supplemental Security Income (SSI)? I'm severely disabled and only get SSI.

A: In order to get both you must qualify for both. To get Social Security, you need to have worked long enough and recently enough and you need to have paid enough Social Security taxes. If you're receiving SSI only, that means you did not pay enough in Social Security tax to qualify. SSI, on the other hand, is a needs-based program for people who are disabled, blind or at least 65 years old and who have low income. Since Social Security is considered income, many people who get Social Security make too much to get SSI. Q: What are "work credits" and how do I earn them?

A: Credits for work are based on the amount of your earnings. You can earn up to four credits each year when you work in a job or operate your own business as a self-employed person and pay Social Security taxes. Each year the amount of earnings needed for credits goes up as average earnings levels increase. In 2007, you earn one credit for each \$1,000 of your earnings.
