Socorro HS students complete 'Texas Bunkhouse'

When parents of some Socorro High School students asked "What did you do at school today?" For some of them the answer was "Built a log cabin." They nicknamed the project the "Texas Bunkhouse". For two years, a group of students worked together to craft the cabin. Drafting students designed it, welding students constructed the frame, it was wired by electrical students and carpentry students did all the woodwork, including rustic pine knot flooring. Media technology students videotaped the entire process.

Their hard work paid off earlier this year when they completed the one-bedroom, onebath log cabin. Some of the students were sophomores and freshmen when the project started in 2005, like senior Manuel Calderon who remembers spending his days working on the cabin during El Paso's hot summer.

"It was hard work, but we enjoyed it," says the 17-year-old. "This project really helped us expand our skills. I am really proud of our work. We showed that we can do this if we work hard."

Calderon worked on the cabin's inside walls, siding, cabinets and porch. Joining the project last year was junior Daniel Tellez who joined the Building Trades class his sophomore year to develop his building skills.

In addition to learning about roofing and installing tile, the students also had to do some problem solving to get the job done.

"Sometimes we didn't have the right products, but the students used what we had and adapted them to work for our project. We also had to learn how to make our own color stain for the wood," says John Kilgore, Advanced Building Trades Instructor. "I was impressed with what these kids accomplished. The cabin turned out better than I imagined."

Horizon residents going home from work or just driving down Eastlake Drive will see an unusual sight the week of Sept. 17. The log cabin will be sitting in front of the Socorro ISD central offices. Students in the Socorro ISD Career and Technology program made a special presentation to the Board of Trustees on Sept. 18. Trustees will be among the first to tour the 12 by 32 foot log cabin. Students who worked on the project will be on hand to give tours of the one-bedroom, one-bath cabin, while culinary arts students will provide snacks for visitors during the tour.

Allen Long, Director of Career and Technology says there are plans to auction the 384 square foot cabin. Auction details will be published as soon as they become available. The cabin was opened to the public on Wednesday, Sept. 19 and Thursday, Sept. 20. Texas' immunization rate drop concerns TMA physicians

More Texas children are at risk of contracting disease than before, according to the justreleased 2006 National Immunization Survey. Texas Medical Association (TMA) physician leaders are voicing concern that Texas fell to 34th nationally in immunizing children ages 19 months to 35 months.

"This is tragic - Texas needs to start going in the right direction. With low immunization rates Texas will see a comeback of once-rare diseases, and we will be victims of our past success," said Jaime Fergie, MD, advisor for TMA's "Be Wise - Immunize" SM vaccination program. "It's unfortunate that parents don't think about the danger of childhood diseases because of how well immunizations work, but it's dangerous to let our guard down." Dr. Fergie specializes in treating pediatric infectious diseases in Corpus Christi.

Texas' 2006 vaccination rate of 74.7 percent dropped the state to 34th place from its 24th-place spot in 2005. Texas vaccinated 76.8 percent of its youngest children in 2005. The 2.1 percent rate decrease led to the 10place fall.

Texas' low child immunization rates inspired TMA physicians to create the "Be Wise — Immunize" program three years ago. The program produced landmark results in 2005. Texas physicians and TMA Alliance members (civic-minded physician-members' spouses) administered more than 25,000 shots to Texas children that year. The program contributed to Texas' surge from 41st in 2004 to the 24th-place score in 2005. In 2005, Texas also rose above the national average for the first time since the survey began in 1994. In the latest survey, Texas fell back below the 77 percent national average rate of child immunization.

"Complete vaccination is complete protection," said Dr. Fergie, noting that patients not completing their vaccine series is part of the reason why Texas immunization rates remain low. For example, the fourth dose of the vaccine for diphtheria, tetanus, and pertussis (DTaP) is recommended before a child turns 19 months of age. Ensuring parents follow through continues to be the biggest challenge to increasing vaccine coverage levels, according to the Texas Department of State Health Services. "It's a shame that some parents don't take full advantage of opportunities to vaccinate their child, or start to and then don't complete the vaccine series," added Dr. Fergie. He notes that patients are not fully protected if they do not complete the recommended series. In three years, "Be Wise - Immunize" program participants, TMA Alliance members, county medical societies, and community coalitions have given more than 90,000 shots to Texas children. Funded by TMA's philanthropic arm, the TMA Foundation, the program is able to provide physicians and volunteers important resources for hosting weekend or after-hour clinics. "Immunization programs like Be Wise have contributed a great deal to the overall education and awareness of the importance of immunizations," said Dr. Fergie. "Such programs have done well for Texas patients, but we have more work to do."




After awhile we unrolled a sleeping bag under one of the tables and he laid down on it. Within seconds, my dancing partner had deserted me for dream-land.

election month. This year is no exception. Although the November 6th election is not for a multitude of candidates, it is for 16 important amendments to the Texas constitution.

During the 80th legislative session (Jan. '07 through May '07), the representatives and senators passed joint smaller cities (10,000 population or resolutions which are now on the November ballot. In order for these resolutions to be placed on the ballot for your vote, each house must have passed the measure with a two thirds majority. This makes it more difficult to change our constitution. However, only a majority number of votes (50% plus 1) is needed to pass the measure in the November election. In an unusual occurrence, an item that normally would have been on the November election was placed on the May ballot for your vote. That amendment allowed the tax rate on school funding to be lowered and

The subjects for those amendments are as follows: • Proposition One: It places Angelo State University under the funding umbrella of Texas Tech University. • Proposition Five: It allows less) to temporarily freeze property taxes under certain conditions of re-

• Proposition Ten: It deletes any reference to the county office of hides and animals (clearly an outdated and unnecessary office).

• Proposition Fourteen: It allows any judges who have reached the mandatory retirement age to complete the current term on the bench. I am sure that you will agree the four amendments have little impact on your everyday lives. In contrast to those items, the remaining items include four amendments authoriz-

vising home equity loan provisions, one amendment providing additional funding for economically distressed areas and other subjects.

The November 6th election is just six weeks away. During the next four to five weeks, I shall present you information about the amendments. In the next issue of the Courier, I shall dedicate the entire article to Amendment Number Three, providing an annual ten percent cap on increases in homestead taxable value. None of the articles will provide a recommendation to you, the voters. I shall only provide the information that I have received, in a balanced format, that has been provided to my office by the House Research Organization.

I hope the articles assist you in understanding the amendments.

Anthony pioneer, Mrs. Johnnie Beeson, dies at 84

Anthony, Texas, will be memorialized with a special service on Saturday, Oct. 22, at 10 a.m. in the West Valley Fire Department, 510 E. Vinton Road, in Vinton.

Mrs. Beeson died in El Paso on Aug. 28, 2007 after Shumaker Harbert, and her brother, James Winborn a lengthy struggle with lung disease.

Born March 14, 1928 in Mississippi, Johnnie moved to New Mexico as a small child, accompanied by her parents, Lloyd and Thelma Shumaker, her siblings, and other relatives, traveling mostly on dirt roads. Immigrants – legal or not – must be able to call for help

Mexico sheriff began scouring the lation, they subject victims of crime town of Chaparral, NM for undocumented immigrants. Local law enforcement acting as the border patrol is a bad idea.

In general, law enforcement strives to gain the trust of the public. In fact, the Otero County Sheriff's website uses the word "trust" many times. By playing border patrol, local law enforcement erodes whatever trust they have in the community. Soon this will spread to other public services like hospitals, fire departments, and schools.

The ramifications can spread even to non-immigrant Latinos because incidents of racial profiling by local authorities are bound to rise. Ultimately, the safety of the public at-large will be negatively affected. Gang activity will be on the rise. Extortion against immigrants who fear the police will happen more and more.

Sound too far fetched?

We have already seen the growth of gang problems in Texas-New Mexico border communities. This behavior by the Otero County Sheriff will shut the door on victims and complainants.

It may look good on paper for the Otero County Sheriff to enforce immigration law, but it is in direct conflict with the goals of communityoriented policing. I'm sure the Otero County Sheriff is interested in diversity and expanding community relationships. This behavior puts those efforts in jeopardy. Complicating the issue is the fact that many family members are of mix immigration status. Some are citizens, other residents, and still others are undocumented. The Immigration Policy Center said in a recent national study, roughly 4.9 million children in the United States live in households headed by undocumented immigrants. About 3.1 million of these children are U.S. born. Families become split in traumatic ways. I say, let's educate law enforcement on the reasons for not inquiring about immigration status. They should be educated on the protections under immigration law for crime victims such as survivors of domestic violence and human trafficking. Authorities need to realize that if they

Finding of No Significant Impact

It has been determined that such a request for release of funds will not constitute an action significantly affecting the quality of the human environment and, accordingly, the town has decided not to prepare an Environmental Impact Statement under the National Environmental Policy Act of 1969 (PL 91-190). The reason for the decision not to prepare such a statement is based upon the fact that all environmental concerns could either be minimized or mitigated.

The town has made an Environmental Review Record for the proposed project, which documents the environmental review of the project and more fully sets forth the reasons why such a statement is not required. The Environmental Review Record is on file at the Anthony Town Hall and is available for public examination and copying, upon request, between the hours of 9:00 A.M. and 4:30 P.M., Monday through Friday.

Public Comments on Findings

All interested agencies, groups, and individuals disagreeing with this decision are invited to submit written comments for consideration by the Town of Anthony, at the address set forth above. Such written comments must be received at the address specified within sixteen (16) days after this publication; all comments so received will be considered, and the town will not request release of funds or take administrative action on the project prior to the end of the that 16-day period.

Release of Funds

The Town of Anthony will undertake the activities described above with a grant from the Texas Capital Fund Program administered by the Texas Department of Agriculture (TDA). That grant was issued from Community Development Block Grants funds under Title I from the 2007 Program Year, under the provisions of the Housing and Community Development Act of 1974. 





Learn to fake authenticity

Attention, high-school seniors, it's time to go over the All-Important College Application Checklist.

Figured out which colleges you'd like to attend? Check.

Forgotten about those colleges and decided where you might actually have a chance? Check.

Realized you've got a problem with those schools too and added appropriate "safe" schools to your list, including the Kalamazoo Kollege for Klueless Kids? (Warning: This school has recently gotten a lot tougher.) Check.

Completed error-free application and admission essay? Check.

You fell for it, didn't you? All those years of schooling have rotted your brain to the point where you can't even spot an obvious set-up. Accuracy is out, my friends!

Mistakes are in. (Mistakes is in?) The following absolutely true

headline appeared on MSNBC.com: "A typo may help your college admission."

It continues: "Steven Roy Goodman, an independent college counselor, tells clients to make a small mistake somewhere in their application — on purpose."

All that stuff teachers have been drilling into your head for the past 12 years about spelling and accuracy? Forget about it. word I just made up.) (Forgeddabout it?)

According to the story, "What Goodman is going for is 'authenticity' - an increasingly hot selling point in college admissions."

But it's not as easy as it sounds. In yet another quote I'm not making up, Goodman said, "There's a little bit of an arms race going on. If I'm being more authentic than you are, you have to be more authentic next month to keep up with the Joneses."

So while earlier students may have cut the academic mustard with a typo or two, this year's ap-

plicants have be prepared to turn in complete gibberish.

Here's the problem. Many of you otherwise promising young scholars (skolars?) are woefully unskilled at faking authenticity, despite years of delivering straightfaced whoppers to your parents.

You need someone to make careless errors for you.

This is where I can help. As a trained professional journalist, I can take your embarrassingly perfect copy and turn it into something incomprehensible. For further authenticity, I can make up stuff out of whole cloth.

Here, for example, is typical college essay:

"If I am accepted into Prestigious University, it will help me reach my goal of becoming a caring and productive member of our society. In addition I will bring about world peace, end poverty and hunger, and produce worthwhile TV reality shows."

But college admission officials aren't dumb. They know no one's going to produce worthwhile reality TV. Plus, all those correctly spelled words will be a dead giveaway that you're not college material.

Here's the same essay, after I have "authenticized" it. (It's a new

"If you loosers dont admit me into PU, I will take up a life of armed robery, probly on the PU campus. YOU HAVE BEEN WARNED!!"

This essay accomplishes a couple of things: 1) It offers a solid reason not to overlook your application, and 2) It establishes right off that you are "authentic," perhaps dangerously so.

Then you can pick the school of your choice.

Texas Gas Service Company (the "Company") hereby gives notice that on August 31, 2007 it filed a Statement of Intent to Increase Rates in the Cities of El Paso, Anthony, Clint, Horizon City, Socorro and Vinton, which together with the environs areas comprise the Company's El Paso Service Area ("EPSA"). The Company seeks to implement a new schedule of natural gas service rates and terms and conditions of service for all classes of customers. If approved, the proposed changes will affect approximately 183,494 residential, 11,872 commercial, 47 industrial, 764 public authority, 34 transportation and 2 stand by customers within these Cities.

The Company's proposed rate schedules will increase base rate revenues by \$4,724,571 for the EPSA. Additionally, the Company requests recovery of revenue-related taxes as a line-item on the bill rather than recovering these taxes as part of base rates as previously done. This change will produce additional revenue of \$725,689, for a total annual revenue increase for the entire EPSA of \$5,450,250. The proposed change in rates does not constitute a "major change" as that term is defined by Section 104.101 of the Texas Utilities Code. In addition, the Company requests reimbursement of all Company and City rate case expenses as allowed by law. The exact amount will not be known until the case is completed.

Based on the proposed rate design, the system-wide average monthly bill for each customer class will increase by the amount and percent shown in the table below:

A PUBLIC HEARING will be held at 6:30 p.m. on Tuesday, September 25, 2007 during the Regular City **Council Meeting** at City Hall, 14999 Darrington Road, Horizon City, Texas. Purpose of the public hearing is to allow any interested persons to appear and testify regarding the following proposed ordinance(s):

1) Ordinance No. 0163, An Ordinance Adopting a Budget for the Fiscal Year Commencing October 1, 2007 and Ending on September 30, 2008, for the Town of Horizon City, Texas.

This budget will raise more total property Taxes than last year's budget by \$319,452 an increase of 25.25%, and of that amount, \$245,239 is tax revenue to be raised from new property added to the tax roll this year.

2) Ordinance No. 0164, An Ordinance Authorizing the Assessment and Collection of Property Taxes within the Town of Horizon City, Texas and Authorizing the City of El Paso Tax Office to perform the Actual Assessment and Collection of said Property Taxes on behalf of the Town of Horizon City, Texas for the Fiscal Year of October 1, 2007 to September 30, 2008.

3) Amendment No. 0020 to Zoning Ordinance No. 0102, to Repeal and Replace Amendment 004, Appendix III, Building Permit Fee Schedules as passed on December 9, 2004, for the Town of Horizon City. Texas.

Other proposed tariff changes include revisions to the Rules of Service, including new or increased service charges. Also, the Company proposes changes to the Cost of Gas Clause to provide for recovery of uncollectible gas costs through the Cost of Gas rather than through base rates. The Company also proposes a new Transportation Schedule, T-1, and revisions to the Transportation General Charges and Provisions. This change addresses commodity imbalance provisions and upstream pipeline balancing service costs. In addition, the Company proposes a new Cost of Service adjustment clause, Rate Schedule COSA, to provide for an annual review by the Cities of the Company's expenses, revenues and plant investment and a corresponding adjustment to the Company's rates to reflect annual changes (increases or decreases) in these categories. Finally, TGS proposes a gas conservation program and tariff to authorize the program.

Complete copies of the filed Statement of Intent, including all proposed rates and schedule changes, are available for inspection at the Company's business office located at 4600 Pollard Street, El Paso, Texas, 79930.
