Fast track claims

Michael J. Astrue, Commissioner of Social Security, announced that the Social Security Administration has implemented its new quick disability determination (QDD) process in the Texas Disability Determination Services effective November 19, 2007. Under QDD, a predictive model analyzes specific elements of data within the electronic claims file to identify claims where there is a high potential that the claimant is disabled and where evidence of the person's allegations can be quickly and easily obtained. "The quick disability determination process has been very successful and efficient. I am happy to say it will now help people filing for disability benefits in Texas," Commissioner Astrue said. "This is a very important step we are taking at Social Security to improve our disability programs."

Wanted

Two suspects wanted in connection with the City's latest bank robbery. El Paso Police Detectives from the Crimes Against Persons Unit and Special Agents from the F.B.I. are investigating the City's 13th bank robbery. Just before 1:30 p.m., an unknown suspect walked into the Chase Bank located at 5209 Wren. Once inside the suspect produced a handgun and threatened the bank employees while demanding money. The suspect fled the scene with an undisclosed amount of money. The suspect is described as a Hispanic male, 19 to 23 years of age, 5'9" in height, thin build, athletic, and was last seen wearing a baseball cap, a white bandana over his face, sunglasses, grey jacket with black stripes on the sleeves, a black shirt, and black pants. The suspect is believed to have left in a 1989 or 1990's Chevrolet 1500 fullsize pickup truck, with a single cab and long bed. The truck is described as a dark blue truck, with the paint fading on the hood and the also peeling. The truck appeared to have fading purple tint and may have had Texas plates. The truck may have been driven by a second suspect described as a Hispanic male, 18 to 21 years of age, 5'7" in height and 120 pounds. No injuries were reported in the incident. Investigators need the public's assistance in finding this suspect or suspects. Anyone with any information on this case should immediately call Crime Stoppers at 566-8477(TIPS).

Enforcement of in-state dairy cattle movement rule delayed through March 31, 2008

Livestock health officials have delayed enforcement through March 31, 2008, for a new in-state movement requirement for Texas dairy breed cattle. The cattle tuberculosis regulation, adopted in September by commissioners for the Texas Animal Health Commission (TAHC), requires Texas dairy cattle to be identified prior to movement within the state. Because they are managed in close confinement, dairy animals can be at a greater risk for disease exposure if an infected animal is in the herd.

"Texas regained cattle tuberculosis (TB)-free status in 2006, and we need every tool available to assist in tracing disease, if it is introduced into the state," said TAHC's Dr. Dee Ellis, assistant state veterinarian. "Months of work can be expended tracing the movement of cattle infected or exposed to TB. Even knowing that the animal originated in Texas can assist epidemiologists in the search for the origin and spread of disease."

Dr. Ellis noted that cattle TB has been detected recently in two New Mexico dairies, a beef herd in Oklahoma, and in a rodeo bull herd in Colorado. Furthermore, eight infected herds have been found in Minnesota, and Michigan has had a long-standing battle against the disease in cattle and free-ranging deer. He stressed that new sections of Texas, TB regulations applicable to cattle entering the state went into effect October 13.

"The delayed implementation of the in-state movement regulation for Texas dairy breed cattle will provide owners adequate time to select and acquire their identification tags," said Dr. Ellis. Through March 31, the TAHC will encourage voluntary compliance. Texas dairy cattle, regardless of age or sex, are to be identified prior to in-state movement, and owners should keep a record of the cattle they identify. The tags should remain on the animal for life.

Dr. Ellis said a several types of identification are acceptable for Texas dairy breed cattle:

- USDA alphanumeric test tags (USDA silver ear tags).
- USDA alphanumeric brucellosis calfhood vaccination tags (USDA orange ear tags).
- Dairy Herd Improvement Association (DHIA) tags.
- Official breed registry tattoos or fire-brand.
- USDA approved Animal Identification Number (AIN) tags for official identification of individual animals. Three forms of official AIN tags, differentiated by the first three digits of the fifteen digit number, are available:
 - Manufacturer code "900" series RFID tags, available from many feed or supply stores;
 - USA prefix RFID tags; and
 - Country code "840" series RFID tags. (Producers who use the "840" series must

Cyber

The word doesn't mean anything by itself but as a prefix it has changed the world. Cyber Monday, Cyber Sunday, cyberlink, cyberhome, cyberpower, cyberchase, even something called cyberduck.

Hmmm.

Like I said, cyber doesn't have a meaning alone unless you use it as a noun, denoting a subculture — maybe not so much a subculture anymore as a major culture, affecting virtually every area of our lives.

Cyber, as a prefix, pretty much indicates anything involving the interaction of humans with computers. Cybernetics is the study of the replacing humans with computers and other related machinations in the performance of activities associated with living.

Welcome to the world our kids are inheriting. I don't know how well we've prepared them for it — I certainly know there are areas they aren't handling well.

It's a fact, though, that our kids are way ahead of us in using computers and related electronic gadgetry to do their dirty work for them. And I do mean dirty work.

It's called cyberbullying.

There have always been those among us who, to one degree or another, seek to prey on others weaker or with vulnerabilities, with evil intent and by utilizing whatever means is at hand. Cain used a rudimentary weapon to assault his brother Abel. The less savory among our kids are using their cell phones, instant messaging, e-mail and the internet to damage their peers.

The big difference between being bullied on the playground and being bullied on the internet, say the vic-

tims, is that you can leave the playground and go home.

Gives the name cyberpunk a whole new meaning.

It's a worldwide problem, according to Internet Safety News (ISN), sponsored by the Center for Missing and Exploited Children, one of many groups and organizations dedicated to helping parents fight an enemy they can't see or touch.

Cyberbullying involves the use of information and technology to publish defamatory personal web sites, on-line personal polling web sites and utilize other electronic media to support conscious, deliberate, repeated and hostile behavior toward others.

In 2001, a reported one in four kids had suffered some form of cyber bullying in the UK. In the good old USA, a popular site called www.schoolrumors.com was technically shut down after being flooded with 70,000 visits in only a matter of weeks. The site encouraged visitors to "click on a particular high school and post their own insults of real students using a false name."

Young girls are, of course, primary among those targeted. Parents may feel safe because their daughter is safely closeted from harm in her own bedroom. Don't bet on it.

According to a survey by Girls Scouts USA of 1,000 girls, ages 13 to 18, 30 percent said they've been approached sexually in an on-line chat room — and I don't mean innocent flirtation. I'm talking really dirty behavior from outright solicitation to sexual insults.

Of those girls, only seven percent said they told their parents and 30 percent said they didn't tell anyone.

More than 80 percent said they felt safe, though, because "what happens on-line isn't really real," and a whop-

ping 84 percent said they depended on their own common sense to decide what was safe or unsafe on the net — not a very comforting idea, looking back at how unwise I was at that age.

Recently, *Business Week* took an indepth look at the dark side of the internet, according to ISN's Anne Collier. Five BN reporters spent four months visiting seedier sites and found that "the Underground Web is bigger, broader, scarier and more damaging than most people realize."

The cyberwaves are awash with gambling, drugs, child porn and predators, money scams and identity thieves.

Though the internet has much of value to offer, navigating these enticing yet dangerous by-ways requires more than a little street-smarts, they concluded.

Like all other dangers in life, avoiding them requires making right and wise choices. Not surprisingly, researchers say the best way to deal with this sort of thing is simply get-

ting away and *staying away* from sources of cyberbullying. Just hang up. Don't respond to harassing e-mails, messages and postings. Close your account and get a new one, and be careful about who you give your address to. As for damaging web sites, notify your ISP and law enforcement.

When it comes to cyberabuse, the best way to shut it down is to shut it off. Maybe we could produce a vaccine to help our kids develop a little healthy cyberphobia.

On November 15, 2007, U.S. Attorney Johnny Sutton announced the arrest of Osvaldo Aldrete-Davila on drug smuggling charges. 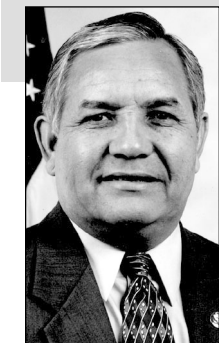

Safeguarding kids toys

Black Friday, the Friday after Thanksgiving, marks the traditional start to the annual holiday shopping season, which means many parents are braving the crowds at toy stores across El Paso to try to find just the right gift for their kids. This year, though, is complicated by several recent recalls of popular Chinese-made children's toys, many due to dangerous amounts of lead, and in one case, a date rape drug. As a parent and grandparent, I am appalled by these recalls and the dangers these toys pose to our children.

Serious questions have risen about the leadership and staffing of the Consumer Product Safety Commission (CPSC), the federal agency responsible for protecting the public from risk of injury or death from consumer products, such as the fact that there is only one inspector at CPSC charged with testing toys to make sure that they are safe for our children.

A subcommittee of the House Energy and Commerce Committee, the committee in the U.S. House of Representatives charged with oversight of the CPSC, is taking important steps forward to protect our consumers, children and adults alike. The subcommittee just recently marked up comprehensive consumer protection legislation, H.R. 4040, the Consumer Product Safety Modernization Act of 2007, which I co-sponsor and which establishes an outline for improving and reforming the nation's consumer product safety system. The bill's provisions include:

- Increased funds and staffing for the CPSC;
- A nationwide ban on products containing lead beyond specified minute amounts;
- Third-party testing and certification for children's products; and
- Mandatory tracking labels for children's products.

The Energy and Commerce Subcommittee held numerous hearings to gather input about H.R. 4040, including CPSC Commissioners, in-

dustry representatives, consumer safety advocates and health care professionals. At one hearing, a physician testified on behalf of the American Academy of Pediatrics about the dangers of ingesting lead, saying that "the Academy commends the bill's authors for establishing a single standard for lead in all children's products, rather than attempting to establish different classes of products with varying standards. It is critically important that all children's products be held to the same aggressive standards to protect children's health and assure parents that all children's products are safe."

Kids should be able to play with their favorite toys without risk of danger or disease, and parents should not have to worry about lead contamination when shopping this holiday season. The federal government has an important role to play in this, and I am proud of the steps the U.S. House has already taken. In the meantime, the CPSC is also publicizing its toll-free hotline for the latest information: 1-800-638-2772.



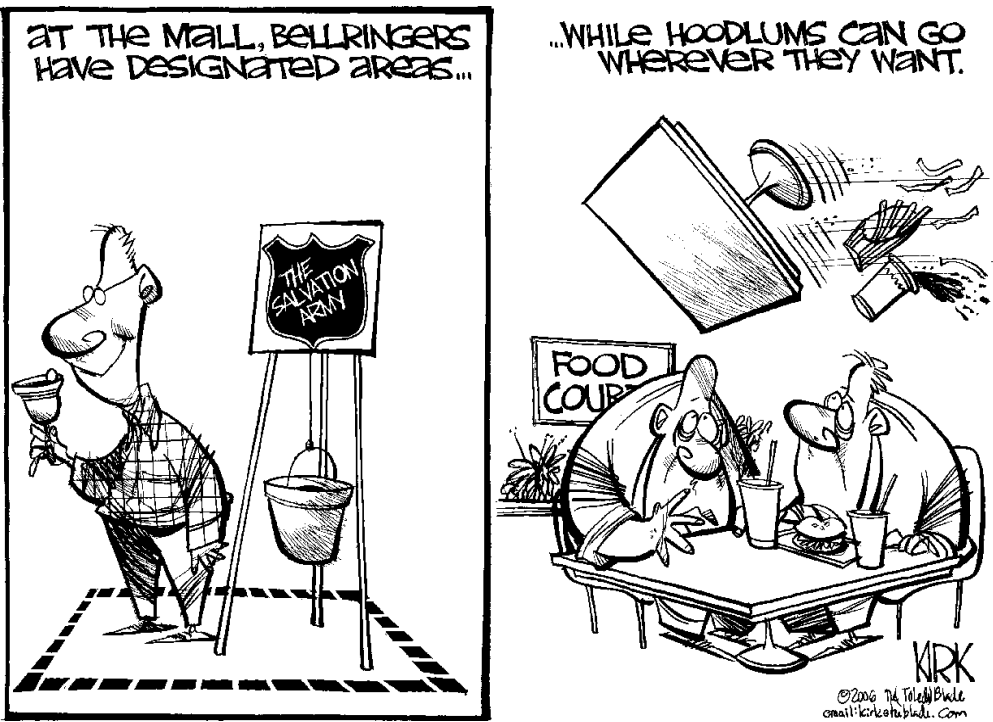

School board notes

Canutillo ISD

Dr. Pam Padilla, CISD superintendent, reported on the impact of the recent tax rate rollback election. She said the district lost \$2 million for the current school year and another \$2 million in matching funds for the next school year.

She said that, regardless of how anyone feels about it, the economic reality is that we will have to look at every possible area to save the district money.

In other action, the board approved:

Tuition waiver requests for families displaced by Storm 2006

District/Campus Improvement Plan goals and objectives

Charley Hecker to be its representative on the El Paso Central Appraisal District

District participation in El Paso Electric's Texas Schools and Cities Conserving Resource (SCORE) program

Acceptance of a \$1,500 donation from Bobby Perel for a commemorative plaque for Gonzalo Garcia baseball complex.

November 14

San Elizario ISD

(Board meeting information is provided by SEISD administrative staff.)

George Luevano, director of support services, reported on two meetings held recently regarding the proposed Pemex pipeline. "Both meetings," according to a draft of board minutes, "were attended to support opposition to on the proposed pipeline until more information is available on the proposed location and the safety of high school students."

Subsequently the board approved Superintendent Dr. Mike Quatrini drafting a resolution to disallow the pipeline in the area and move it further east. Quatrini would present the proposed resolution at the next board meeting.

The board received a check for \$10,000 from Junta Municipal Agua Sanamiento de Juarez for purchase of the unused water treatment plant. It would be dismantled and transported to interior of Mexico where it would be used by a community. The board had approved the sale at its July

meeting.

Luevano reported that the county has completed the Alexandra Flores Park monument. Dedication is planned for December.

The board approved revisions to the 2007-08 district calendar because of changes to TAKS testing by the Texas Education Agency. Last instructional day is now June 6 instead of June 5, 2008.

District and campus improvement plans were approved.

Sports achievements were reported by athletic director Bernie Del Hierro.

Coach Pete Vasquez and his tennis team were honored by the board for having won the District 2-4A championship for the second straight year.

The SEISD high school volleyball team, coached by David Desrosiers, won the District 2-4A championship.

November 20

Tornillo ISD

There was more than food for thought at the Tornillo ISD meeting. There was also a buffet of food for eating for those attending the Nov. 20 meeting.

Trustees officially approved the results of the tax rollback election in which voters approved a new property tax rate that enables TISD to give pay raises to all employees.

The board also approved a required resolution that says it didn't expect there would be a significant impact on the Tornillo school system from a proposed charter school that might be built in the area.

The board accepted the resignation of trustee Letty Trejo. Superintendent Paul Vranish pointed out that she lives in the Dallas area and hadn't attended a meeting since September of 2006. He emphasized that he isn't contesting where she is living, but rather that she hasn't attended board meetings for more than a year.

Trustees agreed to advertise for candidates to fill the position. The vacancy would be filled in January.

Vranish explained problems with the small Bronte ISD which was hurt when the Texas Youth Commission closed a correctional facility in the area. Tornillo will send an appropriate gift to the school district which lost some positions and students because of the closure.

In other action, the board gave the superintendent temporary authority to create, in effect, one-half of a position to meet certain personnel needs in security, maintenance and cafeteria areas. The board also approved pro-rated bonuses based on number of days worked. Ninety days would be the baseline number for making the determination.

Vranish explained problems with the small Bronte ISD which was hurt when the Texas Youth Commission closed a correctional facility in the area. Tornillo will send an appropriate gift to the school district which lost some positions and students because of the closure.

In other action, the board gave the superintendent temporary authority to create, in effect, one-half of a position to meet certain personnel needs in security, maintenance and cafeteria areas. The board also approved pro-rated bonuses based on number of days worked. Ninety days would be the baseline number for making the determination.

A forgettable finish

What is it about the Mike Price-led Miners? In each of the coach's four years they've started their seasons 8-1, 8-2, 4-2 and 4-2. They've finished those four seasons 0-3, 0-2, 1-5 and 0-6.

This year the Miners were surprising on offense, doing a much better job than anyone anticipated. On defense however, UTEP did exactly what it did last year — it couldn't make a tackle to save its football life.

So what does this mean for the UTEP coaching staff? I hate to say it because he's been so loyal to Mike Price and the Miners, but I don't see how they can possibly keep defensive coordinator Tim Hundley.

For the last two seasons, UTEP's defense wasn't just among the worst in C-USA, it was among the worst in the nation. Want proof? There are 119 division-1 teams in the United States. The Miners have the 117th-rated defense.

In 2006, the Miners defense was ranked 105th. Things just continue to get worse.

Last year, UTEP allowed an average of 394.9 yards per game. That is way too much. This year, the Miners allowed an unheard of 504.8 yards.

How did they win a single game? How are they going to win a game next year?

I'm afraid it's going to have to happen with a coaching personnel change or two.

Flying on most of a wing and a prayer

I saw a disturbing headline the other day: “Passengers Revolt After Being Told to Fly on Jet with its Wing Tip Missing.”

Look, people: If you’re going to fly off the handle (Ha!) about every little plane problem that crops up, maybe you should be traveling by train — or ox cart.

What happened — and this is a true story — is that the wing of a SriLankan Airlines plane ripped through the wing of a stationary British Airways 747 at London’s Heathrow Airport, slicing 5 feet off the tip off the SriLankan plane and a huge chunk off the 747, which the namby-pamby British Airlines then grounded.

The next day, passengers boarding the damaged Sri Lankan plane expressed alarm. As the story says, “When cabin crew then admitted there was still a 5-foot wing tip missing, there was a ‘minor revolt’ as seven passengers demanded to be let off the aircraft.”

I find a few interesting things about this sentence:

1) The crew “admitted” wing tip was missing. I wonder how long this took:

Crew: No, it’s all there, all right.

Passenger: Not that wing, the other one.

Crew: Looks good to me.

Passenger: The tip is missing!

Crew: Well, I think that’s a matter of opinion. Besides, it’s time for me to conduct the safety instructions. I’ll take up your concerns with the captain once we’re in the air.

Passenger 2: He’s right. The tip is missing!

Crew: OK, OK, Mr. Chicken Little here is correct. The wing tip is missing. But it’s only 5 feet or so, and the entire engine appears

to be in place. OK, let’s move on to the oxygen masks ...

2) There was a “minor revolt”? The only explanation I can imagine here is that it occurred in England. In America, people would have gone berserk.

3) “Seven passengers demanded to be let off.” So some passengers stayed on? Were they depressed? On their way to the Manly Skydivers Without Parachutes and Helmets Convention?

The story ended with a statement from SriLankan Airlines: “They [the wing tips] are purely for aerodynamics and to keep fuel costs to a minimum. There is no impact on safety at all.”

See, it’s only a question of *aerodynamics*.

Still, I think all airlines should use this incident as a lesson in keeping customers happy.

First, whenever possible airlines should fly with two complete wings, even if the aerodynamics make that totally and completely unnecessary.

Second, if in the interest of maintaining “on-time” schedules — in others words, five, six, seven hours or days behind schedule — airlines are forced to fly planes that are not completely assembled, passengers should receive free upgrades. I propose the following additions to the Travelers Bill of Rights:

One wing tip missing — Everybody, including customers in coach, gets a free bag of peanuts.

Two wing tips missing — Free bag of peanuts plus one free drink, including call brands.

Two wing tips, some windows missing — Same deal but more.

If the airline isn’t willing to do that, then get off and take the next available ox cart.

vivors benefits based on his record. Also, we might be able to pay a one-time payment of \$255 to help with funeral expenses. It sounds like you like to be prepared, so we suggest reading a copy of our online publication, How Social Security Can Help You When A Family Member Dies, at www.socialsecurity.gov/pubs/10008.html, or call us at 1-800-772-1213 (TTY 1-800-325-0778) to ask for a copy to be mailed to you.

Q: I have been getting Social Security disability benefits for many years. I'm about to hit my full retirement age. What will happen to my disability benefits?

A: When you reach “full retirement age” we will switch you from disability to retirement benefits. But you probably won’t even notice the change because your benefit amount will stay the same. It’s just that when you reach retirement age, we start thinking of you as a “retiree” and not as a disability beneficiary. To learn more, visit

Q: My 15-year-old sister has been blind since she was born. I think she should apply for Supplemental Security Income (SSI), but my parents think because she's a minor, they're responsible for her and she won't qualify. Is that right?

A: Not entirely. To qualify for SSI, you must meet certain income and resource limits. Some of your parents’ income and resources count as your sister’s in deciding whether she meets the limits. Once your sister turns 18, their income and resources won’t be considered when deciding her eligibility and payment amount. Tell your parents they can check at any Social Security office to see if your sister qualifies. For more information, visit our [website](http://www.socialsecurity.gov) at www.socialsecurity.gov.

Q: I'm on Supplemental Security Income (SSI) and live with my two

brothers in an apartment. My SSI payment is cut by one-third because the Social Security office says I don't pay enough of the household expenses. How much of the expenses must I pay in order to get the full SSI rate?

A: Under the rules of the program, you must be paying your fair share of the expenses. Because there are three of you in the household, you must pay one-third of the expenses. If you are not paying your share of the rent, utilities, groceries, and other household expenses, your SSI payment must be reduced. - The Socorro Independent School District is meeting and exceeding the standards for “highly qualified” teachers set by the No Child Left Behind Act (NCLB). In a report to SISD’s Board of Trustees this month, SISD’s human resources department reported 2,034 teachers assigned to core areas are all considered “highly qualified” under the federal standards and all SISD core subjects are being taught by “highly qualified”

teachers. A highly qualified teacher is one who:

- Has obtained a Bachelor’s degree or higher;
- Has obtained full State certification; and
- Has demonstrated competency in the core academic subject area(s) that he/she teaches.

The No Child Left Behind Act gives parents the right to know the professional qualifications of the classroom teachers who instruct their children. Parents can request the following additional information concerning their child’s teacher(s):

- Whether the teacher meets the state qualifications and licensing criteria for the grades and subjects he or she teaches; and
- The teacher’s college major, whether the teacher has any advanced degrees and the field of discipline of the certification or degree.

Parents who would like to receive this information should contact their child’s campus principal. “Our community can be proud of the hard work our teachers are doing here in Socorro,” said SISD Board President Charles. E. Garcia. “These highly qualified professionals are making a difference every day in the lives of children.”

■ Two men were arrested after a theft at an east El Paso Wal-Mart turned into a robbery on Monday, Nov. 26. At approximately 6:15 p.m., 18-year old Eleazar Melendez took several DVDs and CDs and began to remove the security devices on them and concealed them on his person.
