# San Elizario dedicates Alexandra Flores Park

The San Elizario Independent School District (ISD) and the County of El Paso officially opened the Alexandra Flores Park on April 2. The dedication ceremony was attended by more than 80 people who gathered at the new community skate park on an unusually calm spring day to mark an important event in recognition of Alexandra. Before her life was cut short in 2001 at only five years of age, Elizario ISD Board of Trustees passed a reso-

Alexandra had attended Loya Primary School, lution to secure a safe and recreational space a campus just a short distance away from where the new park named in her honor now sits on Socorro Road.

The Alexandra Flores Park is a result of a joint project sponsored by the county of El Paso and the San Elizario ISD. The district donated the land for the park while the county financed the construction of the park. County work crews broke ground for the park in early 2007. However, planning for the Alexandra Flores Park actually began in 1997 when the San

# Seven San Elizario HS band members march on to State

Despite a large competitive field of musicians as well as a highly selective panel of judges at this year's Regional UIL Solo and Ensemble Festival, seven San Elizario High School students were able to qualify for state competition by earning a 1 division rating.

The contest was held on February 23 at Americas High School and all students scoring a 1 division (superior) rating advanced to state competition to be held in Austin, Texas over the Memorial Day Weekend. Over 30 students from San Elizario High School performed competitive solo and ensemble pieces but only a few advanced to the state level, surprising Band Director Sharon Hittle.

"A lot of the kids did a great job but unfortunately, the judges were really tough. Some of the ensembles we thought were going to make it to state didn't," Hittle said. Hittle added that it was sometimes difficult to determine which students would move forward in the competition despite a good performance because the judges' mood is always unpredictable.

judges and earned their highest mark as well as a chance to compete in Austin were a trumpet trio consisting of Rocio Flores, Jonathan Covarrubias, and Alan Jacquez playing a selection entitled "Bugler's Holiday." Also, moving on to state was a trombone ensemble made up of Diana Jacquez, Albert Falcon, and Larry Campos performing short pieces by Mozart. Finally, freshman Oscar Rivera blew away the judges by playing "Berceuse" by Barat on his tenor sax.

Hittle and Assistant Band Director, Isaac Medina, helped match the best pieces to the students involved and will continue to work with them several times a week before their trip

"It means a lot to be going. It feels like we accomplished something important because we really had to work hard to go to Austin," Jacquez said.

Jacquez' trio has been practicing since January, often devoting a significant amount of time on the weekends and evenings rehearsing their song.

The current Administration has focused their efforts on the areas between ports of entry and has not provided needed resources to support efficient legal crossing at our nation's international bridges. Don't get me wrong, as a former Border Patrol agent myself, I know firsthand the need for added resources and additional agents. However, I firmly believe the border must be seen in its totality and we cannot focus on a single area. Every single mile of the Northern and Southern borders needs the proper attention in order to secure our homeland.

The PORTS Act would authorize enough Customs and Border Protection officers to fully staff all inspection booths at the ports of entry, both at the Northern and Southern borders. The bill would increase the number of officers by twenty-five percent over five years.





The new Horizon City Middle School is still without a name, mascot or colors.



Flores expressed thanks to everyone in the audience for remembering Alexandra by naming the new park after her daughter.




