Women's shelter receives makeover from Americas HS students

In the span of a couple a months, the Dame La Mano Shelter has gone through a transformation thanks to the hard work of Americas High School students. From the new paint and landscaping to the playground and fixed fence, the shelter's renovation is a result of many hours of hard work of put in by members of 11 service groups at Americas High School. Coordinated and organized by Americas seniors Louis Armendariz and Jason Shirazi, Operation Collaboration combined the manpower of more than 100 student volunteers, parents and teachers. Their efforts were greatly welcomed by shelter staff and residents.

"We don't have the funds to do repairs to the bathrooms, build a playground or plant trees. We don't get state or federal funds. This is a miracle for us. I don't have the words to express my gratitude to these students other than to thank them," said Rosa Arellano who founded the shelter to help abused women get back on their feet. "Everything they have done looks good. They also took the kids to the zoo. For many of our kids that was their first visit. They have done a lot of work. It's very emotional for me to see these kids come down here and volunteer."

"All these students' possess a strength of character and continually help others in their school, in their neighborhoods and in El Paso. Their commitment to service is an inspiration, said SISD Superintendent Dr. Sylvia P. Atkinson.

The shelter, located at 1014 S. Virginia, houses between 40 to 50 women and children at any given time. The shelter aims at helping women back on their feet by providing them with life skills such as paying bills and maintaining a home. The shelter's goal is to get women and their families back on their feet within six to nine months.

"Dame La Mano has met the needs of thousands of homeless women in crisis and their children with limited financial resources obtained mainly through internal fundraising and donations," said Armendariz. "Americas High School involved all of its community service organizations and welcomed any students who were willing to help aid the Dame La Mano Shelter."

"During one weekend, a group of more than a hundred student volunteers painted the inside and outside walls, constructed a new playground, and planted trees and flowers. We are hoping that this project will spark a desire in the hearts of students that will continue to burn as they get older," said Shirazi.

The pair first heard about the shelter through their participation with the Mayor's 100 Teens. During a community meeting, they heard about a shelter that was in need of repairs. Shirazi who was searching for a community project involving the Americas student body immediately volunteered. What followed was a collaboration of local businesses with the students to collect materials and funds. In addition, an Americas High School parent who is a contractor help the students complete their version of an extreme home makeover. The group also received support from their contacts within the Mayor's 100 Teens.

"We asked Mayor Cook's wife, Tram Cook, for help with this project. Fortunately, she had received a grant aimed at helping provided services for women. She gave us \$2,000 which



Teachers' week

This week is National Teacher Appreciation Week, a time for honoring teachers and recognizing the lasting contributions they make in our lives. The 2008 theme is "Great Teachers Make Great Public Schools." Teacher Appreciation Week is sponsored by the National Parent Teacher Association (PTA).

Last week I had the opportunity to meet Paul Cain, a mathematics and physics teacher at Ysleta High School, who was selected from 20 regional finalists in the state as the 2008 Texas Secondary Teacher of the Year. Mr. Cain has taught at Ysleta for 31 years, and has had a tremendous influence on the lives of both students and teachers. He is the second El Pasoan in as many years to achieve this distinction.

Before becoming a teacher, Mr. Cain served in the military. The Army quickly recognized Mr. Cain's talent for teaching and made him a mathematics instructor. In his first year of teaching in public schools, he was only provided with a textbook and was given no guidance on how to teach to young students. Discouraged and frustrated that he made the wrong career move, Mr. Cain quit. That summer, the school's assistant principal told Mr. Cain that he had all the makings of great teacher, and convinced him to stay.

Much like the assistant principal who saw potential in him, Mr. Cain sees the promise in each of his students. He believes that it is a teacher's job to find each student's strengths, and use them to motivate students to participate in the learning process. He is passionate about his profession and mentors newer teachers to help them develop effective teaching methods. It is easy to see why he was selected as this year's top teacher in the state of Texas.

Our community has many great teachers who go above and beyond what is expected. Teachers frequently stay after class or dedicate their lunch hour to tutoring students in need of extra help. Many serve as sponsors for school clubs and organizations, dedicating hundreds of hours each year to student activities. Teacher Appreciation Week is a wonderful opportunity for students, parents, and the community as a whole to thank teachers for their hard work.

In order to provide students with a quality education, schools must have the tools and resources to support classroom instruction. In the Democratic-led Congress, one of our top priorities is putting our children and families first by increasing investments in education

and expanding access to high-quality education for all children. Unfortunately, the President's proposed 2009 budget does not reflect this same priority, and the administration has recommended education funding remain level from the previous year. When accounting for inflation, the President's 2009 budget would actually decrease education spending.

With enrollments on the rise both nationally and in El Paso, public schools need additional funds to provide students with a quality education. As co-founder of the House Diversity and Innovation Caucus, I have pushed for legislation that would encourage underrepresented minorities to pursue educational and career opportunities in the science, technology, engineering, and mathematics fields.

The 2009 budget, recently passed by the House of Representatives, reverses the Administration's policy of under-investing in education for our children. The Democratic budget would provide new investments in key programs such as Head Start, special education, Title I, and other programs under the No Child Left Behind Act. Overall, the House budget would provide \$7.1 billion or 9 percent above the President's 2009 budget request for education and training.

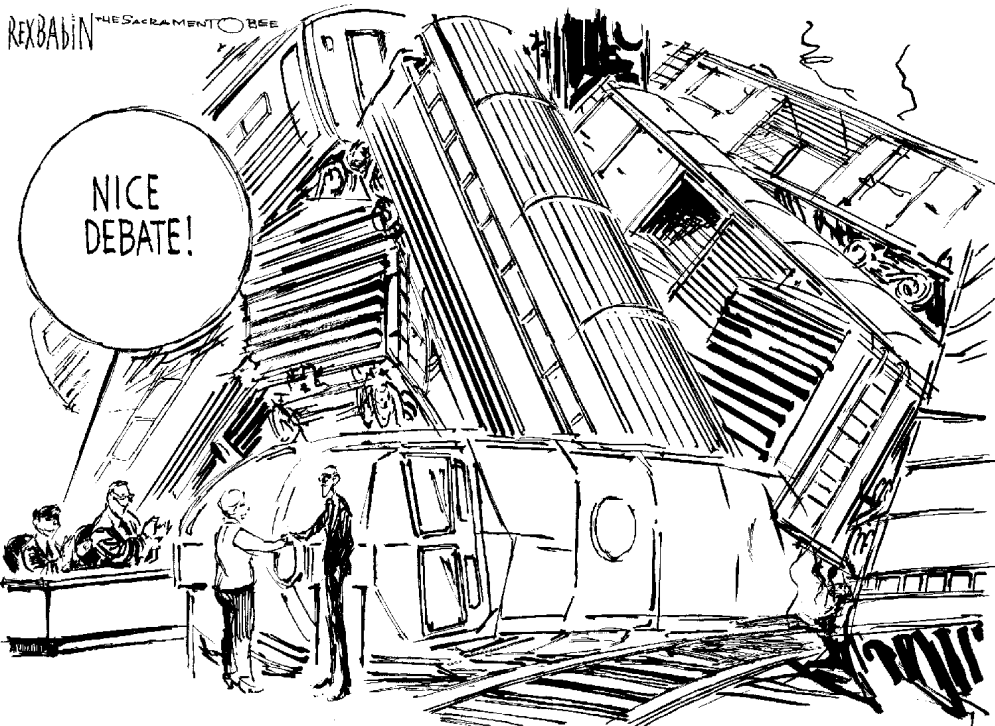
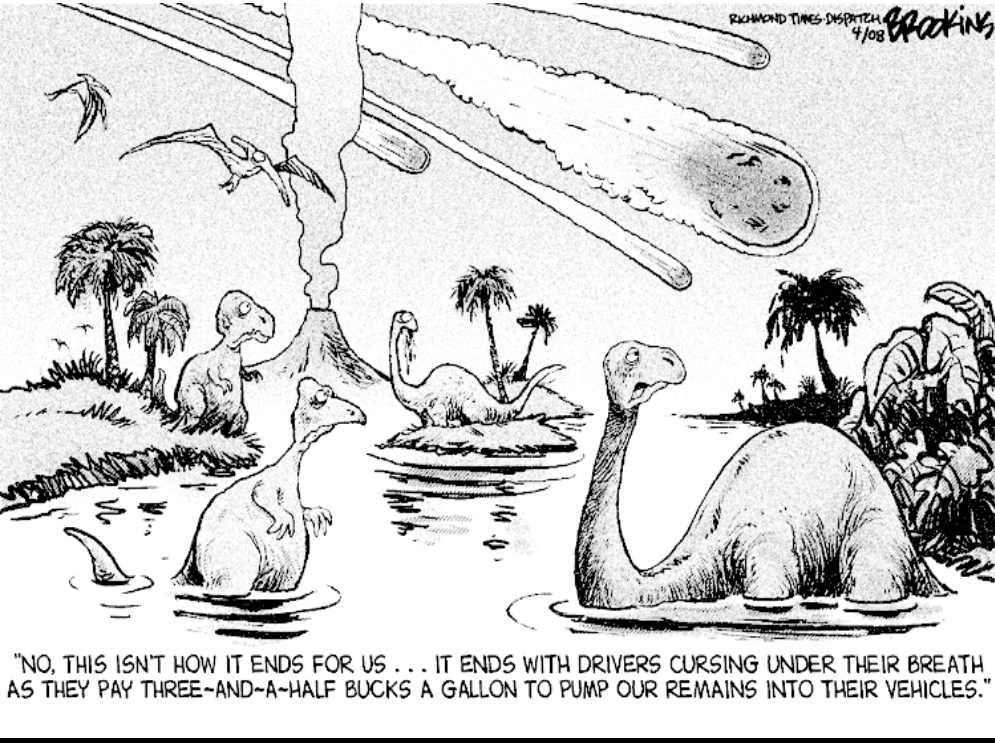

Social Security Q&A By Ray Vigil

Q: My 20-year-old daughter has a severe congenital disability. I worry about what could happen once my wife and I have passed away. Can she get disability benefits without having ever worked?

A: If a parent dies, gets disability benefits or starts receiving retirement benefits, an adult child disabled before age 22 may be eligible for benefits on the parent’s account. Though we make the disability decision using the disability rules for adults, we consider this to be a “child’s” benefit because it is paid on a parent’s Social Security earnings record. Another safety net for this type of situation is the Supplemental Security Income (SSI) program. SSI provides monthly payments to people who have little or no income and who don’t own many

things, and who are blind, disabled or 65 years or older. For more information, visit our website at www.socialsecurity.gov or call us toll-free at 1-800-772-1213 (TTY 1-800-325-0778).

Q: Is it true that a person can own a home and still be eligible for Supplemental Security Income (SSI) benefits?

A: Yes, a person who owns a home and lives in that home can be eligible for SSI benefits. Social Security does not count everything you own in deciding whether you have too many resources to qualify for SSI. For example, we usually do not count the home you live in and the land it is on, life insurance policies with a

The USDA Rural Utilities Service has received an application for financial assistance from the El Paso County Water Control and Improvement District No. 4. The proposed project consists of:

DESCRIPTION OF OWNER’S PROJECT (Water System)

WELL NO. 4:

The project for Well #4 consists of furnishing and installing equipment to pump water from Well No. 4 including pump, shaft, column piping, discharge head base, pump appurtenances and the motor for the well. The obligations under this contract shall consist of delivery, furnishing and installing the well equipment, materials, manufacturer’s shop drawings, submittals, articles, mechanical completion, training, delivery, and other appurtenances and items for complete and functional system of the Well, cement-lined ductile iron piping, controls, valves and related appurtenances; construct retention pond; construct a Concrete Masonry Unit (CMU) building to house all electrical and miscellaneous equipment, AC unit, a steel structural steel canopy, gravel driveway with header curb, furnish and install 12-inch ductile iron well collector line and connect to the existing well transmission main inside the fenced area, all associated above ground yard piping and appurtenances, trench safety system, all labor and materials necessary for an operational well site.

10th STREET BOOSTER STATION SITE:

The booster station water system improvements consists of furnishing and installing filter treatment unit including backwash, inline booster, and reclaim pumps, reclaim tank, prefabricated metal building including ventilation, lighting, architectural fascia, controls and all related appurtenances; construct retention pond; provide and install centrifugal booster pumps, valves, cement-lined ductile iron piping, meter, related appurtenances, CMU building expansion attached to existing booster station; furnish and install 0.5 MG steel reservoir, and all associated above ground yard piping and appurtenances; construct site improvements including site grading, retention pond and gravel driveway with header curb, trench safety system, and a Supervisory Control and Data Acquisition system, all labor and materials necessary for an operational site.

The work covered under this contract will be performed at Well No. 4 site located at 1220 Camp Northeast; the 10th Street Booster Station site is located at 990 Walker Ave.

DESCRIPTION OF OWNER’S PROJECT (Wastewater Treatment Plant)

The overall project will consist of the following improvements to the wastewater plant: The construction of a new 1.2 million gallons per day (mgd) pre-engineered extended aeration wastewater treatment plant located approximately 1.5 miles southeast of the intersection of State Highway 20 (Alameda) and Fabens Road adjacent to the existing wastewater treatment plant. The site is located at 17154 Alameda Avenue. The existing wastewater treatment plant will be abandon in place.

The new plant will be located adjacent and east of the existing Fabens Wastewater Treatment Plant. Work shall include, but not be limited to, all equipment and installation, complete in place, 10 feet beyond the existing limits of the existing fence, according to the plans and specifications as fol-

lows: site work, grading, and site finish work; chain link fence; controls, valves and related appurtenances; architectural fascia and noise attenuation blankets, controls and related appurtenances; plant water booster station including pumps, controls, valves, stainless steel piping and all related appurtenances, headworks system including controls, valves and all related appurtenances; extended aeration system including controls, valves, PVC piping, stainless steel piping, slide gates, blowers, silencers, filters, and all related appurtenances; belt press system including controls, sludge pump, polymer feed system, piping and all related appurtenances; chlorine disinfection system including controls, valves, chlorine equipment , stainless steel weir, jib crane and all related appurtenances; plant drain station including controls, pumps, PVC piping, and all related appurtenances; Plant water station including controls, pumps, and all related appurtenances; effluent flow meter, controls and all related appurtenances.

FINDING OF NO SIGNIFICANT IMPACT

As required by the National Environmental Policy Act, the Rural Utilities Service has assessed the potential environmental effects of the proposed project and has determined that the proposal will not have a significant effect on the human environment and for which an Environment Impact Statement will not be prepared. The basis of this determination is that the original Environmental Information Document (EID) that was conducted in January 2001 for the specific upgrades and expansions to improve the water and wastewater infrastructure within the current District boundaries has not changed. Therefore, no changes to the EID are required. A Supplemental Information Record was conducted on September 2007 to address any changes on the existing environment based on the proposed improvements. No environmental impacts were found to affect the environment receptors in the study area.

In March 2008, Brown and Caldwell, the District’s engineering firm, contracted with Geo-Marine, Inc. to conduct an archaeological survey for construction of the new wastewater treatment plant and the refitting of an existing water tank for the town of Fabens, Texas. The Texas Antiquities Permit number for the project is 4855. No historic or prehistoric cultural materials were located during the survey. Geo-Marine, Inc. also excavated backhoe trenches to sample the larger survey block in an effort to determine if any buried cultural remains were present; no subsurface cultural remains were observed. No isolated occurrences were identified during the course of the project.

extinguish the fire quickly and keep it from spreading to the rest of the building. There were no injuries to firefighters or civilians. Investigators from the Fire Marshals Office also responded to the scene, and determined that an unknown suspect or suspects entered the office building under construction and used available combustibles from the office to set the building on fire. Total damages were estimated at over \$5,000. The Fire Marshals Office is asking for the public’s assistance in apprehending whoever is responsible for setting this fire. Water politics

Over 80 community leaders joined at Holy Spirit on April 27, 2008 for an “Inform the Vote Session” around the Horizon Regional MUD Water Board Elections. The event was held by leaders in the community and sponsored by EPISO. All four of the candidates running for this important election attended the event. The discussion with the candidates focused on continued need for water and sewage infrastructure for El Paso Hills and other Horizon areas. Leaders like Victor Chavez, and El Paso Hills resident shared stories such as the following: “We don’t have sewage drainage; the ground is so hard it won’t drain so we have to have it pumped regularly, sometimes once a moth. This costs us an average of \$100 each time.” Last year, Governor Rick Perry met with colonia leaders. Perry said, what is needed is to “put pressure on the Horizon Regional MUD... for drainage and wastewater services,” (*El Paso Times*). EPISO leaders from area churches are doing walks to ensure that the community is informed and that they get out and vote on May 10.

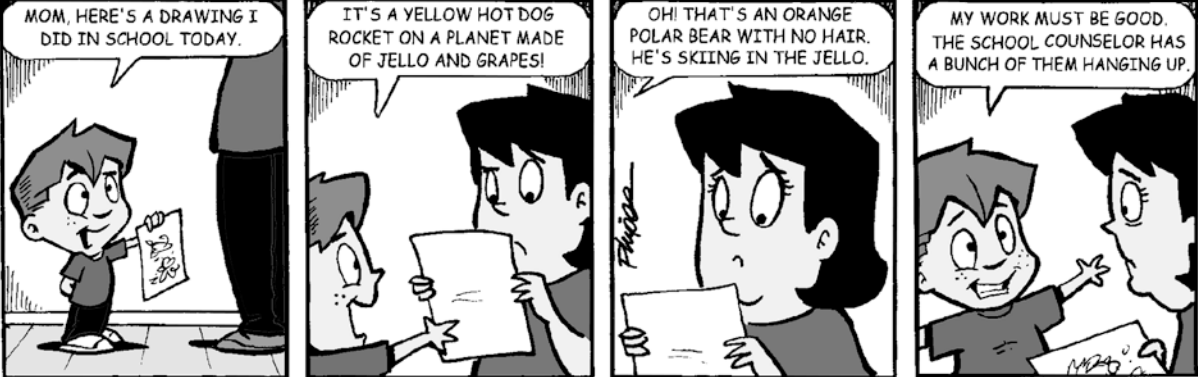

It’s not that I’m against travel. It’s just that if I’m writing about the jungles of the Amazon or the mountains of Tibet, I’d prefer doing it in a place like San Francisco, where I can enjoy good restaurants while I look up the basic information on Wikipedia.

Following a good meal, I’ll be ready for the hard work of travel writing — making stuff up. Do you know which country has the last remaining herd of unicorns? You will if you read my forthcoming travel book, though I haven’t decided yet which country I’m “visiting.”

I could even write about Katmandu — wherever that is — while staying in an American campground, as long as it had high-speed Internet access.
