Crime Stoppers of El Paso is helping the El Paso County Sheriff's Office locate an offender who entered a bar in Socorro and shot a man several times, making this the "Crime of the Week." On Wednesday, January 16 of this year, at approximately 10:40 p.m., a lone male walked into the Champs Sports Bar in the 10400 block of North Loop in Socorro, and fired several rounds at another man at the bar. The bullets struck the victim's upper body, and he was transported to Thomason Hospital. The name of the person shot and his condition has not being revealed. The suspect who fired the gun reportedly fled on foot, and entered a dark minivan, possibly blue in color. The van was last seen traveling west on North Loop. County to purchase new voting machines

Commissioners deny rate increase for county trash service

EL PASO COUNTY — On Monday Commissioners Court unanimously approved a request from the Elections Department to buy 300 new voting machines, among other equipment like computer servers and security key cards, which are necessary for the upcoming Presidential election.

Before the approval was final, the members of Commissioners Court were urged by the executive Director of Voter Education Project Inc., Paul De La Peña, to consider the acquisition of other electoral voting equipment. "These are the same machines that caused problems in 17 states during the past 2004 Presidential elecing the 2000 Presidential election cycle," he said while addressing the court.

Meanwhile, Javier Chacon, Director of the Elections Department explained to the court that although the use of existing electronic voting machines in El Paso County has been in place since 1999, there has never been a problem and "the system has worked fine in the county and the rest of Texas."

Chacon added that the Secretary of the State has a really strong hold about the equipment used in the electoral process, and that "everything has to be approved before the county can consider buying it," he stated. With the pur-

chase of these new machines, the Elections Department will have 1,335 voting machines in place for the November election.

The Elections Department predicts at least 375,000 registered voters will participate in the upcoming presidential electoral process. The estimated cost of the new equipment is \$445,000 dollars.

Many scams, scammers still posing as IRS

WASHINGTON — The Internal Revenue Service cautions taxpayers to be on the lookout for a new wave of scams using the IRS name in identity theft e-mails, or phishing, that have circulated during the last two months

In May and June alone, taxpayers reported almost 700 separate phishing incidents to the IRS. In 2008 so far, taxpayers have reported about 1,600 phishing incidents to the IRS.

"Taxpayers should take steps to keep their personal information out of the hands of identity thieves," said IRS Commissioner Doug Shulman. "That includes not falling for any of the phony e-mails or faxes now in circulation pretending to come from the IRS."

The most common scams involve tax refunds and, this year, economic stimulus payments.

Although most of these scams consist of e-mails requesting detailed personal information, the IRS generally does not send emails to taxpayers, does not discuss tax account matters with taxpayers in e-mails, and does not request security-related personal information, such as PIN numbers, from taxpayers.

Refund e-mail

There are several variations of the refund scam, in which an e-mail claiming to come from the IRS falsely informs the recipient that he or she is eligible for a tax refund for a specific amount. The bogus e-mail instructs the recipient to click on a link to access a refund claim form. The form requests personal information that the scammers can use to access the e-mail recipient's bank or credit card account.

This notification is phony. The IRS does not send unsolicited e-mail about tax account matters to taxpayers.

Filing a tax return is the only way to apply for a tax refund; there is no separate application form. Taxpayers who wish to find out if they are due a refund from their last annual tax return filing may use the "Where's My Refund?" interactive application on the IRS Web site at IRS.gov, the only official IRS Web site.

Heavy rains bring water hazards

Emergency officials urge caution around moving water

Perhaps the biggest cause of flood-related deaths and injuries is the lack of respect for the severity and danger associated with floods and flash floods. El Paso Fire Department officials are reminding residents not to make some of the common mistakes that result in injury or death during flooding caused by the recent heavy rains.

Many people are killed while trying to drive or walk on roads and bridges covered by water. Though the water may look only inches deep, the pool could be far deeper and have very strong currents. It only takes two feet of water to carry away many cars and only six inches of swiftly moving (6 mph) water can sweep a person off their feet.

Trucks, two wheel- as well as four-wheeldrive and sports utility vehicles, are also susceptible to the dangers of pooled water. Such vehicles often give motorists a false sense of security, believing the vehicles are safe under all hazardous conditions. This is simply not true. For instance, large tires add to the Westside and northeast fire stations as priorities.

vehicle's buoyancy and can cause it to lose traction sooner. Simply put, do not allow overconfidence in your vehicle to cost you your life.

Consequently, if you are approaching a flooded roadway, turn around and take an alternate route. Though vehicles in front of you may have passed through the high water, you may not be as lucky.

If your car stalls, abandon it immediately and climb to higher ground. Many deaths have resulted from attempts to move stalled vehicles.

Never let children play near storm drains when the water is rising or is high. Every year, deaths or injuries occur as a result of people being swept away. Sadly, the most frequent victims are children.

If you live in a low-lying area, pay close attention to water levels during heavy rain events. Water levels rise rapidly during flash floods often surprising victims. Be prepared to move quickly to higher ground if water levels begin rising. Sandbags are available at all city fire stations and are free to the public. The personnel at the Storm Water Utilities are in the process of delivering double the normal order of sandbags to all fire stations in the city with

Economic stimulus

In this scam, a taxpayer receives an e-mail pretending to come from the IRS which tells the recipient he or she is eligible for an economic stimulus payment. The message recommends direct deposit into the taxpayer's checking or savings account. To receive the payment, recipients must click on a link to complete and submit an online form by a certain date; otherwise, the e-mail warns, payment may be delayed. The form requests personal and financial data, including checking or savings account numbers that the scammers can use to gain access to the accounts.

Representatives passed the Homes for Heroes Act (H.R. 3329), a bill that would expand housing assistance and supportive services for homeless veterans. It is unacceptable that hundreds of thousands of the brave men and women who have served in our nation's armed forces have no place to call home. The Department of Veterans Affairs (DVA) estimates that more than 400,000 veterans will experience homelessness at some point during the year, while nearly 200,000 veterans are home-

less on any given night. Avoiding Britain's example

This kind of penny-pinching happens all too often in Britain, thanks to the National Institute for Health and Clinical Effectiveness (NICE), the agency that determines which treatments get covered by the British healthcare system.

If some congressional lawmakers get their way, the United States soon will have a similar agency. And it too will deny vital treatment options.

The U.S. Senate is currently considering legislation to create a Comparative Effectiveness Research Institute under Medicare. Like NICE, the new agency would conduct studies on the relative effectiveness of various medical treatments, analyzing how different options stack up against one another.

In theory, this research could provide doctors with more complete information when deciding which treatment to recommend. But in practice, the agency's findings would likely be used by Congress to lower the government's healthcare spending. By generating studies that show that older, cheaper drugs are just as effective as newer cures, cost-conscious lawmakers could rationalize not covering expensive cutting-edge medicines under Medicare, Medicaid, and other publicly-funded programs.

Sound far-fetched? This is precisely what happens time and again in the U.K.

Earlier this year, for example, NICE failed to approve the arthritis drug abatacept. Even though it is one of the only drugs clinically proven to improve severe rheumatoid arthritis, NICE decided that "abatacept would not be a cost-effective use of NHS [National Health Service] resources."

> Comparative effectiveness research is so easily misused because it looks only at the "average" patient. By focusing on which drugs, on average, are cheapest and most effective, comparative effectiveness research can overlook important factors like age, race, gender, and lifestyle.

> So even though a patient's doctor might decide that a drug like Tarceva is the best treatment given the particular needs of his patient, the government could refuse to cover the drug simply because it isn't cost-effective for the "average" patient.


> It's exactly these kinds of tactics that Britain's Court of Appeal recently judged to be "procedurally unfair" when ruling on NICE's decision to deny Alzheimer's patients access to several anti-dementia drugs.

> The legislation currently under consideration in Congress could help American doctors and patients make informed healthcare decisions. Toward that end, it's crucial that any American agency conducting comparative effectiveness research consider what's best for individual patients instead of looking for cheap, one-size-fits-all cures.

> The agency should also be free from political influence. Just as importantly, its recommendations should be nonbinding. In other words, the research should be used to empower doctors and patients — not politicians, bureaucrats, and budget analysts.

> Otherwise, the poor, the elderly, and others receiving government medical care would be subjected to the same kind of treatment we've seen in the U.K.

Officials stop illegal border crossers at rate of almost one per hour for seven days

EL PASO COUNTY — U.S. Customs and Border Protection (CBP) officers performing anti-terror exams at ports of entry in El Paso, West Texas and New Mexico were kept busy from July 3-9 with dozens of immigration violations, drug seizures

and agriculture violations.

Area CBP officers recorded 161 immigration violations at area ports, an average of 23 per day. CBP officers working at El Paso area ports of entry typically record between 100-125 such violations weekly.

Intended immigrants made up the largest group of immigration violators. A total of 87 were identified through thorough document exams. In these cases, individuals will use a legally issued border-crossing card (laser visa) to live or work in the U.S., which is not authorized. CBP officers this week also identified 49 imposters. Imposters generally will use a legitimate entry document assigned to another person and present it as their own. Violators generally lose their documents and are returned

to Mexico. CBP officers also recorded 25 cases of people making false claims to U.S. citizenship, people attempting to enter with counterfeit or altered documents, and people attempting to enter without inspection.

CBP officers working at area ports recorded a total of 16 agriculture violations this week, resulting in \$3,800 in penalties being assessed. Prohibited agricultural items seized this week included pork, pork skins, bologna, raw chicken, mangoes, avocados, pears, apples, grapefruit, oranges, pomegranates, guavas and live





to avoid penalties and to help reduce the potential for the introduction of harmful pests and disease. Failure to declare prohibited items can result in a \$300 penalty for an initial offense. If properly declared, prohibited food items can generally be abandoned at the port of entry without consequence.

In addition to the agriculture and immigration violations, CBP officers working at El Paso area ports made 22 drug seizures. CBP officers confiscated 2,180 pounds of marijuana in those busts.

CBP officers this week also confiscated prohibited medications, a live bird, prohibited fireworks, and assessed \$7,500 in penalties in association with 14 export violations. While anti-terrorism is the primary mission of U.S. Customs and Border Protection, the inspection process at the ports of entry associated with this mission results in impressive numbers of enforcement actions in all categories.

public receive their economic stimulus payment is to file a tax return with the IRS, not a special form. Additionally, the IRS does not request personal or financial information via e-mail.

Information on how to obtain an economic (sic)" and appears to be signed by an IRS em-

stimulus payment may be found in the Economic Stimulus Payment Information Center on the IRS Web site (www.irs.gov). For more information on stimulus-related scams, see IR-2008-11.

Substitute 1040 fax

This scam consists of a cover letter and form that are faxed, rather than e-mailed. The cover letter is addressed "Dear Valued Tax Payer

ployee. The letter says that the IRS is updating clicking on any links in the e-mail and to its files and that recipients who supply the requested information will receive a nominal tax refund. It also states that those who fail to immediately return the completed form risk additional tax and withholding. The attached form is labeled a substitute Form 1040 and is titled "Certificate of Current Status of Beneficial Owner For United States Tax Recertification & Withholding." It requests a large amount of detailed personal and financial information, such as mother's maiden name (often used in security screening), bank account numbers, estimated assets and more. It asks the recipient to sign and fax back the completed form, as well as a copy of the recipient's driver's license and passport.

The letter, signature and form are all fraudulent. Moreover, the IRS does not send unsolicited faxes to taxpayers and does not request such detailed personal and financial information.

This is a variant of earlier scams. For more information, see news releases IR-2004-104 and IR-2004-75.

Company report

This e-mail appears to come from an IRS.gov e-mail address, addresses recipients by name and references the company the recipient works for. These personalized details may convince the recipient that the email is legitimate. The e-mail says that the IRS has a report on the company and asks the recipient to review a copy by clicking on a link to download the report. However, when the link is clicked, malware is downloaded to the recipient's computer.

There are various types of malware, which can hijack a victim's computer hard drive to give someone remote access to the computer, search for passwords and other information and send them to the scammer, or cause other types of identity theft or damage.

The IRS does not compile reports on companies or send e-mails to company staff asking them to review a report. Generally, the IRS does not send unsolicited e-mails to taxpayers.

Tax court

In this scam, an e-mail that appears to come from the U.S. Tax Court contains a petition involving a court case between the IRS and the recipient. The document instructs the recipient to download other files. The downloads transfer malware, or malicious code, to the recipient's computer.

There are various types of malware, which, for example, can hijack a victim's computer hard drive to give someone remote access to the computer, or can search for passwords and other information and send them to the scammer.

The truth is that the Tax Court is not emailing notices to anyone who currently has a case before the court. Visit the court's Web site at http://www.ustaxcourt.gov/ for more information. Recipients are advised to avoid delete the e-mail.

How scams work

To lure their victims, phishing scams use the name of a known institution, such as the IRS, to either offer a reward for taking a simple action, such as providing information, or threaten or imply an unpleasant consequence, such as losing a refund, for failing to take the requested

The goal of the scams is to trick people into revealing personal and financial information, such as Social Security, bank account or credit card numbers, which the scammers can use to commit identity theft.

Typically, identity thieves use a victim's personal and financial data to empty the victim's financial accounts, run up charges on the victim's existing credit cards, apply for new loans, credit cards, services or benefits in the victim's name, file fraudulent tax returns or even commit crimes. Most of these fraudulent activities can be committed electronically from a remote location, including overseas. Committing these activities in cyberspace allows scammers to act quickly and cover their tracks before the victim becomes aware of the theft.

People whose identities have been stolen can spend months or years — and their hard-earned money — cleaning up the mess thieves have made of their reputations and credit records. In the meantime, victims may lose job opportunities or may be refused loans, education, housing or cars.

What to do

Anyone wishing to access the IRS Web site should type www.irs.gov into their Internet address window, rather than clicking on a link in an e-mail or opening an attachment, either of which may download malicious code or send the recipient to a phony Web site.

Those who have received a questionable email claiming to come from the IRS may forward it to the following address: phishing@irs.gov. Use the instructions contained in an article on IRS.gov titled "How to Protect Yourself from Suspicious E-Mails or Phishing Schemes." Following the instructions will help the IRS track the suspicious e-mail to its origins and shut down the scam. Find the article by visiting IRS.gov and entering the words "suspicious e-mails" into the search box in the upper right corner of the front page.

Those who have received a questionable telephone call that claims to come from the IRS may also use the phishing@irs.gov mailbox to notify the IRS.

The IRS has issued previous warnings on scams that use the IRS name to lend the scam legitimacy. More information on identity theft, phishing and telephone scams using the IRS name, logo or spoofed (copied) Web site is available on the IRS Web site at IRS.gov. Enter the terms "phishing," "identity theft" or "email scams" into the search box in the upper right corner of the front page.
