This year, NWZAW will be observed April 6-10, 2009 and will commemorate the 10th anniversary of the campaign.

Work zones can be hazardous for motorists as well as highway crews working to improve Texas' highways. TxDOT maintains approximately 80,000 miles of highway with more than 1,000 construction or maintenance projects underway at any given time. With so much construction, it is all too common for motorists to encounter work zones.

# Socorro ISD named one of America's top urban districts

SISD is finalist for \$2 Million Broad Prize

EL PASO COUNTY — Socorro Independent School District (SISD) is one of five urban school districts nationwide selected as a finalist for the 2009 Broad Prize for Urban Education, The Eli and Edythe Broad Foundation announced today.

The Broad (rhymes with "road") Prize for Urban Education is an annual \$2 million award that honors the urban school districts that demonstrate the greatest overall performance and improvement in student achievement while

reducing achievement gaps among ethnic groups and between low- and non-low-income students.

This is the first year that SISD has been a finalist for the award, which was won last year by another Texas border district, the Brownsville Independent School District.

The winner of The Broad Prize, to be announced on Wednesday, Sept. 16 in Washington, D.C., will receive \$1 million in scholarships for high school seniors who will graduate in 2010. The four finalist districts will each receive \$250,000 in scholarships.

# The onus of the bonus

> But even worse than the fact that the bonuses were paid is why. Every year, Congress is given millions to cover office expenses. What they do not spend gets returned. Ergo, many in Congress are doling out the excessive bonuses to avoid having to return the unspent cash.

> The bonuses caused the average staffer's salary to increase by 17% in the final quarter of 2008. Ironically, that number roughly equals the median Congressional approval rating during that same period.

> If AIG executives were denounced for receiving contractual bonuses after taking government funds, should not Congress be held to the same if not a higher — standard? The situation appears even worse when considering that AIG took "only" \$173 billion in taxpayer funds, whereas Congress has appropriated trillions in bailouts and stimuli. If Congress were a corporation, they would have filed for bankruptcy decades ago. And all of their executives would have been fired.

> The mere fact that the extravagant members of Congress are willing to do anything rather than return the office budget speaks volumes as to


have it, they raise taxes. If they have it, they spend it. And if they don't need it, they find something to spend it on anyway. One must wonder — if there was no extra cash remaining in the office budget, would so many members of Congress be waxing eloquent on how their staffers deserved the bonuses? Or are they only seeking yet another excuse to justify their compulsive spending?

Sadly, staffers aren't the only ones getting congressionally-approved bonuses. Last year, the Postmaster General received \$134,000 as a performance bonus. That's despite the fact that the USPS lost \$2.8 billion that year — and is projected to lose over twice that amount this year according to FOX News.

Congress, of course, has no one to blame but itself. They may think they are fooling the American people as they tried to do with AIG by approving bonuses — before doing an about-face and denouncing them. But, in the end, however, as more of these cases come to light, their duplicity will be uncovered.

When that happens, however, its doubtful that Congress will react with horror to its own hypocrisy and slap a 90 percent tax on its own earnings. If only. Perhaps then they would actually break the elusive 20 percent in their own approval ratings.

# Making the grade

old enough to remember, taking a bad report card home engendered a great deal of fear and trepidation, during what seemed an endless walk or school bus ride home. Perhaps that is the way hospital CEOs currently look at the issue of transparency and public disclosure, as they closely guard their respective institutions' financial and clinical secrets, and damn or withhold any revelation destined to transform stockholders into what amounts to angry parents.

Healthcare consumers, the U.S. federal government, and third-party payers, however, demand the highest standard of care from our nation's hospitals, as well as reliable performance measures to assure quality. Furthermore, such measures must be applicable to all hospitals, whether they reside in the high-tier or low-tier category. There is much evidence to support the contention that hospital report cards, based on objective performance measures, improve the overall healthcare of patients.

The Hospital Quality Alliance (HQA), based on provisions in the Medicare Prescription Drug, Improvement and Modernization Act (MMA) of 2003 and instituted by the U.S. Department of Health and Human Services (HHS), was, indeed, initiated

For those of us who are baby-boomers and precisely to that end. By collecting data on key measures of hospitals' management and quality of care (for example, the care provided, the resources consumed, the total costs of care, and the resulting outcomes), the HQA can tabulate report cards to motivate change and hopefully improve overall patient healthcare. Also, the recently proposed Deficit Reduction Act (DRA) of 2005, by instituting financial incentives to entice our nation's hospitals to imake the gradeî by adhering to established measures of performance, and expanding them when necessary, serves as an additional built-in safeguard to our nation's health.

> High performance scores on HQA performance indicators have been associated with up to 15 percent reductions in the odds of death for common clinical conditions such as acute myocardial infarction, congestive heart failure, and pneumonia. So, the initial results are in, and perhaps only a bit of tweaking and several more performance indicators are required before hospital report cards become a diffuse functioning reality.

That's the only explanation I can come up with.

For those of you who've claimed either verbally or in writing that you earned medals when you really didn't, send me an e-mail and tell me why you did it. I'm curious, I really am. I want to know what makes a United States military veteran lie.

Tell me, too, if you're going to get square with family and friends before you end up in a cemetery with bogus information on your headstone for all eternity.

I'll do another column later, without names, with a summary of the answers — assuming that anyone is willing to respond.

## **Crime Stoppers**

Crime Stoppers of El Paso is assisting officers from the Police Department's Central Region in identifying suspects who injured a victim in a drive-by shooting that took place in front of a downtown night club, making this the "Crime of the Week." Early Saturday morning, March 28, about 1:00 a.m., the victim was standing outside Club 69 at 524 W. San Francisco Street in the Union Plaza district when he heard gunshots from a passing vehicle. The victim immediately attempted to shield a female standing nearby and, as a result, he suffered the loss of a kidney and a puncture wound to his liver. A recently returned Iraqi war veteran, and an innocent bystander, the victim is in serious but stable condition at a local hospital. Detectives investigating the offense have determined that the vehicle was possibly a black or dark gray newer model Cadillac CTS or Deville. One witness gave a partial out-ofstate license plate of XJ-3554. The suspects are believed to be possibly three black males. The shooter was described as a lightskinned African American. After the shooting, the vehicle fled west on San Antonio and then continued heading west on Paisano. 
### **Wanted**

I remember listening a couple of years ago to a National Public Radio interview of a Haitian mother who explained to a reporter about the extreme unsanitary conditions she and her children were living in.

Rather than having a clean yard to play in, her children had to avoid sewage around their home and neighborhood.

She said to the reporter something like, "Could you live in a place like this?"

I don't remember the whole interview; it had a lot to do with political unrest. What I remember connecting on with her was the concern for her children's future more immediately, their physical

It didn't surprise me that for a in? couple of days after that I kept having the image in my head of wading through sewage while carrying my kids on my shoulders so they wouldn't be affected by the refuse.

But the sewage I was wading through wasn't the stuff that in our country we have the luxury of flushing, it was the crud we invite into our homes via our televisions and radios

I'm guilty of this. Sometimes when the kids aren't around, I'm not really on guard as far as the television content is concerned. I'm a grown-up, after all, I'm not a prude, what harm can be done?

Except that one night I noticed that the characters on a couple of the sitcoms I flipped through were going through bed partners as

quickly as someone would a box of tissue. Then, not a few minutes later, a commercial aired for a genital herpes medication. Appropriate marketing, I thought.

Cleaning up the sewage starts with me — the parent.

I can be stunned by the pop-culture content, and I can gripe along with other parents about what our kids are faced with on a daily basis, but nothing gets done if I only examine the junk that's lying around. I have to start removing it from my own life.

The Haitian mother I listened to will have to move to get away from her unsanitary living conditions. Every day they have to smell it and walk around it.

We can't smell our cultural sewage, but if we open our eyes and ears we can certainly see and hear it — if we are willing to. We know this stuff isn't good for us and our families. So why do we invite it

I think it's because we create an appetite for it, and in doing so we become complacent (after all, it's just a show).

We have a lot of excuses for keeping our crud, don't we?

Unlike the Haitian mother, I don't have to move. They only effort I have to make is moving my fingers to change a channel or hit an "off" button.

Let's not ever get to a place in our society or our homes where we have to ask, "Could you live in a place like this?"



There is an exception to the Government Pension Offset which states that if on the last 5 years (which must be continuous) of your career with Texas Retirement System, you work for a district that pays into both Social Security and Texas Retirement System, your social security benefits would not be subject to an offset. 


