Crime Stoppers

A robbery victim died from his injuries. Now Crime Stoppers and the El Paso Police Department are asking for help from the public in locating the suspects involved, making this the "Crime of the Week." On Monday, June 9, 2008, approximately 8:30 p.m., officers from the Mission Valley Regional Command Center responded to 7100 Stiles on an aggravated robbery. Three victims were assaulted after refusing demands for money. At the time, 43-year-old Javier Vallejo suffered head injuries but refused medical treatment. Tragically, he died from his injuries three days later. The suspect who brandished a handgun is described as a Hispanic male with a medium build, wearing a ski mask, who spoke English and Spanish. His accomplice was a Hispanic male, medium build, with very short hair. They were last seen fleeing the scene in a dark-colored, full-sized SUV, possibly a Ford Expedition, with tinted windows and a beige or tan colored stripe across the middle. The SUV was driven by a third, unknown suspect. If you have any information at all about this

Clint ISD Pre-K program receives \$500,000

The Clint Independent School District (ISD) has been awarded over \$500,000 for the

Prekindergarten Early Start Grant Program to enhance and expand the District's program. Clint ISD is one of only two Districts in the county to receive the grant from the Texas Education Agency. The purpose of this grant is to prepare students to enter kindergarten on or

above grade level. The goal of the grant program is to provide high-quality services supported by community partnerships and local resources to help children reach their full potential.

Clint ISD has offered the community a universal prekindergarten program since 2004. This means, any four year old living in the District can attend pre-kindergarten at no charge. The District chose to implement a universal prekindergarten based on research which shows that students who grow up in poverty have a limited vocabulary as compared to their middle class peers and therefore enter kindergarten at a disadvantage. 85% of the District's 11,500 students are economically disadvantaged. The District currently serves 670 students in prekindergarten at five campuses.

"Our mission is to make sure all of our students reach their full potential and are prepared to enter college after graduation. This preparation should begin in the earliest stages of childhood," says Dr. Edward Gabaldon, Superintendent.

Clint ISD collaborated with Education Service Center for Region 19 Head Start teachers, as well as with District pre-kindergarten and kindergarten

Ways to help veterans

If you're in a veterans service organization or are someone who wants to help veterans, this is a good time to start planning your efforts for this winter and next year.

Stand Downs (www.va.gov and put Stand Down in the search box), the Moving Wall (www.themovingwall.org) and donating to groups that let veterans go on adventures free of cost are all good places to direct your energies.

Contact the volunteer group at the closest Department of Veterans Affairs medical center, and block out one day a month to go and assist. Get its annual calendar and sign up to help at some of the bigger events, such as root beer float parties, barbecues and field trips.

Host a Christmas party for a whole unit at the closest VA medical center, complete with presents (maybe a big television for the day room) and pizza (with staff permission) and drinks. Call the volunteer department in advance to see what is needed.

If you're near a shelter where a large number of homeless veterans

are helped, think about serving daily meals, handing out clothing and pulling shifts at the facility.

Sign up to drive veterans to distant medical centers for their care. This door-to-door chauffeuring (and then back home again) can be invaluable to veterans who are unable to drive.

If you're an attorney who does pro bono work to help veterans with their claims, commit to helping an additional veteran each month.

If you're in college, see about tutoring a veteran who's just now going back to school.

If you want to make a cash donation to an organization, be sure to check www.charitywatch.org to verify that your dollars will go to veterans, not to a money machine that spends most of the donations on itself and "admin" costs.

TABC there to help

Hola, mi gente. Most of you who are reading this column have consumed some sort of alcoholic beverage. Some prefer beer while others prefer wine or liquor. All of these beverages are regulated by the Texas Alcoholic Beverage Commission (TABC).

Before an establishment can sell or serve any type of alcoholic beverage, it must submit an application for a license to sell, distribute or serve it. The agency completely vets any applicant to make sure that no criminals are allowed to be involved in the sale of alcohol. The process can be tedious at times but in the long run the best applicants eventually receive the license.

Since I am a member of the Licensing and Administrative Procedures Committee, many El Pasoans seek information or assistance from my office concerning their applications with TABC. The first thing that we inform them is that we have no authority over the agency but that the staffers at TABC are more than willing to discuss with us any issues regarding pending or existing licenses.

In most cases, we are able to inform the applicants why their licenses are not issued. After that problem is resolved, many of the locations receive their licenses shortly thereafter.

The issuance of licenses is just part of their job. TABC is also responsible for the public well being and safety. By this I mean the agency must make sure that licensees are all abiding by current liquor statutes. The most obvious statute is the sale of alcohol to minors. There have been news reports about businesses being penalized or even shut down because of the sale to minors. No one wants to see people lose their livelihoods but that is preferable to having minors gain unlawful access to alcohol.

Perhaps the most important responsibility that TABC has is to make sure that license owners operate in the public interest. By that I mean being a good community business that does not adversely affect the neighborhood. Rowdy bars or bars that have been proven to be a drug haven eventually are closed.

In a recent meeting with the chief of enforcement at TABC, I became aware that the agency is striving to assist businesses to be good law abiding neighbors. Previously, it was ap-

parent that the enforcement officers were more intent on playing gotcha than assisting clubs, restaurant bars or liquor stores in good business practices.

My office has worked both sides of that equation. We have helped neighbors close down a bar that completely disregarded the residents rights to peace. The process to close the bar was somewhat slow but eventually justice was done. During the last legislative session, I filed a bill that could have helped resolve conflicts between residents and poorly managed bars much more quickly (our senate sponsor failed to follow through).

TABC will continue to enforce the laws but will now have a new focus on helping liquor license owners be in compliance. Through this, the state will generate more tax revenues; and at the same time residents can feel confident that liquor businesses that are bad neighbors will be held accountable.

We worked with the city of El Paso on some issues during the last session; I anticipate a meeting very soon between the city, TABC and my office.

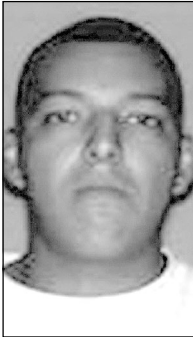

Wanted

The hunt is on for Christian Avalos. This week's individual sought for his involvement in a stabbing that took place at a house party in San Elizario, TX earlier this month. Avalos, 18, is 5'9" tall with a medium build. He has black hair and brown eyes. On October 4, 2009 at about 1:30 a.m., Sheriff's Deputies were dispatched to a residence in the area of Gaucho Rd. in San Elizario, TX in reference to a stab-

bing. Deputies arrived and found a 25 year old male victim who told officers he had been stabbed multiple times while attending a party at a residence on Gaucho Rd. The victim, who will not be identified, survived the attack. Through the course of the investigation, Crimes Against Persons Detectives learned that there were four suspects — all from San Elizario — involved in the stabbing. Last Tuesday, October 13, 2009, CID Detectives arrested two of the men

suspect identified as Moises Soria (23) turned himself in to authorities. He was also charged and booked with Engaging in Organized Criminal Activity/Aggravated Assault Deadly Weapon. One suspect remains at large, he is identified as 18 year-old Avalos of San Elizario. Avalos knows he is wanted and is believed to remain in the area hiding from Law Enforcement. Avalos is also known to work in construction.

Dear Editor:
The "Cash for Clunkers" program for new cars may have ended, but the IRS wants to remind taxpayers that many people might overlook another special break available. If you buy a new vehicle this year, there's a special federal tax deduction available that can help you save money, in some cases hundreds of dollars. This tax break will allow people who buy a new vehicle in 2009 to deduct the sales and excise taxes they pay when

they file their tax return next year. The tax deduction is available on the 2009 federal tax return even for those who claim the standard deduction.

The deduction is part of the American Recovery and Reinvestment Act of 2009 and applies to taxes paid on up to \$49,500 of the purchase price for qualified new cars, light trucks, motorcycles or motor homes. Generally, vehicles weighing 8,500 pounds or less qualify. This means that most new cars and many new

trucks will qualify. New motor homes qualify regardless of weight.

Buyers are entitled to a partial deduction if they earn between \$125,000 and \$135,000 (\$250,000 and \$260,000 for joint filers). The deduction is eliminated for those who earn over these amounts.

To qualify the vehicle must be new and purchased in 2009 after Feb. 16 and no later than Dec. 31. There is still time left but the clock is ticking.

Into the abyss

With gold topping a whopping \$1049 an ounce this week, and the Independent reporting that the Saudi Arabia, Abu Dhabi, Kuwait, Qatar, Japan, France, Brazil, Russia, and China may all planning to stop trading oil in dollars, some are wondering what has changed to bring King Dollar to its knees.

The answer is unsettling: nothing. Nothing has changed — particularly in the nation’s monetary expansion, which has more than doubled from a year ago. Nothing has changed, either, on the fiscal side of the equation, with the national debt expected pile on another \$14.025 trillion between 2010-2019, practically 100 percent of the Gross Domestic Product.

What’s worse is that the nation appears poised to shut itself down economically — with a ludicrous, ruinous tax on energy, oil, gasoline, natural gas, and coal. And to spend itself into the grave — with “health care for all” and an expansive entitlement regime extended far beyond the nation’s means to sustain itself.

Throw on bad debt, waves of foreclosures, and ever increasing unemployment (U-6 came in at 17 percent for September), and one starts to get the picture. The dollar is only as good as the economy, the nation’s ability to produce, and importantly, our collective ability to pay back our debts.

Only problem is: it now appears that it will never happen. The national debt has grown every single year since 1958. And it will equal the entire GDP some time in 2010. Call it a tipping point. Call it decline. Call it whatever

one wants. But it is a crisis of epic proportions.

Unfortunately, the nation’s leaders are either oblivious or in which case they are fools. They are powerless — and cannot even save their own land. Or they do not care — in which case they are not “leaders” at all. Instead, they are charlatans, pretending to embody the national interest but only driving the nation into The Abyss.

Neither party has produced a plan to deal with this emergency, although the warning signs have been abundant for over a decade. And without a demonstrable will to boldly act, nations overseas will continue to make their own plans.

The dollar is involved with transactions the world over. And when the Fed, Treasury, and Congress inflate the currency and expand our debt obligations the way they are, foreign nations know eventually it means their dollar holdings will be that much less valuable. Combined, this includes trillions of dollars of reserves, treasuries, corporate bonds, and securities. So they want to dump them.

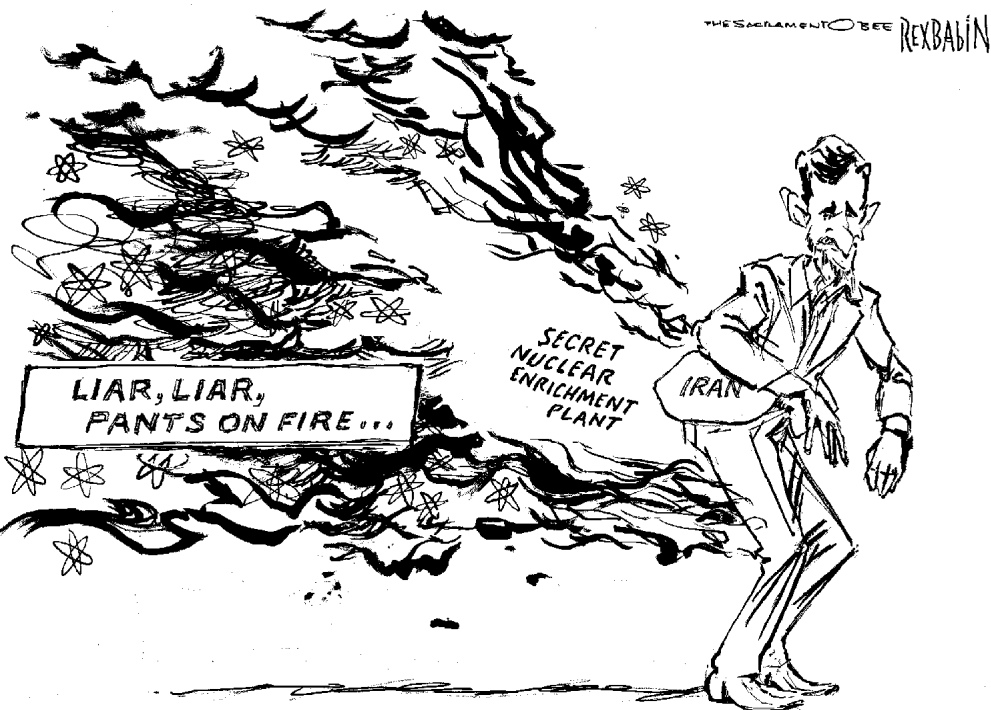
Who could blame them? We make bad decisions. And then, in essence, ask foreign powers (who are often hostile) to pay for them.

So, what do we do? Do we steer the ship of state out of turbulent waters? No, we have continued to steer it toward the deep beyond.

Which means the run on the dollar is close at hand. Perhaps even inevitable. Fear in our ability to pay back our debts will encourage that run — the capability and willingness by the nation’s leaders could prevent it.

But since nothing has yet changed, the best Americans can do is stock up on gold and, perhaps, canned goods. And hold on tight.

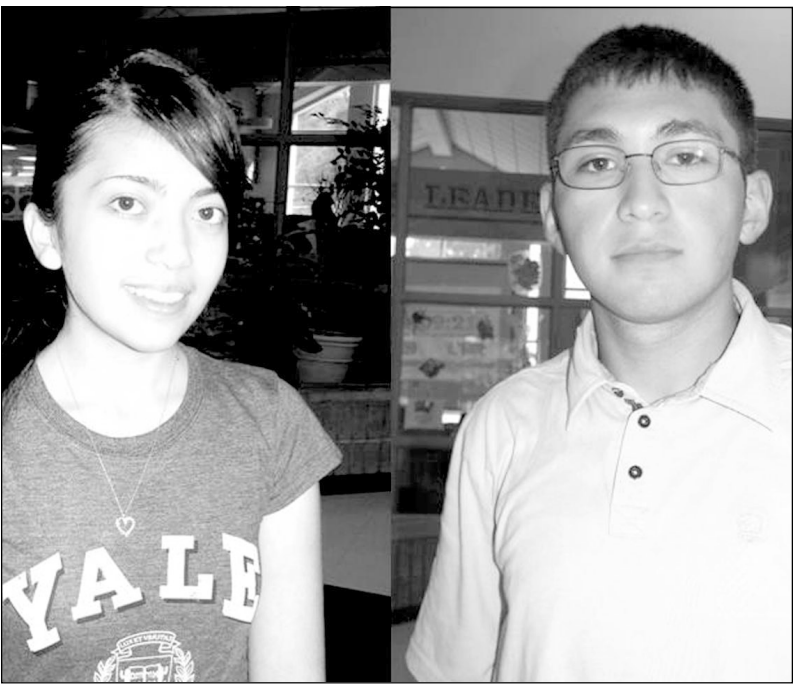

teachers to develop program activities that will prepare students to enter kindergarten on or above grade level. The grant funds, totaling \$585,000, will be utilized by the District to focus on college readiness in early childhood programs through language development and technol-

ogy integration. Technology and age appropriate software in math, science and reading acquired will help enrich their language. Each pre-kindergarten classroom will be equipped with a technology center which will include desktop computers for the students.

“Providing our prekindergarten students with a jumpstart in oral language development and academics skills is critical to their success from this point on,” says James Littlejohn, Assistant Superintendent for Instruction.

Jets hope to fly wings of Sanchez

It’s the early ’70s and The Beatles have just broken up. Paul McCartney forms a band named Wings and soon hits the top of the charts with a song called “Jet.” Jet had a catchy tune, but absolutely nobody understood the lyrics (with the possible exception of Denny Laine).

During that time, somewhere in New York, the Jets had a quarterback named Namath, who entered the words “long bomb” into the everyday lexicon of the National

Football League. He amazed everyone, and once even modeled in panty hose like a modern-day Mrs. Vanderbilt.

It’s 2009, and it’s another day for the New York Jets. People still don’t understand the words to McCartney’s “Jet,” and a lot of people cannot believe the performance of the New York Jets and their latest amazing quarterback, Mark Sanchez.

Drafted after his junior year at USC, Sanchez — dubbed “the San-

chize” by New York media — was labeled not ready for primetime by USC and former Jets head coach Pete Carroll. Before he had even thrown a pass in the NFL, Sanchez raised eyebrows when he posed in a Jersey Shore photo-shoot with several bikini-clad women (not that there’s anything wrong with that). As one would expect with someone of Buddy Ryan descent, Ryan has brought back the 3-4 and has made the pass rush a hallmark of his defense. Not only that, he’s benched players for Twittering on the Internet. In this day and age, you just have to respect a move like that.

But champions aren’t crowned in October, and a career isn’t made in three or four decent games. Either way, Sanchez and Ryan hope Jet fans will always love them.

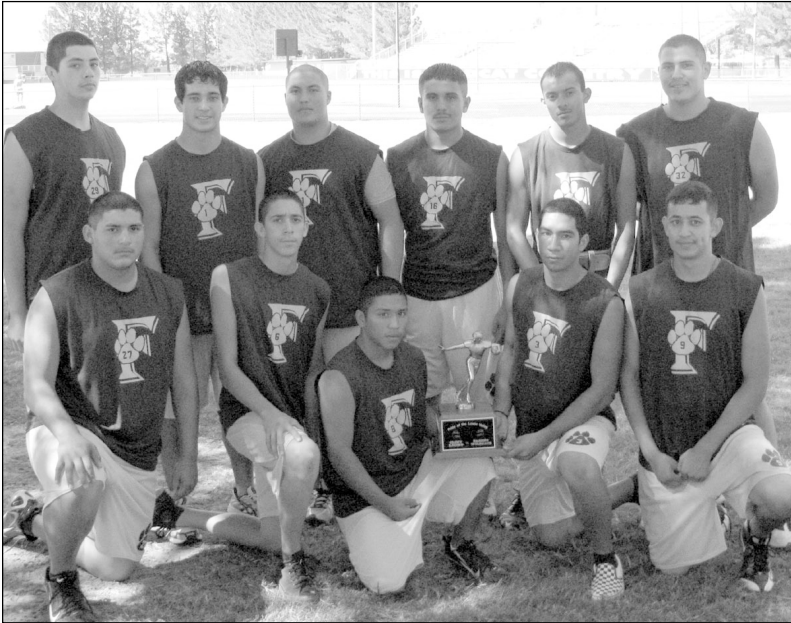

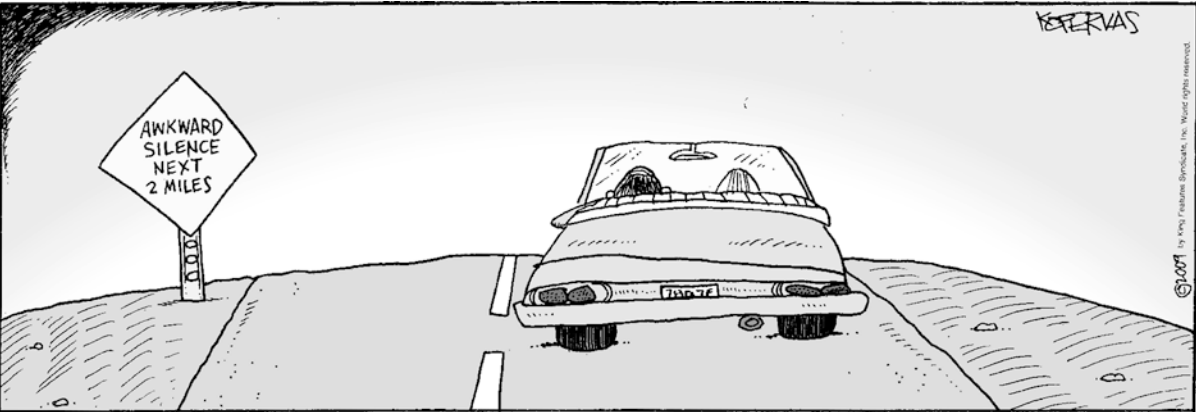
Outside linebacker Angel Ornelas and Fabens High School Senior said “before we played other teams, but our team just didn’t click. Now, with

Your good health

DEAR DR. DONOHUE: About three years ago, I had a procedure to reduce the size of my prostate. It was Greenlight PVP laser procedure. My doctor did it on an outpatient basis. Since then, I have a normal flow for someone who is 79 years old. I sleep through the night without having to get up to go to the bathroom. Perhaps you could comment on this treatment. — L.M.

Prostate gland enlargement — benign (noncancerous) prostate hyperplasia or hypertrophy — is something that happens to just about all men. Fifty percent of men between the ages of 51 and 60 have some gland enlargement, and by age 80, more than 80 percent have it. Not all these men have to deal with its exasperating consequences — frequent urination, nighttime urination, difficulty starting the stream — but enough do that it is a quite common problem.

Sometimes medicines can relax the chokehold that the big prostate has on the urethra, the tube draining the bladder, and there also are medicines that shrink the gland.

When medicines strike out, a large number of invasive procedures are readily available. The standard operation, TURP — transurethral resection of the prostate — is done with a scope and instrument passed into the urethra and advanced upward to the gland. The doctor shaves away portions of the gland. TUNA — transurethral needle ablation; TUMT — transurethral microwave therapy; and TUIP — transurethral incision of the prostate are procedures done very much like a TURP, but they employ different techniques for reducing the gland's size. Some are done in the doctor's office.

Greenlight Laser Photovaporization is a technique in which the prostate gland is downsized by vaporizing the excess with a laser that emits a green light. One big advantage this of-

fers is a reduction of bleeding. The green-light laser seals blood vessels in the process. I am sure many men readers will appreciate your bringing up the topic.

DEAR DR. DONOHUE: My 3-year-old granddaughter wakes up within a few hours of going to bed. She screams, and nothing consoles her. It's like watching "The Exorcist." I understand this is called night terror. Any suggestions? — C.S.

Many children suffer from night terrors. They usually occur in the first hours of sleep. The child suddenly screams, is wide-eyed, has a fast heartbeat, might be sweating, could thrash about or get up and walk zombielike. The child has no recollection of this the next day. The episodes are terrifying to on-lookers. Speak to the child soothingly until he or she goes back to sleep. Night terrors peak between ages 5 and 7, and then tend to disappear. The child's doctor should be informed of these so an exam to rule out any serious condition can be done.

Apply now to retire in early 2010

If you're planning on retiring sometime early in the new year, now is the time to apply for retirement benefits. The most convenient way to apply for Social Security benefits is online — from the comfort of your home or office. Just go to www.socialsecurity.gov/applyonline. Our website will walk you through the online retirement application process. We will tell you what information you will need to answer the questions on the application. Further, we will describe the documents you may need to present once you have submitted your application.

Before you start your application, we recommend you get an estimate of your retirement benefit. This too, you can do on the Social Security website at www.socialsecurity.gov/estimator. The Retirement Estimator uses your personal employment history to estimate your retirement benefit. It also will help you to answer some of the questions on the retirement application.

You can use the online application to apply for Social Security retirement or spouses benefits if you:

- Are at least 61 years and 9 months old;
- Want to start your benefits in the next four months; and
- Live in the United States.

You will want to be fully informed of your options and their consequences before applying. The website will tell you everything you need to know about the Social Security "basics" so you'll be ready to re-

- The name and address of your employer(s) for this year and last year;

The beginning and ending dates of any active U.S. military service you had before 1968;

- The name, Social Security number and date of birth or age of your current spouse and any former spouse. You also should know the dates and places of marriage and dates of divorce or death (if appropriate); and

- A copy of your Social Security Statement.

Even if you don't have all the information we need, you should go ahead and apply. We will contact you later if we need additional documentation.

Applying online means there is no need for you to go to a Social Security office or wait for a scheduled

appointment with a Social Security representative. Besides, retiring online is so easy. You can apply in as little as 15 minutes.

So if you want to start the new year off as a retiree, or plan to start collecting benefits early in the new year, now's the time to take action. Don't delay; apply online today at www.socialsecurity.gov/applyonline.


