Haitian scam

According to the Haitian Embassy in Washington and the Greater Washington Haiti Relief Committee, Haitian Americans who hope to transport family members from the earthquake-ravished island should be cautious of an emerging scam. The fraudulent scheme appears to offer Haitian Americans the documents they need to by pass the official government process for bringing family members from Haiti to the United States. Potential victims, who are reportedly handed fliers or reached by telephone, are told to wire \$500 in exchange for the documents and a confirmation number that will allow them to fly to Haiti to extract five relatives. The promised documents and flight in return for advance cash are entirely fraudulent. El Paso Collaborative gets \$10 mil. grant for homes

Foreclosed, abandoned homes to get new lease on life


The El Paso Collaborative for Community and Economic Development (Collaborative) was recently awarded a \$10 million federal grant to help create affordable housing in the El Paso area.

The federal Housing and Urban Development grant project, known as a Neighborhood Stabilization Program, is a joint effort between we are also concerned about the people that had to leave these homes. the Collaborative, the Lower Valley Housing Corporation, Habitat for What happened to them? How are they doing?," she said. "It would be Humanity-El Paso and Project Vida.

The grant dollars will be used to reinvest in homes that have been foreclosed or abandoned as a result of the depressed economy and housing market collapse over the last few years.

The goal of the project is to acquire and rehabilitate a minimum of 100 single-family homes in 22 different low-income areas located inside and outside the city limits of the City of El Paso. Eighty-five of the homes will be returned for use for homeownership and fifteen of the homes will be returned to use as rental properties.

Project Vida will manage the rental units for the first two years and will provide property management training to the Collaborative who will manage the properties afterwards.



The grant will partner with four different local contractors in order to refurbish the selected homes including for a conventional loan and perhaps have little to no history with a Dawco Builders, LLC, Karma-JKS Properties Inc., Wright & Dalbin bank," she said. "This grant gives us an opportunity to help those Architects and Senercon.

Dawco and Karma-JKS will help to acquire and rehabilitate the properties and sell them to income-eligible households as part of the project. Wright & Dalbin will conduct construction cost analysis, provide drawings as necessary and assist with environmentals.

While the grant project holds great promise, Collaborative Executive Director Delia Chavez said the grant award is "bittersweet."

"This grant really is bittersweet because the homes we will be working on became available through foreclosure or abandonment. So while we will be helping some people to get into affordable housing,

Chavez said the Collaborative, a small community lender with a staff of 6, was surprised to receive the grant which was available through a competitive

"We are excited to be able to help people through this project and it is encouraging because this will bring some positive changes both for the Collaborative and and the community," she said.



Although the grant project is just getting underway, Chavez and the other grant collaborators already have the end goal in mind of helping those families who may be struggling to find functional housing.

"As a community lender, we typically work with families who would have a very hard time qualifying

clients even more."

Potential renters or home owners will be able to qualify for the grant-revitalized homes based on a HUD financial threshold that is determined by their family size and income.

Anthony High School named one of nation's best

ANTHONY - Anthony High School, along with three other schools in El Paso county, were the only schools that earned medals as one of "Americas Best High Schools," according to U.S. News & World Report magazine. Anthony High School was recognized with a Bronze medal, along with Tornillo High School. The Maxine Silva Magnet School in El Paso ISD and Fabens High School were both awarded Silver medals.

According to the January issue of U.S. & World Report there were over 21,000 schools analyzed. The January 2010 issue of features the top 100 high schools in the United States (Gold medal winners), with three being from Texas - The School of Science & Engineering Magnet in Dallas (#8), IDEA Quest Academy & College Prepatory (#13) from Donna, Texas, and KIPP Houston High School (#16).

"This award represents the efforts of the entire AISD community to raise our expectations for the performance of our students. Performance is a direct reflection on the expectations that have been set," said Ronald Haugen, Superintendent of Anthony Independent School District.

In addition to the Gold, Silver and Bronze medal award winners, there was also an Honorable Mention category. Anthony and Tornillo High School were one of 1,189

Medals, or 2.5%, and a total of only 100 Gold medal winners, or 0.5%.

Veterans Post By Freddy Groves

Dependants can use GI Bill benefits

Not only are veterans going back to school by the thousands, but those who choose the new Post-9/11 GI Bill also have the option of giving those education benefits to a spouse or dependent.

To qualify for the transfer of education benefits, the veteran

- Aug. 1, 2009.
- Have at least six years in the service and agree to serve for four more (there are provisions for those who cannot agree to four more years).
- Be eligible to retire before 2013 (or be qualified to retire due to having served for 20 years).
- Transfer to either a spouse or a dependent child (the time can be divided between them).
- Already be registered in the DEERS system with eligible family members listed.

After the veteran is verified as being eligible to receive the benefits, the spouse or dependent will receive a certificate of eligibility that will pay for up to 36 months of tuition, books and housing.

For certain disabled veterans, there is the Survivors and Dependents Educational Assistance Program. The veteran must have a service-connected disability that is permanent and total, must be receiving care, and will be discharged from the service due to the disability. • Be on active duty on or after Dependents of veterans who died on active duty can take advantage of education benefits for 45

> Honorably discharged veterans who wish to go to school themselves using the Post-9/11 GI Bill must first qualify by having at least 90 days of service on or after Sept. 11, 2001, or who have a service connected disability after only 30 days.

Overseeing lottery safeguards

Hola mi gente. Recently an Associated Press article in the El Paso Times reported that a consulting company hired by the Lottery Commission apparently was also working for GTECH, the company that currently manages the lottery. The Commission hired Gartner Inc. as an independent consultant to assist in writing the rules under which bids are requested and processed.

During the time that Gartner was working for the Commission, it also signed a contract to work for GTECH. Although the contract has a specific date, it is impossible to know how closely Gartner and GTECH previously working together without a formal contract on lottery issues. Certainly, other companies who submitted bids see a problem.

During committee hearings in the past legislative session (House Committee on Licensing and Administrative Procedures), as a member I questioned why GTECH seemed to be consistently the bid winner. Other states have contracted with companies other than GTECH and I just thought that somewhere along the line the state would have been better served by trying one of those companies.

In response to media inquiries, GTECH, Gartner and Commission all stated that it was their opinion that the bid process was not compromised. The bids, which were submitted for the estimated \$100 million annual revenues, should be allowed to be continued according to those three entities.

Shortly after reading the article, I wrote a letter to the principals explaining my feeling that the dual role played by Gartner was reason enough to scrap the current bidding process. I insisted that the process start again from the very beginning with additional safeguards in place

Since our committee is scheduled to meet soon for interim hearings, I also requested that the Chair of the Committee, the Honorable Edmund Kuempel, place on the agenda an item for us to hear testimony from the Lottery Commission, GTECH and Gartner. The public needs to hear their accounts of the incident under sworn testimony.

I sincerely feel that it is imperative to start over and to have hearings in order to safeguard the confidence that taxpayers have in the state bidding process. Even if the dual role was actually a mistake, we need to address this as if there were intentional efforts to undermine a fair process.

If we don't, taxpayers will always have a question in their mind about the Lottery Commission bid requests. The impression of wrongdoing will also discourage other companies from bidding. This could potentially be very costly to the state.

It is the responsibility of agency executives and elected officials that being me — to safeguard your money, which is sent to Austin, from improper bid awards or even the appearance of impropriety.

View from here By David Nace Legitmizing theft

How do you legitimize taking wealth from the citizens of a country that produce wealth and jobs and give it to those that do not? A hundred years ago, collectivists could rely on the writings of Karl Marx to promote class envy and advocate class warfare to create a Utopian communist state where the means of production were communally shared among the citizens of a country. But the reality of communism is, that after a violent revolution that destroyed private ownership of land and capital, capitalism was replaced by a far more repressive dictatorship that destroyed millions of lives and constrained all but the elite in the Communist party into lives of misery.

Now the collectivists have found a new philosophy, one currently being promoted by the Obama administration, to suppress capitalism and replace it with collectivism. This new philosophy does not even require an armed uprising to seize power. This new philosophy is environmentalism. Environmentalism allows a collectivist elite to obtain bureaucratic control of privately controlled land, labor and capital without firing a shot. Once they obtain control, environmentalists and their allies are able to utilize propaganda and guilt to retain control rather than utilizing the brutal political repression that was required under communist

The environmentalist movement has learned to use falsified data, media bias and propaganda to convince the public of the urgency of its Malthusian claims. This was the concept behind the formation of the Apollo Alliance in 2003. The third component of the Apollo Alliance was ACORN and other self proclaimed "social justice groups" that would also share in the spoils of ravaging capitalism. While this alliance was able to create and promote the myth of "green jobs", the result of their policies will be green unemployment.

While the environmental policies of the Apollo Alliance will be devastating to most industries, government subsidies and funding is used to create "clean energy" jobs in favored industries that employed union workers. The Apollo Alliance was instrumental in drafting both the Stimulus Bill and Cap and Tax legislation. In both bills there was significant funding for "green jobs" that required payment of union wages and for a host of ACORN sponsored programs.

While environmentalists have used scientific fraud and propaganda to promote the false premise of global warming to enhance their power and prestige, ultimately, it will be their organized labor allies that will suffer. Despite government manipulation of the marketplace, green energy programs ultimately cost two jobs for each one they create. While environmentalists may have no problem with constraining all but the enlightened elite to lives of misery if they believe that is what is required save the planet, the demise of capitalism will affect the ability of labor unions to survive. Even in a socialist country, not everyone can be a government employee.



His only recourse was revolution and then seizure of private property to achieve worker's true worth. However, instead of the communal worker's utopia that Marx predicted, workers were constrained to lives of misery in support of the Communist Party. How much better will American workers fare under enviro-marxism?

Congressman investigates E-rate funding hold up, new gym gets use

The article in last week's *Courier* (Tornillo High School stalled by 'bureaucratic process') regarding the E-rate funding delay for Tornillo High School closed with a short statement that reporter Jamie Henneman had not been able to reach Congressman Ciro Rodriguez or Senator John Cornyn regarding the funding before press time. Earlier in the same article, Tornillo Superintendent Paul Vranish was quoted as saying "enlist[ing] help from federal legislators about the federal funding has been 'a joke." The quote was aimed at USAC (the division in charge of the E-rate funding), not Rodriguez or Cornyn or their staffs. In an e-mail Vranish writes:

When your reporter was interviewing me over the phone I was expressing my frustration with USAC by sharing with her that they simply will not give a response. I pointed out that we even tried the Congressman and his staff and that they were treated in a similar fashion—which I found shocking. My comment that "they" were a "joke" was targeted at USAC—not the Congressman's staff. I stand by that comment and I also stand by the comment that this is

an unaccountable bureaucracy run amok. But again, I mean USAC — not the Congressman's staff.

There issome information regarding this situation with our funding. During [a] call with Mr. Blanco (chief of staff to Congressman Ciro Rodriguez) I also spoke with Brian Young who informed me that he had pressed USAC again and found out that they had a Tornillounrelated complaint against one of the vendors we were planning to use. USAC would not disclose to Mr. Young which vendor (again, incredible) but Young suggested that Tornillo ISD query our vendors as to who the offender may be. We did and found out the subject of their investigation. This vendor claims he will be exonerated in two weeks but we have asked Mr. Young to follow up with USAC to determine if that assessment is accurate. In short, had we been told this back in May we could have simply moved to another vendor and this problem would have been averted. Once again, they are a JOKE - anunaccountable bureaucracy run amok! When their own employee, a very decent man



"There's nothing more important than getting the students of Tornillo High School into a new building with up-to-date technology and that has always been a top priority of Congressman Rodriguez. He is aware of the issues surrounding the delay and our staff has been in frequent communication over the last several weeks with both Superintendent Vranish and the federal officials responsible for disbursing federal E-rate funds. We will continue to pursue a speedy resolution to the problem."

On positive note, Tornillo ISD has been able to put their new gym to use. On Friday, Jan 15, The Tornillo Coyotes won three games against the Fabens Wildcats. The games were between each district's JV and varsity boys' and varsity girls' teams.







DEAR DR. DONOHUE: I have had acid reflux for quite some time, and doctors have prescribed different medicines, the last being omeprazole. Medicines were not relieving the burning pain. The best advice came from an online message board that said to "sleep on your left side." Figuring it wouldn't hurt to try this method, I began sleeping on my left side. Once my body learned to stay in that position, the pain does not bother me now at all at night. Why don't doctors share such simple methods for relief rather than prescribing medications? Please pass this information on to others. -N.S.

When it works, a change in allow four weeks for delivery. sleeping position is a simple way to deal with a big problem. It doesn't work for everyone. In fact, it works for only a few, but it's still valuable advice and is something that should be suggested more often. A change in sleeping position also can work for snoring. There is a possibility of a strep vaccine. Doctors currently are working on it.

Is the doctor sure that these repeated sore throats are strep throats? The only definite proof is a culture of the throat or specific tests for the strep germ. Most sore throats are viral-caused.

If a child has severe and frequent strep throats, removing the tonsils lessens the number of infections. "Frequent" means seven or more infections in one year or five or more in the preceding two years.


