Water money

Vinton was recently selected by the Border **Environmental Cooperative Commission** (BECC) for its Project Development Assistance Program. Under this program BECC will be conducting the planning, environmental analysis and final design of Vinton's waste water system. Once certified, the project will be eligible for construction fund assistance up to \$18 million. Under the BECC program, Vinton will have 5 years to complete the construction of its wastewater system. Additionally, the Texas Water Development Board (TWDB) recently notified Vinton officials that Vinton is eligible for \$8.5 million in funding under the Disadvantaged Communities Program and \$11.7 million under the Tier II fund. Lastly, Vinton also received approval from the U.S. Army Corps of Engineers for a \$6 million dollar grant for water/ wastewater/storm water improvements.

City of Socorro receives \$4 million to start Safe Routes to School projects

SOCORRO — The Texas Dept. of Transportation Commission approved eight Safe Routes to Schools (SRTS) projects for the City of Socorro Texas. Approximately \$4 million in funding will be utilized by the Socorro to provide the necessary infrastructure to make it safer for students to bike or walk to school.

The approved funding will be use to construct 78,500 LF [feet] of

sidewalks, install crosswalks, school sings, and widening of waterway bridges for safety. The improvements will target communities located around Campestre Elementary, Escontrias Elementary, Hilley Elementary, Hueco Elementary, Rojas Elementary, Salvador Sanchez H. Middle, Socorro Middle, and Ernest Serna Elementary and Middle schools.

"This project will increase physical activity of our children and will promote a healthier life style in the community. We are

Jerry F. Hall Memorial Soccer Complex to be dedicated in Anthony

ANTHONY — For Anthony Mayor Art Franco, a long-held wish will soon become a reality.

The new Jerry F. Hall Memorial Soccer Complex will be dedicated at 1 p.m. Sunday, June 13. The inaugural game will feature the Anthony All-Stars and AB United. The soccer facility is named for the long-time Town Council member who died of cancer last year.

The new soccer field, the first one in the town, is receiving finishing touches, the mayor says. It is the first of what will be four soccer fields in Anthony Municipal Park. The complex will eventually have adaptable soccer facilities for youth as well as adults.

In a November 2004 County Courier story, Franco had said his main wish for 2005 was a soccer complex through a partnership with an outside soccer club. Because the town and the club were unable to work out suitable arrangements, the project never got off the ground.

Hall served on the Town Council from 1976 to 2006 when he retired for health reasons. He was mayor pro-tem for 10 years and was one of the original councilmen who secured funding for the municipal park.

El Paso flood control coming

Memorial Day weekend, there was an abundance of thunderstorm clouds that could be seen in many directions. This brought to my mind the summer of 2006 during which our county experienced a rain and flood event unique over hundreds of

In the 80th Legislative Session, I passed a bill, along with Senator Shapleigh, that created a stormwater district (District) in El Paso County which would be under the umbrella of the El Paso Water Utility/Public Service Board.

One of the conditions that I set in order for the bill to go forward was that the District extend its focus into the areas outside the municipality of El Paso. I received a solid commitment from Ed Archuleta, the President/Chief Executive Officer of the El Paso Water Utilities Public Service Board, that the District would indeed cover the county

It has been almost four years since the great floods. I am very pleased to have been informed that the District recently published a draft of its plan to impose control on the

> Over the next few articles, I shall touch on different parts of the county and the plans on paper to remediate damages from the arroyo runoff.

> The City of Socorro is perhaps the area that is most impacted by the flow of runoff through several arroyos. The new developments that have been built contributed to a great amount of the flooding in Socorro. Horizon City runoff is diverted to first the Sparks community and then Socorro through three or more

A water treatment facility just hit with flooding. north of Sparks is the point at which the many arroyos converge. The District plan will place a massive basin above the treatment plant. The embankment will be 37 feet high with the capacity to hold back 139 acre-feet of water. The basin behind the embankment will release the water at a more reasonable rate and without soil sediment. The released

channel, expected to be concrete lined, without the force normally experienced previously. The concrete walls will eliminate erosion in the Sparks community as well.

The end result will be the stark reduction of water and sediment making its way into Socorro. In Socorro, the runoff will be diverted to another basin that will hold in excess of 600 acre feet of water. The basin will be just west the newer homes south of Stockyard. Runoff from the truckstops, around the interstate, will be diverted by a new channel to the same basin mentioned in this paragraph. This will reduce the flow onto homes located on Thunder Road. Whenever rain comes, this area is inevitably hard

The bill that I passed creating the stormwater district in El Paso County is creating very positive benefits. As the City of El Paso advances eastward, these flood remediation programs will eventually important and will have cost less taxpayer money.

Bailouts for dummies

financial services takeover bill can be Senators to avoid voting on whether intimidating to understand for many people, including myself. However, Chrysler, GM, Citigroup or Goldman when all the smoke clears it really comes down to four basic points:

1. Congress would set up a financed through increased charges to banks, which will be paid for by financial institution customers and savers. This permanent bailout fund bailouts in the first place.

2. Political appointees unelected bureaucrats can also declare any company to be a financial institution. This extreme power gives these unelected authorities the ultimate coercive power over business and America's economy.

and Chrysler under TARP are a good example of the Obama Administration's trial run for this power.

You might remember that Obama took care of his labor [supporters] through a political deal that benefitted the United Auto Workers union at the expense of those private individuals and banks who lent GM and Chrysler money through loans and bonds purchased. Ownership of both auto companies was redistributed to the politically powerful union leaving no doubt about how the bailout-takeover authority will be yielded.

3. When the government decides The government takeovers of GM to take over a company, that

company is not allowed to fight it in court. So, if you own shares of a company, and the government takes control of that company, you as an owner of the company cannot challenge the decision to take your property in a court of law. Sounds more like a third world dictatorship than America — doesn't it?

4. Finally, the Dodd-Goldman Sachs bill doesn't actually deal with any of the root causes of the collapse of the home mortgage market. For example, government policies forced government sponsored mortgage giants Fannie Mae and Freddie Mac to underwrite mortgages to people who were less likely to pay them back. Congress then built the house of cards even higher by ordering private banks to make similar if not even more risky loans if they wanted to expand across state lines, or merge with other banks to stay competitive.

Not surprising to anyone even remotely paying attention, many of the people who didn't actually qualify for loans, eventually couldn't repay them, and the house of cards which made up the entire home mortgage industry collapsed.

Now, the same Congressional scoundrels largely responsible for forcing the financial services industry into accepting the idiotic idea that if you lend a crack dealer \$300k for a home mortgage that you will get paid back, are "fixing the problem". Feel better yet?

In sum, the Dodd-Goldman Sachs bill doesn't fix anything. Instead, it perpetuates the very problem it claims to want to solve - leaving the very root causes in place while insulating the politicians responsible for building the house of cards from the consequences of their political rather than market based decisions. Crazy, isn't it?

What's up doc? By Albert Balesh, M.D.

Cocky Cocci


There's a plague brewing in the salty southern desert lands of Arizona, along the Mexican border, that goes beyond politics, national origins, or the color of one's skin. While not communicable from beast to human or human to human, it is no less dangerous because carried on the winds of all-too-common dust and sandstorms. Its calling card of profound fatigue, cough, shortness of breath, fever, and night sweats leaves one prostrate at best, and, when it instigates nodules, cavities, and pneumonia in the lungs, or dissemination to other organs far and wide, its hapless victim can be down for the count for anywhere from 4 months to over a year. The alarm and call to arms has been sounded in south-central Arizona, the southern San Joaquin Valley in California, the southwestern Rio Grande Valley of Texas, and northern Mexico where the scourge is endemic, and perhaps it is none too soon for El Paso, Juárez, and Las Cruces to heed indicators pointing to a possible spread of this cocky adversary, otherwise known as Coccidioidomycosis, "Cocci," or Valley Fever, to the unsuspecting bosom of virgin territory.

Coccidioidomycosis, unaffectionately known as Cocci, is a soil-dwelling fungus as hard to isolate from dry southwestern dirt as the elusive gold of the old prospecting days. It is there, though, just waiting to be borne into the channels and hidden pockets of elderly lungs by a sudden gust of wind. While it is asymptomatic in 60% of its predominant prey, elderly male retirees spending their golden years in new homestead and construction development sites in the more populated central and southern regions of Arizona, other groups such as HIV and immunocompromised patients, transplant patients and those taking immunosuppressors and glucocorticoids, those placed on tumor necrosis factor alpha therapy by their physicians for a score of maladies, and pregnant women in their second and third trimesters are also fertile terrains for the finicky fungus. The nodules and cavities it produces in the lungs may produce no signs or symptoms, but may

become evident on a chest x-ray or CT scan performed for another reason, and therefore require no medical or surgical intervention. Potential spread to distant organs like the skin, bones, joints, soft tissues, and meninges, however, can become a nightmare for 1% of the unlucky souls whose path and airways the arthroconidial (barrel-shaped) adversary has crossed. Even though dissemination to recesses far and wide of the human body and possible subsequent downward spiral into the abyss of fatal meningitis are so rare as to make choking to death on a fast-food French fry more common, the acute pneumonia and chronic symptomatology of the mangy microbe are by no means trouble free. In fact, a 2-3-month history, with no signs of improvement, of night sweats, extreme fatigue, cough, and a fever that may or may not be present, should trigger a closer look. As some clinicians like to put it, a low threshold for suspicion of Cocci should be in the front, not back, of the mind when a patient states that those symptoms have not improved over time. Couple that with increased eosinophils (a type of white blood cell alarm) on blood work, enlarged lymph nodes known as hilar or mediastinal lymphadenopathy in the center of the chest between the lungs on chest x-ray, and positive, if not dubious and unreliable, serologic tests performed on the sputum, and both the most experienced stalwart doubter and the most inexperienced, off-the-beatentrack, rural, bumpkin physician reach the same forgone conclusion that Cocky Cocci

Were that not all! Asymptomatic Cocci presents an additional series of problems, not the least of which are the emotional concerns it engenders in those who fall victim to its innocuous lung nodules, that just so happen to resemble and cannot be easily distinguishable on chest x-ray from pulmonary malignancies. The verdict is still out on treatment, too. Most would agree that primary pulmonary Cocci usually requires no therapy, with signs and symptoms gradually disappearing over a two to four-month period. Extensive, disseminated disease with no signs of improvement, local



elected mayor in 1993.

"I relied on his experience," the mayor remembers. "Hall was very helpful."

The soccer complex isn't the only thing on the mayor's mind.

He reports the town has received a three-year, \$1.17 million grant from the Texas Department of Transportation to establish a bus route that will link Las Cruces with El Paso. The mayor hopes construction can begin in August or September of this year on the new building, to include restrooms, on city land near Walgreens downtown.

A bus route, with funding from the New Mexico Department of Transportation, already links the communities. However, the grant, which took effect in September of 2009, was only for one year.

In other developments:

• The town will be taking part in the Mayor's Challenge, a summer food service program in which it partners with Anthony ISD to provide nutritious meals at no cost to youth from 1 to 18 years of age. Sponsored by the Texas Department of Agriculture, the program is designed "to help fight food insecurity in the community."

The program will run from June 10 through July 22 from 11:45 a.m. to 12:45 p.m. The meals will be served in Enrique Viramontes (Triangle) park. The town will be responsible for cleanup.

"It's a great idea; it's a great partnership between the town and the school district," the mayor says.

- Franco says he will be meeting with architects on June 7 to discuss preliminary plans for the new city hall which will be built across from Anthony High School. He hopes to start construction this fall.
- From the Texas Comptroller of Public Accounts, comes a grant of \$24,000 to increase electrical efficiency in Town Hall. Franco says it will provide energy-efficient refrigerated air conditioning for the town offices.



pulmonary disease provoking fatigue and night sweats that just don't seem to get better over time, and dreaded meningitis, on the other hand, require medical treatment of sometimes up to and over one year, as well as surgical intervention when the sky starts falling. While oral triazole antifungal drugs, such as fluconazole, itraconazole, and newer formulations, are the name of the game, they cause birth defects the offspring of pregnant women taking them. The primitive big gun, intravenous Amphotericin B, when used in more serious and resistant cases of cantankerous Cocci, is not without its problems either for the kidneys. So, damned if one has to treat 1% of the time, and fingers crossed 99% of the time that Cocky Cocci will fade into the sunset on its own, the clinician is left with some hard decisions.

Cocci and its distant, yet all-too-common cousin, the athlete's foot fungus, are as different as night and day in their ramifications. Yet they both need to be stepped on!





Your good health By Paul G. Donahue, M.D.

DEAR DR. DONOHUE: I have had acid reflux for quite some time, and doctors have prescribed different medicines, the last being omeprazole. Medicines were not relieving the burning pain. The best advice came from an online message board that said to "sleep on your left side." Figuring it wouldn't hurt to try this method, I began sleeping on my left side. Once my body learned to stay in that position, the pain does not bother me now at all at night. Why don't doctors share such simple methods for relief rather than prescribing medications? Please pass this information on to others. -N.S.

sleeping position is a simple way to deal with a big problem. It doesn't work for everyone. In fact, it works for only a few, but it's still valuable advice and is something that should be suggested more often. A change in sleeping position also can work for snoring. Sleeping on the side, right or left, can open up the throat and stop snoring. Redundant throat tissue, like a reed in a wind instrument, lies behind snoring. Sewing a pocket in the back of the pajamas and putting either a tennis ball or a marble in it keeps snorers off their backs.

Other self-help tips for GERD (gastroesophageal reflux disease, heartburn or acid indigestion all are the same condition) include staying away from foods that cause it. Onions, garlic, coffee, carbonated beverages, alcohol, chocolate, fried and fatty foods, citrus fruits and juices, tomato sauces, peppermint, spearmint and spicy foods are notorious troublemakers.



The process allows us to identify and make speedy decisions for the most obviously disabled individuals. Recently 38 more conditions were added to our original list of 50 conditions - 25 rare diseases and 25 cancers. The expansion of the list means tens of thousands of Americans with devastating disabilities, such as early-onset Alzheimer's disease, now can get approved for benefits in a matter of days, rather than months or years. 

Manufacturing on El Paso's west side. Mr. Lemus had made the ride many times before and was wearing a safety helmet, and also had safety lights in front and back of his bicycle. He was riding on the far right side of the roadway, and was within 2 miles of his destination when an unknown vehicle ran him down. He was struck in the 7300 block of South Desert. This is the first significant accident involving a bicycle this year. Two bicyclists were killed by vehicles in 2009. Although it is unknown what type of vehicle struck Lemus and fled the scene without rendering aid, investigators are hoping that someone witnessed the incident as it took place on the Gateway next to I-10 heading east into town. Lemus was spotted by a passerby who called police. He was taken to a local hospital in critical condition, where he now remains in a medically induced coma. The vehicle involved would show a considerable amount of front-end damage.
