#### Canutillo ISD forum

Canutillo Independent School District voters will have an opportunity to meet the candidates who are running for the CISD Board of Trustees, from 6 to 8 p.m., Thursday, October 21, at the Canutillo High School Auditorium (6675 South Desert Blvd.). Canutillo High School's Student Council is hosting the Candidates' Forum. The event will begin with selfintroductions by the candidates, followed by questions and answers forum, and concluding with a small reception. The public is invited to attend and meet the candidates. Seven candidates have signed up to run for three at large positions on the CISD Board of Trustees. The term of office will be for four years. Candidates for the CISD School Board (listed in the order that their names will appear on the ballot) are: Eddie Orozco, Yvonne Sapien-Sanchez, Patsy Mendoza, Mago Arellano, Sergio Coronado, Shonda Jordan, and Laure Searls.

#### Crime Stoppers

Crime Stoppers of El Paso is assisting El Paso Water Utilities in identifying and locating the unknown persons who have removed almost two dozen storm drain grates in various parts of the city, leaving behind very dangerous holes in the roadway, making this the "Crime of the Week." Heavy storm drain grates serve a valuable purpose in that they prevent large objects from falling into the stormwater system. Although usually 2 to 3 feet long and located along the curb of a street, they can also be quite a bit bigger and extend out across all or part of the street. It would take two people working together to remove even the smaller storm drain grates. The major problem with these thefts is the very large hole they leave behind, putting pedestrians, children and pets in danger of falling in. Also, the holes can be very damaging to vehicles and motorcycles. Most of the thefts have occurred in the central, east, and Mission Valley areas; but other areas have also been targeted. In addition, replacing the stolen grates, even the smaller ones, costs approximately \$1,000 to \$1,200 each and diverts stormwater crews from other, more essential functions. # Horizon City voters decide on three charter amendments, referendum

HORIZON CITY - Horizon City voters will decide on proposed amendments to the city charter and a referendum on use of sales tax funds when they go to the polls during the upcoming general election.

Election Day will be from 7 a.m. to 7 p.m., Tuesday, November 2. Early voting began October 18 and will continue through

For Horizon City voters, polling places on Election Day will be: Part of Precinct 147, at Horizon Heights ES, 13601 Ryderwood; and Precinct 167 and parts of Precincts 157 and 168, at Desert Hills ES, 300 N. Kenazo.

Early voting will continue through Friday, October 29, at the Oz Glaze Center, 13969 Veny Webb Road. The early voting location will be open from 8 a.m. to 5 p.m., through October 22; from 7 a.m. to 7 p.m., October 23; from 12 to 5 p.m., October 24; and from 7 a.m. to 7 p.m., October 25 through October 29.

According to Dr. Robert Coleman, Horizon City planning director, a charter committee met last spring to review the city charter's policies on term limits and compensation for the mayor and council members. The committee also reviewed regulations on use of Horizon City sales tax monies. He said that the three propositions and one referendum on the ballot for the November election are the results of this committee's recommendations.

On the Horizon City ballot are three proposed amendments to the city charter:

- Proposition 1- Regarding consecutive term limits, amend the charter to state that the mayor's office is separate from the council members' offices when it comes to term limitations mentioned in the charter.
- Proposition 2- Regarding term of office, amend the charter to state that the term of office for the mayor and council members be four year terms instead of the current two year

• Proposition 3-Regarding compensation for elected officials, amend the charter to provide each member of city council with \$125 and the mayor \$500 per month stipends.

"The idea behind proposing a distinction between the mayor and council members' offices when it comes to consecutive term limits was mainly for clarification purposes because of a recent inquiry," said Coleman. "As for expanding term lengths, the committee felt that it is important to give folks the opportunity to continue to serve after they've been trained and have gained important experience in the first two years," he said.

"There are only a limited number of folks who are willing to invest their efforts and time to serve as council members and mayor. These people invest a lot of their time and wealth for the city, and right now they are not getting any compensation, other than reimbursements for expenses incurred when they are on city council business," said the planning director.

Coleman said that the charter committee determined that it was in the best interest of the city to provide some kind of compensation to repay the mayor and council members for their time and out of pocket expenses. "The proposed stipends provide an incentive for interested individuals to serve," he said.

Also on the ballot for Horizon City voters is a referendum that is asking for permission to redirect one half of one percent of the city's share of the sales tax, which is 2 percent of the 8.25 percent collected, to support street maintenance and economic development.

Coleman explained that instead of asking for a tax increase to address growth concerns, city officials are proposing to voters that the city be allowed to redirect one half of one percent of the sales taxes for street maintenance and for economic development.

According to Coleman, Horizon City's two percent sales tax revenues would be about \$650,000 based on 2010-11 fiscal year projections. Therefore, one half of one percent

#### **REQUEST FOR RELEASE OF FUNDS**

On or about November 8, 2010 the Canutillo Independent School District will submit a request to the U.S. Department of Housing and Urban Development for the release of Economic Development Incentives funds under Public Law 108-447 and House Report 108-792 of the FY2005 Appropriations Act of December 8, 2004, as amended, to undertake a project known as New Irrigation Well -\$120,280 for the purpose of affording students instructional opportunities to practice the necessary skills associated with farming practices.

#### FINDING OF NO SIGNIFICANT IMPACT

The Canutillo Independent School District has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR) on file at Canutillo ISD Administrative Offices, External Funding Office, 7965 Artcraft, El Paso, Texas 79932 and may be examined or copied weekdays (8:00) A.M. to (4:00) P.M.

Any individual, group, or agency disagreeing with this determination or wishing to comment on the project may submit written comments to the Canutillo ISD, External Funding Office. All comments received by November 5, 2010 will be considered by the Canutillo ISD prior to authorizing submission of a request for release of funds. #### **RELEASE OF FUNDS**


The Canutillo Independent School District certifies to U.S. Department of Housing and Urban Development that Dr. Damon Murphy in his capacity as Superintendent consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. U.S. Department of Housing and Urban Development approval of the certification satisfies its responsibilities under NEPA and related laws and authorities, and allows the Canutillo Independent School District to use Program funds.

#### **OBJECTIONS TO RELEASE OF FUNDS**

U.S. Department of Housing and Urban Development will consider objections to its release of funds and the Canutillo Independent School District's certification received by November 23, 2010 or a period of fifteen days from its receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer or other officer of the Canutillo Independent School District approved by U.S. Department of Housing and Urban Development; (b) the Canutillo ISD has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient or other participants in the project have committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by U.S. Department of Housing and Urban Development; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58) and shall be addressed to U.S. Department of Housing and Urban Development Offices at EDI-SP Staff, Room 7146, 415 7th Street, SW, Washington, DC, 20410. Potential objectors should contact U.S. Department of Housing and Urban Development to verify the actual last day of the objection period.
