Wanted

Andres Rafael Salas, 27, is the Manhunt Monday Most Wanted Fugitive. He has a variety of aliases including Sniper, Andres Gallegos, Francisco Gallegos, Rafael Gallegos and Francisco Salas. He is 5'7" tall, weighs 200 pounds. He has black hair and brown eyes. He is heavily tattooed. He is wanted for a 2009 assault on his then five-month pregnant girlfriend In August of 2009, after getting in a verbal argument with his then girlfriend, Salas unlawfully, intentionally and knowingly entered her apartment located in the 7600 block of North Loop in El Paso, through a back window



and proceeded to violently assault the woman who was pregnant. Salas even shoved the woman by her stomach causing her to fall down. Salas then grabbed the woman by the neck choking her as he pinned

her up against the wall. Salas then took money from the woman's purse and other items from the apartment before fleeing the scene. He was arrested a short time later. Salas has recently failed to show for court for this incident and the 243rd District Court has issued a warrant of rrest for him. Salas is known to work in welding and has several contacts in the El Paso area. He is believed to remain in the Borderland hiding with friends or relatives. In more ways than one, young Farris isn't running alone.


He runs under the watchful eye of Coach Franks Munene who was a NCAA track champion at UT El Paso under Ted Banks. Employing nutritional and wellness techniques, Munene's basic philosophy focuses on having his young athletes work smarter, not harder.

Very much a part of the training equation are his father and mother, Dr. Kelly and Tracy Farris. Elliott is the oldest of seven children. The parents fully support him in his unique training regimen. Dr. Farris is part of the medical staff of the University Medical Center Neighborhood Health Center in Fabens. His mother home-schools Elliott who is the equivalent of a high school senior.

Munene, who took Elliott under his coaching wing only 15 months ago, likes the home-schooling approach because it allows him to work with the youth without having to counter the influence of more traditional track coaching methods commonly used in high schools. Unemployed Texans will be paid benefits for past weeks

Long-term unemployed again will be eligible for unemployment benefits

AUSTIN - The deadline for jobless Texans to qualify for emergency unemployment benefits has been extended to January 3, 2012. In December, Congress passed the bill which extends the filing deadline to allow long-term claimants to continue receiving unemployment benefits. President Barack Obama signed the

bill shortly after it was passed. This action did not add more weeks for those who previously exhausted all state and federal benefits.

Benefits to approximately 100,000 Texans stopped due to the previous deadline. The Texas Workforce Commission (TWC) has been advising those claimants to continue requesting payment, so they now can receive payment. This legislation did not add benefits for those who have exhausted all their regular, Emergency Unemployment Compensation, and Extended Benefits.

Claimants who are eligible for the federally funded extensions will receive statements from TWC with their new benefit amounts. TWC began sending payments to claimants' accounts today and will try to have most eligible claimants paid by the end of this week. Claimants should continue to request unemployment benefit payments on their scheduled day, and check their account balances throughout the week.

Claimants can find updated information on their claims at http://ui.texasworkforce.org, or by calling UI Tele-Serv at 1-800-558-8321 and pressing option 2. There is no need to call TWC to qualify for this extension unless claimants receive a letter telling them to call. Emergency unemployment benefits are entirely federally funded, so Texas employers will not be charged for any claims paid on this extension.

It matters little whether martinis are shaken or stirred, as long as they are served in the company of friends who go by the colorful and exotic names of Cialis, Levitra, and Viagra. Without making light of male impotence and erectile dysfunction (ED), which can be extremely debilitating and demoralizing, their drug remedies sound more like sheiks of Araby than therapeutic aids.

So, let us embark on a quest for the truth, and perhaps we can either verify or debunk some of the so-called miracles attributed to these pills, while at the same time clarifying their indications, contraindications, mechanisms of action, and side effects. Having said that, the author concedes that boys will be boys, no matter what their ages, and I take no responsibility for creating mountains out of mole hills, or for uncaging sexual tyranosauri.

know that it takes two to tango. Unfortunately, fifteen to thirty million American women are forced to dance alone, because for every 1,000 men in the U.S., 22.3 have plumbing problems that preclude dancing lessons. The numbers have increased threefold over the last ten years, and pharmaceutical companies saw a lucrative market back in 1998, when sidenafil citrate (Viagra) was first introduced. Since then, the triumvirate of Cialis, Levitra, and Viagra have rivaled Coca Cola and Budweiser as household names. After all, can a Coke cure the 5% of 40-year-old men and the 15-25% of 65-year-old men who experience ED, which, contrary to popular opinion, is not an inevitable part of the aging process?

Please excuse the pun, but let's get to the bottom of this. Two chambers in the penis, called the corpora cavernosa and filled with smooth muscles, fibrous tissue, spaces, veins, and arteries, are the culprits. When blood is prevented from flowing into the corpora cavernosa, it takes no Isaac Newton to realize that whatever goes up must come down. Diseases such as diabetes, kidney disease, chronic alcoholism, multiple sclerosis, vascular diseases, and neurologic disease, which cause damage to the structures of the corpora cavernosa, are the perpetrators of the majority of cases of ED. Tight control of blood sugar levels goes far to reversing or checking the progression of ED in the 35-50% of diabetic men who have long ago given up "dating" the former prom queen, if you know what I mean. For them and others, smoking cessation, weight control, and regular exercise can also help.

While common medicines (blood pressure drugs, ED, by definition, is the repeated inability to achieve antihistamines, antidepressants, tranquilizers, appetite suppressants, and ulcer drugs), stress, anxiety, guilt, depression, and low self-esteem can also contribute to our ups and downs, the medical arsenal of cures and remedies are no less colorful and varied, ranging

> drugs, vacuum devices, surgically implanted devices, and vascular surgery. Some of these therapies are more suited to torture chambers, haunted houses, and Vincent Price than medical science.

I will restrict myself here, for purposes of brevity, to oral drug therapy, and, although I would have liked to volunteer as a guinea pig and tester, I must rely instead on second-hand information. Cialis, Levitra, and Viagra are what are called phosphodiesterase inhibitors. They are prescribed by physicians, who must adjust their doses from 25 mg to 100 mg per day, are taken no more than once a day, and are administered usually one hour before sexual activity. Improving the response to sexual stimulation by relaxing smooth muscle in the corpora cavernosa, they allow increased blood flow to the penis. Side effects include aching in the penis, warmth or a burning sensation in the urethra, redness of the penis due to increased blood flow, minor urethral bleeding, and a wealth of factual and fictional horror stories. The independent and unbiased users I surveyed complained of drugassociatedheadaches, stomachaches, tunnel vision, burst blood vessels and bloodshot eyes, and anxiety, while nonetheless enthusiastically touting the beneficial effects of oral drug therapy with an end justifies the means philosophy.





Voting bill filed again

Hola mi gente. Perhaps the most important industry in East El Paso County is agriculture. I have seen different estimates as to how much our farmers and ranchers benefit El Paso, but it is in the multi-millions of dollars.

At the center of the huge agricultural industry is the El Paso Water Improvement District #1. The District manages the distribution of irrigation water from where the Rio Grande enters Texas to where it exits into Hudspeth County. Without the dedication and service that District provides, farmers could not produce the goods that are shipped throughout the country.

Some of you may recall a bill that I filed in 2005 that caused quite an uproar with certain other elected officials. That bill would have allowed landowners and primary users of the district services to be eligible to vote in District elections. That meant that others who live within the district could not. The argument by the local senator and state representative, both of whom will no longer be in office after January, was that the bill violated voter rights.

If you did not understand the issue completely, you might tend to agree. However, since 1973, the same issue has been argued at the U.S. Supreme Court and in state supreme courts. The Supreme Court ruled twice in 1973 that if a district is limited in its authority and if there is a disproportionate impact on landowners by the district obligations, then there are no voting rights violations if district-voting eligibility rests with landowners who utilize the irrigation services.

As a matter of fact, the same voter eligibility is legal in other counties of Texas. The water district that serves Cameron, Hidalgo and Maverick Counties has provisions defining those eligible to vote in district elections as landowners or those who utilize the services. Upon review by the Civil Rights Division of the U.S. Department of Justice, the finding confirmed that there were no issues whatsoever with voting rights or with the disenfranchisement of minorities.

I have filed the same bill for this session and hope to pass it with the support of the entire El Paso delegation. It is important for agriculture in the county that the bill passes. The farmer's bear the entire burden of the operating cost of the district and, according to the U.S. Supreme Court, should shoulder the responsibility, exclusively, of its operation; including elections.

Imagine if you are a resident of the city of El Paso, Horizon, Socorro or Clint, that voters who live outside the cities could affect the policies in your community by being eligible to vote in municipal elections. A resident of San Elizario could get elected to the city council of Horizon and vote for issues that benefit San Elizario. That is in no way proper. That same principal should be considered with this bill.

If farmers pay the fees for the operating costs of the District, then they should be the only ones eligible to vote on District matters.


Dear Editor:

The Village of Vinton has filed an application to decertify a portion of CCN No. 12563 from Vinton Hills Alegre, LLC with the Texas Commission on Environmental Quality to provide water utility service in El Paso County.

The proposed utility service area is located approximately 15 miles north of downtown El Paso, Texas, and is generally bounded on the north by approximately 1,800 feet north of Vinton Rd.; on the east by Border Steel Road; on the south by Douglas Rd.; and on the west by Kiely Rd. the total area being requested includes approximately 21.4 acres and one (1) current customers. The proposed amendment affects customers and/or areas located in the following zip code(s):**79821**.

A request for a public hearing must be in writing. You must state (1) your name, mailing address, and daytime telephone number; (2) the applicant's name, application number or another recognizable reference to this application; (3) the statement, "I/we request a public hearing"; (4) a brief description of how you or the persons you represent, would be adversely affected by the granting of the application for a CCN; and (5) your proposed adjustment to the application or CCN which would satisfy your concerns and cause you to withdraw your request for a hearing.

within thirty (30) days from the date of this publication or notice. A public hearing will be held only if a legally sufficient hearing request is received or if the Commission on its own motion requests a hearing. Only those individuals who submit a written hearing request or a written request to be notified if a hearing is set will receive notice if a hearing is scheduled.

If a public hearing is requested, the Executive Director will not issue the CCN and will forward the application to the State Office of Administrative Hearings (SOAR) for a hearing. If no settlement is reached and an evidentiary hearing is held, the SOAR will submit a recommendation to the Commission for final decision. If an evidentiary hearing is held, it will be a legal proceeding similar to a civil trial in state district court.

in Orlando. Elliott says his personal best time at that distance is 15:36.

In contrast, this is a major improvement over the 2009 AAU championships in which Elliott finished a distant 24th in a field of 35.

Munene continues to brim with confidence about his young protégé.

Looking back to August of 2009, the coach says that he could see a God-given special talent in the boy. "I see a lot in him; I made him realize his talents.

A formula for success, in Munene's view, is talent and hunger, a hunger to succeed. He saw that in Elliott. And another essential factor is believing in himself. All this the coach saw in him.

"He is a very disciplined person; my job is to guide him. I taught him the basics," Munene says.

Munene basics do not include the usual long runs. It consists of a more complete package of training to include emphasis on weights, nutrition and overall wellness. Rather than arduous long runs, he stresses flexibility, quickness and efficiency in his training regimen.

On an average, he will run maybe 45-50 miles a week. Elliott says he devotes about 12 hours a week to training in one form or another. Coach gives him Friday off before a meet to make sure his body is fully rested.

Social Security Q&A By Ray Vigil Q: Are Supplemental Security documents as proof of your child's

federal income tax?

A: No. SSI payments are not subject information, and preferably a recent to federal taxes. However, if you also receive Social Security benefits, those benefits may be subject to income taxes.

Q: I receive my Supplemental Security Income (SSI) payments on the first of the month. What happens when the first of the month falls on a Saturday?

A: If you receive an SSI payment record); on the first of the month, and the first of the month falls on a Saturday, Sunday, or legal holiday, your payment should arrive on the previous banking day. For more information, visit our Schedule of Social Security Benefit Payments at www.socialsecurity.gov/pubs/ calendar.htm. Keep the reference handy. And remember, if you have direct deposit, you'll never have to wait for your payment to arrive in your mailbox; it will be directly deposited into your account.

Q: *What are some of the documents* Social Security will accept as proof of identity for a child?

A: We can accept only certain Vigil, El Paso, Texas 79935.

Income (SSI) benefits subject to identity. An acceptable document must be current (not expired) and show your child's name, identifying photograph. We generally can accept a non-photo identity document if it has enough information to identify the child (such as the child's name and age, date of birth, or parents' names). We prefer to see the child's U.S. passport. If that document is not available, we may accept the child's: • Adoption decree;

> • Doctor, clinic, or hospital record; • Religious record (e.g., baptismal

Daycare center or school record; or • School identification card. (Your child may need to be present if a picture ID, such as a student ID, is presented as proof of identity.)

All documents must be either originals or copies certified by the issuing agency. We cannot accept photocopies or notarized copies of documents.


