Good business

Texas has been ranked the top exporting state in 2011 for the 10th year in a row, according to data released by the U.S. Department of Commerce, a sign of Texas' continued role as a leader in the global marketplace. "For a full decade now, Texas has been the nation's epicenter for international trade thanks to the continued strength of our state economy and the opportunities created by our business climate," Gov. Perry said. "We remain committed to the bedrock conservative values of low taxes, reasonable regulations and fair courts that attract and keep employers in Texas, and we will continue to develop the world-class workforce necessary to meet the demands of any 21st century employer." Texas' exports in 2011 totaled more than \$249.8 billion, up 20.7 percent from \$206.9 billion in 2010, outperforming overall U.S. exports, which grew by 15.8 percent in 2011. The state's top export recipients were Mexico, Canada, China, Brazil and the Netherlands, which respectively imported \$86.6 billion, \$21.9 billion, \$10.9 billion, \$9.9 billion and \$9.0 billion in Texas-manufactured goods. Texas' top exporting industries in 2011 were petroleum and coal products, chemicals, computer and electronic products, non-electrical machinery, and transportation equipment. In 2011, Site Selection Magazine, DCI and Area Development Magazine each ranked Texas as the best business climate. Additionally, Texas won Site Selection Magazine's 2010 Governor's Cup for the most new and expanded corporate facilities announced over the year. According to *USA Today*, Texas has moved past New York as the nation's second largest economy, and the Wall Street Journal has credited the state's low taxes and employer-friendly environment with helping make Texas the job creation capital of the nation. Additionally, Texas consistently ranks among the top states for Fortune 500 headquarters.

TEA Commissioner responds to over-testing concerns

As education officials implement the State of Texas Assessments of Academic Readiness, or STAAR test, which ninth grade students begin taking in March and which replaces a much-maligned previous standardized test known as TAKS, serious concerns over too much testing are brewing.

During the State Board of Education (SBOE) meeting in January, board members pressed the Texas education commissioner about whether high-stakes standardized testing is warping classroom teaching to ensure students spend more time preparing for the exams than actual learning.

Robert Scott, head of the Texas Education Agency, responded that having kids cram is "a perversion of what's intended" and that tests are supposed to ensure students don't fall through the cracks while holding teachers and school districts accountable.

But Scott also acknowledged that some schools over-prepare for tests whose results have become the overwhelming standard by which education is measured statewide. Instead, he said, officials need to find a balance.

SBOE Board Member George Clayton, a Dallas English teacher, complained that some schools have become little more than testing centers, offering mini-exams every two weeks to prepare for full, end-of-the-year standardized tests.

"That's all we do is test and prepare for tests. Make an assessment, look at the data, prepare another test; from August until the end of the school year," Clayton said.

"We do have many districts and many campuses that are overemphasizing testing," Scott said. However, Scott added, "Parents care about kids; teachers care about kids. The system doesn't give a damn about kids unless you make it care, and that's really what the idea of testing and accountability was about."

Scott said that testing ensures "different subgroups of kids" are not overlooked while higher-performing students pull up the average for a school or district that is then deemed successful overall.

Scott said that while simply spending a year teaching for standardized tests "won't work" and doesn't improve students' scores, it's hard for state officials to legislate against such behavior, which has only been encouraged by how much credence Texas now gives to test results.

"I've been a proponent of standardized testing, for some things, and I want to continue to use it, for some things. But we have overemphasized it, and even if we haven't overemphasized it specifically at the state level, the perception out there is that it is the end-all, be-all, and that is causing behavior in many cases, to compound upon itself, and even

if that's not the intent at the state level, that's reality," stated Scott.

"And perception is reality, so once they perceive that is all that counts, that it's all we're looking at, that's all they focus on. And so I think that this new accountability system will try to bring back some of that balance and recognize that there are plenty of other things going on in schools and plenty of other things we need to be focusing on," the Commissioner said.

"What I worry about is that the policies that we set in the Legislature, and how that translates down to the local level. I think the sentiment that it comes down to is that for many years people have said that schools districts need to operate like businesses. In many

cases, they are," said Scott.

"The assessment and accountability regime has become not only a cottage industry but a military-industrial complex. And the reason that you're seeing this move toward the "common core" is there's a big business sentiment out there that if you're going to spend \$600-\$700 billion a year in public education, why shouldn't there be one big Boeing, or Lockheed-Grumman contract where one company can get it all and provide all these services to schools across the country," Scott stated. "I mean, that's really what you're looking at. We're operating like a business," he concluded.

Bufford Rd. to get upgrade

SOCORRO – The City of Socorro will make some changes to Bufford Rd. to improve traffic flow. Socorro's rep for District 3, Mary Garcia, met last week with Planning and Zoning Director Sam Leony and Interim-City Manager Alejandro Vidales to go over plans to re-designate traffic lanes. The road runs through District 3 and passes in front of the new Bulldog Championship Park.

"We are not widening Bufford Rd. We are simply re-aligning the traffic lanes for the safety and security of Bulldog Championship Park neighbors and visitors coming to the park," said Garcia.

Traffic will continue to flow in one east and one west bound lanes. A new turning lane will be marked out to allow residents to access their homes without impeding traffic. A de-acceleration lane will be added on park property to maintain traffic flow on Bufford Rd.

"As a complement to the park, we are going to re-align the lanes in the existing roadway from existing right of way to the existing right of way. There has been a lot of misinformation out there but not a single inch will be taken from any of the residents in front of the new park. And since it's part of the road maintenance, there will not be any additional expense," said Leony.

Construction of Bulldog Championship Park is on schedule and it is still expected to open on Memorial Day weekend.

Wounded Warriors have
help to get to workforce

Newly returned wounded veterans have the option of entering a three-year internship program to become federal contracting specialists. The program, at the Acquisitions Academy of the Department of Veterans Affairs in Frederick, Md., is called Warriors to Workforce. Veterans can earn 24 business credits, required to become contracting professionals for the federal government, followed by the internship.

The Academy has three directions of emphasis:

- Contracting Professional School: Graduates complete the core courses to get an Acquisitions Certificate at Levels I, II and III. Possible specialties are Leasing, Health Care Services, Technology and Construction. Upon graduation, a veteran will have the education background to get a Federal Acquisitions Certification in Contracting and be eligible for positions starting at GS-11.
- Program Management: Coursework will enable graduates to certify as a federal program and project manager both in the VA and throughout federal government.
- Acquisition Internship: This is a paid two-year internship starting at a GS-7 with a track to GS-11. Emphasis is on leadership, communication, business savvy and more.

Facilities Management and Supply Chain Management courses will be coming soon.

No matter which avenue is taken, the program emphasizes training and on-the-job experience. If there's any field that needs new workers, it's acquisitions in the federal government.

To qualify, a veteran must have a service-related injury that impacts employment and little education after high school. Veterans are expected to work for at least three years after certification, and are guaranteed a job in acquisitions in the VA. The cost of the course is \$97,489, which is picked up by VA funding. The first-year business courses are covered by the GI Bill.



Budget can't stand on its own

Hola, mi gente. If you have ever experienced really hard financial times, there is a possibility that you may have used gimmicks to get past delinquent financial responsibilities. One of those gimmicks may have been holding off paying a bill until next month hoping the situation would allow you to get back on track.

Businesses use gimmicks at times when the books are slightly unbalanced. A skilled accountant can move an item in a very simple manner that results in the balancing of the books.

Those kind of sleight of hand tricks are not out of hand because the consequences fall on individuals or companies who ultimately pay a price for improprieties.

However, these are types of bookkeeping gimmicks should be minimized or completely eliminated when dealing with public monies. When a government budget is said to be balanced, that is exactly what it should be – not accounting tricks.

Did you know that the conservative leadership pushed through an appropriations bill that was balanced but only because of accounting tricks? This was not just a few dollars. There were billions of dollars that were balanced on paper only.

For instance, in order to reduce the shortfall by about \$2 billion, the appropriations bill fails to pay school districts in August of 2012. That is right; the state expects school districts to maintain fiscal accountability for twelve months but only pays the districts for 11 months within the two-year budget cycle.

If you have family members who survive month to month because of Medicaid, you know how difficult it is for the very poor and the elderly to balance their budgets. It may come down to health issues or groceries. It is very scary that the conservatives intentionally under-funded Medicaid for the fiscal years starting in September 2011. In this case, the leadership must be proud of a balanced budget even though those who survive on Medicaid paid for it.

Rightly so, there is a voter backlash to the gimmickry. Since the conservatives held a majority of 101 members to 49, it is only the conservatives who can be held accountable.

In many races throughout Texas, incumbent Republicans are being challenged on their vote for a budget that was balanced by pushing off billions of dollars to be accounted for in the 2013 session. Perhaps that is why more than 20 conservative members decided to retire.

As I understand it, to be fiscally conservative is a policy of pay as you go; never over extending the ability to pay for services rendered. If I am correct, then the comments by Republican candidates that the leadership passed a “fiscally reckless” budget are accurate.

The House Members on my side of the aisle were fighting to implement responsible ways of balancing the budget. In some cases, our efforts included raising tax revenues by reducing certain exemptions for industries such as oil and gas. The fight in reality was either balancing the budget through education and Medicaid cuts or by asking big businesses to prosper a little less.

I am sorry to report that big business won without any compromise.

Social Security Q&A By Ray Vigil

Q: I am receiving Social Security disability benefits. Will my benefits be affected if I work and earn money?

A: We offer work incentives that can help you keep your benefits while you test your ability to work. For example, there is a trial work period during which you can receive full benefits regardless of how much you earn, as long as you report your work activity and continue to have a disabling impairment. For more information about work incentives, we recommend that you read Working While Disabled—How We Can Help. You'll find it online at www.socialsecurity.gov/pubs/10095.html.

Q: Is there a time limit on Social Security disability benefits?

A: Your disability benefits will continue as long as your medical condition has not improved and you cannot work. We will review your case at regular intervals to make sure you are still disabled. If you are still receiving disability benefits when you reach full retirement age, we will convert those benefits to retirement benefits.

Q: My child is disabled. Can she qualify for Supplemental Security Income?

A: SSI makes monthly payments to people with limited income and resources who are 65 or older, or blind, or disabled. Your child younger than age 18 can qualify if he or she meets Social Security's definition of disability for children, and if his or her income and resources fall within the eligibility limits. We also consider the income and resources of family members living in the child's household. For more information, call 1-800-772-1213 (TTY 1-800-325-0778) or visit www.socialsecurity.gov/pubs/10026.html.

Q: I'm going to visit relatives outside the country for two weeks. Can I still get Supplemental Security Income (SSI) payments while I'm there?

A: Your SSI usually will stop if you leave the United States for 30 consecutive days or more. Since you are going to be away for only two weeks, your SSI should not be affected. However, it's important that you tell Social Security the date you plan to leave and the date you plan to come back. Then we can let you know whether your SSI will be affected. Lin lights up our inner fan

Let’s face it, even the most dedicated NBA fans find it hard to get excited about the league’s regular season games.

The same teams win, the same teams lose, and officials call traveling about once every five games.

Another downer about the regular season is that there are so many games that players take a lot of them off. Oh, they arrive at the arenas but they don’t exactly give it there all – especially on defense.

There are a few stars that fans pay to see like Kobe and LeBron and Dirk and Manu. You know you’ve really made it when you can be identified by your first name alone.

But there’s also Kevin Durant and Blake Griffin and Steve Nash and Dwight Howard and Paul Pierce and Kevin Love and Derrick Rose and many others to watch.

There’s still no doubt that the vast majority of NBA regular season games are virtually unwatchable.

Then, just when you thought there was nothing new going on in NBA regular-season land, a savior comes out of nowhere to inject some life, and watchability, to the sport.

Since the New York Knicks went out and picked up Amare Stoudemire and Carmelo Anthony, they have gone out and played uninspired basketball.

But because of injuries and family emergencies, the Knicks have had to play

without their two superstars for a week.

To make up for their absence, Knicks coach Mike D’Antoni was forced to look way down his bench to find replacements.

One was a seldom-used point guard out of Harvard who had already been cut from two other NBA teams.

But once in a while – about as often as lightning strikes a tree in your backyard – a complete nobody defies all logic and rises up to become a somebody – a very special somebody.

Jeremy Lin was given the opportunity to step in and help the lowly Knicks or at least keep them afloat until the stars come back.

What Lin has accomplished in his first five games has taken the league by storm. In fact, the NBA calls it pure “Linsanity.”

Since taking over the team from the all-important point guard position, Lin had led the New Yorkers to five straight victories and he has Madison Square Garden in the palm of his hand.

In his first five games as the Knicks point guard, Lin, scored 25, 28, 23, 38 and 20 points. That comes out to 26.8 points per game. He’s also averaging 8.0 assists and 4.2 rebounds.

His most important stat is that his team is 5-0 with him as the leader. The Knicks and their two superstars were 8-15 before that.

In his third game as a starter, critics said what he had done was nice, but now he was going up against Kobe Bryant and the Los Angeles Lakers.

They said that Kobe was going to be upset because Lin was grabbing all the attention and

that he was going to teach the young upstart a thing or two.

Well, although Kobe struggled (shooting just 11 for 29 from the floor) he did score 34 points. But Lin stole the show by scoring 38 points and dishing out seven assists to lead the Knicks to another win.

And what makes Lin even more popular is his attitude and humbleness. He never talks about himself; he talks about his teammates and respects his opponents.

Another thing he does is make his teammates better. That is one thing that Stoudemire and Melo have never done.

On a team loaded with no-names, Lin has instilled a belief-system in every player that

they too can compete with the best of the NBA – and they’re doing it.

For want of a nail

Imagine being invited to the White House for dinner, but it’s with Joe Biden instead of the president. Or hiring a high-powered attorney for the big case, but when you meet him he has a cheap watch, unpolished shoes and a dead-fish handshake.

In sports, as in life, an entire career’s worth of work can change in a single moment.

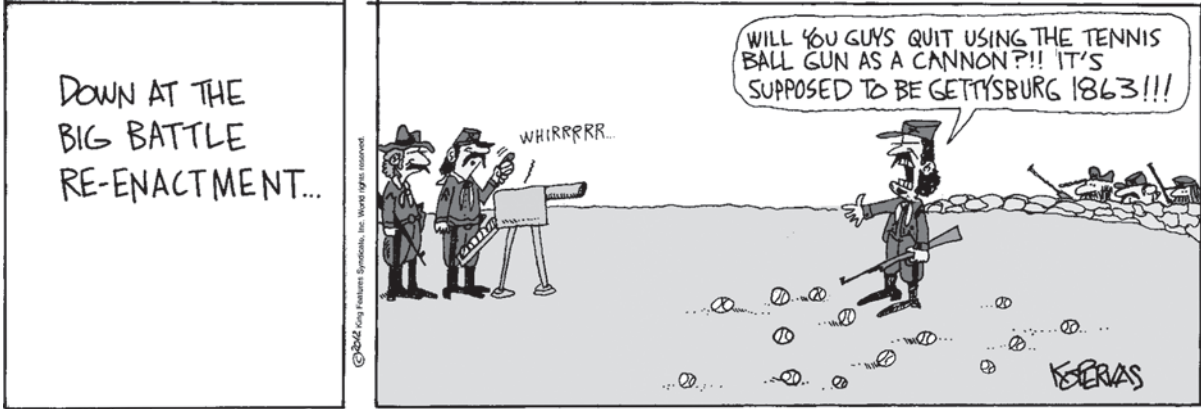

Just as the elephant is afraid of the mouse, true or not, the small mistake ruins the picture in its entirety.

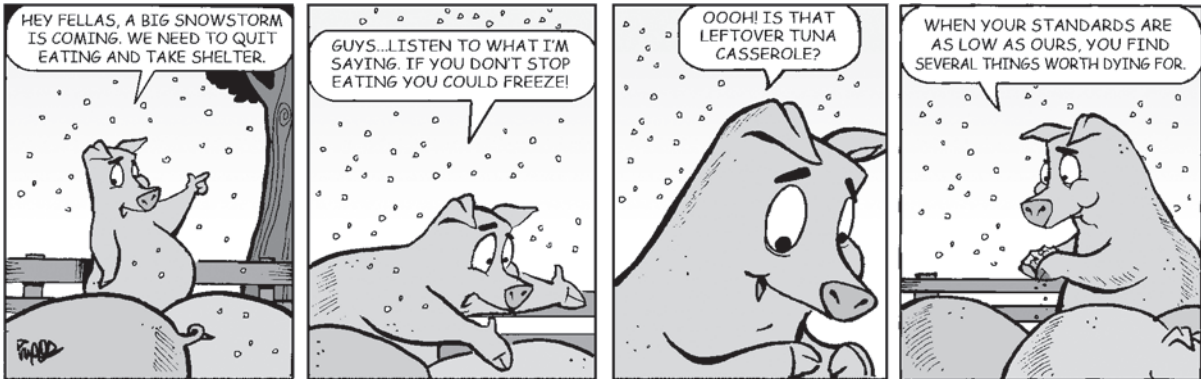

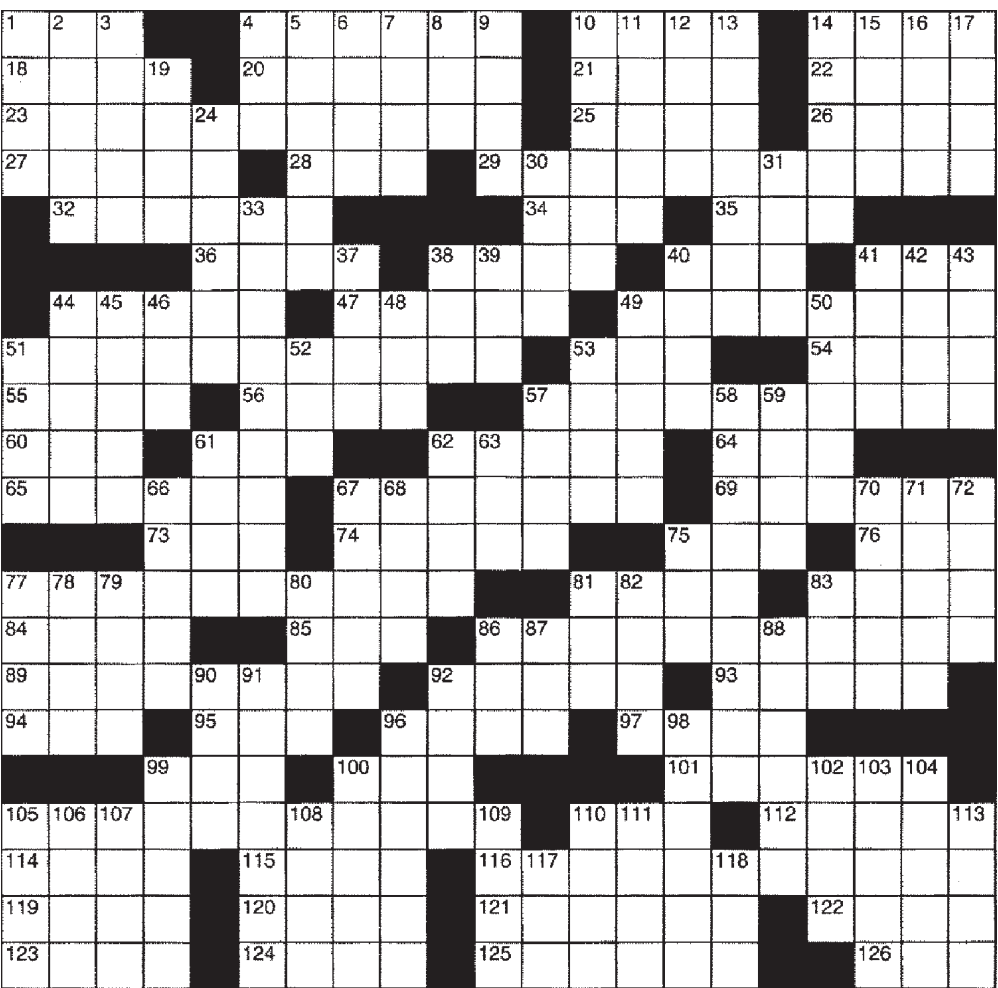

Your good health By Paul G. Donahue, M.D.

DEAR DR. DONOHUE: I believe I read in your column about something that can be given for hepatitis C. My doctor says there isn't any treatment. Will you please advise me? – Anon.

Chronic infection (lifetime infection) happens to about 80 percent of those infected with the hepatitis C virus. Worldwide, the virus infects 170 million people. In the United States, 3.2 million are infected. Of the chronically infected, close to 20 percent will develop either liver cirrhosis or liver cancer. It takes 20 to 30 years before signs of such complications become apparent.

Predicting who benefits from treatment, therefore, is not an easy task. Perhaps your doctor said you would not benefit from treatment now. Indications favoring treatment are finding hepatitis C virus RNA (ribonucleic acid) in the blood and documenting liver changes suggesting cirrhosis is beginning to take place. As I said, only 20 percent of those infected with this virus are at risk for these complications.

Treatment isn't 100 percent effective for all. Success depends on which strain of virus infects a person. Strains 1 and 4 are less susceptible to treatment.

Standard treatment is ribavirin and peginterferon. New treatments are about to become available, and they show great promise in improving treatment success. Boceprevir and teleprevir are going to be launched for general use later this year. They will establish a new era for treatment.

The booklet on hepatitis A, B and C details these illnesses, how they are acquired and how they are treated. DEAR DR. DONOHUE: Please tell me what causes brown spots on the hands and arms. Is there anything you can do to prevent them or erase them? – A.C.

Sunlight and aging cause those brown spots, known as solar lentigos. To prevent them, use sunscreen on the affected skin every day of the year, whenever you go outdoors. You can't prevent aging. In popular language, these spots are called age spots or liver spots, even though the liver has not one thing to do with them.

If you're desirous of getting rid of them, doctors can freeze them off or use a laser on them. You can apply tretinoin cream, an acne medicine. It takes a long time to fade the spots, but they will lighten in time. Bleaching creams like Eldopaque and Solaquin also work.

You have to be sure that your insurance covers the cost. This is cosmetic medicine and often not covered by insurance policies.

DEAR DR. DONOHUE: Is it possible for a man with prostate cancer, before it is treated, to pass the cancer to his wife through intercourse? This subject came up during lunch with friends. Some said it was possible. – C.N.

Prostate cancer is not passed from a man to his wife through intercourse or in any other way.

NOTICE OF EL PASO ELECTRIC COMPANY'S PETITION TO CHANGE RATES AND TO RECONCILE FUEL COSTS, AND RESPONSE TO CITY OF EL PASO'S SHOW CAUSE ORDER

El Paso Electric Company (EPE or Company) publishes this notice that on February 1, 2012, it filed with the Public Utility Commission of Texas (Commission) its Petition and Statement of Intent and Application for Authority to Change Rates and to Reconcile Fuel Costs. This filing has been assigned Commission Docket No. 40094. This filing was also made with those municipal authorities in EPE's Texas service territory that have original jurisdiction over EPE's electric rates and have requested a copy of the filing. The filing made with the City of El Paso (El Paso) also serves as EPE's rate filing package ordered by El Paso to be filed by February 1, 2012 in compliance with El Paso's October 4, 2011 resolution.

EPE is proposing to change its rates for electric service provided to its approximately 290,000 Texas retail customers. All such customers, all classes of customers and all areas in Texas in which EPE serves will be affected by this change in rates, as well as the request to reconcile fuel costs.

STATEMENT OF INTENT TO CHANGE RATES EPE's request to increase its base rates is based on the financial results for a 12-month test year ending on September 30, 2011. EPE's proposed rate change would increase its base revenues for firm service by \$13.766 million, which is an increase of 3.2%, increase interruptible service rates by \$3.173 million, a surcharge for an anticipated \$8.658 million of rate case expenses, and an increase of \$0.658 million in service charges and other miscellaneous revenues. The overall combined effect of EPE's proposed rate changes would be to increase

its adjusted test year revenues by \$26.255 million, an overall increase of 5.6% in its Texas base rates. This increase is premised in part on EPE's request (1) to recover EPE's investment in its newest generation facility, Phase II of Newman Unit 5; and (2) to recover EPE's other capital additions made since June 30, 2009, which is the end of the test year in EPE's last rate case.

The impact of the rate change on various customer classes will vary from the overall impact described in this notice. The typical Residential Service customer using 600 kilowatt-hours of energy per month will see an average bill increase of \$4.00 per month, or 5.5% under the proposed rates in this proceeding. The typical Residential customers located within the El Paso city limits will also see a Rate Case Expense Surcharge on their monthly bills of \$1.32 for twelve months.

El Paso has already ordered that EPE's existing base rates inside that city are temporary, such that inside the city, upon a final decision, any increase in rates would be, and any decrease in rates may be, retroactive back to November 15, 2011. For the rate change that it is proposing, EPE has proposed that the effective date of its rate change be March 7, 2012 for the areas where the Commission has original jurisdiction and for those areas where municipal authorities retain regulatory jurisdiction. EPE has proposed that the effective date of this rate change be suspended, so that with the suspension and the compliance tariff approval process, its rates would be applicable beginning on March 7, 2012. The proposed effective date is subject to suspension and extension by actions that may be taken by the Commission and other regulatory authorities.

REQUEST FOR SURCHARGE El Paso has designated EPE's current base rates within the city as temporary rates, effective November 15, 2011. Because EPE's requested

base rates exceed those temporary rates, EPE is requesting a surcharge that would relate back to usage from November 15, 2011 to recover the temporary base rate deficiency, together with interest, solely from customers within El Paso. The amount of the surcharge will not be known until rates are finally established.

TARIFF REVISIONS

EPE is proposing changes in rate design to move customer classes closer to their class cost of service. Additionally, EPE is proposing revisions to some tariffs. These changes include, but are not limited to, the consolidation of certain related classes with the elimination of the unnecessary duplicative classes. The complete set of proposed tariff schedules is presented in Schedule Q-8.8 of EPE's filing.

EPE's request to reconcile fuel and purchased power costs is separate from its request to change base rates and is briefly described below.

RECONCILIATION OF FUEL COSTS EPE requests authority to reconcile its fuel and purchased power costs for the period from July 1, 2009 through September 30, 2011 ("Reconciliation Period"). This request, if granted, will affect all Texas retail customers who pay fixed fuel factors. During the Reconciliation Period, EPE incurred a total of \$356.493 million in eligible fuel, fuel-related, and purchased power expenses (offset by off-system sales) to generate and purchase electric energy for its Texas retail customers. At the conclusion of the Reconciliation Period, after adjustments, EPE had a cumulative under-recovery of such expenses of \$12.762 million. EPE seeks to carry over this cumulative Reconciliation Period fuel under-recovery balance into the subsequent Reconciliation Period beginning October 2011.
