Tax free

The opportunity for Texans to save money on energy efficient appliances is fast approaching. The state's annual ENERGY STAR® Sales Tax Holiday is from Saturday, May 26 through Monday, May 28, 2012. "As Texans focus on their household budgets, they can save twice on energy efficient appliances purchased during Memorial Day weekend," Texas Comptroller Susan Combs said. "Shoppers do not have to pay sales tax on the appliances, and those energy efficient products will also help them save on their utility bills." The sales tax break applies to ENERGY STAR® qualified air conditioners priced at \$6,000 or less; refrigerators priced at \$2,000 or less; ceilingfans;fluorescentlightbulbs;clothes washers; dishwashers; dehumidifiers; and programmable thermostats. Desert Weeds

Local artists Oscar Moya and Lydia Limas will present a printmaking workshop to demonstrate how desert vegetation can be used to create a piece of artwork.

The unique workshop will be held at 2 p.m., Saturday, May 26, at the El Paso Museum of Archeology, 4301 Transmountain. The free demonstration is open to adults and children age 3 and up.

Participants will learn how to use leaves and weeds found in the surrounding desert landscape to produce a drawing or painting that is transferred onto paper with a press. The result is a unique collagraph print or monoprint which can be framed. All necessary materials will be provided for the Saturday afternoon workshop.

Moya began his Desert Weeds series in

2009 by experimenting with plants and leaves in his backyard. "I was amazed at the incredible detail and the beautiful textures," Moya said. "And, I found that children as young as three years old easily get involved in creating potentially limitless unique art through this process," he added.

Moya has participated in group exhibitions in the United States, Mexico, Canada, and in Europe. Moya's recent collaborative printmaking projects include Centenario de la Revolucion Mexicana, Arceo Press, Portafolio, 2010, and teaching Desert Weeds basic printmaking workshops in the El Paso region since

Scam alert: Protecting senior Texans from Advance Fee Fraud

customer, there were no Presidents' Day weekend plans in sight. There was only the stark reality of his wife's long suffering mind and his long suffering heart. Although he was all too aware that both he and his wife suffered from Alzheimer's disease, he had no idea that they were also victims of a scam to defraud aging and unwell victims. It all started back when "good friends" called again to convince him that if he sent them another \$15,000, he would finally receive the \$2 million

Fortunately, a vigilant employee at her elderly customer's frequent visits to the bank and decided to contact the Texas Attorney General's Office. By that time, she explained, the customer had already wired his "good friends" \$75,000 via Western Union so that he would be eligible to claim his \$2 million prize. The bank employee pleaded with the customer and at one point, it appeared she elderly man's "good friends." had convinced him to stop sending money to the scam artists. But his "good friends" kept calling, so the elderly man returned to the bank to liquidate his CDs because he had already drained his checking and savings accounts.

The bank employee explained the scheme in detail to the Attorney Office. Apparently operating under his "good friends"" instructions, the elderly man would withdrawcashin\$15,000 increments. Then, he would take the money to a nearby Western Union outlet, which would take possession of the cash and wire the money per the elderly man's instructions. Although the concerned bank employee showed the customer documents from the Office of the Attorney General's website, warning about advance fee scams, he was undeterred. So when she contacted the Attorney General's Office, she wanted to know what else she could do to make him stop without violating bank regulations or other laws.

General's Office agreed to help and General's Office, she was able to immediately contacted a colleague – Outreach coordinator John Elizarde. who also has a background in law enforcement. Before he was appointed Outreach coordinator, Elizarde was assigned to the attorney general's law enforcement division, where he worked regularly with the Southwest Border Anti-Money Laundering Alliance. The Alliance was launched in 2010 to help Texas and other border states coordinate money laundering prevention, investigations and prosecutions. Under an agreement between all the local bank grew concerned about four border states and Western Union, the Alliance also established new protocols for sharing Western Union's extensive information about wire transfers that originate in border states. Relying upon his extensive knowledge of the money services business and his contacts at Western Union, Elizarde sought to uncover the real identity of the

After speaking with the concerned bank teller, Elizarde sent an email inquiry to his contact at Western Union's Consumer Protection Ethics and Compliance Division. When Elizarde's phone rang thirty minutes later, his Western Union contact was on the line. The news was predictable – and not good. Western Union had quickly reviewed the wire transfers and confirmed that the 90-year-old man's money had been sent to the Philippines and Nigeria.

Worse, because wire transfers are converted to cash or cashier's checks when they arrive, there is simply no way to identify the perpetrators or recoup the money from foreign countries that are thousands of miles away. But, because of a vigilant defense.

For the 90-year-old bank who fielded the call at the Attorney bank teller's call to the Attorney prevent her elderly customer from being defrauded again.

> After it was contacted by the General's Outreach Attorney coordinator, Western Union immediately put a nationwide flag on all transactions by the local bank's elderly customer. A systemwide alert instructed all Western Union outlets to contact the company's corporate office before processing the bank customer's future wire transfer requests.

> As a law enforcement veteran who had studied advance payment scams, Elizarde recognized that the unscrupulous offshore criminals who posed as the elderly victim's "good friends" would not simply stop calling. So Elizarde also contacted MoneyGram, another large money services firm with outlets across Texas, and arranged for that firm to implement similar security measures that would protect the elderly bank customer.

> Although it is virtually impossible to recover the elderly couple's money from the foreign criminals who defrauded them, this case shows how a vigilant bank teller, quick-thinking state authorities and a responsive Western Union orchestrated a coordinated effort to prevent a 90-year-old victim from losing his life's savings to an advance fee scam. These scams – which can range from fraudulent foreign lottery winnings to a non-existent sweepstakes prize or even a made-up inheritance from a purported long-lost relative abroad frequently target our senior citizens. Concerned family members, friends, bank officials and long-term care personnel are seniors' first line of





Hola, mi gente. After so many is there to motivate people to vote when the uncertainties, the 2012 primary election has finally begun. Thanks to a flawed redistricting map pushed forward by the conservative leadership in Austin, our primary election was delayed by 60 days.

This primary is in stark contrast to the 2008 election which featured a monumental battle between then Senator Barack Obama and Senator Hillary Clinton. El Paso was really fired up for that race and it showed in a much higher turnout than previous presidential primaries.



SkillsUSA one of the best kept secrets in Texas

SkillsUSA includes with its masonry of career training programs ethical lessons. The students recite a creed that teaches the importance of education, fair play, the satisfaction of hard work, the American way of life, and having moral and spiritual

"Forty-five years and not everyone knows about us," said Linda Holcombe, executive director of the Texas Industrial Vocational Association (which works with SkillsUSA to train career technology teachers).

However, awareness of SkillsUSA is building in Texas. Holcombe said that one of the highlights of the year for their teachers and students occurs during the SkillsUSA-Texas Day at the state Capitol, where a mock legislative session is held.

The exposure at the Capitol is apparently paying off.

"In 2007... we aligned 19 career and tech courses to fulfill the fourth year of science and math," Holcombe said. "We've also created a career technology course for a speech credit, and another for a finearts credit."

The organization recently wrapped up SkillsUSA Month in March, celebrated in many public schools. Holcombe said SkillsUSA saw a 10 percent membership increase over the past year.

According to Holcombe, industry required certifications are tickets to well-paying jobs in specialized, high-tech fields.

"The certifications keep them from from graphic design to sheet metal being ditch-diggers," Holcombe said. "They prepare them for the world of work because they get the training industries need."

> Asoneexample, home construction courses offered through SkillsUSA do not simply train a student how to be a carpenter. Skills learned may lead to a career in architecture and structural engineering - "not just hammering in nails," she added.

> "Career technology is not the old shop class," she said. "If you're in class and just making ash trays for four years, it should be shut down! Schools need to be up to date with technology and the job market."

> Safety is another aspect of career technology training that can be applied to a wide variety of jobs. OSHA certifications are available for students at the entry level, which is a prerequisite in many manufacturing environments.

> If you know a junior high or high school student who is interested in 3-D animation, plumbing, advertising art, cosmetology, production, firefighting, aircraft repair, drafting, cabinetry, commercial baking, machinery, collision repair, nurse assisting (there are so many I'll have to cut this list short), let them know about SkillsUSA – as well as the goodpaying career opportunities that await in skilled labor fields.

Your good health By Paul G. Donahue, M.D.

DEAR DR. DONOHUE: I am a 55-year-old man who finally bit the bullet and had a colonoscopy. My doctor had badgered me to have one for the past five years. I don't have cancer. I don't have polyps. I do have diverticulosis. I didn't know I had it before the scope exam. I've never had even a twinge of pain. What is this, and what do I need to do about it? – H.L.

A diverticulum is a small, balloonlike protrusion of the colon lining through the muscle wall of the colon and onto its outer surface. By "small," I mean that diverticula range from 0.2 inches to 0.4 inches (0.5 cm to 1 cm) in largest diameter, around the size Orlando, FL 32853-6475. Enclose of a pea. 

To be eligible for SSI a person must have \$2,000 or less in countable resources. (A married couple must have \$3,000 or less in countable resources.) Not all of your resources count toward the SSI resource limit. For example:



tattoos on his neck and arms. In the Sheriff's Office in October 2011 stating he was in the process of making arrangements to sell his vehicle to Arenivas. Arenivas took the vehicle on a test drive and never returned. Charges were later filed against Arenivas and he was arrested for this offense. He has failed to show for court for this crime. An arrest warrant has been issued for Arenivas. He remains the Borderland hiding with friends or relatives. If anyone has seen or has any information on the whereabouts of Arenivas to they can contact Crime Stoppers at 566-TIPS (8477). Callers will remain anonymous and may be eligible for a reward if the information provided leads to the apprehension of Arenivas.
