### Bridge repair

A new maintenance project on I-10 will be in place starting Sunday, June 3. This project will consist of bridge deck repairs to the Geronimo overpass and Robert E. Lee overpass, as well as repairs to the associated approach slabs along with the installation of armor joints and bridge joint seals. The eastbound side of the Geronimo overpass will initially be repaired. Due to the intensity of the project, it will be necessary to close I-10 from 3 a.m. Sunday to 5 a.m. Monday morning between Airway and Geronimo. This closure is required in order to provide adequate time to perform the required repair work including saw cutting, concrete removal, installation of new concrete and bridge armor joints. The detour route will consist of eastbound traffic exiting off of I-10 at the Geronimo Exit Ramp and returning on to I-10 at the following entrance ramp. As the repair work progresses, crews will continue operations on the westbound lanes. These complete closures will occur every Sunday in June and the first four Sundays in July. Schedules subject to change due to weather conditions.

# **New Clint High School campus nears completion**

CLINT - Of the nine school districts in El Paso County, Clint Independent School District (CISD) is the largest in square mileage (379.9 square miles) and is one of the fastest developing areas in the county. That is one reason the district is looking forward to the opening of its new Clint High School campus.

The new Clint High School is located at the corner of Alameda and Denton (13890 Alameda) on 65 acres of land and is scheduled

school year. A ribbon-cutting ceremony is budget for that school year was \$74.4 million. planned for the new Clint High School in August, stated Laura Cade, CISD public information officer.

Cost to construct the new school is estimated at \$45 million, which was approved by the Clint Independent School District (CISD) Board of Trustees and funded through a bond issuance program passed by voters in 2006. Approximately 75 percent of this cost is being paid by the State's Instructional Facilities Allotment (IFA). About \$10 million of the cost is being paid by Clint ISD taxpayers.

CISD tax rate for 2010-2011 was \$1.33 per to open its doors in August for the 2012-13 \$100 of taxable property value. The adopted


The district currently serves more than 11,700 students.

Six hundred students are expected to attend the new high school when it opens this coming school year. "The 223,668 squarefoot building can accommodate 940 students so there is plenty of room for growth," stated Cade.

The new campus includes the main building, agriculture science, automotive, JROTC, and stadium facilities. The school will have 22 regular classrooms, five science classroom/ labs, four computer labs, an art room, auto collision lab, and 14 other special classrooms and labs, according to Cade.

Other special features of the new campus include inter-active smart boards in all classrooms, a spacious commons area, and multi-purpose gymnasiums for athletics and other events like staff development and indoor firing range competitions.

The campus will also have a cosmetology lab, a professional greenhouse, sealedbuilding envelopes, drought tolerant plants, and occupancy sensors in classrooms. The new stadium will consist of a complete track and field area, artificial turf field, home bleachers with capacity to seat nearly 3,000 fans and visitors bleachers for over 1,500 fans. The stadium will also include a press box, concession outlets and restroom facilities. The new CHS will have two gymnasiums - one of which is a competition gym, but both are designed as multi-use facilities for athletics, staff development, and other presentations, explained Cade. The existing Clint High School, which opened in 1965, currently serves about 550 students. Once the new high school campus opens plans are to renovate the buildings and convert it into the Clint Junior High School campus. The present Clint Junior High School facility will be used to house the Clint Early College Academy, Cade stated. Clint I.S.D. encompasses three major, separate and distinct communities - the Town of Clint, the town of Horizon City,

# NOTICE OF PUBLIC MEETING TO DISCUSS PROPOSED TAX RATE

The San Elizario Independent School District will hold a public meeting at 5:30 p.m., Wednesday, June 6, 2012 in the SEISD Administrative Office, 1050 Chicken Ranch Rd., San Elizario, Texas.

### The purpose of this meeting is to discuss the school district's tax rate that will be adopted. Public participation in the discussion is invited.

The school district has elected to adopt a tax rate before receiving the certified appraisal roll from the chief appraiser(s) of the appraisal district(s) and before adopting a budget. In accordance with Texas Tax Code, Section 26.05(g), the chief appraiser(s) of the appraisal district(s) in which the school district participates has (have) certified to the assessor for the school district an estimate of the taxable value of property in the school district as provided by the Texas Tax Code, Section 26.01(e). In accordance with the Texas Education Code, Section 44.004(j), following adoption of the tax rate, the school district will publish notice and hold another public meeting before the school district adopts a budget.





# Tire dumping must stop

Hola, mi gente. The May 21st Commissioners Court meeting had on its agenda an item dealing with clean up in areas on the far west and far east side outside of the city of El Paso. The dialogue primarily dealt with funding that originated from the Rio Grande Council of Governments (COG).

The COG provides the cleanup money through grant programs that the state and federal governments offer. That funding has been dwindling significantly in the past several years so today and in the future the impetus for the cleanups will be local money.

One the biggest problems that has existed for decades is the dumping of scrap tires. I have seen dumped tires in clumps of a few dozen to over 19,000 tires. In working with TCEQ over a period of 18 months, my office filed a bill that addressed the specific concerns of the agency enforcement division. It was a bill that had support from a variety of entities. Unfortunately, the County of El Paso decided to strongly support a bill that required punching holes in tires; clearly an insignificant effort at eliminating tire dumping.

The problem with the current situation is that those individuals who transport tires are not regulated strongly. They have the option to take all of the tires on their truck to the location where tires are legally and properly disposed; or, they have the option to remove any tires at their discretion.

Through different provisions in the bill I filed, a transporter could be assessed criminal penalties for the first time for unlawfully disposing of tires. Because of the criminal aspect of the regulation, police and sheriff's deputies would have the option of stopping a transporter for reasons such as an improper display of its company on the truck; something that is required now but no one enforces it because it is a civil violation.

Although I will not be returning as the state representative for District 75 in the next session, I have spoken with candidates who are likely to be elected to that office. The bill could possibly be filed again and I hope that I can, in a different elected office, advocate for the support of that bill.

On top of pushing for the bill, I see opportunities for opening dialogues with the private sector for the purpose of getting monetary support for tire cleanups in addition to the other garbage that is dumped by independent contractors and by individuals who cannot, or will not pay the fees at the Clint landfill.

I look forward to pushing solutions that reduce tire dumps and other illegal dumping. Gracias, mi gente, and I remain your friend and public servant, Chente por la gente.

# Buckling up: The simple choice that can save your life

*Click It or Ticket' safety campaign runs through Memorial Day*

TEXAS – All of us are faced with hundreds, if not thousands, of decisions every day. Most don't involve life or death matters, but there is one simple decision that does have lifealtering consequences. Choosing to wear a seat belt every time you're in a vehicle is one of those decisions. It's one act that can save your life or the life of someone you love. And it's also the law.

Whether you're the driver or a passenger sitting in the front seat or the back, Texas

law now requires everyone in a vehicle to be secured by a seat belt. Children under the age of 8 must be in a child safety seat or booster seat unless they are taller than 4 feet 9 inches. Most Texans are buckling up, thanks to the Texas Department of Transportation's annual *Click*  Since roughly one out of every four vehicles registered in Texas is a pickup truck and pickups are twice as likely as passenger vehicles to roll over in a crash, that's cause for concern.

According to a recent study by the Texas Transportation Institute, only 80 percent of pickup truck passengers buckle up. Compare that to the more than 90 percent of passengers in all other types of vehicles who regularly put on their seat belts. The National Highway Traffic Safety Administration reports that half of pickup drivers who died in traffic crashes in 2010 were not wearing a seat belt.

Not buckling up doesn't make sense – financial or otherwise. While a ticket for not wearing a seat belt can cost anywhere from

\$25 to \$250 plus court costs that drive up the expense even more, drivers and passengers who do not wear seat belts put themselves at risk for the greatest cost of all – serious injury or death. Depending on the type of vehicle, wearing a seat belt reduces the risk of fatal injury by up to 60



*It or Ticket* safety campaign. Every May, thousands of local law enforcement agencies join the Texas Department of Public Safety to ticket anyone

who isn't wearing a seat belt or whose children aren't properly secured.

The threat of getting an expensive citation has been a powerful motivator to get more drivers and passengers to buckle up. Since the *Click It or Ticket* campaign began eleven years ago, the state's seat belt use rate has steadily climbed, and now almost 94 percent of motorists in Texas buckle up. The net effect is fewer deaths and injuries. TxDOT's crash statics indicate that 95 percent of the 778,448 Texans involved in crashes in 2010 where there were no injuries were wearing seat belts.

Texas now ranks seventh in the nation for seat belt use. In spite of all the progress we've made, one group of motorists remains significantly less likely to buckle up. That group is pickup truck drivers and passengers.

It doesn't matter what kind of vehicle you're in. It doesn't matter where you're sitting. It doesn't matter if it's day or night. The smart choice is to buckle up, every time, everywhere, and to make sure everyone in your vehicle does the same. Buckling up is the one simple decision that all of us can make every day to save not only our own lives but also those of our loved ones. *Click It or Ticket*. It's the law.

The four Garcia students will use their scholarships to participate in different programs throughout El Paso.


