## **Exodus to El Paso**

Local historian Elias Bonilla, a wellknown historian from Tornillo, Texas, will give a presentation, entitled The railway exodus of the Mormon children and women to El Paso, at 2 p.m., Saturday, September 1, in the El Paso Museum of History's Seminar Room, 510 N. Santa Fe Street. The Saturday afternoon event is in conjunction with the history museum's current exhibit, titled Finding Refuge in El Paso: The Mormon Exodus from Mexico A Centennial Celebration, 1912 – 2012. According to Bonilla, it was on July 28, 1912 that the order was given to evacuate all women and children from the seven Mormon colonies in Northern Mexico. They were sent by train to safe refuges in selected communities in the United States. This exodus was in the aftermath of the Mexican Revolution. The men staved behind to protect their homes and agricultural properties from marauding revolutionaries who had turned against the new government.

## Over 6,000 students return to Canutillo schools

CANUTILLO – More students are attending Canutillo Independent School District (CISD) schools than ever before.

On its first day of school on Monday, August 27, CISD reported an enrollment of 6,128 students – up from 5,898 students at the same time last year.

The growth has mostly come from the new neighborhoods in the Upper Valley and Helen of Troy areas that include several subdivisions like Cimarron, Del Sol, Canutillo Palms, and College Park among others. As of today, CISD's

#### Socorro Search

On Friday, Aug. 10, 2012, City of Socorro Police officers secured the area around 10331 North Loop because of a reported assault. They found the victim just sitting on the ground in the middle of the parking lot. The victim went on to explain she was actually sitting in her car, with the door open and her left leg hanging out. This all happened in the parking lot of the La Fiesta Bar. That's when our suspect, Paola Pulido, walked up to her and asked her if she had anything to say to her. The assault escalated to the point that Paola slammed the victim's car door about three times on the victims left leg actually breaking it in three places. Testimony indicates Pulido then grabbed the victim and pulled her onto the pavement and the ground. The victim tried to stand up to either make a run for it or at least defend herself but never could stand up because of her broken left leg. Pulido is described as Hispanic, 5'4" tall, between 140-150 pounds and about 30 years old. Pulido continued to hit her and pull her hair while the victim was on the ground. That's when others got involved and separated the two. The victim's broken left leg required surgery. Investigators have not been able to get a picture nor a location of Pulido, but they know she's still in the area. Right now, if she comes forward she faces assault charges. But if she is caught by law enforcement she could face other additional charges. If anybody is found guilty of helping her hide from police, they too could face charges. If you've heard something or know where she'd hiding call the police. In the City of Socorro the number is 858-6986.





Fabens will count heavily on the play of quarterback Eric Ochoa and a punishing ground game featuring Alex Ortega and J.J. Pacheco.



## Your good health By Paul G. Donahue, M.D.

DEAR DR. DONOHUE: My 88-vear-old relative has high blood pressure and atrial fibrillation, both of which are well-controlled by medication. She is mentally sharp but has developed arthritis in various joints. She's been told that she can't take any medicine for pain because it would interfere with her medicines for blood pressure and atrial fib. I know she could have a better quality of life with less pain. Is there something she can take? - A.H.

I have to presume your relative has osteoarthritis, the kind of DEAR DR. DONOHUE: I just arthritis almost all older people develop. Cushioning cartilage in joints crumbles and eventually becomes functionless. Bone rubs against bone, and that is painful and stiffens joints.

Your relative ought to try heat in the form of hot baths, hot packs or heating pads. Heat lessens joint pain. If heat doesn't do the trick for her, she should try ice packs. Heat can be left on a joint for 15 minutes; ice for 10.

If she has hip, knee or foot arthritis, padded shoes or padded shoe inserts lessen the force foot hits the ground.

An exercise program supervised by a physical therapist will strengthen muscles around the affected joints, provide them greater range of motion.



## El Paso County Water Control and Improvements District No. 4 Notice of a Finding of No Significant Impact

The USDA, Rural Utilities Service has received an application for financial assistance from the El Paso County Water Control and Improvements District No. 4 (District). The proposal consists of water and wastewater improvements within the town of Fabens, El Paso County, TX and is summarized below:


- A new 500,000-gallon ground storage tank, booster station and 8-inch water main (I-10 site) would be constructed at 1770 N. Fabens Street within University Land property.
- A new 450-foot deep water supply well (10th Street site) would be drilled and equipped with a well pump, motor, piping and appurtenances within the existing Booster Station site at 991 Walker Street.
- A new 700 gallon per minute nano-filtration system (10th St. site), building, piping and appurtenances would be installed within the existing Booster Station site at 991 Walker Street.
- 8,100 feet of 16" water main pipeline would be constructed between the 10th Street Booster Station site at 991 Walker Street and the proposed 500,000-gallon ground storage tank (I-10 site) at 1770 N. Fabens Street on Citizens Transfer Station Landfill Road.
- 5,025 feet of 12" force main would be constructed between the Ikard Lift Station at 1212 E. Main Street and the District's wastewater treatment plant (WWTP) at 17270 Alameda Street within Alameda Ave (TxDOT ROW).

As required by the National Environmental Policy Act and agency regulations, the Rural Utilities Service prepared an Environmental Assessment of the proposal that assessed the potential environmental effects of the proposal and the effect the proposal may have on historic properties. The Environmental Assessment was published on July 12, 2012 and July 19, 2012 for a 30-day public comment period. No comments were provided, therefore, no changes to the Environmental Assessment document are required. Upon consideration of the applicant's proposal, federal and state environmental regulatory and natural resource agencies, and public input the agency has determined that the proposal will not have a significant effect on the human environment and for which an Environment Impact Statement will not be prepared. The basis of this determination is the lack of adverse impacts to prime and unique farmlands, formally classified lands, floodplains, wetlands, waterbodies, and water quality. The proposal is not likely to adversely impact federal or state protected species. The proposal will not result in disproportionate adverse impacts to high minority and low-income populations. The impacts to air, noise, and traffic patterns within the project area will be temporary and minor.

In order to avoid or minimize any adverse environmental impacts, the Rural Utilities Service will require the applicant to incorporate the following mitigation measures into the proposal's design: Ceasing all work in the immediate area of discover if cultural materials are encountered during construction and notifying the appropriate authorities; and implementing standard dust and noise minimization measures with construction activities occurring between 7:30 a.m. and 5:00 p.m.

A general location map of the proposal is shown below.




