EPE combines natural gas, solar energy resources for future needs

EL PASO COUNTY – El Paso Electric (EPE) officials reported recently that construction is underway on the first phase of the Montana power plant near the intersection of Montana and Zaragoza streets in far-east El Paso County. The plant’s first two generating units are expected to be operating by summer of 2015.

The Environmental Protection Agency (EPA) issued a greenhouse gas (GHG) permit for EPE’s four-unit natural gas burning Montana Power Station last spring, and it became effective after no appeals were filed prior to the expiration of the appeals period.

The issuance of the EPA permit allows EPE to stay on track to meet the growing needs of the communities it serves, stated EPE officials. EPA’s permit action follows the Texas Commission on Environmental Quality’s 2014 decision mandating that a separate permit be issued for emissions other than GHG.

In response to nearby neighborhood residents’ concerns about the GHG permit, EPA stated that the agency took into account that EPE, at its own initiative, undertook special efforts to reach resolution with community members including an agreement for ongoing community engagement through a citizen advisory panel.

The new units are designed to work in concert with the 107 megawatts (MW) of

solar energy that is being added to EPE’s power grid by 2016.

As solar power prices decrease, it is becoming a more-attractive form of energy and EPE is taking advantage of it. EPE entered into a 20-year agreement to buy power from the 50 MW Macho Springs solar plant being built near Deming, New Mexico by First Solar Inc. (of Tucson, Arizona). It is New Mexico’s largest solar project.

According to EPE officials, the new solar facility, which is about the size of 300 football fields, will generate enough clean energy to power more than 18,000 homes. This project will also displace more than 40,000 metric tons of CO₂, the equivalent of taking 7,500 cars off the road, and will displace more than 340,000 metric tons of water consumption annually in Southern New Mexico and West Texas, officials reported.

Macho Springs, along with three other New Mexico solar plants including one in Santa Teresa and an additional 10 MW solar plant that will be completed in El Paso by the end of the year, will expand total solar generation to 6 percent of EPE’s dedicated generation resources.

Earlier this year, EPE signed a 30-year agreement with Newman Solar LLC (owned by Colorado-based juwi solar Inc.) which is building the 10 MW solar energy facilities in Northeast El Paso next to EPE’s Newman Generation Station. The new installation is expected to go operational by the end of 2014 and will provide power to an additional 3,800 homes.

Also, plans are in the design stages for two

utility-scale solar energy generating facilities that could add a combined maximum capacity up to 25 MW. The largest project, a 20 MW solar facility, would be located on approximately 218 acres at the Fort Bliss Army post. The second project is a 3 to 5 MW solar facility that would be located on approximately 20 acres at EPE’s new Montana Power Station. The anticipated commercial operation date for both projects is targeted for the end of 2016.

While EPE’s solar portfolio is growing, the company still obtains most of its power from the Palo Verde nuclear power plant near Phoenix, which provides up to 633 MW of power, and from three El Paso natural gas-fueled power plants, which provide up to 1,023 MW. It also gets power from the Four Corners coal-fired power plant in New Mexico in which it has a seven percent part ownership.

“This combination of clean burning natural gas and solar generation will efficiently provide the power necessary to meet the anticipated growing needs of our region,” Tom Shockley, EPE’s Chief Executive Officer, told reporters recently.

EPE first began serving its customers in 1901. It was then known as the El Paso Electric Railway Company. Today, El Paso Electric is a regional electric utility providing generation, transmission, and distribution service to approximately 394,000 retail and wholesale customers in a 10,000 square mile area of the Rio Grande Valley in West Texas and Southern New Mexico. Its service territory extends from Hatch, New Mexico to Van Horn, TX.

Take action if your credit card stolen

Despite high-profile media attention, the odds of having your credit or debit card number stolen by crooks remains at historically low levels. That said, it's always good to know what to do in case lightening does strike and someone fraudulently uses your card. Left unchecked, they might try to run up bills, drain your checking account or worse – steal your identity.

Here are actions to take if this happens to you.

First, contact the bank or credit union that issued your card. You'll find a toll-free number on the back of your card, on your billing statement or at the company's website. Close the compromised account and open a new one with a different account number. Change related passwords or PIN numbers and notify companies that have automatic payments tied to the closed account to make sure you don't miss a payment. Also log all calls, letters and emails you have with your card issuer about the fraud – this will be helpful if you need to file a claim or police report.

Contact one of the three major credit bureaus, Equifax (888-766-0008), Experian (888-397-3742) or TransUnion (800-680-7289), and place an Initial Fraud Alert on your credit file if you suspect you have been, or are about to be, a victim of identity theft. Whichever bureau you contact will notify the other two to do the same. If you wish, you can renew these fraud alerts each quarter, free of charge. If you determine that you actually have suffered identity theft, you can also file an Extended Fraud Alert, which will stay on your reports for seven years.

Placing a fraud alert entitles you to one free credit report from each bureau. Although the alert makes it harder for someone to open new credit accounts in your name, it won't necessarily prevent them from using existing accounts. That's why it's important to close compromised accounts and to carefully review your credit reports for errors, fraudulent activity, or suspicious credit inquiries from an unfamiliar source. Also be aware that posting a fraud alert could delay your own ability to obtain new credit.

If you determine someone has stolen from your account or your identity has otherwise been compromised, file an identity theft report with the police. The Federal Trade Commission's "Defend: Recover From Identity Theft" website contains step-by-step instructions for completing and filing the report with local, state and federal law-enforcement agencies (www.ftc.gov/consumer).

Also send copies of the report –

by certified mail, return requested – to the credit bureaus and companies whose accounts were impacted. You can also file a complaint with the FTC, which will enter the information into a secure online database shared by thousands of civil and criminal law-enforcement authorities worldwide (<https://www.ftccomplaintassistant.gov>).

Most card issuers provide "zero liability" coverage for unauthorized credit and debit card use when you promptly report the loss. Rules vary, so ask your bank or credit union for its policies.

VetSuccess on campus

What started as a pilot program at the University of South Florida in 2009 to help veterans make the transition from the military to academics now has expanded to VetSuccess centers on 94 campuses across the country.

Part of the VetSuccess program includes having Department of Veterans Affairs vocational rehab counselors and a Vet Center coordinator right on the campus. Those counselors keep in touch with both VA Vet Centers and the other medical facilities where they can refer veterans for medical services and give help in applying for veterans benefits.

The schools themselves are in favor of the arrangement and even provide space on the campus. The schools are chosen because of their proximity to other VA facilities, such as a regional offices, vocational rehab centers, employment services offices, medical centers or Vet centers. The fact that the pilot program has grown by to more than 90 schools in four years is a testament to its success.

If you've considered going back to school but haven't because of your comfort level in a civilian or academic setting, call the counselors at your school of choice. Go in for a talk and see what types of help they can offer you. They'll be able to walk you through the benefits you could get as a student.

Ask about peer-to-peer counseling, and let them hook you up with veterans who've been where you are. You'll be able to ask your questions and get advice about what steps you need to take to have the best chance of success.

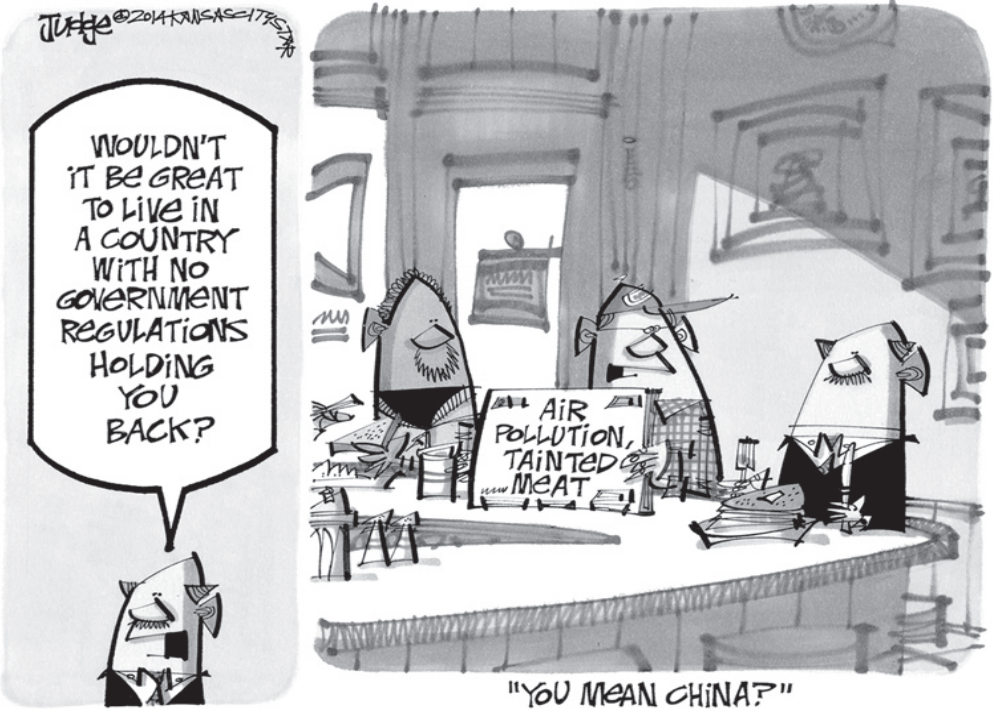

Steel mill partners with American Red Cross on disaster preparedness and relief efforts

When disasters happen close to home or across the nation, the American Red Cross is there to provide shelter, food, lifesaving blood, emotional support, and other assistance to those in need.

To enable the Red Cross to respond immediately to the needs of individuals and families impacted by disaster anywhere in the United States, regardless of cost, an American Red Cross Disaster Responder Program was established several years ago. The program consists of a select group of leading corporations that provide the highest level of support to American Red Cross preparedness and relief efforts.

A member of this critical responder program is ArcelorMittal. Located alongside Interstate-10 highway near the Rio Grande River in El Paso County's Upper Valley, is ArcelorMittal's Vinton steel mill, which produces more than 260,000 metric tons of steel using electric arc furnace (EAF) technology and rolls approximately 240,000 metric tons of steel, according to ArcelorMittal Vinton officials.

ArcelorMittal Vinton currently has about 350 employees and specializes in producing rebar for the commercial and industrial construction industries, as well as fabricated products, grinding balls and smooth rounds.

According to Penny Ledesma, Corporate Responsibility Manager for ArcelorMittal Vinton, the steel mill provides national leadership for disaster response by ensuring that the Red Cross can be on the scene of a disaster at a moment's notice.

To bring awareness to the disaster relief efforts, ArcelorMittal facilities from across the country are partnering with their local Red Cross chapters to host events for employees and the greater community during September, which is National Preparedness Month, Ledesma stated.

"As ArcelorMittal employees, we are members of the Red Cross family, one of the largest humanitarian forces in the world," Ledesma declared. As members, the steel mill's workers are offered important benefits including access to an online training program, a suite of mobile apps that allows access to

information on what to do before, during and after disasters and emergencies, and discounts when purchasing lifesaving products from the Red Cross store.

American Red Cross officials stated that they rely on the generous support of the disaster responder program partners because it allows them to prepare for the unexpected and respond immediately when an event occurs. By providing funding in advance to disaster relief, the responders' program ensures that the Red Cross is able to sustain its mission and provide help to those affected by a disaster, Red Cross officials explained.

As one of the nation's premier humanitarian organizations, the American Red Cross helps people in need throughout the U.S. and, in association with other Red Cross networks, throughout the world. Subsequently, its efforts depend on the many generous contributions of time, blood, and money.

As if a guy named Spielberg or Scorsese or Howard mailed in the script, Jeter singled in

the winning run in the bottom of the ninth to win his final game in Yankee Stadium.

Jeter would also come through in his final big league at bat in Boston on the final day of the season.

Jeter singled in a run before being taken out of the game for a pinch runner in front of thousands of appreciative Red Sox fans standing in unison.

Now this isn’t the first time a player has ended his career in front of a New York City or Boston crowd so why all the love, emotion and respect?

Every decade or so a player comes around that transcends sports in a way that kind of captures how you pictured the game when you were a little kid.

These special players play the game and conduct their lives the way you thought all your heroes did.

Of course, all of us kids eventually grow up to realize those kind of players, and people, just don’t exists anymore.

Ah but they do.

Sometimes players like Cal Ripkin Jr. and Tony Gwynn and Peyton Manning and David Robinson and Mariano Rivera and Grant Hill

and Jason Witten and Calvin Johnson and J.J. Watt and Russell Wilson and Roger Federer come around and remind us that despite all the bad news the media finds so sexy – sports is littered with good people.

But sometimes an athlete comes around who distinguishes himself among the very best.

He wasn’t the best at anything, but he was very good at everything.

It seemed like every single time the Yankees needed something special to spark the team, it was inevitably Jeter who would make the catch or get the hit or steal the base.

His clutch plays are so legendary that he has two nicknames, “Captain” and “Mr. November.”

But even more than the way he played the game on the field was the way he respected it.

Sometimes a player is considered special by the things he never did.

He never showed up the other team. He

never liked to talk about himself. He never failed to hustle on every play. He never got into trouble with the law. He never had to apologize about doing something stupid and he never put himself ahead of the team.

The news surrounding every sport always seems to be riddled with stories about infidelity and drug arrests and weapons charges and theft and PEDs and sexual assaults and domestic abuse and anything else negative under the sun.

Men like Derek Jeter come around to remind us of the other untold stories about honor and respect and selflessness and work ethic and reliability and loyalty.

Watching a Yankees game next season will seem awfully weird without #2 standing in the infield. It’ll certainly feel like there’s something missing.

There is.

Though they’re still out there, the numbers of Derek Jeter-like role models are dwindling.

Maybe there are young players out there who saw the way Jeter conducted himself through his final season and say to themselves, “I want to live my life like that guy.”



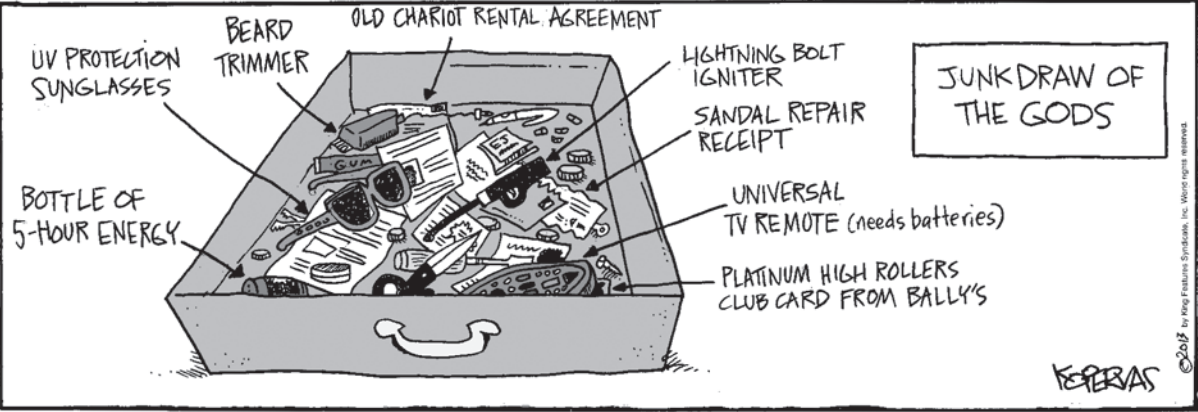

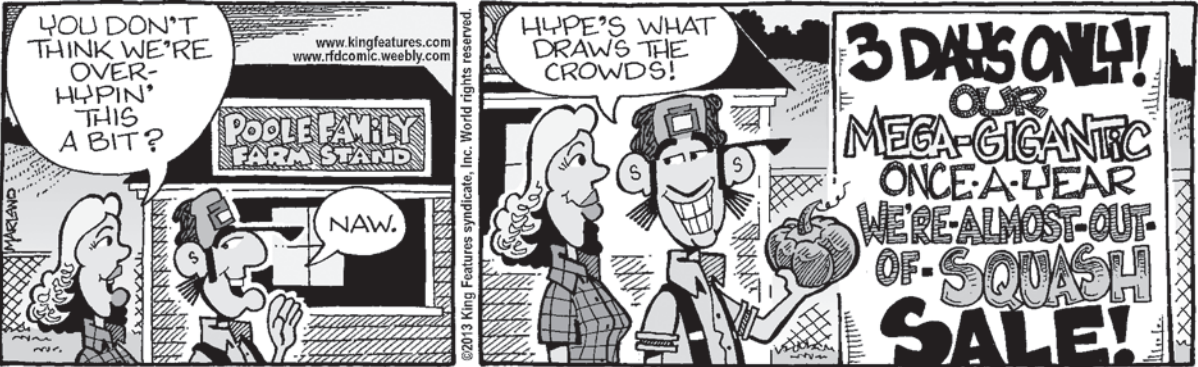

Your good health

DEAR DR. DONOHUE: I have a yearly checkup with a number of blood tests. All has been well for a number of years, except for my HDL cholesterol. I am a 62-year-old woman, and my HDL has hovered around 39. I watch my diet carefully, exercise daily and have taken and am still taking niacin, but the HDL refuses to budge. My total cholesterol and LDL cholesterol are fine. What should I do? – L.Y.

HDL cholesterol is the so-called good cholesterol. It’s believed to remove cholesterol from the walls of arteries and take it to the liver for disposal. For women, HDL cholesterol ought to be 50 mg/dL (1.3 mmol/L) or higher. For men, the target is 40 (1.04) or higher. British researchers have punctured the HDL balloon. They say that HDL cholesterol doesn’t protect the heart and that its benefits have been greatly overblown. HDL is a complicated substance, composed of a variety of components, each having different and often opposing effects. The full extent of how it figures into artery-hardening and heart disease hasn’t been completely explained. If you were my patient, I’d tell you to forget your HDL cholesterol. You’ve done everything you can to raise it, but it hasn’t budged. More importantly, your total cholesterol and bad cholesterol, LDL cholesterol, are at favorable levels. The main attention should be directed to these cholesterol

components. If your doctor hasn’t said you need to be strict about HDL cholesterol, don’t pay so much attention to it. DEAR DR. DONOHUE: I had a persistent cough. My primary-care physician thought I was allergic to Old Spice aftershave lotion, so my husband stopped using it, to no avail. Then she thought it might be acid reflux, and put me on medicine that did nothing. She sent me to a specialist, who took chest X-rays and all that good stuff. He gave me a cough medicine with a tiny bit of codeine in it. He said my cough would stop shortly. It didn’t. He sent me to an ear, nose and throat doctor. The first question he asked was what the humidity of our house was. It runs around 40 percent to 45 percent. He told me to get it up to 50 percent to 75 percent. We did, and my cough left in four days. It took three years and four doctors before I learned what was really wrong. I hope you can pass this along to the person with a chronic cough. – R.G.

A dry environment is not often thought of as a cause of cough. I’m happy the ENT doctor gave you and me the tip. The three major causes of a persistent cough are asthma, postnasal drip and gastroesophageal reflux disease (heartburn). R.G. has alerted us to think of other possibilities. Trick, don’t treat cyber thieves

Kids and kids at heart look forward to the end of October, when we use tricks and treats in equal measure to celebrate Halloween. No doubt, you’ll be passing out treats to costumed hobgoblins and hooligans in your neighborhood this Halloween night. But be careful that you’re not fooled by a different kind of trickster looking for a larger handout – such as your identity. October also is Crime Prevention Month and National Cyber Security Awareness Month. So it is the perfect time to remind you to safeguard your personal information – whether it’s online, on paper, or given out in person. Don’t share your personal information, such as your full name, date of birth, mother’s maiden name, and your Social Security

number, with anyone unless you are certain it is safe. Shred paperwork that includes personal information before throwing it out. And never reply to emails claiming to be from Social Security and asking for such information. Finally, don’t carry your Social Security card or number with you. These tips should help reduce your risk of identity theft. Identity theft is one of the fastest-growing crimes in America. 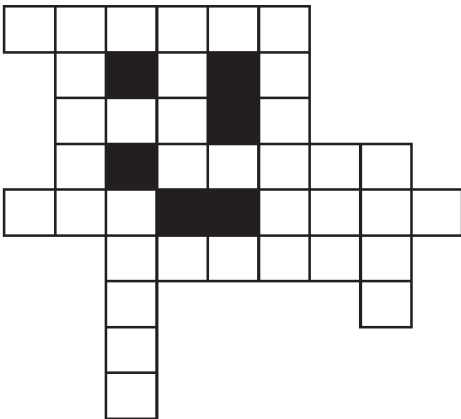
