# Resetting your retirement after divorce

Retirement planning can face derailment after a divorce. Here are a few steps to reset one’s retirement goals after divorce.

Gather a personal finance team. It’s a good idea to hire a financial professional to offer advice on all relevant financial, investment, tax, estate and retirement details of a divorce negotiation. Afterward, individuals may continue with these advisors or interview new ones. Personal referrals are best, but the following resources may help:

- The Certified Planner Board of Standards;
- The Association for Financial Counseling and Planning Education;
- The Financial Planning Association; and
- Your state CPA society.

Budget. Spending priorities can change after a divorce. Newly divorced spouses should track all new spending diligently so they can reset their budget for retirement. (<http://www.practicalmoneyskills.com/retirementcalc>) Qualified financial advisors can help review a divorcing individual’s budgeting strategy to make sure as much money goes to savings as possible.

Evaluate all retirement assets. When divorce is finalized, it is a wise idea to take inventory of all retirement assets to determine whether they still fit investment goals. If one’s 401(k) or employer plan administrator does not have a calculator to help estimate how accounts will grow under certain investment scenarios, refer to Bankrate.com’s various retirement calculators for help.

Review Social Security benefits. Most experts urge individuals to wait as close to age 70 as possible to start drawing their Social Security benefits. Check the Social Security Administration’s Delayed Retirement Benefits page (<http://www.ssa.gov/retire2/delayret.htm>) for a discussion of how and when to start taking payments. Also keep in mind that retirees married 10 years or longer who have stayed single may be entitled to Social Security benefits on their ex-spouse’s record if they meet certain requirements.

Be honest about new financial limitations. If a serious retirement shortfall emerges after divorce, it’s important to reset financial

## PTSD book for kids

Veterans with PTSD carry a big burden: not always knowing how to control a reaction to a trigger. Veterans who have small children have an even bigger burden when the little ones don’t understand what’s wrong.

Seth Kastle, a career veteran with multiple deployments under his belt, has taken matters in hand and written a book to help them understand why he is the way he is now – and that it’s not their fault.

While some PTSD includes symptoms of nightmares or insomnia or any number of other symptoms, Kastle’s manifested in anger, and he couldn’t explain it to his daughters.

“Why Is Dad So Mad?” should be mandatory reading for veterans with PTSD and their small children. The book is loaded with kid-friendly pictures, with the tale told by a family of lions.

The most overriding message about the book came from Kastle’s 6-year-old daughter: “No matter what, when they’re mad or sad at you, they still love you.”

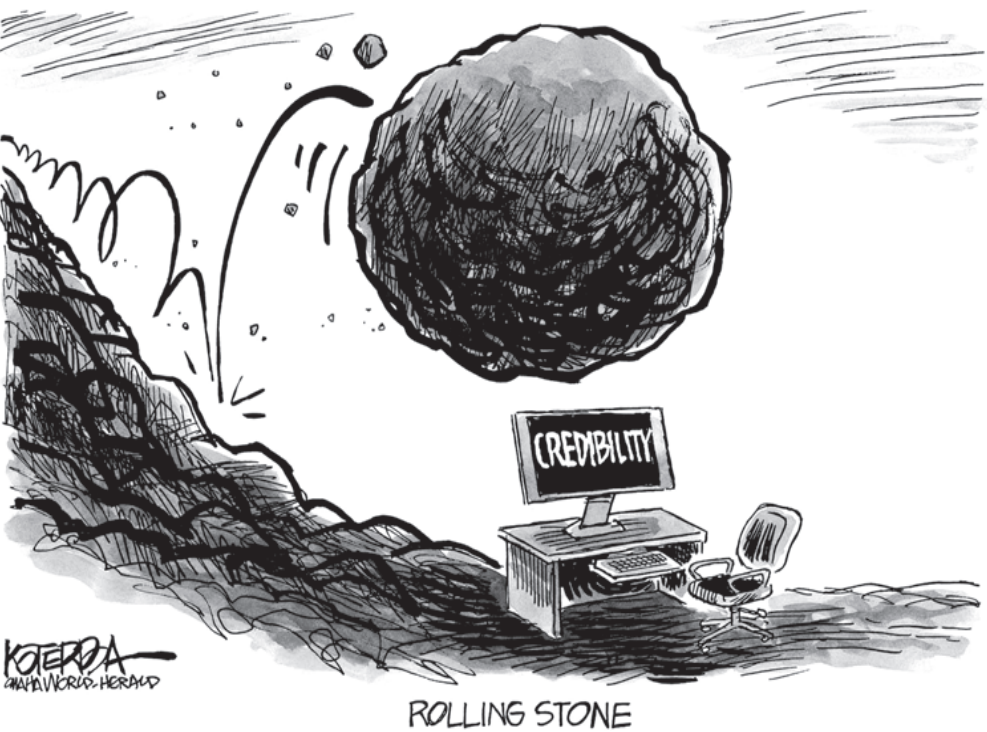
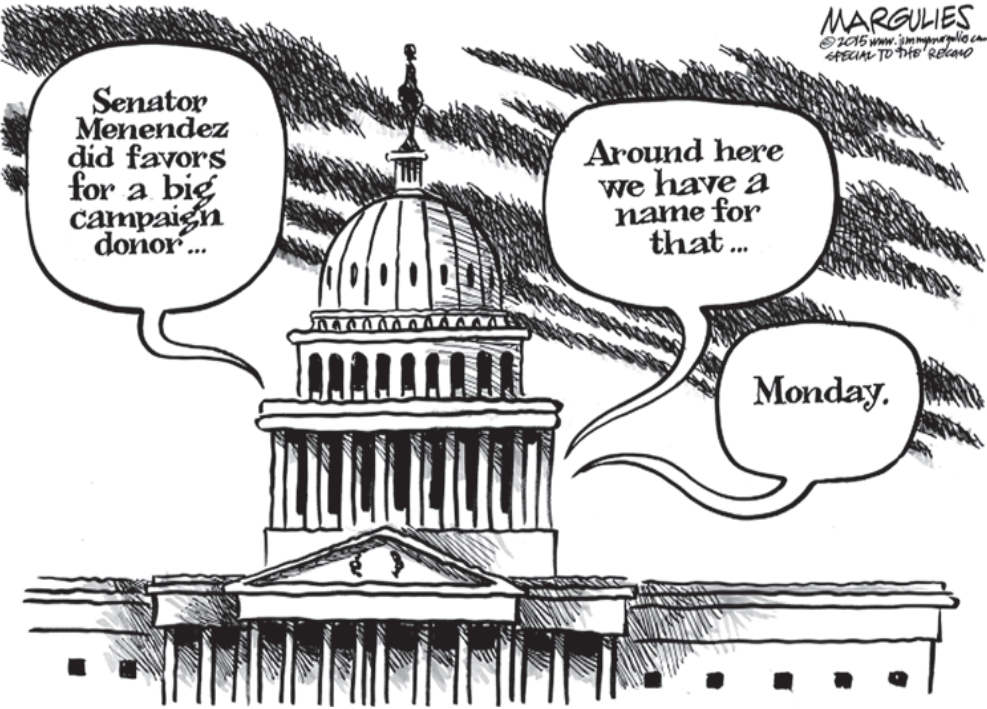
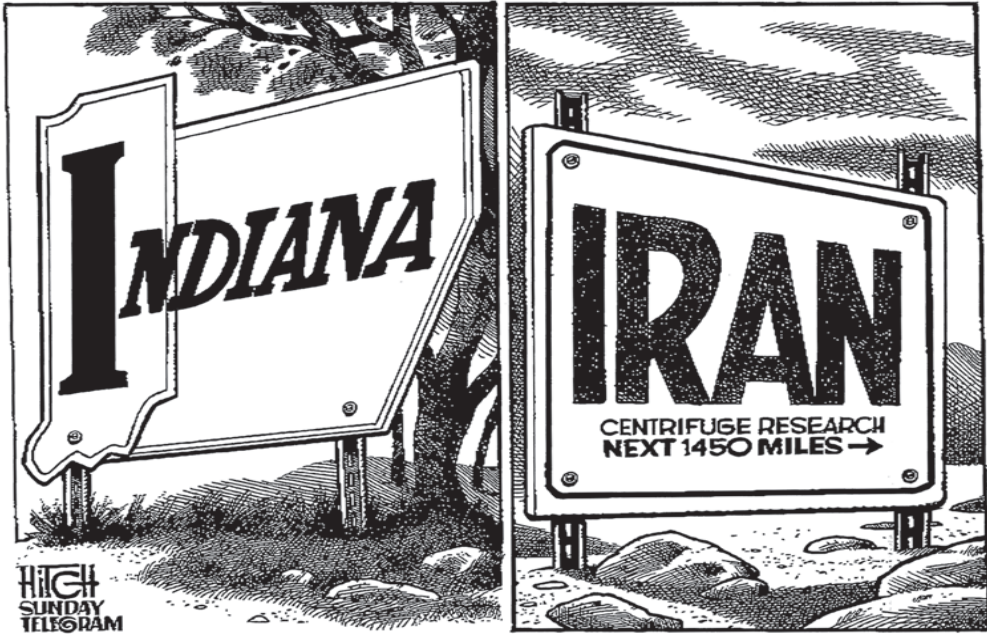

‘Income confiscation’ is taking away the good life from American wage earners

*The liberal notion of ‘income inequality’ is a divisive political ploy*

NATION – It’s not “income inequality” that threatens the future economic growth of our country, it is “income confiscation” that saps our strength, according to Dan Weber, president of the Association of Mature American Citizens (on the web at [www.amac.us](http://www.amac.us)).

America was built on the premise that “hard work deserves to be rewarded, not deterred, and we reward hard work in a free society with what we call income,” Weber explained.

He said that “the economy slows when the incentive to work is replaced by government programs that create dependence. It happens when our leaders beat the war drums of class warfare and income inequality, instead of encouraging Americans to work and allowing them to keep the income they sacrifice to earn.”

In an Opinion Article published at Townhall.com this week, Weber railed against the “unconscionably divisive” tactics that liberal politicians are using these days to win votes. “Chief among their ploys is the fabricated notion of income inequality, a campaign phrase with a nice ring to it, if you are a politician who has little else to offer.”

Weber pointed out that while “all men are created equal,” as the Declaration of Independence phrases it, each of us is

“blessed with different talents, levels of opportunity, ambitions and the proclivity or disposition for work.” The incentive for that disposition for work is a paycheck, he said.


Therefore, he added, “The real culprit that is hurting American workers is not income inequality, it is government gluttony, or in a phrase, income confiscation. We work hard, and the government takes more and more of what we earn. Bloated taxation, or income confiscation, is destroying the country we love.”

Weber offered solutions as well as opinion. He said: “We have to cut taxes and discontinue programs that do not work, that take away jobs and responsibilities from the private sector that belong there, that the president thinks buy him votes, or that a congressman considers his personal pet project – all with your money. We have to root out the pervasive overspending and fraud in government and genuinely commit to eliminating wasteful spending.”

The AMAC chief said we need to neutralize the impact of the invective that left leaning politicians are using to recruit voters.

“The liberals have used the term Income Inequality in conjunction with their attacks

# Canutillo ISD adjusts school boundary lines

The Canutillo Independent School District established new

boundary lines for its elementary schools as it prepares to open its newest elementary campus this summer. The CISD Board of Trustees approved the boundary changes in a unanimous vote on

Feb. 24, 2015, after reviewing three different scenarios.

The adopted scenario, “Scenario 2,” established an opening enrollment of 406 students for the new Congressman Silvestre and Carolina Reyes Elementary School and will alleviate overcrowding at three CISD elementary schools. No boundary changes occurred to the Deanna Davenport Elementary School located in the Westway neighborhood. The opening enrollment number at Reyes Elementary was intentionally set low to accommodate the arrival of additional students in the fast-growing neighborhoods along the I-10 and Transmountain

Road corridors.

“We invested a large amount of time to collect sound data, establish effective decision objectives, and include our entire community to review and comment on these changes,” said CISD Superintendent Dr. Pedro Galavíz. “These transparent efforts have paid off so that we can focus on the final construction and staffing of our new school together with registering new and returning students at all of our high quality campuses.”

The process to redraw the boundary lines began last year with district administrators compiling information from the district, the city’s planning and inspections department, the county, and from developers and homebuilders in the district. CISD established five objectives for redrawing

the boundary lines: anticipate growth; keep neighborhoods together; recognize federal funding implications based on student demographics; alleviate overcrowding at target schools; and maximize CISD facilities. CISD officials held 10 community meetings throughout the district to present the proposed changes to parents and students as well as to district staff and administrators.

The new elementary school boundary map is posted on the homepage of the CISD website. Registration for the 2015-2016 school year will occur May 4-8 for elementary schools, May 18-21 for middle schools, August 10-14 for Canutillo High School and the first week of August for Northwest Early College High School.

# School districts, Town of Anthony schedule elections for May

EL PASO COUNTY – Elections for school boards, a bond issue, and a municipality in out-lying El Paso County communities are less than a month away as early voting period is slated to start Monday, April 27 and continue through Tuesday, May 5. Election Day is scheduled for Saturday, May 9.

On the ballot for May 9 are elections for Anthony Independent School District, San Elizario Independent School District, Socorro Independent School District, Clint Independent School District, and El Paso Community College (EPCC). The Town of Anthony is set to elect a new mayor and fill two council member slots.

Anthony ISD will have three at-large board of trustees seats up for election in May. Only three candidates are running for election, so they will not be contested races. Current board president Christine Singh is seeking re-election, as is board secretary Mary R. Jones. Roberto Guerrero Jr. is campaigning for the other spot on the board as current trustee Robert M. Haro Jr. is not seeking re-election.

Four at-large board of trustee seats for San Elizario ISD are included in the upcoming election. The seats are numbered 4 through 7. Place 7 will be the only contested race with

two candidates on the ballot. Current board member Armando Martinez will face challenger Bernice Barragan. Incumbents Vicente Delgadillo (Place 4), Antonio Araujo (Place 5) and Irene Jaquez (Place 6) are running uncontested.

Socorro ISD has incumbent HectorGonzalez running unopposed in District 1 (Montwood); and two at-large seats are being sought by Antonio “Tony” Ayub (incumbent), Michael Najera (incumbent), Frank Del Toro, and Kenneth Gezelius.

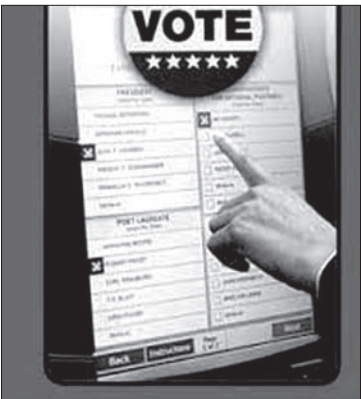
Voters in the Clint ISD will be asked to approve a bond issue in the May election. Clint ISD officials are proposing an \$80 million bond sale to address facility upgrades and overcrowding.

Under the proposal, the tax rate would increase by about 7 cents to about \$1.41 per \$100 property valuation. That translates to an increase of \$49 a year on the district’s portion of a tax bill on a home valued at \$75,000 with a standard exemption, according to Clint ISD officials. The Clint

district, which serves about 11,800 students in 14 schools, has an annual operating budget of about \$84 million.

EPCC also will hold elections in May for two Board of Trustees positions. Three candidates have filed to run. The race for the District 3 seat, primarily representing Central El Paso and the Fort Bliss area, will be the only competitive race. Current trustee Belen B. Robles, a consultant, is seeking re-election. She will run against U.S. Army Master Sgt. Joe Fierro Jr., who oversees mobilizations and deployments of all units in the Fort Bliss area. Incumbent Brian Haggerty is the lone candidate for the District 2 position, which represents Northeast El Paso.

As for the Town of Anthony, up for election are Mayor, Place 1 and Place 2. Current mayor Lee Vela has decided not to seek a second term, and running to replace him are current council member Benjamin Romero and Martin Lerma, a firefighter for the West Valley Fire Department



Besides the elections within El Paso city limits, voters in some of the other county communities will also go to the polls this May 9. Anthony ISD, San Elizario ISD, Socorro ISD, Clint ISD, El Paso Community College (EPCC), and the Town of Anthony are scheduled to hold early voting from April 27 through May 5.

# The Chihuahuas are an El Paso success story

It’s amazing how quickly, no matter how bright and shiny it was coming out of the box, a child will become board of a new toy.

Maybe it’s the short attention span; maybe it’s one of those “the grass is always greener” kind of things, but in the mind of a child – the clock is ticking on the newness factor of a toy and the meter speeds up with each passing day.

When that meter hits zero, usually in a couple months, the toy is tossed aside never to be played with again.

Don’t get me wrong, the toy will always hold some sentimental value with the kid and will always be thought of fondly, but it will become an afterthought.

And when you really think of it, adults aren’t very different.

We get excited about the unveiling of a new gadget or a new restaurant or a new blockbuster movie, but soon after, we jump ship and begin our search for the next big thing.

Nowadays, if anything stays around for

more than a few months it is considered a success.

Well the biggest success story of professional baseball last summer was the El Paso Chihuahuas.

Rarely does a minor league team get the kind of national attention the Chihuahuas did in their first year of existence.

And remember that this came after months of litigation and vocal resistance from El Pasoans who had developed a four-decades-long intolerance to change.

In fact, many locals are so fearful of change that they vigorously fought the demolition of a couple of dirty non-working smokestacks.

By the way, now that they’re gone, does anybody miss them? Has anybody even thought of them?

Case in point.

When it was inevitable that the franchise would become a reality, many on the opposition said that the novelty would fade quickly. That the newness factor would dwindle after the first season and fans would lose interest.

And instead of hoping for an El Paso success story, many of the more vocal opponents have been monitoring the

situation closely just waiting for that “I told you so” moment once the attendance figures proved their somber predictions correct.

Usually it’s sad to bring bad news to people. This bad news I deliver with much delight and an ear-to-ear smile.

Over 10,000 fans crammed Southwest University Park last Thursday for the Chihuahuas season opener. Over 8,000 followed on Friday and over 9,000 attended the game on Saturday.

And it was amazing how many of those fans were wearing El Paso Chihuahuas caps and t-shirts and jerseys. Even the babies and small kids they were carrying around were decked out in Chihuahuas’ garb.

Whether it was the game itself, the food, the drink, the between-innings entertainment or just the idea of having something else to do in El Paso – the fans were having a blast.

I looked around closely and I didn’t see a single person lamenting the fact that city hall was no longer standing on that site.

The team’s general manger Brad Taylor told me that ticket sales were way ahead of the over half-a-million that attended in

season one.

He said the interest in the franchise was skyrocketing and that he felt the city had totally embraced the team as its own mainly because they had tried so hard to keep the style and feel of those “Jim Paul” days at Dudley Field and Cohen Stadium.

You can also throw in the fact that the Chihuahuas play in the best minor league ballpark in the United States. Plus let’s not forget that this is Triple-A baseball; one small step from the major leagues. So the quality of play is the best it’s even been here.

So while there are still some here that have stubbornly proclaimed they will never attend a game, the vast majority of the city, some kicking and screaming, will go out to the ballpark and have a great time.

They’ll take their visiting family and friends to a ballgame... and they’ll go a second and third time.

And as El Pasoans come to the realization that taking a chance can actually pay off, they may start looking around the city and ask themselves, “what else around here can we change?”

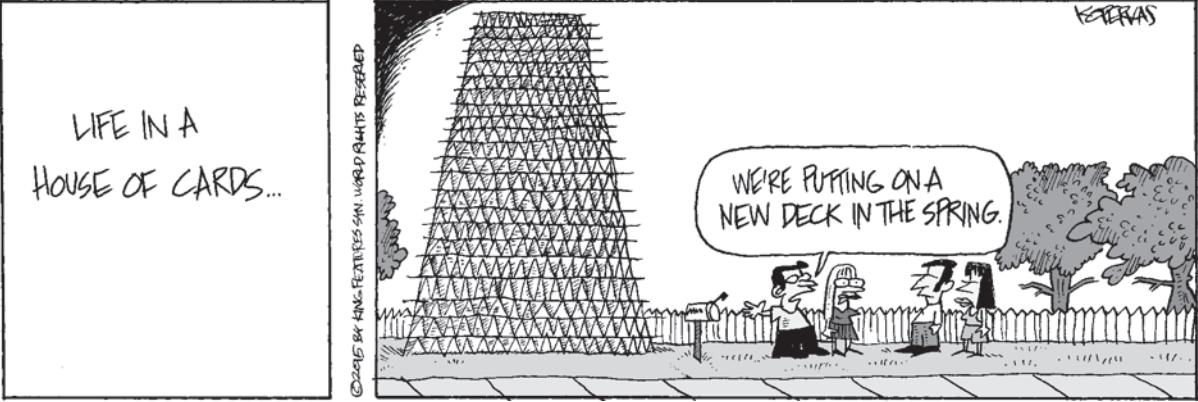

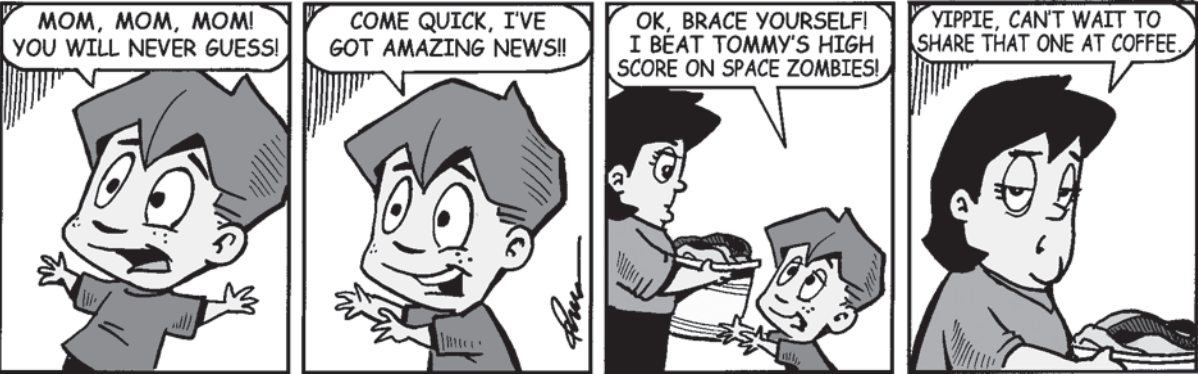

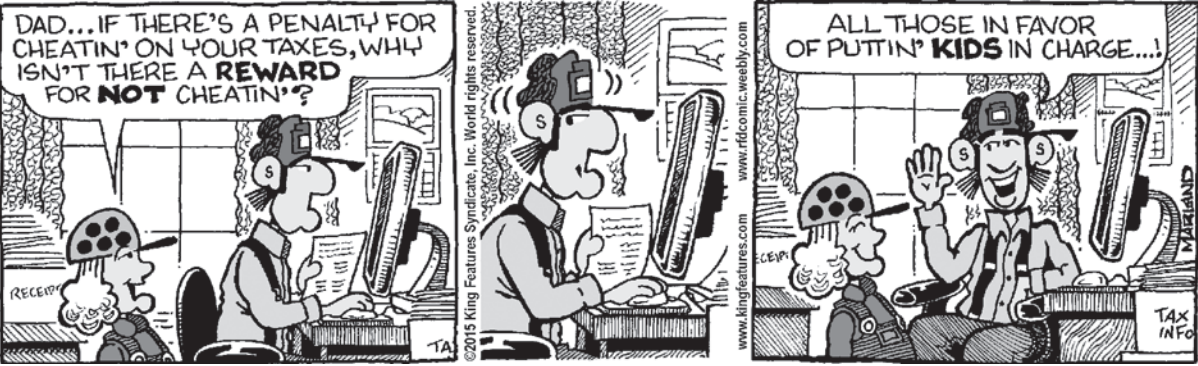

Your good health

DEAR DR. ROACH: My wife drinks in excess of 3 liters of diet soda a day, sometimes even more. She has colitis, for which she takes Lialda, and on her last visit to her primary care physician, her blood work revealed borderline bad levels in her liver. The doctor seems to think she needs to stop “drinking alcohol,” but I have been married to her for more than 30 years, and I know it’s not drinking that is causing this. We both consume only moderate amounts of alcohol. Could it be the chemicals in diet soda? – F.J.R.

dementia? – M.E.

First of all, the data on this subject is preliminary. That being said, there is data that suggests that people who drink two or three cups of coffee a day have a reduced risk of Alzheimer’s disease. The researchers have speculated, and some studies done on lab rats support that it’s the caffeine, and since regular coffee has much more caffeine than tea, coffee would be easier. However, there have been other studies suggesting that substances in tea besides caffeine may reduce Alzheimer’s risk as well.

I’m not recommending either coffee or tea based on this research. This data shows an association but doesn’t prove that coffee reduces Alzheimer’s risk. But if it’s your habit to drink a few cups of coffee, or a few pots of tea a day, it may reduce risk of dementia.

DEAR DR. ROACH: You had an article from a man that said he had his prostate removed and was wondering about taking testosterone. You said he would likely have an increased risk of prostate cancer recurrence. I, too, have had my prostate removed and was wondering how you could have an increased risk of prostate cancer after having the prostate removed. Could you explain? – C.G.

Even the best surgery can leave some prostate tissue in place. It’s also possible that some tumor cells spread before surgery. Any residual cancer can be stimulated, in theory, by

Social Security Q&A By Ray Vigil

Q: I applied for Medicare benefits last week. How can I check the status of my application?

A: Checking the status of your application is easy. If you applied for benefits, you can check the status at our secure website, [secure.ssa.gov/apps6z/IAPS/applicationStatus](https://secure.ssa.gov/apps6z/IAPS/applicationStatus), but you must wait

5 days from the date you originally filed. You will need to enter your Social Security number and the confirmation number you received when you filed your application. Your application status also shows the date that we received your application, any requests for additional documents, the address of the office processing your application, and whether a decision has been made about your benefits. If you are unable

to check your status online, you can call us at 1-800-772-1213 (TTY 1-800-325-0778), Monday through Friday from 7 a.m. to 7 p.m.

Q: I receive Supplemental Security Income (SSI), and I just got promoted and received a pay increase at my job. Do I need to tell Social Security about the promotion?

A: Because the Supplemental Security Income program is needs-based, the amount of the payment you receive is partly based on your income. You will need to report your wages monthly to make sure you get timely and accurate payments. The law requires you to report your earnings by phone or mail or take your pay stubs to Social Security at the beginning of

each month. When you report your earnings, make sure to include overtime, vacation pay, and bonuses. If your income changes because of a job loss or promotion, Social Security will likely either increase or decrease your payments. 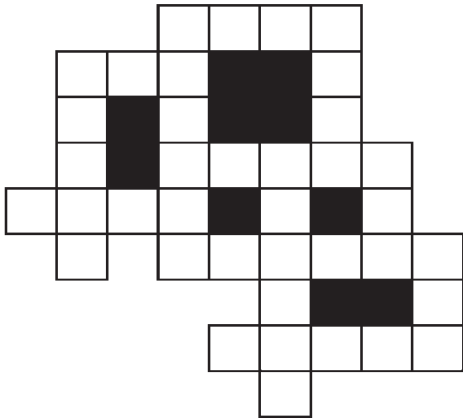
