Socorro - Socorro Independent School District (SISD) students have studied and practiced for the next round of STAAR tests, which are scheduled for the week of April 20. SISD schools are offering encouragement and fun this week to get ready for the test days.

Bill Sybert School will have two rallies on April 17. At both events, SISD's board trustee Michael Najera will talk to students and offer words of encouragement before the big test.

Ernesto Serna School will be having a carnival-themed rally called Target the STAAR. The games will include strategies that students have learned to help with STAAR content objectives, such as analyze, check twice, focus and pace yourself. SISD superintendent José Espinoza will be the guest speaker.

At Benito Martinez, the rally will include grilled hamburgers, inflatable toys, water toys and a mechanical bull. There also will be an extreme obstacle course for kids. The theme is STAAR Warrior, based on the TV show American Ninja Warrior.

"We just want to give the students a day where they can relax and enjoy themselves," said Benito Martinez Principal Greg Hatch. "Next week they will be ready."



'Income confiscation' is taking away the good life from American wage earners

The liberal notion of 'income inequality' is a divisive political ploy

NATION - It's not "income inequality" "blessed with different talents, levels of that threatens the future economic growth of our country, it is "income confiscation" that saps our strength, according to Dan Weber, president of the Association of Mature American Citizens (on the web at www.amac.us).

America was built on the premise that "hard work deserves to be rewarded, not deterred, and we reward hard work in a free society with what we call income," Weber explained.

He said that "the economy slows when the incentive to work is replaced by government programs that create dependence. It happens when our leaders beat the war drums of class warfare and income inequality, instead of encouraging Americans to work and allowing them to keep the income they sacrifice to earn."

In an Opinion Article published at Townhall.com this week, Weber railed against the "unconscionably divisive" tactics that liberal politicians are using these days to win votes. "Chief among their ploys is the fabricated notion of income inequality, a campaign phrase with a nice ring to it, if you are a politician who has little else to offer."

He said: "We have to cut taxes and discontinue programs that do not work, that take away jobs and responsibilities from the private sector that belong there, that the president thinks buy him votes, or that a congressman considers his personal pet project - all with your money. We have to root out the pervasive overspending and fraud in government and genuinely commit to eliminating wasteful spending."






