Bilbo will talk about the historic Bataan Death March and about the annual memorial marathon at White Sands Missile Range that commemorates these soldiers' sacrifices, at EPAS's next monthly gathering, which is scheduled for 2 p.m., Saturday, April 15, at the El Paso Museum of Archaeology, 4301 Transmountain Road. The event is free and open to the public.

WWII chronicles report that after the April 9, 1942 United States surrender of the Bataan Peninsula on the main Philippine island of Luzon to the Japanese during WWII, approximately 75,000 Filipino and American troops on Bataan were forced to make an arduous 65-mile march to prison camps. That grueling trek became known as the Bataan Death March.



# Sanctuary cities do not have a mandate to protect criminal illegals

Weber is president of the Association of Mature American Citizens, the largest conservative watchdog organization for seniors. He says the protection of illegal immigrants who have committed crimes is "indeed a crime and a preposterous stretch, even for leftist ideologues such as DeBlasio and Garcetti. A Harvard-Harris poll conducted just last month showed that 80% of the country oppose sanctuary cities. Obviously, there is bipartisan support for President Trump's efforts to protect American citizens from illegal immigrants who could do them harm. Why? Because the mayhem these criminals cause has become an almost daily occurrence. Some pretty dastardly crimes have been committed by miscreant illegals that sanctuary cities and sanctuary states protect."

Weber was referring to the arrest of an illegal charged with sexually attacking his girlfriend's two-year-old daughter. He also stabbed a woman outside of a local bar and then stabbed his girlfriend when she confronted him about the sexual abuse of her daughter.

"The man in this case, Tommy Alvarado-Ventura, is from El Salvador and has been deported four times for entering the country illegally. He keeps coming back like a bad penny. The incident occurred just two weeks ago in Nassau County in New York, State which established itself as a sanctuary state. The Police Commissioner of Nassau County, Thomas Krumpter, told reporters that it was 'probably the most heinous criminal act I've ever seen.' But, it is probably even more of a criminal act on the part of some elected officials that they are willing to sacrifice the safety of law abiding residents in order to provide a safe haven for villains like Tommy Alvarado-Ventura."

If illegals from south of the border can set up their criminal enterprises in America so readily, what is stopping illegal ISIS terrorists from entering the country to wreak havoc? The poem at the base of the Statue of Liberty reads 'Give me your tired, your poor, your huddled masses yearning to breathe free.' The invitation does not include malicious rapists and murderers. Whether you voted for Mr. Trump or not it is shear insanity to oppose him on the issue of whether cities and states should cooperate with Immigration and Customs Enforcement authorities," says Weber.

> He adds that illegals also have a significant negative impact on our economy and cites a report issued by the Federation for American Immigration Reform claiming that undocumented aliens cost U.S. taxpayers some \$100 billion a year. Weber points out that senior citizens bear the brunt of that cost. "Every dollar a sanctuary city or state spends on protecting illegals is a dollar that is not available to support services for the elderly."

Using nationwide employment data, the BLS created projections of which occupations are likely to increase and which are likely on the decline. Unsurprisingly, healthcare and technology jobs are on the rise, while employment in manufacturing and farming is falling. It even identified 15 specific occupations as "fast declining." At the top of the list of jobs on the way out are locomotive firers - though the surprise for many may be that the job even still exists. Also included in the top 10 are telephone operators, switchboard operators, postal service mail sorters, and sewing- and shoemachine operators.



- On April 17, 1964, the Ford Mustang is officially unveiled by Henry Ford II at the World's Fair in Flushing Meadows, New York. The new car debuted in Ford showrooms on the same day, and almost 22,000 Mustangs were immediately snapped up by buyers.
