Pet cities

With National Homeless Animals Day this last Saturday and over 85 million U.S. pet-owning households projected to spend \$72 billion this year, the personal finance website WalletHub has released an in-depth report on 2018's Most Pet-Friendly Cities. In order to determine where Americans' animal companions can enjoy the best quality of life without breaking the bank, WalletHub compared the creature-friendliness of the 100 largest cities across 24 key metrics. The data set ranges from minimum pet-care provider rate per visit to pet businesses per capita to walkability. El Paso ranked 84th in this study. Other stats:

- · Columbus, OH has the lowest average veterinary care costs (per visit), \$37.26, which is 2.1 times lower than in New York, NY, the city with the highest at \$79.30.
- Miami, FL has the most veterinarians (per square root of population), 0.3360, which is 88.4 times more than in Newark, NJ, the city with the fewest at 0.0038.
- St. Paul, MN has the lowest monthly dog-insurance premium, \$34.84, which is 2.4 times lower than in New York, NY, the city with the highest at \$83.50.
- San Francisco, CA has the most pet businesses (per square root of population), 0.8546, which is 23.8 times more than in Newark, NJ, the city with the fewest at 0.0359.


Amish Uber





> The biggest reason for the overall disparity in incarceration is different rates of offending. Blacks account for about 50 percent of homicides. It's not that the police are simply making up these crimes. The numbers for violent crime accord with reports from crime victims of the race of their assailants.

> The same applies to police shootings. Joseph Cesario, a professor of psychology at Michigan State University, writes that "the differences in involvement in criminal situations between black and white citizens fully explains the population-level disparity in fatal police shootings."

> Now, it's entirely fair to argue that different rates of offending are a function of the vestiges of racism, and that it is urgent to pursue criminal justice reform given how the status quo affects black families and communities. But the idea that we are living in a latter-day apartheid South Africa, with a system designed to jail and immiserate blacks out of sheer maliciousness, is contemptible, poisonous and wrong.

> It is telling that Elizabeth Warren is going there. There are two reasons. One is that she has a Bernie Sanders problem: She is a white politician who has overwhelmingly devoted herself to economic issues. She needs to play identity politics catchup. Two, in reaction to Donald Trump, the left is embracing a sweeping indictment of America as undemocratic and racist at the





SISD tech grant gives more laptops to students

All Salvador H. Sanchez middle school students to get personal digital device

EL PASO COUNTY – The Socorro Independent School District has been awarded the 2018-2019 Technology Lending Grant by the Texas Education Agency to provide more students access to high-quality digital resources and courses

The \$150,000 grant has allowed SISD to expand its Digitally Nurturing Academics 1:1 program (one student to one laptop) to sixth-grade students at Salvador H.

Sanchez Middle School, making it the first middle school in the district to give 100 percent of its students personal laptops for 24/7 access to digital learning.

"We are very excited to be the first middle school to provide laptops to every student," said Iris Jimenez, the school principal. "All of our students will have the opportunity to experience and engage in blended learning through the many technology tools that are available to them."

Along with the laptops, students at the school will have access to 65 hot spots



- On Aug. 27, 1955, the first edition of "The Guinness Book of Records" is published in Great Britain. The book was intended to be given away for free in pubs to promote the Guinness brand; however, it became so popular that the Irish brewer started selling it.
- On Aug. 28, 1996, Charles, Prince of Wales and heir to the British throne, and his wife, Princess Diana, formally divorce. In 1981, nearly 1 billion television viewers in 74 countries tuned in to witness their marriage ceremony at St. Paul's Cathedral in London.
- On Aug. 29, 1962, American poet Robert Frost leaves for the Soviet Union. The goodwill tour was sponsored by the U.S. State Department in an effort to thaw Cold War relations.




Bodybuilder son takes steroids

DEAR DR. ROACH: My 23-year-old son is a bodybuilder, and much to my dismay, he takes steroids. I know he takes testosterone, and I don't know what else. How will this affect him? – Anon.

Testosterone has many bad long-term effects, and he really should stop it. As a resident, I took care of a seemingly very

healthy, very muscular 30-yearold man with terrible heart failure due to a heart attack. Many similar reports have led to suspicion that steroids taken for bodybuilding increase risk of heart attack and even sudden death. There appear to be many other long-term effects, including neuropsychiatric effects of anger and aggressive behavior. They also may



reduce sperm count and affect fertility.

I don't know what else he may be taking, but I would strongly urge him to evaluate all supplements carefully.

DEAR DR. ROACH: I was a healthy female until I had an injury to my back. I experience pain and tingling in my right side, going down the back of my right leg. Sitting is especially painful, as is standing in one place for too long. Now the pain has started in my left side also. I have tried chiropractors, acupuncture, physical therapy, epidural shots and pain pills. I also had two laminectomies (decompression surgery on the spinal canal) on L4/L5 last year, with no relief from the pain. Upon seeing another neurosurgeon, I have been told that I have some large Tarlov cysts (1 cm). There does not seem to be a great amount of information about these on the internet, plus I am not sure what information out there is accurate. One doctor on the internet is all about having surgery on them. The neurosurgeon I am seeing does not want to do surgery just yet. He says that surgery does not always bring about pain relief. Can you share some information about these Tarlov cysts and what can be done for the continued back and leg pain? Dealing with this for several years has caused much emotional distress and depression. - F.H.

Tarlov cysts, also called perineurial cysts, occur along the lining of the spinal cord and nerve roots. In one study, in 500 people with MRI scans, 23 had Tarlov cysts, but only five had any symptoms from them. In this study, the cysts were drained by a needle, which relieved the pain, although the pain usually
