Best states for police

With President Joe Biden's State of the Union address calling for the nation to "fund the police" with better training and resources, the personalfinance website WalletHub has released its report on 2022's Best & Worst States to Be a Police Officer, as well as accompanying videos and expert commentary. In order to determine the best states to pursue a career in law enforcement, WalletHub compared the 50 states and the District of Columbia across 30 key indicators of police-friendliness. The data set ranges from the median income for law-enforcement officers to police deaths per 1,000 officers to state and local police-protection expenses per capita. Texas was rated 18th in the report, ranking (1-Best; 25-Avg.):

- 7th Law-Enforcement Officers per Capita;
- 15th Median Income for Law-Enforcement Officers (Adjusted for Cost of Living);
- 49th Median Income Growth for Law-Enforcement Officers;
- 36th Violent-Crime Rate;
- 33rd State & Local Police-Protection Expenses per Capita; and
- 50th Police Deaths per 1,000 Officers.

Note: "Law-enforcement officers" includes police and sheriff's patrol officers, detectives and criminal investigators.

Mural recognizes Canutillo's rich history

CANUTILLO-Toremind the thousands of people who visit the Outlet Shoppes at El Paso that they are actually in Canutillo, a colorful mural that masterfully heralds the upper valley community's rich history now adorns a large wall at the southwest entrance to the outlet mall courtyard.

Scalia was right - again

Supreme Court justices in American history, and the opinion overturning Roe is a reminder of it.

In Planned Parenthood of Southeastern Pennsylvania v. Casey, the 1992 Supreme Court decision upholding (and amending) Roe v. Wade, the justices in the majority believed that they could settle once and for all the dispute itself the final arbiter.

Scalia thought this was outlandishly wrongheaded and said so in a dissent that looks farsighted 30 years later. Not only did the Court fail to calm the political waters on abortion, it made itself central to the political and moral argument over the issue.

If there's any doubt about that, consider the security fencing reminiscent of the days after January 6 that is now going up around the Supreme Court building. Consider the left-wing group planning protests at the homes of conservative justices. Consider the proposal from Sen. John

Justice Antonin Scalia was among the most prescient Cornyn of Texas that justices get 24/7 security details.

It's extraordinary that now, at the very least, the firestorm over the leak of Justice Samuel Alito's draft whiff of physical intimidation is part of the Court's deliberations on Roe.

In his dissent in Casey, Scalia analogized the Court's jurisprudence on abortion to its decision in Dred Scott v. Sandford, the notorious 1857 case in which the Court denied the petition of a slave named Dred Scott for freedom.

The Court issued a sweeping decision, declaring unconstitutional the Missouri Compromise of 1820 that had banned slavery north of latitude 36 degrees 30' in the Louisiana Purchase. It did this, in part, because it thought it could forge a settlement on slavery that had eluded the political branches.

Instead, the Chief Justice Roger Taney made himself

infamous for decision that, like Roe and Casey, was wrongly decided, that entrenched and extended a profound social wrong, that



democratic decision-making, and that utterly failed to create political and social peace.

The decision was immediately excoriated by opponents of slavery in the harshest possible terms. They called into question its legitimacy and indeed the legitimacy of the Court itself. Serious and sober-minded men like Abraham Lincoln and William Seward advanced conspiracy theories for how the Court could have arrived at such an atrocious place. (There were indeed improprieties around the Court's deliberations.)

Scalia invoked a portrait of Roger Taney at Harvard Law School by the great painter Emanuel Leutze in

The world has felt crazier every day for the last two years. interesting that social media has the power to This past weekend proved again that it's not getting better.



a female Folklorico dancer in a light blue dress. Apodaca related that the mural, *Movements of the Past*, is a symbol that celebrates the spirit of this borderland community. Another mural, Somos Fiesta by local artist Paola Martinez, features an array of brightly colored pinatas, an allusion to this area's diversity and culture.

The purpose for painting the women in art mural by an all-female crew is meant to inspire future generations to accelerate progress towards gender equality and, at the same time, to showcase the unique culture of the Canutillo community, explained Estella Ramos, an art teacher at Jose J. Alderete Middle School (AMS) which is in the Canutillo school district and located near the outlet mall.

"As a female artist I have always had a dream of collaborating with other women artists on a project. All that I lacked was a subject and a location. I was fortunate to find both," Ramos commented during the mural's unveiling.

"My husband, Dr. Regino Ramos Jr. (the CISD music director and a Canutillo native), has always told me stories of the history of Canutillo. I

discovered that Canutillo is rich with history, but people living here don't know about it. I knew that doing a mural about Canutillo's history in a high traffic venue, like The Outlet Shoppes at El Paso, would help make people aware of Canutillo's rich history. We were very fortunate to find a willing ally in The Outlet Shoppes and their staff," the AMS art teacher stated.

Joining E. Ramos with this endeavor were CISD faculty members Heather Cawley, Northwest Early College High School (NECHS) art faculty member; Stacy Edgar, Canutillo High School (CHS) art faculty member; Rocio Ortega, Canutillo Middle School (CMS) art faculty member, and Nidia Avila, AMS Principal.

Clint Independent School District provides the following educational program/services to identified disabled children who reside within the district beginning on the third birthday through age twenty-one.

- 1) Instructional Program: including Early Childhood (beginning on the third birthday through age five), Resource (grades K-12) and Self-Contained (grades K-12)
- 2) Diagnostic Services
- 3) Transportation Services
- 4) Speech Therapy
- 5) Counseling Services
- 6) Adaptive Equipment Services
- 7) Physical Therapy
- 8) Occupational Therapy
- 9) School Health Services
- 10) Homebound Services
- 11) Autism Support

Services are provided to identified auditorial and visually impaired children who reside within the district from birth through age twenty-one and to private/home school students who qualify for special education services.

In compliance with the Family Educational Rights and Privacy Act of 1974 and Public Law 105-17, parents and adult students have the right to inspect educational records. District policies FL and FL-P provide for record access, confidentiality, and complaint procedures.

Destruction of Special Education Records

Attention Parents/Guardians, Former Students, Eligible (Adult) Students: Special Education records collected by the Clint Independent School District (CISD) related to the identification, evaluation, educational placement, or the provision of Special Education services must be maintained under state and federal laws for a period of five years after Special Education services have ended for the student. Special Education services end when the student no longer is eligible for services, graduates, completes his or her educational program at age 22, or moves from the district. Clint ISD intends to destroy Special Education records of those students that ceased receiving services during the school year 2016-2017.

Parents or adult students need to recognize that these records may be needed by the student or the parent for Social Security benefits or other post-school benefits. Records scheduled for destruction may be requested no later than the end of the work day on June 24, 2022 by emailing the CISD Special Education Office at lorraine. martinez@clint.net.

Can Prilosec be taken for more than 14 days?

DEAR DR. ROACH: What's the story with Prilosec? Doctors routinely tell people with GERD or acid stomach to take this forever.

Yet it clearly describes only a 14-day treatment on the box. A physician assistant told me that because of a rare infrequent condition some users have that the manufacturer is legally bound to post the 14-day limit, but that the general population can safely ignore it. Can you enlighten and reassure those of us whose physicians have said to take it long term? -C.D.C.



The patient instructions in the over-the-counter versions of proton pump inhibitors, such as omeprazole (Prilosec), do recommend a 14-day course. However, longer courses may indeed be prescribed by a licensed prescriber, such as a PA. Even so, there are relatively few people who need lifelong medication. Those who do may have a condition such as Barrett's esophagus, in which PPIs – the most potent medical treatment to suppress stomach acid – are necessary. They not only relieve symptoms, they are also prescribed in hopes of reducing the risk of developing cancer of the esophagus. The data on this are still not clear.

For people with acid reflux (also called gastroesophageal reflux disease), PPIs are usually not needed lifelong. However, it may still be reasonable to use these drugs long term if the prescriber feels the benefit outweighs the risk.

There are several risks of long-term use of PPIs. Stomach acids are important in protecting against bacteria, and two kinds of bacterial infections are more common in PPI users. The first is in the colon, especially of Clostridium difficile, where PPI users are about 30% more likely to be infected and may do so even without the antibiotic use that is the most common risk factor for C. diff. The second is pneumonia, although the apparent association may not be as strong as formerly thought.

Low stomach acid may decrease absorption of vitamins and minerals, especially magnesium, iron and vitamin B12.

PPIs were thought to increase the risk of a rare tumor, gastric carcinoid, based on data from rats, and of colon cancer. Those risks have not been seen in humans. Early data suggest increased risk of kidney disease and dementia. That risk appears to be small,

Long-term PPI use has some risk of side effects and should be used only when there are benefits to PPIs that can't be obtained with other treatments, including other medications and lifestyle changes. This especially includes better diet, weight loss when appropriate and not eating right before bed.

DEAR DR. ROACH: I'm not against medical marijuana when prescribed, but why do patients want or need to smoke it? What does the secondhand smoke do to children and adults around those who are smoking it? -C.G.

Secondhand cannabis smoke has potential adverse effects. It can be irritating to the eyes and respiratory tract. The psychoactive component, THC, can be absorbed by someone in close proximity, especially if exposed over a prolonged period. This is also true for the vapor made by an e-cigarette device.

Cannabis smoke is irritating for the user as well. Many people who use medical cannabis use edibles containing extracts, THC and CBD. These have no risk to others, although they do carry a higher risk of acute intoxication for the user. In any event, cannabis users should take care not to expose people who do not want to be exposed, especially children.




