### **Diversity**

With hate crimes on the rise, personal-finance website WalletHub has released its report on 2024's Most Diverse Cities in America, as well as expert commentary, to identify the places where people have the most unique blend of perspectives, which brings social and economic benefits. To determine the places in the U.S. with the most mixed demographics, WalletHub compared the profiles of more than 500 of the largest cities across five major diversity categories: socioeconomic, cultural, economic, household and religious. El Paso was ranked 253rd in the report. Other stats:

- · Murfreesboro, TN has the highest income diversity, which is two times higher than in Hockessin, DE, the city with the lowest.
- · Germantown, MD has the highest racial and ethnic diversity. which is four times higher than in Laredo, TX, the city with the lowest.
- South Valley, NM has the highest occupational diversity, which is 3.2 times higher than in Cambridge, MA, the city with the lowest.

"The diverse most cities demonstrate diversity in many dimensions – not just in race and gender but also everything from residents' languages and birthplaces to their job types and household sizes. These cities blend together a multitude of different perspectives, helping people to better understand the world around them and become more empathetic. This exchange of ideas also tends to increase the economic success of diverse cities. The most diverse cities overall are a trio of Maryland towns close to Washington, D.C.: Gaithersburg, Silver Spring, and Germantown. These Maryland cities have some of the most diversity when it comes to race, language and educational attainment. However, individual cities across the country stand out in different categories. For example, South Valley, NM, has the most occupational diversity, while St. Louis has the most religious diversity."



# Moments

- On July 8, 1918, Ernest Hemingway was working as an ambulance driver for the American Red Cross while serving on the Italian front in World War I when he was struck by an Austrian mortar shell as he handed out chocolate to soldiers in a dugout.
- · On July 9, 1993, British forensic scientists announced a positive identification of the remains of Russia's last czar, Nicholas II, his wife, Czarina Alexandra, and three of their daughters. Mitochondrial DNA was used on the family's bones, which had been excavated from a mass grave near Yekaterinburg two years earlier.
- On July 1985. conservation Greenpeace's flagship, the Rainbow Warrior, sank in New Zealand's Auckland Harbor after French agents in diving gear planted a bomb on the vessel's hull. The ship had been preparing for a protest voyage to a French nuclear test site in the South Pacific.
- On July 11, 2005, Hurricane Dennis blasted onto the East Coast near Pensacola Beach with a storm surge of 15 feet,

wiping out power for over 1 million in Florida and Alabama, with Mississippi also being declared a disaster zone along with those two states. The hurricane had already hit Cuba, the Dominican Republic and Haiti earlier in the week, causing 21 fatalities and massive property damage.

- On July 12, 1967, race riots broke out in Newark, New Jersey, after a Black cab driver was arrested and beaten by police. The riots resulted in 24 deaths, 1,100 wounded, 1,300 people arrested and property losses in excess of \$5 million. The violence was believed to have been triggered by a number of factors, including rumors that the cabbie had died and charges that the police involved were brutally racist, along with poor mayoral leadership.
- On July 13, 1920, the U.S. Post Office banned customers from mailing children and animals. While it's hard to believe such a ruling would even be necessary, officials wisely decreed it so after several cases involving parents dispatching a child and one person posting a skunk!
- On July 14, 1953, Egyptian politician Rawya Ateya became the first female parliamentarian in the Arab world.

# San Elizario Independent School District SPECIAL EDUCATION/CHILD FIND

The San Elizario Independent School District provides services for children who are eligible for special education. Eligible special education students will be afforded a free, appropriate public education beginning on their third birthday and continuing through their 21st year. Children who are identified as auditorially impaired, visually impaired or deaf-blind may be served from birth through 21 years of age. The San Elizario Independent School District provides special education and related services to students residing within the District boundaries. A student with a disability must meet eligibility guidelines in one or more areas including physical disability, intellectual disability, emotional disturbance, learning disability, autism, speech impairment, traumatic brain injury, visual or auditory impairment. This impairment must significantly affect the student's ability to progress adequately without support services.

If a child is experiencing learning difficulties, the parent may contact the person listed below to learn about the district's overall general education referral or screening system for support services. This system links students to a variety of support options including referral for special education evaluation. Students having difficulty in the regular classroom should be considered for tutorial, compensatory, and other support services that are available to all students. At any time, a parent is entitled to request an evaluation for special education services. Within a reasonable amount of time, the district must decide if the evaluation is needed. If the evaluation is needed, the parent will be notified and asked to provide consent for the evaluation. The district must complete the evaluation and the report within 45 school days of the date the district received the written consent. The district must give a copy of the report to the parent. If the District determines that the evaluation is not needed, the district will provide the parent with a written notice that explains why the child will not be evaluated. This written notice will include a statement that informs the parent of their rights if they disagree with the district. Additionally, the notice must inform the parent how to obtain a copy of the Notice of Procedural Safeguards-Rights of Parents of Students with Disabilities.

# Educación Especial / Programa De Identificación De Niños (Child Find)

El Distrito Escolar Independiente de San Elizario provee servicios a los niños que califican para recibir educación especial. Los estudiantes que califiquen recibirán una educación pública gratuita y adecuada comenzando con su tercer cumpleaños hasta el fin de su vigésimo-primer año (21). Los niños que son identificados con problemas auditivos, visuales, sordos o ciegos pueden ser atendidos desde su nacimiento hasta los veintiún años de edad. El Distrito Escolar Independiente de San Elizario provee servicios de educación especial y otros servicios relacionados a los estudiantes que vivan dentro de los límites del distrito. Un estudiante con una discapacidad debe cumplir con las guías que reúnen los requisitos en una o más áreas incluyendo: discapacidades físicas, discapacidad intelectual, alteraciones emocionales, discapacidad de aprendizaje, autismo, discapacidad del habla, daño cerebral por trauma, o discapacidad visual o auditiva. Esta discapacidad debe afectar significativamente la habilidad del estudiante para progresar adecuadamente sin asistencia.

Si un alumno está teniendo dificultades en su aprendizaje, los padres pueden contactar a la persona encargada (ver información al final) para que les informe acerca del programa general de derivación (referral) del distrito o sistema de detección para servicios de asistencia. Este sistema enlaza a los estudiantes con una gran variedad de opciones de apoyo que incluyen la derivación para que se le practique una evaluación de educación especial. Los estudiantes que estén teniendo dificultades en un aula regular deber ser considerados para recibir tutoría, planes de compensación educativa y otros servicios de apoyo que estén disponibles para todos los estudiantes. Los padres tienen derecho, en cualquier momento, de pedir una evaluación para recibir servicios de educación especial. El distrito debe decidir, dentro de un plazo razonable, si dicha evaluación es necesaria. En caso afirmativo, el padre será notificado y se le pedirá permiso para realizar la evaluación. El distrito debe llevar a cabo la evaluación y el reporte sobre los resultados dentro de 45 días escuela a partir de la fecha en que el distrito recibió el permiso del padre por escrito. El distrito debe proporcionar una copia del reporte al padre. Si el distrito determina que la evaluación no es necesaria, debe proporcionar por escrito una notificación que explique el por qué. Esta notificación por escrito debe incluir una declaración que informe al padre sobre sus derechos si es que no está de acuerdo con la decisión del distrito. Además, la notificación debe informar al padre cómo obtener una copia del Aviso sobre Garantías Procesales-Derechos de los Padres de Alumnos con Discapacidades.

all of them," he added.

Grijalva explained that LVWD is the only water district in El Paso County that will accept septic haulers' wastewater transfers into its sewer system. He asserted that LVWD stepped up to allow the wastewater transfers because El Paso Water does not allow septic haulers to use its sewer system for such transfers.

El Paso Water spokesperson Denise Parra said that EPWater does not allow septic haulers' wastewater transferring loads into its system because their officials do not know what is in it. EPWater's treated wastewater is cleaned and treated to use for irrigation and industrial purposes, to replenish the aquifer or returned to the environment. The wastewater from the Bustamante Plant will eventually be source water for the new Advanced Water Purification Facility that will take the water through several phases of filtration and purification to transform it into drinking water.

Grijalva, on the other hand, said that the water being put into its water system is gray water – that is bath water, laundry water, and such. He said that every septic hauler's wastewater load is visually

These warnings come courtesy of the Consumer Product Safety Commission (www.cpsc.gov/recalls).

In the case of the stove, the manufacturer is stepping up with a free inspection and repair.

The manufacturer of the tiller is sending out new assembly instructions.

Other recent recalls on the CPSC website include defective crib bumpers that can obstruct breathing, a pool drain cover that can entrap swimmers, a smoke and carbon

So many defective products! And without product safety alerts we might never know, until someone we know gets hurt.

A few hints:

- Before you buy a product, check online for any safety alerts.
- Save your receipts when you buy products, especially those that are complicated enough to come with a user manual. Tape the receipt inside the front cover of the manual or keep a folder of receipts for products you purchase.
- To stay safe, sign up for product recall alerts. Besides the CPSC website, check www.recalls.gov for an even wider selection of product types and, foodsafety.gov for The remedy for the caustic vinegar cleaning solution, food alerts. Right now they have a salmonella alert for black pepper.



# Meds usually safe after expiration date

DEAR DR. ROACH: I recently tested positive for COVID using an expired home test, and I self-isolated for five

days. I also realized every Tylenol, antihistamine, DayQuil, NyQuil and allergy pill that I had was past its expiration date. Some were only expired by a few months, but most were expired by two to four years. I guess I don't get sick often. My question is: Before I dispose of these, how effective are they, and



are any of them dangerous to use? -K.L.

Drug manufacturers are required to make expiration dates, and they guarantee that the drugs are what they say they are and are effective until a certain date (at least if they are properly stored in a cool and dark area). This does not necessarily mean that they become ineffective or dangerous after expiring, and many drugs have been proven to maintain efficacy for years or decades after the printed expiration date.

A military study found that 90% of drugs are still effective 15 years after expiration. It is rare for a drug to become dangerous; however, the tetracycline class of antibiotics is one where toxicity has been found.

In general, if a drug is a few months to a year past its expiration date, it is probably OK. (Liquid drugs, nitroglycerin and insulin are notable exceptions.) But at some point, you have to ask yourself whether it is worth the small risk of the medicine being less effective, especially for inexpensive over-the-counter (OTC) drugs.

Also, COVID test kits may have an extended expiration date. The Food and Drug Administration maintains a list at tinyurl.com/COVIDTestKitExpire.

DEAR DR. ROACH: Can you comment on N-acetyl cysteine (NAC), an OTC supplement for psychiatric illness? I am interested in its safety and effectiveness and whether there any side effects or cautions when taking it. Also, what is the safe daily dosage, and how long does it take for benefits to occur? -L.B.

NAC has been intravenously used for many years in medicine as a specific antidote to acetaminophen toxicity. It is also used via inhalation to thin out thick mucus so that it can be coughed out. As you say, several recent studies have looked at its effectiveness with a variety of mental health issues, including depression, obsessive-compulsive disorder, and cannabis use disorder. Although there is a risk of a severe allergic response when used intravenously, it is generally safe when used orally. Some studies have looked at the effectiveness of NAC by itself, while others looked to see whether NAC can improve outcomes in combination with the standard treatments.

Although the literature is mixed, I say that there is promise with this treatment. When I recommend it, it is most commonly with patients who do not want to use the standard treatments or who want the lowest possible dosage. The dose used in most studies is 1-3 grams daily.

In one well-done study that looked at adults with major depression, the group who combined NAC with the standard treatment showed superiority over those who received the standard treatment alone. The difference was seen after 20 weeks of treatment. Not all studies showed a benefit

I want to emphasize that an OTC supplement, no matter how promising, is not a substitute for medical care, especially psychiatric care. If you have a mental health issue, ask your mental health provider about NAC.




